HOUSE BILL 1451

AS INTRODUCED

An Act relating to motor vehicles; amending 47 O.S. 2011, Section 15-113, which relates to penalties for handicapped parking violations; increasing fine for violations; directing portion of fine to be deposited in certain revolving fund; creating revolving fund; providing for codification; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 47 O.S. 2011, Section 15-113, is amended to read as follows:

Section 15-113. A. Any person who knowingly makes or procures the making of a false statement in an application submitted pursuant to Sections 15-111 through 15-113 of this title is guilty of a misdemeanor and upon conviction shall be punished by a fine of ~~Five Hundred Dollars (\$500.00)~~ Six Hundred Dollars (\$600.00) for each falsified statement. This penalty shall be stated on all applications.

B. 1. Any person who has not been issued a physically disabled parking placard pursuant to the provisions of Section 15-112 of this

1 title, a physically disabled license plate issued pursuant to the
2 provisions of Section 1135.1 of this title, a disabled veterans
3 license plate pursuant to the provisions of Section 1135.2 of this
4 title, a disability sticker issued by the Department of Veterans
5 Affairs and federal military bases, or a physically disabled placard
6 or license plate issued by another state, and uses a placard,
7 sticker, or license plate to park in a disabled parking place is
8 guilty of a misdemeanor and upon conviction shall be punished by a
9 fine of ~~Five Hundred Dollars (\$500.00)~~ Six Hundred Dollars
10 (\$600.00). A person transporting a physically disabled person with
11 an authorized placard, sticker or license plate, as provided in
12 subsection A of Section 11-1007 of this title, shall be excluded
13 from the provisions of this section.

14 2. Any person who has been issued a physically disabled parking
15 placard pursuant to the provisions of Section 15-112 of this title,
16 a physically disabled license plate issued pursuant to the
17 provisions of Section 1135.1 of this title, or a disabled veterans
18 license plate pursuant to the provisions of Section 1135.2 of this
19 title, and knowingly allows the placard or license plate to be used
20 by a person not issued the placard or license plate as described in
21 paragraph 1 of this subsection, is guilty of a misdemeanor and upon
22 conviction shall be punished by a fine of ~~Five Hundred Dollars~~
23 ~~(\$500.00)~~ Six Hundred Dollars (\$600.00).

1 C. A person who knowingly makes a counterfeit physically
2 disabled parking placard or physically disabled license plate is
3 guilty of a misdemeanor and upon conviction shall be punished by a
4 fine of ~~Five Hundred Dollars (\$500.00)~~ Six Hundred Dollars (\$600.00)
5 for each counterfeit placard or license plate made by such person.

6 D. One Hundred Dollars (\$100.00) of the fine associated with
7 violations in this section shall be paid to the State Treasurer and
8 placed to the credit of the Independent Living Services Revolving
9 Fund created in Section 2 of this act.

10 SECTION 2. NEW LAW A new section of law to be codified
11 in the Oklahoma Statutes as Section 625.3 of Title 59, unless there
12 is created a duplication in numbering, reads as follows:

13 There is hereby created in the State Treasury a revolving fund
14 for the Department of Rehabilitation Services to be designated the
15 "Independent Living Services Revolving Fund". The fund shall be a
16 continuing fund, not subject to fiscal year limitations, and shall
17 consist of all monies appropriated or contributed thereto. All
18 monies accruing to the credit of the fund are hereby appropriated
19 and may be budgeted and expended by the Department for activities
20 related to the Independent Living Services Act. Expenditures from
21 the fund shall be made upon warrants issued by the State Treasurer
22 against claims filed as prescribed by law with the Director of the
23 Office of Management and Enterprise Services for approval and
24 payment.

SECTION 3. This act shall become effective November 1, 2019.
