17	A. A charter school sponsored as provided for in Section 3-132
18	of Title 70 of the Oklahoma Statutes and a virtual charter school
19	sponsored by the Statewide Virtual Charter School Board pursuant to
20	Section 3-145.3 of Title 70 of the Oklahoma Statutes shall be
21	prohibited from using its State Aid allocation or any other state-
22	appropriated revenue to advertise or to contract with an individual

On the Internet, through the press, radio or television, or 8 9 by use of any other medium. 10 The State Board of Education and the Statewide Virtual С. Charter School Board shall promulgate rules necessary to implement 11 the provisions of this section. 12 13 SECTION 2. NEW LAW A new section of law to be codified 14 in the Oklahoma Statutes as Section 3-142.2 of Title 70, unless 15 there is created a duplication in numbering, reads as follows: 16 A. Any student enrolled in or employee of a charter school 17 sponsored as provided for in Section 3-132 of Title 70 of the 18 Oklahoma Statutes or a virtual charter school sponsored by the 19 Statewide Virtual Charter School Board pursuant to Section 3-145.3 20 of Title 70 of the Oklahoma Statutes shall be prohibited from 21 receiving compensation or any financial incentive for recruiting 22 students to the school.
