- 4. Any final disciplinary action resulting in loss of pay, suspension, demotion of position, or termination.
- C. Except as may otherwise be made confidential by statute, an employee of a public body shall have a right of access to his or her own personnel file.
- D. Public bodies shall keep confidential the The home address, addresses, home telephone numbers and social security, Social

 Security numbers of any person employed or formerly employed by the public body and information related to personal electronic communication devices of current and former public employees shall
