HOUSE BILL 4118

AS INTRODUCED

An Act relating to professions and occupations;
amending 59 O.S. 2011, Section 887.12, which relates
to physical therapists; modifying continuing
education hours for physical therapists and physical
therapist assistants; and providing an effective
date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 59 O.S. 2011, Section 887.12, is
amended to read as follows:

Section 887.12 A. 1. Except as otherwise provided by the
Physical Therapy Practice Act, all licenses shall expire on January
31 of each year. A license may be renewed during the month of
January of each year upon:

- a. application,
- b. evidence of satisfactory completion of a program of
continuing education or of alternative requirements,
as required by the State Board of Medical Licensure

1 and Supervision pursuant to subsection B of this
2 section, and

3 c. payment of fees.

4 2. Applications for renewal of licensure shall be sent by the
5 Board to all licensed physical therapists and physical therapist
6 assistants at their last-known address. Failure to renew a license
7 three (3) months after notification shall effect a forfeiture of the
8 license granted pursuant to the provisions of the Physical Therapy
9 Practice Act. Upon recommendation of the Board, a lapsed license
10 may be revived upon the payment of all unpaid registration fees and
11 pursuant to such rules as may be promulgated by the Board.

12 3. A physical therapist or physical therapist assistant who
13 fails to apply for a renewal of a license for five (5) years may
14 renew the license by complying with the provisions of the Physical
15 Therapy Practice Act relating to the issuance of an original
16 license.

17 B. For physical therapists and physical therapist assistants,
18 the Board shall establish by rule the requirements for:

19 1. A program of continuing education; and

20 2. Alternative requirements to establish continuing competence
21 to practice.

22 The Board shall also establish by rule the ~~minimum~~ hours of
23 continuing education needed to satisfy these requirements, with a
24 minimum requirement of at least forty (40) hours per year of

1 continuing education for physical therapists and twenty (20) hours
2 per year of continuing education for physical therapist assistants.

3 In establishing these requirements, the Board shall consider any
4 existing programs of continuing education currently being offered to
5 licensed physical therapists or physical therapist assistants.

6 SECTION 2. This act shall become effective November 1, 2020.
