14	BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
15	1ST SESSION OF THE 57TH OKLAHOMA LEGISLATURE:
16	SECTION 1. The Secretary of State shall refer to the people for
17	their approval or rejection, as and in the manner provided by law,
18	the following proposed amendment to Sections 1 and 23 of Article VI
19	of the Oklahoma Constitution to read as follows:
20	Section 1. A. The Executive authority of the state shall be
21	vested in a Governor, Lieutenant Governor, Secretary of State, State
22	Auditor and Inspector, Attorney General, State Treasurer,
23	Superintendent of Public Instruction, Commissioner of Labor,
24 2 -	Commissioner of Insurance and other officers provided by law and

<sup>1</sup> this Constitution, each of whom shall keep his <u>or her</u> office and <sup>2</sup> public records, books, and papers at the seat of government, and <sup>3</sup> shall perform such duties as may be designated in this Constitution <sup>4</sup> or prescribed by law.

<sup>5</sup> B. The Secretary of State shall be appointed by the Governor by
<sup>6</sup> and with the consent of the Senate for a term of four (4) years to
<sup>7</sup> run concurrently with the term of the Governor.

8 <u>C. Upon expiration of the term of the Commissioner of Insurance</u>
 9 elected in 2022, the Commissioner of Insurance shall be appointed by
 10 the Governor by and with the consent of the Senate and shall serve
 11 at the pleasure of the Governor.

12 Section 23. A. There shall be elected by the qualified 13 electors of the State, at the first general election, a chief 14 officer of the Insurance Department, who shall be styled the 15 "Insurance Commissioner", whose term of office shall be four years: 16 Provided, That the first term of the Insurance Commissioner so 17 elected, shall expire at the time of the expiration of the term of 18 office of the first Governor elected The Commissioner of Insurance 19 shall be appointed by the Governor by and with the consent of the 20 Senate as provided in Section 1 of this article. The Insurance 21 Commissioner of Insurance shall be at least twenty-five (25) years 22 of age and well versed in insurance matters. 23

B. No person shall be eligible to serve as Insurance
Commissioner for a period of time in excess of eight (8) years.

1	Such years need not be consecutive. Any years served by a person
2	elected or appointed to serve less than a full term to fill a
3	vacancy in such office shall not be included in the limitation set
4	forth herein. Any person serving in such position at the time of
5	passage of this amendment shall be eligible to complete the term for
6	which he or she has been elected and shall be eligible to serve an
7	additional eight (8) years thereafter, notwithstanding the
8	provisions of this amendment. The Legislature is hereby authorized
9	to enact laws to implement the provisions of this subsection.
