  - 2. "Municipal office" means any elective municipal office for which Declarations of Candidacy are filed with the secretary of the county election board as required by Sections 16-109 and 16-110 of Title 11 of the Oklahoma Statutes established under state or municipal law; and
  - 3. "Municipal political committee" means any committee composed of one or more persons whose purpose includes the election or defeat of one or more candidates for municipal office but which is not required to register with the Ethics Commission or the Federal Election Commission.
- 14 Section 13, Chapter 313, O.S.L. SECTION 2. AMENDATORY 15 2014, as amended by Section 1, Chapter 334, O.S.L. 2015 (11 O.S. 16 Supp. 2020, Section 56-103), is amended to read as follows: 17 Section 56-103. A. The Municipal Campaign Finance and 18 Financial Disclosure Act shall apply only to municipalities with a 19 population of more than ten thousand (10,000) according to the most 20 recent Federal Decennial Census and a general fund expenditure 21 budget in excess of Ten Million Dollars (\$10,000,000.00) in the 22 fiscal year in which the municipal elections are held any candidate 23 for municipal office or elected municipal official who accepts or 24 expands in excess of Five Hundred Dollars (\$500.00).
