The Board of Mental Health and Substance 17 Abuse Services is hereby authorized and directed to create a trust 18 into which all real property held by or for the benefit of the 19 Department of Mental Health and Substance Abuse Services shall be 20 transferred. 2.1 The trust shall provide that: 22 the property placed into the trust may never be sold, 23 except for the tracts specifically described in 24 subparagraph c of this paragraph, if it is determined

by the trustees for the Department's Real Property

Trust and by the Department that such a sale is in the

best interests of the Department, and then the

proceeds shall be used exclusively for tangible

infrastructure improvements that benefit the persons

Except as provided in subsection C of this section, the Office of Management and Enterprise Services is authorized and directed to provide all requested assistance to the Department of Mental Health and Substance Abuse Services in leasing property placed in such trust.

Τ	C. The Commissioners of the Land Office are authorized and
2	directed to provide all requested assistance to the Department of
3	Mental Health and Substance Abuse Services in leasing mineral
4	interests placed in such trust.
