1 ENGROSSED HOUSE BILL NO. 4118 By: Hasenbeck, Smith, Boles, 2 and Humphrey of the House 3 and 4 Taylor and Burns of the Senate 5 6 7 [courts - court reporter salaries - secretary bailiff salaries - effective date -8 9 emergency] 10 11 12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: SECTION 1. 13 AMENDATORY 20 O.S. 2021, Section 106.9, is 14 amended to read as follows: 15 Section 106.9 A. Each court reporter regularly engaged by the 16 district court, the Workers' Compensation Court of Existing Claims, 17 or the Corporation Commission shall be paid a salary pursuant to the 18 salary schedule established by the annual appropriation for the 19 district courts and Corporation Commission and in accordance with 20 the job description for the position to which appointed. On October 21 1, 2021, each court reporter shall receive a one-time stipend of One 22 Thousand Two Hundred Fifty Dollars (\$1,250.00) For fiscal year 2023 23 and each fiscal year thereafter, each court reporter shall receive 24 an annual salary of Fifty-three Thousand Dollars (\$53,000.00).

In addition to their base salaries, official court reporters 1 в. 2 who are certified or licensed shorthand reporters and those acting shorthand reporters pursuant to paragraph c of Section 106.3B of 3 4 this title shall be paid annually the sum of Four Hundred Dollars 5 (\$400.00) for each year of service to the district court, the Workers' Compensation Court, the Workers' Compensation Court of 6 7 Existing Claims and the Corporation Commission, with a maximum of twenty (20) years of service only to be used for the purpose of 8 9 longevity, not to exceed Eight Thousand Dollars (\$8,000.00) per 10 year, payable monthly. For the purpose of payment for longevity, 11 "years of service" is defined as all years served as a certified or licensed court reporter in the district court, the Workers' 12 13 Compensation Court and the Corporation Commission after June 30, 14 Such longevity payments shall begin on July 1 of each year 1978. 15 following completion of one (1) year's service as defined herein. 16 С. In addition to their base salaries, official court reporters 17 who are certified shorthand reporters shall be paid the following: 18 The sum of One Thousand Five Hundred Dollars (\$1,500.00) per 1. 19 year, payable monthly, to any official court reporter who is a 20 Registered Professional Reporter (RPR), as recognized by the State 21 Board of Examiners of Certified Shorthand Reporters. To qualify as 22 a RPR, an official court reporter shall have a proficiency level in 23 reporting testimony and proceedings of a speed of not less than two 24 hundred twenty-five (225) words per minute in taking a question-and-

answer-type dictation, two hundred (200) words per minute in taking a jury charge and one hundred eighty (180) words per minute in taking literary material, shall pass a Written Knowledge Test with a score of at least seventy percent (70%), all as determined by an examination recognized by the Board, and shall complete thirty (30) hours of continuing education per three-year cycle commencing at the date of recognition;

2. The sum of One Thousand Five Hundred Dollars (\$1,500.00) per 8 9 year, payable monthly, to any official court reporter who is a 10 Registered Merit Reporter (RMR), as recognized by the State Board of 11 Examiners of Certified Shorthand Reporters. To qualify as a RMR, an 12 official court reporter shall have a proficiency level in reporting 13 testimony and proceedings of a speed of not less than two hundred 14 sixty (260) words per minute in taking a question-and-answer-type 15 dictation, two hundred forty (240) words per minute in taking a jury 16 charge and two hundred (200) words per minute in taking literary 17 material, shall pass a Written Knowledge Test with a score of at 18 least seventy percent (70%), all as determined by an examination 19 recognized by the Board, and shall complete thirty (30) hours of 20 continuing education per three-year cycle commencing at the date of 21 recognition;

3. The sum of One Thousand Five Hundred Dollars (\$1,500.00) per
year, payable monthly, to any official court reporter who is a
Registered Diplomat Reporter (RDR), as recognized by the State Board

1 of Examiners of Certified Shorthand Reporters, and who completes
2 thirty (30) hours of continuing education per three-year cycle
3 commencing at the date of recognition;

4 4. The sum of One Thousand Five Hundred Dollars (\$1,500.00) per
5 year, payable monthly, to any official court reporter who is a
6 Certified Realtime Reporter (CRR), as recognized by the State Board
7 of Examiners of Certified Shorthand Reporters, and who completes
8 thirty (30) hours of continuing education per three-year cycle
9 commencing at the date of recognition; or

10 5. Any official court reporter who is the holder of more than 11 one certification shall be compensated in the additional amounts 12 specified in paragraphs 1 through 4 of this subsection for each 13 certification up to a maximum of Six Thousand Dollars (\$6,000.00) 14 per year over and above the reporter's base salary, payable monthly.

15 D. Court reporters temporarily employed by the district court, 16 Workers' Compensation Court of Existing Claims, or Corporation 17 Commission shall be compensated by the court fund of the court which 18 they serve at a rate to be set by such court. In addition, court 19 reporters temporarily employed pursuant to this subsection who are 20 required by the terms of their employment to travel outside their 21 county of residence shall receive reimbursement for mileage actually 22 and necessarily traveled to and from the place of attendance at a 23 rate not to exceed the rate of reimbursement specified in the State 24 Travel Reimbursement Act for state employees. Any travel

reimbursement shall be paid from the court fund of the court where
 the service of the temporarily employed court reporter is provided.
 SECTION 2. AMENDATORY 20 O.S. 2021, Section 125, is
 amended to read as follows:

5 Section 125. A. In all counties of the state there is created the office of secretary-bailiff for district judges and associate 6 7 district judges, with each such secretary-bailiff to be appointed by order of the district judge or associate district judge to serve at 8 9 the will of the appointing judge as an unclassified employee of the 10 state exempt from the provisions of the Oklahoma Merit System of 11 Personnel Administration. The Chief Justice shall approve by 12 administrative directive the number and assignments of secretary-13 bailiffs in all counties of the state. Each secretary-bailiff shall 14 be paid a salary pursuant to the salary schedule established by the 15 annual appropriation for the district courts and in accordance with 16 the job description for the position to which appointed. For fiscal 17 year 2023 and each fiscal year thereafter, each secretary-bailiff 18 shall receive an annual salary of Forty-two Thousand Dollars 19 (\$42,000.00). In every county of the state each district judge and 20 each associate district judge may by order appoint additional 21 necessary court personnel subject to the approval of the Chief 22 Justice. A part-time bailiff shall be paid out of the court fund of 23 the county where appointed at the rate set by administrative 24 directive for each hour that such person actually attends the court

and performs services, or a pro rata fraction thereof for less than an hour of service. Notwithstanding any other provision of law, each district judge and associate district judge may contract with the sheriff of the county to allow a deputy sheriff to provide bailiff service to the court.

B. With the approval of the presiding judge, a special judge
may appoint a secretary-bailiff or other personnel in accordance
with the administrative order of the Chief Justice.

9 C. No judge shall engage more than one full-time secretarybailiff at any given time except only during the progress of a jury 10 trial, when a part-time bailiff may be engaged subject to the 11 12 approval of the Chief Justice. In the latter event, no more than 13 one additional bailiff shall be engaged to take charge of the jury. 14 The costs of meals and lodging of bailiffs ordered to keep a jury 15 together during the process of a trial or after the jury retires for 16 deliberation shall be lawfully paid from the court fund.

17 D. A district judge who sits regularly in more than one county 18 may employ only one full-time secretary-bailiff in the judicial 19 district of the judge, and in any other county of the district the 20 judge may engage a bailiff only on a part-time basis when such judge 21 sits in the county as a judge pursuant to the procedures set forth 22 by the Chief Justice in the administrative directive. The cost of 23 the operation of the office of a district judge of a multi-county 24 judicial district, including the purchase of equipment and supplies,

1 may be apportioned among the counties of that judicial district, or 2 appropriate division of that district, based upon the percentage of 3 revenue collected by the courts of the district.

E. The Administrative Director of the Courts shall develop and promulgate job descriptions, salary schedules and time-keeping forms for part-time bailiff personnel. The Chief Justice of the Oklahoma Supreme Court, through the Office of the Administrative Director of the Courts, shall promulgate rules for the compensation for overtime for all secretary-bailiff and part-time bailiff personnel employed.

F. Persons employed by a county that does not meet the requirements of Section 951 of Title 19 of the Oklahoma Statutes, and who serve as full-time secretary-bailiffs or full-time bailiffs shall be eligible to participate in the state retirement system and state insurance programs and any other benefits as are provided to state employees in the unclassified service. All part-time bailiff personnel shall be compensated by the local court fund.

17 G. On October 1, 1989, the position of full-time bailiff shall 18 be redesignated as the position of secretary-bailiff in accordance 19 with the job descriptions, salary schedules, and procedures approved 20 by the Chief Justice. Additional secretary-bailiff positions shall 21 be created as funding and employee positions are available. 22 Counties shall be allowed to provide additional support personnel to 23 the judges sitting in such counties to the extent that funding is 24 available.

1	H. Any secretary-bailiff, who is CLEET-certified as a basic
2	peace officer, shall have and exercise all the powers and authority
3	of a peace officer. The Office of the Administrative Director of
4	the Courts shall promulgate rules which prescribe the duties for all
5	CLEET-certified secretary-bailiffs. The provisions of this
6	subsection will not entitle a CLEET-certified secretary-bailiff to
7	participate in the Oklahoma Police Pension and Retirement System.
8	SECTION 3. This act shall become effective July 1, 2022.
9	SECTION 4. It being immediately necessary for the preservation
10	of the public peace, health or safety, an emergency is hereby
11	declared to exist, by reason whereof this act shall take effect and
12	be in full force from and after its passage and approval.
