NEW LAW 1.3 in the Oklahoma Statutes as Section 431 of Title 63, unless there is 14 created a duplication in numbering, reads as follows: 15 This act shall be known and may be cited as the "Oklahoma Flower 16 and Pre-Packaging Act". 17 A new section of law to be codified SECTION 2. NEW LAW 18 in the Oklahoma Statutes as Section 431.1 of Title 63, unless there 19 is created a duplication in numbering, reads as follows: 20 Upon the effective date of this act, all medical marijuana 21 flower, trim, shake, kief, or other flower-based product not defined 22 as a concentrate shall be sold by licensed medical marijuana 23 processors and licensed medical marijuana commercial growers to 24 licensed medical marijuana dispensaries only in pre-packaged form in

3	B. The packaging of medical marijuana flower may contain non-
4	opaque materials provided that it meets all other packaging and

8	C. The display and smelling of medical marijuana shall be
