Twenty Dollars (\$20.00) of the fee authorized by Section 24 1135.5 of Title 47 of the Oklahoma Statutes for the Diabetes

Awareness license plates shall be deposited to the Diabetes
 Awareness License Plate Revolving Fund created in subsection B of

4 There is hereby created in the State Treasury a revolving Β. 5 fund for the State Department of Health to be designated the "Diabetes Awareness License Plate Revolving Fund". The fund shall 6 7 consist of all monies received pursuant to subsection A of this section. All monies accruing to the credit of the fund are hereby 8 9 appropriated and may be budgeted and expended by the State 10 Department of Health for grants to Diabetes Solutions of Oklahoma to 11 raise awareness and provide resources, as well as promote acceptance 12 and inclusion for people with diabetes. Expenditures from the fund 13 shall be made upon warrants issued by the State Treasurer against 14 claims filed as prescribed by law with the Director of the Office of 15 Management and Enterprise Services for approval and payment.

16 SECTION 2. AMENDATORY 47 O.S. 2021, Section 1135.2, as 17 last amended by Section 4, Chapter 543, O.S.L. 2021, is amended to 18 read as follows:

Section 1135.2 A. The Oklahoma Tax Commission is hereby authorized to design and issue appropriate official special license plates to persons in recognition of their service or awards as provided by this section.

23 Special license plates shall not be transferred to any other
24 person but shall be removed from the vehicle upon transfer of

ownership and retained. The special license plate may then be used
 on another vehicle but only after such other vehicle has been

4 Special license plates shall be renewed each year by the Tax 5 Commission or a motor license agent. The Tax Commission shall annually notify by mail all persons issued special license plates. 6 7 The notice shall contain all necessary information and shall contain instructions for the renewal procedure upon presentation to a motor 8 9 license agent or the Tax Commission. The license plates shall be 10 issued on a staggered system except for legislative plates and 11 amateur radio operator license plates.

12 The Tax Commission is hereby directed to develop and implement a 13 system whereby motor license agents are permitted to accept 14 applications for special license plates authorized under this 15 section. The motor license agent shall confirm the applicant's 16 eligibility, if applicable, collect and deposit any amount 17 specifically authorized by law, accept and process the necessary 18 information directly into such system and generate a receipt 19 accordingly. For performance of these duties, motor license agents 20 shall retain the fee provided in Section 1141.1 of this title for 21 registration of a motor vehicle. The motor license agent fees for 22 acceptance of applications and renewals shall be paid out of the 23 Oklahoma Tax Commission Reimbursement Fund.

Prisoner of War License Plates - such plates shall be 3 1. 4 designed for honorably discharged or present members of the United 5 States Armed Forces and civilians who were former prisoners of war held by a foreign country and who can provide proper certification 6 7 of that status. Such persons may apply for a prisoner of war license plate for no more than two vehicles with each vehicle having 8 9 a rated carrying capacity of one (1) ton or less. The surviving 10 spouse of any deceased former prisoner of war, if the spouse has not 11 since remarried, or if remarried, the remarriage is terminated by 12 death, divorce, or annulment, may apply for a prisoner of war 13 license plate for one vehicle with a rated carrying capacity of one 14 (1) ton or less. The fee provided by this section for the special 15 license plate authorized by this paragraph shall be in addition to 16 all other registration fees provided by law, except the registration 17 fees levied by Section 1132 of this title;

National Guard License Plates - such plates shall be
 designed for active or retired members of the Oklahoma National
 Guard. Retirees who are eligible for such plates shall provide
 proof of eligibility upon initial application, but shall not be
 required to provide proof of eligibility annually;

Air National Guard License Plates - such plates shall be
 designed for active or retired members of the Oklahoma Air National

Guard. Retirees who are eligible for such plates shall provide proof of eligibility upon initial application, but shall not be required to provide proof of eligibility annually;

United States Armed Forces License Plates - such plates 4 5 shall be designed for active, retired, former or reserve members of the United States Armed Forces, and shall identify which branch of 6 7 service, and carry the emblem and name of either the Army, Navy, Air Force, Marines or Coast Guard, according to the branch of service to 8 9 which the member belongs or did belong. Former members who have 10 been dishonorably discharged shall not be eligible for such plates. 11 Persons applying for such license plate must show proof of present 12 or past military service by presenting a valid Uniformed Services 13 Identity Card or the United States Department of Defense Form 14 (DD)214. Retired or former members who are eligible for such plates 15 shall provide proof of eligibility upon initial application, but 16 shall not be required to provide proof of eligibility annually;

17 5. Congressional Medal of Honor Recipient License Plates - such 18 plates shall be designed for any resident of this state who has been 19 awarded the Congressional Medal of Honor. Such persons may apply 20 for a Congressional Medal of Honor recipient license plate for each 21 vehicle with a rated carrying capacity of one (1) ton or less. 22 There shall be no registration fee for the issuance of this plate; 23 6. Purple Heart Recipient License Plates - such plates shall be 11 7. 12 designed for any resident of this state presenting proper 13 certification from the United States Department of Veterans Affairs 14 or the Armed Forces of the United States certifying that such 15 resident has been awarded the Purple Heart military decoration. 16 Such persons may apply for a Purple Heart recipient license plate 17 for vehicles having a rated carrying capacity of one (1) ton or 18 The surviving spouse of any deceased veteran who has been less. 19 awarded the Purple Heart military decoration, if such spouse has not 20 since remarried, or if remarried, the remarriage has been terminated 21 by death, divorce or annulment, may apply for such plate for one 22 vehicle with a rated carrying capacity of one (1) ton or less. The spouse of the deceased person, if the spouse 10 has not remarried, or if remarried, the remarriage is terminated by 11 death, divorce, or annulment, may apply for a killed in action 12 license plate upon presenting proper certification that the person 13 was killed in action and that the person making the application is 14 the qualifying spouse of the deceased person. The qualifying spouse 15 may apply for a killed in action license plate for no more than two 16 vehicles with each vehicle with a rated carrying capacity of one (1) 17 ton or less. The qualifying spouse or family member may apply for a killed in action license plate for no more than two vehicles 8 9 with each vehicle with a rated carrying capacity of one (1) ton or 10 The license plate shall have a white background and the less. 11 legend "Killed in Action" and shall contain any combination of numbers and letters from one to a maximum of seven in black, as for 12 13 personalized license plates. To the left of the numbers and letters 14 shall be the Battlefield Cross in gold. The killed in action 15 license plate shall be exempt from any minimum issuance criteria 16 related to license plate applications;

17 Gold Star Families License Plates - such plates shall be 12. 18 designed to honor members of the United States Armed Forces who were 19 killed while on active duty. The parents, siblings, half-siblings 20 or grandparents of the deceased person may apply for a gold star 21 license plate upon presenting proper certification that the person 22 was killed while on active duty and that the person making the 23 application is the parent, sibling, half-sibling or grandparent of 24 the deceased person. The family member may apply for a gold star

Such persons may apply for a 12 military decoration license plate for each vehicle with a rated 13 carrying capacity of one (1) ton or less;

World War II Veteran License Plates - such plates shall be 15 designed to honor honorably discharged former members of the United 16 States Armed Forces who are residents of this state and who can be 17 verified by the Oklahoma Military Department of the State of 18 Oklahoma, the Department of Veterans Affairs or the Armed Forces of 19 the United States as having served on federal active duty anytime 20 during the period from September 16, 1940, to December 7, 1945. The 21 former members may apply for a World War II Veteran license plate 22 for vehicles with a rated carrying capacity of one (1) ton or less.

The license plate shall have the legend "Oklahoma" and shall contain, in the center of the plate, either the Thunderbird Insignia

For the purpose of license plate 5 identification, the plate shall contain four digits, two digits at the left and two digits at the right of the insignia or emblem. 6 7 Centered on the bottom of the license plate shall be the words "WORLD WAR II"; 8

9 17. Korean War Veteran License Plates - such plates shall be 10 designed to honor honorably discharged former members of the United States Armed Forces who are residents of this state and who can be 11 12 verified by the Oklahoma Military Department of the State of 13 Oklahoma, the Department of Veterans Affairs or the Armed Forces of 14 the United States as having served on federal active duty anytime 15 during the period from June 27, 1950, to January 31, 1955, both 16 dates inclusive. The former members may apply for a Korean War 17 Veteran license plate for vehicles with a rated carrying capacity of 18 one (1) ton or less.

The license plate shall have the legend "OKLAHOMA" and shall contain, in the center of the plate, either the Thunderbird Insignia of the 45th Infantry Division in the prescribed red and gold coloring or the emblem of the Army, Navy, Air Force, Marines or Coast Guard according to the branch of service to which the member belonged. Such persons may 8 apply for a Military Reserve Unit license plate for each vehicle 9 with a rated carrying capacity of one (1) ton or less;

10 22. Oklahoma City Bombing Victims and Survivors License Plates
11 - such plates shall be designed and issued to any victim or survivor
12 of the bombing attack on the Alfred P. Murrah Federal Building in
13 downtown Oklahoma City on April 19, 1995;

14 23. Civil Air Patrol License Plates - such plates shall be 15 designed and issued to any person who is a member of the Civil Air 16 Patrol. Such persons may apply for a Civil Air Patrol license plate 17 for each vehicle with a rated carrying capacity of one (1) ton or 18 less upon proof of membership in the Civil Air Patrol. The license 19 plate shall be designed in consultation with the Civil Air Patrol;

20 24. Ninety-Nines License Plates - such plates shall be designed 21 and issued to members of the Ninety-Nines. Persons applying for 22 such license plate must show proof of membership in the Ninety-23 Nines. The license plates shall be designed in consultation with 24 the Ninety-Nines;

Such 6 license plate may be issued for each vehicle with a rated carrying 7 capacity of one (1) ton or less;

8 30. Legislative License Plates - such plates shall be designed 9 for persons elected to the Oklahoma Legislature and shall designate 10 the house of the Legislature in which the legislator serves and the 11 district number;

Disabled Veterans License Plates - such plates shall be 12 31. 13 designed for persons presenting proper certification from the United 14 States Department of Veterans Affairs or the Armed Forces of the 15 United States certifying such veteran has a service-connected 16 disability rating of fifty percent (50%) or more, regardless which 17 agency pays the disability benefits, or that such veteran has been 18 awarded a vehicle by the United States government or receives a 19 grant from the United States Department of Veterans Affairs for the 20 purchase of an automobile due to a service-connected disability 21 rating or due to the loss of use of a limb or an eye. 20 SECTION 3. AMENDATORY 47 O.S. 2021, Section 1135.5, as 21 last amended by Section 6, Chapter 543, O.S.L. 2021, is amended to 22 read as follows:

16 The Tax Commission is hereby directed to develop and implement a 17 system whereby motor license agents are permitted to accept 18 applications for special license plates authorized under this 19 section. The motor license agent shall confirm the applicant's 20 eligibility, if applicable, collect and deposit any amount 21 specifically authorized by law, accept and process the necessary 22 information directly into such system and generate a receipt 23 accordingly. For performance of these duties, motor license agents 24 shall retain the fee provided in Section 1141.1 of this title for

Below the 6 symbol and letters and numbers shall be the words "American Red 7 Cross" in black. The plates shall not be subject to the design 8 9 requirements of any other license plates prescribed by law other than the space for the placement of the yearly decals for each 10 succeeding year of registration after the initial issue; 11

Desert Storm License Plates - such plates shall be designed and issued to any honorably discharged or present member of the United States Armed Forces who served in the Persian Gulf Crisis and the Desert Storm operation. 23 be designed and issued to any honorably discharged or present member
24 of the United States Armed Forces who saw combat in the United

10 plates shall be designed and issued to any resident of this state

9 SECTION 7. AMENDATORY 47 O.S. 2021, Section 1135.5, as 10 last amended by Section 6, Chapter 543, O.S.L. 2021, is amended to 11 read as follows:

12 Section 1135.5. A. The Oklahoma Tax Commission is hereby 13 authorized to design and issue appropriate official special license 14 plates to persons wishing to demonstrate support and provide 15 financial assistance as provided by this section.

16 Special license plates shall not be transferred to any other 17 person but shall be removed from the vehicle upon transfer of 18 ownership and retained. The special license plate may then be used 19 on another vehicle but only after such other vehicle has been 20 registered for the current year with a motor license agent.

21 Special license plates shall be renewed each year by the Tax 22 Commission or a motor license agent, unless authorized by the Tax 23 Commission to be renewed for a period greater than one (1) year. 24 The Tax Commission shall notify by mail all persons issued special

license plates. The notice shall contain all necessary information
 and shall contain instructions for the renewal procedure upon
 presentation to a motor license agent or the Tax Commission. The
 license plates shall be issued on a staggered system.

5 The Tax Commission is hereby directed to develop and implement a system whereby motor license agents are permitted to accept 6 applications for special license plates authorized under this 7 section. The motor license agent shall confirm the applicant's 8 9 eligibility, if applicable, collect and deposit any amount 10 specifically authorized by law, accept and process the necessary information directly into such system and generate a receipt 11 12 accordingly. For performance of these duties, motor license agents shall retain the fee provided in Section 1141.1 of this title for 13 registration of a motor vehicle. The motor license agent fees for 14 acceptance of applications and renewals shall be paid out of the 15 Oklahoma Tax Commission Reimbursement Fund. 16

If fewer than one hundred of any type of special license plates 17 authorized prior to January 1, 2004, are issued prior to January 1, 18 2006, the Tax Commission shall discontinue issuance and renewal of 19 that type of special license plate. Any such authorized special 20 license plate registrant shall be allowed to display the license 21 plate upon the designated vehicle until the registration expiration 22 date. After such time the expired special license plate shall be 23 removed from the vehicle. 24
