13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:						
14	SECTION 1. NEW LAW A new section of law to be codified						
15	in the Oklahoma Statutes as Section 93.3 of Title 25, unless there						
16	is created a duplication in numbering, reads as follows:						
17	In memory of the September 11, 2001, terrorist attacks on the						
18	World Trade Center, Pentagon, and the plane crash victims of the						
19	United Airlines Flight 93, the 9/11 Freedom Flag that commemorates						
20	this day in American history, shall be authorized to be flown on						
21	flagpoles throughout the state in remembrance.						
22	SECTION 2. AMENDATORY 21 O.S. 2021, Section 375, is

- Section 375. A. It shall be unlawful and constitute a
 misdemeanor for any person to place, hoist, raise or display any
 flag, standard, colors or ensign upon or over any publicly owned
 tax-supported property or premises except roads, streets, highways,

- 1. The flag, standard, colors or ensign of the United States of America;
- 2. The flag of any nation formerly having dominion over the land now comprising the State of Oklahoma or any portion of said land;
- 3. The official flag of any of the fifty states of the United

 - 4. An Alfred P. Murrah Federal Building commemorative flag;
 - 5. The official flag of any municipality in this state;
 - 6. The Boy Scouts of America flag;
 - 7. The Girl Scouts United States of America flag;
- 17 8. The American Red Cross flag;
- 18 9. The American Ex-Prisoner of War flag;

- B. Any person convicted of a violation of this section shall be punished by a fine of not less than Fifty Dollars (\$50.00) nor more
