20 SECTION 1. AMENDATORY 47 O.S. 2021, Section 1132A, is

24 to the Oklahoma Vehicle License and Registration Act there shall

7 B. ~~Motor~~ Upon the effective date of this act through May 31,
8 2023, motor license agents selected as provided in subsection A of
9 this section shall receive all fees provided by the Oklahoma Vehicle
10 License and Registration Act; ~~provided, the amount of fees remitted~~
11 ~~to the motor license agent for each online transaction processed by~~
12 ~~the motor license agent through any online system shall be reduced~~
13 ~~by One Dollar and fifty-six cents (\$1.56).~~

14 C. The selection step required pursuant to subsection A of this
15 section shall be installed and operational no later than January 1,
16 2021.

17 SECTION 2. It being immediately necessary for the preservation
18 of the public peace, health or safety, an emergency is hereby
19 declared to exist, by reason whereof this act shall take effect and
20 be in full force from and after its passage and approval."

2 in subsection A of this section shall receive all fees provided by
3 the Oklahoma Vehicle License and Registration Act; ~~provided, the~~
4 ~~amount of fees remitted to the motor license agent for each online~~
5 ~~transaction processed by the motor license agent through any online~~
6 ~~system shall be reduced by One Dollar and fifty six cents (\$1.56).~~

7 C. The selection step required pursuant to subsection A of this

9 2021.
