5 SECTION 1. NEW LAW A new section of law to be codified 6 in the Oklahoma Statutes as Section 34.210 of Title 62, unless there 7 is created a duplication in numbering, reads as follows:

A. As used in this section, "state data" means all data files
hosted, procured, owned, processed, secured, stored, or created by
this state or its state agencies, while in the course of state
business and shall include any and all data not otherwise prohibited
from such classification by state or federal law. Such data shall
be the property of this state unless prohibited by law.

B. While this state is the owner of state data, individual
state agencies shall comply with their respective statutory
obligations in managing state data including responding to open
records requests, reporting and responding to data breaches and any
other statutory obligations required when hosting, accessing,
storing, collecting, or processing state data.

20 C. The Chief Information Officer for the State of Oklahoma may 21 establish standards and criteria for sharing state data between state 22 agencies. Agency requests to share state data shall be denied if the 23 stated purpose does not meet the established standards and criteria 24 for sharing state data as established by the CIO. State agencies may

1 decline requests to share state data if the state data requested is 2 otherwise privileged or prohibited from being shared by state or 3 federal law.

D. The powers provided in this section shall be in addition to
and not in substitution for any powers provided to the Office of
Management and Enterprise Services or the Chief Information Officer by
rule or law.

8 E. No powers provided in this section shall exempt or supersede 9 a state agency's statutory responsibility to protect data and to 10 comply with requirements of the Oklahoma Open Records Act or 11 applicable state or federal law.

F. The provisions of this section shall not be applicable to the judicial department of state government or any entity organized within the judicial department and shall not be applicable to the legislative department or any entity organized within the legislative department.

12 D. State data may be shared between state agencies upon request from the Office of Management and Enterprise Services. The request 13 shall be on a form provided by the Office of Management and 14 Enterprise Services and shall specify why the data is being 15 requested and what the intended purpose is for the requested data. 16 After reviewing the documentation, the Office of Management and 17 Enterprise Services shall grant or deny the request for access and 18 utilization of the requested data. 19

20 The Office of Management and Enterprise Services may deny 21 requests to share state data if the stated purpose does not meet the 22 established standards and criteria for sharing state data. State 23 agencies may decline requests to share state data if the state data

requested is otherwise prohibited from being shared by state or
 federal law.

If a state agency's request for state data has been declined 3 Ε. 4 by another state agency, the initial requestor may seek a final 5 determination from the Office of Management and Enterprise Services as to whether the requested state data shall be shared. If a state 6 agency disputes the decision of the Office of Management and 7 Enterprise Services, the Office of Management and Enterprise 8 9 Services cabinet secretary shall make a final determination whether the request to share state data will be granted or denied. 10

F. The powers provided in this section shall be in addition to and not in substitution for any powers provided to the Office of Management and Enterprise Services by rule or law. No powers provided in this section shall exempt or supersede a state agency's statutory responsibility to protect data and to comply with requirements of the Oklahoma Open Records Act.

17 SECTION 4. This act shall become effective November 1, 2021.
