3	Section 14-130. The A. Except as provided by subsection B of
4	this section, the secretary of each county election board shall

6	absentee ballots at the office of the county election board on the
7	day preceding the election.
8	B. The list of voters requesting absentee ballots in a
9	precinct shall not be publicly posted if the number of voters in
10	such subgroup is less than one hundred (100).
11	SECTION 3. This act shall become effective November 1, 2021.
