8	An Act relating to higher education; prohibiting state educational institutions from refusing to
9	provide certain student transcripts; banning conditional release of transcripts; proscribing
10	higher fees or less favorable treatment for certain requests; prohibiting prevention of student
11	enrollment under certain circumstances; defining term; construing provision; providing for
12	codification; and providing an effective date.

15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. NEW LAW A new section of law to be codified
17	in the Oklahoma Statutes as Section 3218.16 of Title 70, unless
18	there is created a duplication in numbering, reads as follows:
19	A. A state educational institution within The Oklahoma State
20	System of Higher Education shall not:
21	1. Refuse to provide a transcript of a current or former
22	student on the grounds that the student owes a debt to the
23	institution;

Condition the provision of a transcript on the payment of a
 debt, other than a fee charged to provide the transcript;

3 3. Charge a higher fee for obtaining a transcript or provide
4 less favorable treatment of a transcript request because a current
5 or former student owes a debt to the institution; or

6 4. Prevent a current, former, or prospective student from
7 enrolling due to a missing or withheld transcript issued by an out8 of-state educational institution.

B. As used in this section, "debt" means any money, obligation,
claim, or sum, due or owing, or alleged to be due or owing, from a
current or former student, but shall not include the fee, if any,
charged to all students for the actual costs of providing
transcripts.

14 C. Nothing in this section shall be construed to require the 15 institution to forgive or cancel a debt owed by a current or former 16 student to the institution.

17 SECTION 2. This act shall become effective November 1, 2022.18
