16	SECTION 1. AMENDATORY 70 O.S. 2021, Section 8-103.2, is

(1) year from on the first day of attendance at the receiving school unless the transfer is from a school district which does not offer the grade the student is entitled to pursue.

B. If the student is granted an emergency transfer pursuant to Section 8-104 of this title, was granted a transfer for any reason prior to January 1, 2000, or enrolls transfers during the school year or transfers more than one time pursuant to the Education Open Transfer Act and qualifies for a hardship waiver pursuant to the rules of the Oklahoma Secondary School Activities Association, eligibility to participate in school-related extramural athletic competition shall be determined by the Oklahoma Secondary School Activities Association. If the student does not meet the criteria provided in subsection A of this section and does not qualify for a hardship waiver, the student shall not be eligible to participate in school-related extramural athletic competition governed by the Oklahoma Secondary School Activities Association for a period of one (1) year from the first day of attendance at the receiving school.

SECTION 2. This act shall become effective November 1, 2022.
