17	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
18	SECTION 1. From the funds appropriated to the Oklahoma Tourism
19	and Recreation Department in Enrolled House Bill No. 2900 of the 1st
20	Session of the 58th Oklahoma Legislature, the Department shall make
21	available matching funds to multicounty organizations pursuant to
22	Section 2234 of Title 74 of Oklahoma Statutes. The matching funds
23	made available shall be equal in amount to the funds made available
24	in the fiscal year ending June 30, 2021.

1 SECTION 2. Appropriations made to the Oklahoma Tourism and Recreation Department by Enrolled House Bill No. 2900 of the 1st 2 3 Session of the 58th Oklahoma Legislature, not including appropriations made for capital outlay purposes, may be budgeted for 4 5 the fiscal year ending June 30, 2022 (hereafter FY-22), or may be budgeted for the fiscal year ending June 30, 2023 (hereafter FY-23). 6 Funds budgeted for FY-22 may be encumbered only through June 30, 7 2022, and must be expended by November 15, 2022. Any funds 8 9 remaining after November 15, 2022, and not budgeted for FY-23, shall 10 lapse to the credit of the proper fund for the then current fiscal 11 year. Funds budgeted for FY-23 may be encumbered only through June 12 30, 2023. Any funds remaining after November 15, 2023, shall lapse 13 to the credit of the proper fund for the then current fiscal year. These appropriations shall not be budgeted in both fiscal years 14 simultaneously. Funds budgeted in FY-22, and not required to pay 15 obligations for that fiscal year, may be budgeted for FY-23, after 16 17 the agency to which the funds have been appropriated has prepared and submitted a budget work program revision removing these funds 18 from the FY-22 budget work program and after such revision has been 19 approved by the Office of Management and Enterprise Services. 20 21 5/17/2021 10:13:03 AM 58-1-2205 JR 22
