facilities to be known as the Oklahoma Veterans Centers (for the purpose of securing special treatment or hospitalization the adjoining facilities of Griffin Memorial Hospital shall be considered an integral part of the Oklahoma Veterans Centers at Norman, and may be utilized to care for eligible veterans), which shall be available for care of war veterans discharged other than under dishonorable conditions. located at the East Half (E 1/2) of the Northwest Quarter (NW 1/4) and the West Half (W 1/2) of the Northeast Quarter (NE 1/4) of Section 28, Township 9 North, Range 2 West, Indian Meridian, Cleveland County, such tract containing 160 acres, more or less.

C. Further provided such centers The Oklahoma State Veterans

Homes established in this section shall be under the administration and control of the Oklahoma Veterans Commission. No person
