17	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:		
18	SECTION 1. AMENDATORY 29 O.S. 2011, Section 5-301, is		
19	amended to read as follows:		
20	Section 5-301. A. No person may set or use at any time any		
21	poison, cyanide coyote getter, or other similar device $_{m au}$ using		
22	cyanide gas or other poisonous gas as the lethal agent, for the		
23	purpose of killing predators, except in accordance with the		
24	following conditions and procedures:

1 1. Signs of a size and character and with wording to be 2 determined by the State Oklahoma Department of Agriculture, Food, and Forestry indicating the presence of cyanide coyote getters or 3 4 other similar device using cyanide gas or other poisonous gas as the 5 lethal agent, shall be posted on all properties where said coyote getters are set to the right and left of all entrances from public 6 7 roads and highways and from adjacent lands and at corners of 8 perimeter fences.

9 2. Such devices shall not be set from April 1 to September 30 10 of each calendar year; provided that, any devices set or used within 11 a commercial hunting area by a person holding a big game or big game 12 and upland game combination license pursuant to Section 4-106 of 13 this title or a licensed farmed cervidae facility by a person 14 holding a farmed cervidae facility license pursuant to the Oklahoma 15 Farmed Cervidae Act may be set or used at any time of the year. 16 3. All signs as required by this article shall be in place 17 twenty-four (24) hours before said devices are set and shall be 18 properly maintained in place during the permission period herein 19 provided.

4. A game warden may issue a permit for the setting of such
devices and such permit must be obtained prior to the setting of
such devices. Each permit shall be made in triplicate, the original
to be retained by the landowner concerned, one copy retained by the

1 game warden and the other copy mailed immediately to the Department 2 for its permanent record.

5. In applying for a permit, the landowner shall state the number of devices to be set and the approximate location to the nearest forty (40) acres.

6 6. Written permission permits required by this section shall
7 cover a period not exceeding six (6) months; provided, however, that
8 said permits shall be subject to renewal for a like period of time.

9 7. All signs required by this section shall be removed at the 10 end of the permission period, unless said permit is renewed prior to 11 the expiration date thereof.

12 8. No predator control devices shall be on any property without13 the written permission of the record owner or lessee thereof.

B. Predatory control conducted by the <u>State Oklahoma</u> Department of Agriculture, <u>Food</u>, <u>and Forestry</u> or the Oklahoma Department of Wildlife <u>Conservation</u> shall be exempt from <u>the</u> provisions of paragraphs 4, 5 and 6 of subsection A of this section.

18 C. The Director <u>of the Department of Wildlife Conservation</u> may 19 issue depredation permits to landowners for control of any nuisance 20 wildlife.

D. Any person convicted of violating the provisions of this section shall be punished by a fine of not less than Fifty Dollars (\$50.00), or by imprisonment in the county jail for not more than

1	thirty (30) days, or by both such fine and imprisonment.
2	SECTION 2. This act shall become effective November 1, 2021.
