Extension Service. Such funds shall be used for training within the Master Irrigators Program.

SECTION 2. From the funds appropriated to the Oklahoma

Conservation Commission in Enrolled House Bill No. 2900 of the 1st

Session of the 58th Oklahoma Legislature, the sum of Fifty Thousand

Dollars (\$50,000.00) shall, under the direction of the Executive

Director of Conservation, be allocated to the Master Irrigator

Program affiliated with the Oklahoma State University Agricultural

Extension Service. Such funds shall be used for studying the

Ogallala Aquifer.

SECTION 3. Appropriations made by Enrolled House Bill No. 2900 of the 1st Session of the 58th Oklahoma Legislature, not including appropriations made for capital outlay purposes, may be budgeted for the fiscal year ending June 30, 2022 (hereafter FY-22) or may be budgeted for the fiscal year ending June 30, 2023 (hereafter FY-23). Funds budgeted for FY-22 may be encumbered only through June 30, 2022, and must be expended by November 15, 2022. Any funds remaining after November 15, 2022, and not budgeted for FY-23, shall lapse to the credit of the proper fund for the then current fiscal year. Funds budgeted for FY-23 may be encumbered only through June 30, 2023. Any funds remaining after November 15, 2023, shall lapse to the credit of the proper fund for the then current fiscal year. These appropriations may not be budgeted in both fiscal years simultaneously. Funds budgeted in FY-22, and not required to pay
