10	An Act relating to state use; amending 74 O.S. 2021, Section 3001, which relates to the State Use
11	Committee; providing entity name; modifying member of Council; requiring certain meetings; directing the
12	State Purchasing Director to administer the State Use Program; providing certain authority and
13	responsibilities; amending 74 O.S. 2021, Section 3003, which relates to definitions; modifying certain
14	definitions; amending 74 O.S. 2021, Section 3004, which relates to procurement schedules; modifying
15	entity responsible for procurement schedule; directing State Purchasing Director to award and
16	manage contracts to certain organizations; directing deposit of certain fee; amending 74 O.S. 2021,
17	Section 3004.1, which relates to contracts; authorizing certain contracts or awards; modifying
18	allowing expenditures; amending 74 O.S. 2021, Section 3004.2, which relates to the State Use Committee
19	Revolving Fund; allowing certain fee or levy; amending 74 O.S. 2021, Section 3005, which relates to
20	fair market pricing; modifying entity responsible for determining fair market price of certain products and
21	services; modifying time period for price changes to be effective; 74 O.S. 2021, Section 3006, which
22	relates to distribution agency; allowing the State Purchasing Director to contract with a third-party
23	for certain operations and distribution; amending 74 O.S. 2021, Section 3007, which relates to procuring a
24	product or service at a certain price; modifying

1 procurement source; modifying entity responsible for determining fair market price; modifying procurement requirements; removing certain exemption; authorizing 2 municipalities and counties to make certain purchases from gualified organizations; amending 74 O.S. 2021, 3 Section 3008, which relates to exceptions; removing exemption; requiring certain pricing review; allowing 4 for temporary exception under certain circumstances; 5 allowing Central Purchasing Division to prescribe rules to carry out this act; amending 74 O.S. 2021, Section 3009, which relates to annual reporting; 6 requiring certain report; repealing 74 O.S. 2021, Section 3010, which relates to exemptions; providing 7 for codification; and providing an effective date. 8 9 10 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: 11 SECTION 1. AMENDATORY 74 O.S. 2021, Section 3001, is 12 amended to read as follows: 13 Section 3001. A. There is hereby created in the Office of Management and Enterprise Services a committee an advisory council 14 to be known as the "State Use Committee Advisory Council". 15 The Committee Council shall consist of seven (7) members and one 16 nonvoting member as follows: 17 A private citizen conversant with the employment needs of 18 1. people with severe significant disabilities who shall be appointed 19 by and serve at the pleasure of the Governor to act as an advocate 20 for the employment needs of people with severe significant 21 disabilities; 22 2. The Director of the Office of Management and Enterprise 23 Services or designee; 24

3. The Director of the Division of Services for the Blind and
 Visually Impaired of the State Department of Rehabilitation
 Services, or designee;

4 4. The past president of Oklahoma Community-Based Providers or
5 designee to serve for a one-year period, who may be reappointed by
6 the succeeding president One member who shall be a state use
7 provider who shall be appointed by the President Pro Tempore of the
8 Senate;

9 5. An individual or a parent or guardian of an individual with severe significant disabilities who participates in vocational 10 programming through a sheltered environment facility qualified non-11 profit agency for individuals with disabilities, to be selected by 12 the Committee appointed by the Speaker of the House of 13 Representatives; 14 The Director of Human Services, or designee; and 6. 15 7. A certified procurement officer from any state agency 16 appointed by the State Purchasing Director, selected to represent 17 the customer agencies of the State of Oklahoma; and 18 8. As a nonvoting member, a A person employed by the Office of 19 Management and Enterprise Services Central Purchasing Division as a 20

21 contracting officer in the purchasing division, appointed by the 22 State Purchasing Director with the advice of the Committee and 23 designated specifically to solicit, develop, and negotiate contracts

24 with agencies and individuals.

1 B. The Committee shall elect from among its membership a Chair 2 and a Vice Chair who shall both serve for a period of one (1) year. C. The private citizens on the Committee Council shall 3 serve for a period of two (2) years and may be reappointed by the 4 5 appointing authority. Any private citizen appointed pursuant to this section to fill a vacancy occurring prior to the expiration of 6 the term for which the predecessor was appointed shall be appointed 7 only for the remainder of the term. 8

9 D. Any member of the Committee shall be prohibited from voting
10 on any issue in which the member has an interest <u>The State Use</u>
11 <u>Advisory Council shall meet a minimum of twice a year for the</u>
12 <u>purpose of exchanging ideas to market and improve the State Use</u>
13 <u>Program</u>.

14 SECTION 2. NEW LAW A new section of law to be codified 15 in the Oklahoma Statutes as Section 3001.1 of Title 74, unless there 16 is created a duplication in numbering, reads as follows:

17 The State Purchasing Director, under the supervision of the 18 Director of the Office of Management and Enterprise Services, shall 19 have authority and responsibility to administer and oversee the 20 State Use Program including but not limited to:

Promulgating rules relating to the program;
 Qualification of organizations participating in the program;
 Contracting with qualified organizations for products and
 services to be included on the procurement schedule;

1 4. Determination of fair market price of all products and services to be included on the procurement schedule; and 2 5. Designation and publication of a procurement schedule. 3 AMENDATORY 74 O.S. 2021, Section 3003, is SECTION 3. 4 5 amended to read as follows: Section 3003. As used in this act Section 3001 et seq. of this 6 7 title: "Blind person" means a person having a visual acuity not to 1. 8 9 exceed 20/200 in the better eye, with correcting lenses, or visual acuity greater than 20/200 but with limitation in the field of 10 vision such that the widest diameter of visual field subtends an 11 12 angle no greater than twenty (20) degrees; 2. "Committee Council" means the State Use Committee Advisory 13 Council; 14 3. "Qualified nonprofit agency for the severely handicapped 15 employment of people with significant disabilities" means a 16 nonprofit agency: 17 employing severely disabled persons with significant 18 a. disabilities who constitute at least seventy-five 19 percent (75%) of the personnel direct labor hours 20 engaged in direct production, manufacturing, 21 processing and/or assembling of products or services 22 offered by the agency for procurement by this state 23 and or who meet the definition of "blind person" blind 24

1 2 person as provided for in paragraph 1 of this section,
or

3 b. which is certified as a sheltered workshop by the Wage 4 and Hour Division of the United States Department of 5 Labor;

6 4. "Severely disabled person" "Person with significant
7 <u>disabilities</u>" means an individual with a physical or mental
8 disability constituting a substantial handicap to employment and
9 preventing the person from engaging in normal competitive employment
10 and/or includes any blind person;

11 5. "Qualified organization" means a blind person, <u>or</u> qualified 12 nonprofit agency for the severely handicapped, or severely disabled 13 <u>person</u> <u>employment of people with significant disabilities</u>

14 contracting to supply goods or services;

15 6. "Manufactured" means goods made by manual labor;

16 7. "Produced" means to have brought into existence or created 17 from raw materials;

18 8. "Processed" means the action of taking something through an 19 established and mostly routine set of procedures or steps to 20 substantially convert a potential product from one form to another. 21 This action involves a sequence of multiple steps each requiring a 22 distinct decision-making process to evolve a potential product to 23 the next step; and

1 9. "Assemble" means to put or fit together or put together the 2 parts of a potential product; 10. "Central nonprofit agency (CNA)" means a qualified 501(c)3 3 nonprofit entity meeting the qualifications in the Request for 4 5 Procurement (RFP) issued by the Office of Management and Enterprise Services selected to administer and oversee the State Use Program; 6 7 and 11. "Procurement schedule" means a designated schedule of 8 9 products and services currently approved by the Office of Management and Enterprise Services Central Purchasing Division as suitable to 10 procure from qualified organizations participating in the State Use 11 12 Program. SECTION 4. AMENDATORY 74 O.S. 2021, Section 3004, is 13 amended to read as follows: 14 Section 3004. The Committee Office of Management and Enterprise 15 Services Central Purchasing Division shall designate and distribute 16 by regulation a schedule, hereinafter referred to as the procurement 17 schedule, of the products directly manufactured, produced, processed 18 or assembled or services directly performed, offered or provided by 19 any severely disabled person with significant disabilities or 20 qualified nonprofit agency for the severely disabled employment of 21 people with significant disabilities, as defined by this act in 22 Section 3003 of this title, which the Committee State Purchasing 23 Director determines are suitable for procurement by the state. 24 No

1	state agency shall purchase, pursuant to Section 3007 of this title,
2	products or services purporting to be made by severely disabled
3	persons in workshops which are not certified by the Committee or by
4	severely disabled individuals who are not certified by the Committee
5	The products and services on contract will be published on the
6	procurement schedule and will be designated as mandatory. The
7	Office of Management and Enterprise Services Central Purchasing
8	Division shall have the authority to qualify organizations for
9	inclusion in the State Use Program, monitor qualified organizations
10	for continued compliance to remain active in the program, and remove
11	organizations from the program. Central Purchasing shall have the
12	authority to award and manage contracts to the qualified
13	organizations as well as to renegotiate or cancel contracts when
14	appropriate.
15	SECTION 5. AMENDATORY 74 O.S. 2021, Section 3004.1, is
16	amended to read as follows:
17	Section 3004.1 A one-percent fee of any contract for products
18	or services of the severely disabled shall be assessed against the
19	qualified organization and The State Purchasing Director may enter
20	or award contracts for products or services to a qualified
21	organization as defined in Section 3003 of this title and assess a
22	contract management fee or levy. The contract management fee or
23	levy shall be deposited in the State Use Committee Advisory Council

1 salary, administrative costs, annual trainings, professional association memberships, qualified agency operational improvement 2 grants, periodic economic advantage study, Annual Report 3 development, and other expenses incurred by the Central Purchasing 4 5 Division of the Office of Management and Enterprise Services for promoting goods and services provided by qualified organizations. 6 SECTION 6. 74 O.S. 2021, Section 3004.2, is 7 AMENDATORY amended to read as follows: 8

9 Section 3004.2 There is hereby created in the State Treasury a 10 revolving fund for the Office of Management and Enterprise Services to be designated the "State Use Committee Advisory Council Revolving 11 Fund". The fund shall be a continuing fund, not subject to fiscal 12 year limitations, and shall consist of all proceeds from the one-13 percent management fee or levy on contracts for purchases of 14 products or services of the severely disabled people with 15 significant disabilities, as provided in Section 3004.1 of this 16 title. The fund shall be invested in any of the types of 17 instruments in which the State Treasurer is authorized by law to 18 invest. Interest earned shall be retained by the fund. All monies 19 accruing to the credit of the fund are hereby appropriated and may 20 be budgeted and expended by the Office of Management and Enterprise 21 Services for the salary and other administrative expenses of the 22 buyer and clerical and technical support in the Central Purchasing 23 Division of the Office of Management and Enterprise Services 24

1 responsible for contracts for the products and services of the 2 severely disabled people with significant disabilities and expenses the Office incurs to support Committee State Use operations 3 including services of the Centralized Non-Profit Agency (CNA). 4 5 Expenditures from the fund shall be made upon warrants issued by the State Treasurer against claims filed as prescribed by law with the 6 Director of the Office of Management and Enterprise Services for 7 approval and payment. 8 9 SECTION 7. AMENDATORY 74 O.S. 2021, Section 3005, is amended to read as follows: 10 Section 3005. The Committee Office of Management and Enterprise 11 12 Services Central Purchasing Division shall determine the fair market 13 price of all products and services included in the procurement schedule and shall revise such prices in accordance with changing 14 market conditions; provided, however, a change in price shall not be 15 effective prior to the expiration of fifteen (15) thirty (30) days 16 17 from the date on which such change is made by the Committee Approved fair market prices shall be reflected on State 18 approved. Use contracts and procurement schedules within thirty (30) days of 19 20 approval and distribution. SECTION 8. AMENDATORY 74 O.S. 2021, Section 3006, is 21 amended to read as follows: 22 23 24

1	Section 3006. The Committee <u>State Purchasing Director</u> may
2	designate contract with a central nonprofit agency to facilitate

4	1. Management of the day-to-day operations of the program;
5	2. The facilitation, promotion, and the distribution of orders
6	of the state for products or services on the procurement schedule
7	among qualified nonprofit agencies for people with severe
8	<u>significant</u> disabilities <u>;</u>
9	3. Scheduling and conducting annual training sessions;
10	4. Publishing the approved State Use Procurement Schedule;
11	5. Promotion of the State Use Program through development and
12	distribution of program marketing material, promotion of program
13	through continued contact with current and future customers; and
14	6. All other duties assigned by the RFP through the Office of
15	Management and Enterprise Services.
16	SECTION 9. AMENDATORY 74 O.S. 2021, Section 3007, is
17	amended to read as follows:
18	Section 3007. A. Whenever the State of Oklahoma <u>this state</u> or
19	any of its agencies intends to procure any product or service
20	included in the procurement schedule, that entity shall secure the
21	product or service from a qualified nonprofit agency providing
22	employment to people with severe significant disabilities at the
23	fair market price determined by the Committee Office of Management
24	and Enterprise Services Central Purchasing Division, if the product

or service is available within the period required by the entity <u>and</u>
 meets the specifications of the entity.

B. An agency of this state shall not evade the intent and
meaning of this section by slight variations from standards adopted
by the Office of Management and Enterprise Services <u>Central</u>
Purchasing Division.

C. Provided, the requirements of this section shall not apply to the procurement of janitorial services by the Oklahoma State Bureau of Investigation. The Bureau shall conduct background investigations and national criminal history record checks on companies and individuals with which it contracts to provide janitorial services.

D. When the fair market price for a product or service approved 13 by the Committee exceeds a current market price for the same product 14 or service, and such lower market price has been verified by the 15 agency through compliance with the fair market analysis process 16 approved by the Office of Management and Enterprise Services, the 17 state use contracting officer may grant a temporary exception to a 18 requesting agency so that the agency may purchase the product or 19 service from the vendor offering the lower market price. The 20 temporary exception shall automatically expire when a new fair 21 market price is established by the State Use Committee Any 22 municipality or county agency of this state is authorized to 23 purchase products and services from any qualified organization as 24

1 defined in Section 3003 of this title. The qualified organization 2 shall be able to meet the needs and specifications for the products or services required by the purchasing body at the fair market 3 price. Procurements made pursuant to the provisions of this section 4 5 shall not be subject to competitive bid requirements. SECTION 10. AMENDATORY 74 O.S. 2021, Section 3008, is 6 amended to read as follows: 7 Section 3008. A. Nothing in Sections Section 3001 et seq. of 8 9 this title pursuant to purchases of products and services from people with severe significant disabilities shall be construed to 10 prohibit any department or agency of the state from manufacturing or 11 12 supplying its own products or services for its own use. Procurements made pursuant to this act Section 3001 et seq. of this 13 title shall not be subject to the competitive bid requirements of 14 the Oklahoma Central Purchasing Act, Section 85.1 et seq. of this 15 title. 16 B. The Office of Management and Enterprise Services Central 17

Purchasing Division shall require an annual qualified organization pricing review for all products and services approved and designated on the procurement schedule. The method of the pricing review shall be defined in the promulgated rules.

22 <u>C. When the fair market price for a product or service approved</u>
 23 <u>by the Office of Management and Enterprise Services Central</u>

24 Purchasing Division exceeds a current market price for the same

1 product or service, and such lower market price has been verified by 2 the agency through compliance with the fair market analysis process approved by the Office of Management and Enterprise Services Central 3 Purchasing Division, the State Use contracting officer may grant a 4 5 temporary exception to a requesting agency so that the agency may purchase the product or service from the supplier offering the lower 6 market price. 7 SECTION 11. AMENDATORY 74 O.S. 2021, Section 3009, is 8 9 amended to read as follows: 10 Section 3009. A. The State Use Committee Office of Management and Enterprise Services Central Purchasing Division shall prescribe 11 12 rules to carry out the purposes of the provisions of Sections 3001 13 through 3009 of this title. The rules shall include requirements for: в. 14 Publishing a catalog listing goods and services and jobs 15 1. that workshops qualified agencies employing people with significant 16 17 disabilities can provide the state, annually; and 2. Conducting a minimum of six two meetings per year of the 18 State Use Council, in compliance with the Oklahoma Open Meeting Act, 19 Section 301 et seq. of Title 25 of the Oklahoma Statutes; 20 3. Making available to contractors the minutes of all meetings; 21 4. Notifying contractors at least ten (10) days prior to 22 meeting dates. Meetings shall be called by the Committee Chair; 23 24

1	5. Establishing guidelines by which a vendor may file a
2	grievance.
3	C. The Committee shall report any violations of the intent of
4	the laws to the Attorney General's office within thirty (30) days of
5	their determination of such violations.
6	D. <u>C.</u> The Committee shall file an Annual Report <u>On an annual</u>
7	basis, the Office of Management and Enterprise Services shall within
8	sixty (60) days after the close of the legislative <u>fiscal</u> year <u>,</u>
