8	An Act relating to special license plates; amending 47 O.S. 2011, Section 1135.7, as amended by Section
9	5, Chapter 69, O.S.L. 2018 (47 O.S. Supp. 2020, Section 1135.7), which relates to the design and
10	issuance of special license plates; authorizing Tax Commission to enter into certain licensing
11	agreements; providing for transfer of funds for certain licensing fees; providing certain exception;
12	and providing an effective date.

15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. AMENDATORY 47 O.S. 2011, Section 1135.7, as
17	amended by Section 5, Chapter 69, O.S.L. 2018 (47 O.S. Supp. 2020,
18	Section 1135.7), is amended to read as follows:
19	Section 1135.7. A. The Oklahoma Tax Commission or private
20	vendor with whom the Commission has contracted is authorized to
21	design and issue special license plates to any person that applies
22	to the Tax Commission or private vendor for the creation of a
23	special license plate and meets the minimum standards and
24	qualifications specified in this section.

1 If the following standards and guidelines are satisfied, the В. Tax Commission shall authorize the issuance of a special license 2 3 plate to the person making application for the special license plate: 4 5 1. The license plate is to: show membership in or affiliation with an 6 a. 7 organization, or demonstrate support for an organization, group or 8 b. 9 cause; 2. The license plate does not advertise or endorse a product, 10 brand, or service that is provided for sale; 11 12 3. The license plate does not promote any philosophy based on prejudice or that is contrary to state civil rights laws; and 13 4. Two hundred prepaid applications for the special license 14 plate are received by the Tax Commission or private vendor. 15 C. The fee for special license plates shall be determined in 16 accordance with Section 1 of this act 1135.9 of this title. If the 17 special license plate does not provide financial assistance the fee 18 shall be no less than Fifteen Dollars (\$15.00) per year of renewal 19 and shall be in addition to all other registration fees provided by 20 the Oklahoma Vehicle License and Registration Act. Unless otherwise 21 provided in this section, Fifteen Dollars (\$15.00) of the fee shall 22 be apportioned as follows: Eight Dollars (\$8.00) of the special 23 license plate fee shall be deposited in the Oklahoma Tax Commission 24

1 Reimbursement Fund to be used for the administration of the Oklahoma 2 Vehicle License and Registration Act and the remaining amounts of 3 the special license plate fee shall be apportioned as provided in Section 1104 of this title. 4 5 D. For special license plates that provide financial assistance created pursuant to the provisions of this section, the Tax 6 Commission shall be authorized to enter into a licensing agreement 7 with an organization for any licensing fees that may be required to 8 9 use the organization's logo or design. 10 The fee for special license plates that provide financial Ε. assistance shall be determined in accordance with Section 1 of this 11 act 1135.9 of this title. Provided, the fee shall be no less than 12 13 Thirty-five Dollars (\$35.00) and shall be in addition to all other registration fees provided by the Oklahoma Vehicle License and 14 Registration Act. Thirty-five Dollars (\$35.00) per year of renewal 15 of the fee shall be apportioned as follows: 16 1. Twenty Dollars (\$20.00) of the fee shall be 17 a. apportioned to the License Plate Special Program 18 Assistance Revolving Fund created in Section 1135.8 of 19 this title to be used in the manner detailed in the 20

application for the special license plate; except as
provided in subparagraph b of this paragraph.
b. If the Tax Commission has entered into a licensing

23b.If the Tax Commission has entered into a licensing24agreement with an organization for the use of its

1 design or logo pursuant to Chapter 74 of Title 47 of 2 the Oklahoma Statutes, an amount to be determined in 3 the licensing agreement, but not to exceed twenty 4 (\$20) dollars per license plate issued, shall be 5 transferred monthly to that organization as payment of 6 licensing fees and no fee shall be apportioned to the 7 License Plate Special Program Assistance Revolving 8 Fund. 9 2. Eight Dollars (\$8.00) of the fee shall be deposited in the 10 Oklahoma Tax Commission Reimbursement Fund to be used for the 11 administration of the Oklahoma Vehicle License and Registration Act; 12 and 3. Any remaining amounts of the fee shall be apportioned as 13 provided in Section 1104 of this title. 14 15 E. If F. Except as otherwise provided in subsection D and 16 subparagraph b of paragraph 1 of subsection E of this section, if a person applies for a special license plate that provides financial 17 assistance, the application shall designate a state agency to be 18 responsible for expending the funds generated by the special license 19 plate and the application shall designate a specific public purpose 20 for which the funds are to be used. The application shall include 21 an acknowledgment from the designated state agency of their 22 agreement with acceptance of the designated funds. 23 24

F. G. Special license plates shall not be transferred to any other person but shall be removed from the vehicle upon transfer of ownership and retained. The special license plate may then be used on another vehicle but only after such other vehicle has been registered for the current year.

Special license plates shall be renewed each year by the Tax 6 Commission or a motor license agent, unless authorized by the Tax 7 Commission to be renewed for a period greater than one (1) year. 8 9 The Tax Commission shall notify all persons issued special license 10 plates of the renewal procedures prior to the expiration of the 11 special license plate. The notice shall contain all necessary information and shall contain instructions for the renewal procedure 12 upon presentation to a motor license agent or the Tax Commission. 13 The license plates shall be issued on a staggered system. 14

The Tax Commission is hereby directed to develop and implement a 15 system whereby motor license agents are permitted to accept 16 applications for special license plates authorized under this 17 The motor license agent shall confirm the applicant's 18 section. eligibility, if applicable, collect and deposit any amount 19 specifically authorized by law, accept and process the necessary 20 information directly into such system and generate a receipt 21 accordingly. For performance of these duties, motor license agents 22 shall retain the fee provided in Section 1141.1 of this title for 23 registration of a motor vehicle. The motor license agent fees for 24

1	acceptance of applications and renewals shall be paid out of the
2	Oklahoma Tax Commission Reimbursement Fund.
3	G. H. All special plates issued by the Tax Commission prior to
4	the effective date of this act November 1, 2005, shall not be
5	subject to the requirements and qualifications outlined in this
6	section.
7	H. I. As used in this section, "person" includes an individual,
8	group, organization or not-for-profit corporation that is recognized
9	as such by the Internal Revenue Service.
10	SECTION 2. This act shall become effective November 1, 2021.
