SECTION 2. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1698.309 of Title 69, unless there is created a duplication in numbering, reads as follows:

The bridge over Turkey Creek in Woodward County approximately 2 miles East of the Ellis and Woodward County border on Highway 15 shall be designated as the "Bud Martin Memorial Bridge". The Department of Transportation shall cause suitable permanent markers bearing that name to be placed on the bridge.

SECTION 3. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1698.310 of Title 69, unless there is created a duplication in numbering, reads as follows:

The bridge over the Cimarron River on Highway 15 approximately thirteen miles north of Boise City shall be designated as the "Private Robert "Bob" Clark Memorial Bridge". The Department of Transportation shall cause suitable permanent markers bearing that name to be placed on the bridge.

SECTION 4. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1698.311 of Title 69, unless there is created a duplication in numbering, reads as follows:

Notwithstanding any other provision of law, the section of State Highway 287 beginning at the municipal limits of Boise City and extending southeast to the Oklahoma-Texas border in Cimarron County shall be designated as the "President Donald J. Trump Highway". The
