COMMITTEE SUBSTITUTE

An Act relating to memorial bridge and highway designations; designating the William Charles "Charley" Coen Memorial Highway; requiring certain markers; designating the Bud Martin Memorial Bridge; designating the Private Robert "Bob" Clark Memorial Bridge; designating the Donald J. Trump Highway; providing for funding of signage; requiring certain markers; providing for codification; providing for noncodification; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1698.308 of Title 69, unless there is created a duplication in numbering, reads as follows:

The section of U.S. Highway 64 beginning at the western municipal limits of the town of Buffalo in Harper County, extending to N1860 Road, shall be designated as the "William Charles "Charley" Coen Memorial Highway". The Department of Transportation shall cause suitable permanent markers bearing that name to be placed on the highway.

1       SECTION 2.       NEW LAW       A new section of law to be codified  
2 in the Oklahoma Statutes as Section 1698.309 of Title 69, unless  
3 there is created a duplication in numbering, reads as follows:

4       The bridge over Turkey Creek in Woodward County approximately 2  
5 miles East of the Ellis and Woodward County border on Highway 15  
6 shall be designated as the "Bud Martin Memorial Bridge". The  
7 Department of Transportation shall cause suitable permanent markers  
8 bearing that name to be placed on the bridge.

9       SECTION 3.       NEW LAW       A new section of law to be codified  
10 in the Oklahoma Statutes as Section 1698.310 of Title 69, unless  
11 there is created a duplication in numbering, reads as follows:

12       The bridge over the Cimarron River on Highway 15 approximately  
13 thirteen miles north of Boise City shall be designated as the  
14 "Private Robert "Bob" Clark Memorial Bridge". The Department of  
15 Transportation shall cause suitable permanent markers bearing that  
16 name to be placed on the bridge.

17       SECTION 4.       NEW LAW       A new section of law to be codified  
18 in the Oklahoma Statutes as Section 1698.311 of Title 69, unless  
19 there is created a duplication in numbering, reads as follows:

20       Notwithstanding any other provision of law, the section of State  
21 Highway 287 beginning at the municipal limits of Boise City and  
22 extending southeast to the Oklahoma-Texas border in Cimarron County  
23 shall be designated as the "President Donald J. Trump Highway". The

1 Department of Transportation shall cause suitable permanent markers  
2 bearing that name to be placed on the highway.

3 SECTION 5. NEW LAW A new section of law not to be  
4 codified in the Oklahoma Statutes reads as follows:

5 The cost associated with signage related to Section 4 of this  
6 act shall be paid by the Senate and House of Representatives authors  
7 and coauthors of this act.

8 SECTION 6. This act shall become effective November 1, 2021.
