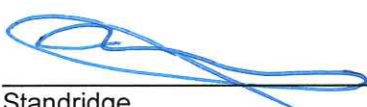
together with Engrossed House Amendments thereto, beg leave to report that we have had the same under consideration and herewith return the same with the following recommendations:

"An Act relating to motor vehicles; providing for certain fee for Diabetes Awareness license plates; creating the Diabetes Awareness License Plate Revolving Fund; amending 47 O.S. 2021, Section 1135.2, as last amended by Section 4, Chapter 543, O.S.L. 2021, which relates to special license plates; creating the Air Medal license plate; amending 47 O.S. 2021, Section 1135.5, which relates to additional official special license plates; modifying inclusions; requiring certain designation; reauthorizing the Paramedic License plate; creating the Diabetes Awareness License Plate; creating the Alliance of Mental Health Providers of Oklahoma License Plate; creating the Stillwater Public Schools License Plate; updating statutory language; providing for codification; and providing an effective date."

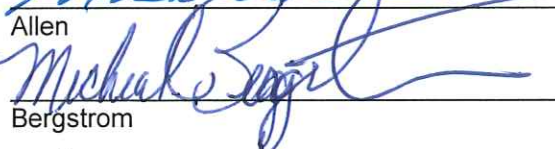

19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. NEW LAW A new section of law to be codified
21 in the Oklahoma Statutes as Section 1104.33 of Title 47, unless
22 there is created a duplication in numbering, reads as follows:

23 A. Twenty Dollars (\$20.00) of the fee authorized by Section
24 1135.5 of Title 47 of the Oklahoma Statutes for the Diabetes

1 Awareness license plates shall be deposited to the Diabetes
2 Awareness License Plate Revolving Fund created in subsection B of
3 this section.

4 B. There is hereby created in the State Treasury a revolving
5 fund for the State Department of Health to be designated the
6 "Diabetes Awareness License Plate Revolving Fund". The fund shall
7 consist of all monies received pursuant to subsection A of this
8 section. All monies accruing to the credit of the fund are hereby
9 appropriated and may be budgeted and expended by the State
10 Department of Health for grants to Diabetes Solutions of Oklahoma to
11 raise awareness and provide resources, as well as promote acceptance
12 and inclusion for people with diabetes. Expenditures from the fund
13 shall be made upon warrants issued by the State Treasurer against
14 claims filed as prescribed by law with the Director of the Office of
15 Management and Enterprise Services for approval and payment.

16 SECTION 2. AMENDATORY 47 O.S. 2021, Section 1135.2, as
17 last amended by Section 4, Chapter 543, O.S.L. 2021, is amended to
18 read as follows:

19 Section 1135.2 A. The Oklahoma Tax Commission is hereby
20 authorized to design and issue appropriate official special license
21 plates to persons in recognition of their service or awards as
22 provided by this section.

23 Special license plates shall not be transferred to any other
24 person but shall be removed from the vehicle upon transfer of

1 ownership and retained. The special license plate may then be used
2 on another vehicle but only after such other vehicle has been
3 registered for the current year.

4 Special license plates shall be renewed each year by the Tax
5 Commission or a motor license agent. The Tax Commission shall
6 annually notify by mail all persons issued special license plates.
7 The notice shall contain all necessary information and shall contain
8 instructions for the renewal procedure upon presentation to a motor
9 license agent or the Tax Commission. The license plates shall be
10 issued on a staggered system except for legislative plates and
11 amateur radio operator license plates.

12 The Tax Commission is hereby directed to develop and implement a
13 system whereby motor license agents are permitted to accept
14 applications for special license plates authorized under this
15 section. The motor license agent shall confirm the applicant's
16 eligibility, if applicable, collect and deposit any amount
17 specifically authorized by law, accept and process the necessary
18 information directly into such system and generate a receipt
19 accordingly. For performance of these duties, motor license agents
20 shall retain the fee provided in Section 1141.1 of this title for
21 registration of a motor vehicle. The motor license agent fees for
22 acceptance of applications and renewals shall be paid out of the
23 Oklahoma Tax Commission Reimbursement Fund.

1 B. The special license plates provided by this section are as
2 follows:

3 1. Prisoner of War License Plates - such plates shall be
4 designed for honorably discharged or present members of the United
5 States Armed Forces and civilians who were former prisoners of war
6 held by a foreign country and who can provide proper certification
7 of that status. Such persons may apply for a prisoner of war
8 license plate for no more than two vehicles with each vehicle having
9 a rated carrying capacity of one (1) ton or less. The surviving
10 spouse of any deceased former prisoner of war, if the spouse has not
11 since remarried, or if remarried, the remarriage is terminated by
12 death, divorce, or annulment, may apply for a prisoner of war
13 license plate for one vehicle with a rated carrying capacity of one
14 (1) ton or less. The fee provided by this section for the special
15 license plate authorized by this paragraph shall be in addition to
16 all other registration fees provided by law, except the registration
17 fees levied by Section 1132 of this title;

18 2. National Guard License Plates - such plates shall be
19 designed for active or retired members of the Oklahoma National
20 Guard. Retirees who are eligible for such plates shall provide
21 proof of eligibility upon initial application, but shall not be
22 required to provide proof of eligibility annually;

23 3. Air National Guard License Plates - such plates shall be
24 designed for active or retired members of the Oklahoma Air National

Guard. Retirees who are eligible for such plates shall provide proof of eligibility upon initial application, but shall not be required to provide proof of eligibility annually;

4. United States Armed Forces License Plates - such plates shall be designed for active, retired, former or reserve members of the United States Armed Forces, and shall identify which branch of service, and carry the emblem and name of either the Army, Navy, Air Force, Marines or Coast Guard, according to the branch of service to which the member belongs or did belong. Former members who have been dishonorably discharged shall not be eligible for such plates. Persons applying for such license plate must show proof of present or past military service by presenting a valid Uniformed Services Identity Card or the United States Department of Defense Form (DD)214. Retired or former members who are eligible for such plates shall provide proof of eligibility upon initial application, but shall not be required to provide proof of eligibility annually;

5. Congressional Medal of Honor Recipient License Plates - such plates shall be designed for any resident of this state who has been awarded the Congressional Medal of Honor. Such persons may apply for a Congressional Medal of Honor recipient license plate for each vehicle with a rated carrying capacity of one (1) ton or less. There shall be no registration fee for the issuance of this plate;

6. Missing In Action License Plates - such plates shall be designed to honor members of the United States Armed Forces who are

1 missing in action. The spouse of such missing person, if the spouse
2 has not since remarried, or if remarried, the remarriage is
3 terminated by death, divorce, or annulment, and each parent of the
4 missing person may apply for a missing in action license plate upon
5 presenting proper certification that the person is missing in action
6 and that the person making the application is the qualifying spouse
7 or the parent of the missing person. The qualifying spouse and each
8 parent of the missing person may each apply for the missing in
9 action license plate for each vehicle with a rated carrying capacity
10 of one (1) ton or less;

11 7. Purple Heart Recipient License Plates - such plates shall be
12 designed for any resident of this state presenting proper
13 certification from the United States Department of Veterans Affairs
14 or the Armed Forces of the United States certifying that such
15 resident has been awarded the Purple Heart military decoration.
16 Such persons may apply for a Purple Heart recipient license plate
17 for vehicles having a rated carrying capacity of one (1) ton or
18 less. The surviving spouse of any deceased veteran who has been
19 awarded the Purple Heart military decoration, if such spouse has not
20 since remarried, or if remarried, the remarriage has been terminated
21 by death, divorce or annulment, may apply for such plate for one
22 vehicle with a rated carrying capacity of one (1) ton or less. The
23 license plate created by this paragraph shall be exempt from the fee
24 provided by this section for special license plates;

1 8. Pearl Harbor Survivor License Plates - such plates shall be
2 designed for any resident of this state who can be verified by the
3 United States Department of Veterans Affairs or the Armed Forces of
4 the United States as being:

5 a. a member of the United States Armed Forces on December
6 7, 1941,

7 b. stationed on December 7, 1941, during the hours of
8 7:55 a.m. to 9:45 a.m. Hawaii time at Pearl Harbor,
9 the island of Oahu, or offshore at a distance not to
10 exceed three (3) miles, and

11 c. a recipient of an honorable discharge from the United
12 States Armed Forces.

13 Such person may apply for a Pearl Harbor Survivor license plate
14 for each vehicle with a rated carrying capacity of one (1) ton or
15 less;

16 9. Iwo Jima License Plates - such plates shall be designed for
17 any resident of this state who can be verified by the United States
18 Department of Veterans Affairs or the Armed Forces of the United
19 States as being:

20 a. a member of the United States Armed Forces in February
21 of 1945,

22 b. stationed in February of 1945 on or in the immediate
23 vicinity of the island of Iwo Jima, and
24

1 c. a recipient of an honorable discharge from the United
2 States Armed Forces.

3 Such person may apply for an Iwo Jima license plate for each
4 vehicle with a rated carrying capacity of one (1) ton or less.

5 Such license plate shall have the legend "Oklahoma OK" and shall
6 contain three letters and three numbers. Between the letters and
7 numbers shall be a logo of the flag-raising at Iwo Jima. Below the
8 letters, logo and numbers, the plate shall contain the words "FEB."
9 at the left, "Iwo Jima" in the center and "1945" at the right. Such
10 plates shall not be subject to the design requirements of any other
11 license plates prescribed by law other than the space for the
12 placement of the yearly decals for each succeeding year of
13 registration after the initial issue;

14 10. D-Day Survivor License Plates - such plates shall be
15 designed for any resident of this state who can be verified by the
16 United States Department of Veterans Affairs or the Armed Forces of
17 the United States as being:

18 a. a member of the United States Armed Forces on June 6,
19 1944,

20 b. a participant in the Allied invasion of the coast of
21 Normandy on June 6, 1944; provided, if such
22 participation cannot be verified by the United States
23 Department of Veterans Affairs or the Armed Forces of
24 the United States, the Tax Commission may, in its

1 discretion, accept evidence of such participation from
2 the person applying for the license plate, and
3 c. a recipient of an honorable discharge from the United
4 States Armed Forces.

5 Such person may apply for a D-Day Survivor license plate for
6 each vehicle with a rated carrying capacity of one (1) ton or less;

7 11. Killed in Action License Plates - such plates shall be
8 designed to honor members of the United States Armed Forces who were
9 killed in action. The spouse of the deceased person, if the spouse
10 has not remarried, or if remarried, the remarriage is terminated by
11 death, divorce, or annulment, may apply for a killed in action
12 license plate upon presenting proper certification that the person
13 was killed in action and that the person making the application is
14 the qualifying spouse of the deceased person. The qualifying spouse
15 may apply for a killed in action license plate for no more than two
16 vehicles with each vehicle with a rated carrying capacity of one (1)
17 ton or less. The fee provided by this section for the special
18 license plate authorized by this paragraph shall be in addition to
19 all other registration fees provided by law, except the registration
20 fees levied by Section 1132 of this title. Beginning ~~on the~~
21 ~~effective date of this section of this act~~ November 1, 2021, the
22 killed in action license plate shall be designed to honor members of
23 the United States Armed Forces who were killed in action while
24 engaged in combat with a hostile force. The parents, siblings,

1 half-siblings, grandparents or spouse of the deceased person, if the
2 spouse has not remarried, or if remarried, the remarriage is
3 terminated by death, divorce or annulment, may apply for a killed in
4 action license plate upon presenting proper certification that the
5 person was killed in action and that the person making the
6 application is the qualifying spouse or family member of the
7 deceased person. The qualifying spouse or family member may apply
8 for a killed in action license plate for no more than two vehicles
9 with each vehicle with a rated carrying capacity of one (1) ton or
10 less. The license plate shall have a white background and the
11 legend "Killed in Action" and shall contain any combination of
12 numbers and letters from one to a maximum of seven in black, as for
13 personalized license plates. To the left of the numbers and letters
14 shall be the Battlefield Cross in gold. The killed in action
15 license plate shall be exempt from any minimum issuance criteria
16 related to license plate applications;

17 12. Gold Star Families License Plates - such plates shall be
18 designed to honor members of the United States Armed Forces who were
19 killed while on active duty. The parents, siblings, half-siblings
20 or grandparents of the deceased person may apply for a gold star
21 license plate upon presenting proper certification that the person
22 was killed while on active duty and that the person making the
23 application is the parent, sibling, half-sibling or grandparent of
24 the deceased person. The family member may apply for a gold star

1 families license plate for no more than two vehicles with each
2 vehicle having a rated carrying capacity of one (1) ton or less.
3 The fee provided by this section for the special license plate
4 authorized by this paragraph shall be in addition to all other
5 registration fees provided by law, except the registration fees
6 levied by Section 1132 of this title;

7 13. Military Decoration License Plates - such plates shall be
8 designed for any resident of this state who has been awarded the
9 Distinguished Service Medal, the Distinguished Service Cross, the
10 Distinguished Flying Cross, the Bronze Star military decoration or
11 the Silver Star military decoration. Such persons may apply for a
12 military decoration license plate for each vehicle with a rated
13 carrying capacity of one (1) ton or less;

14 14. Vietnam Veteran License Plates - such plates shall be
15 designed for honorably discharged or present members of the United
16 States Armed Forces who served in the Vietnam Conflict. Such
17 persons may apply for a Vietnam veteran license plate for each
18 vehicle with a rated carrying capacity of one (1) ton or less;

19 15. Police Officer License Plates - such plates shall be
20 designed for any currently employed, reserve or retired municipal
21 police officer or full-time, reserve or retired university police
22 officer certified by the Council on Law Enforcement Education and
23 Training or common education police officer certified by the Council
24 on Law Enforcement Education and Training. Police officers may

1 apply for police officer license plates for vehicles with a rated
2 capacity of one (1) ton or less or for a motorcycle upon proof of
3 employment by or retirement from a municipal, university or common
4 education police department by either an identification card or
5 letter from the chief of the police department or the Oklahoma
6 Police Pension and Retirement Board. Retirees who are eligible for
7 such plates shall provide proof of eligibility upon initial
8 application but shall not be required to provide proof of
9 eligibility annually. The license plates shall be designed in
10 consultation with municipal police departments of this state;
11 provided, the license plate for motorcycles may be of similar design
12 to the license plate for motor vehicles or may be a new design in
13 order to meet space requirements for a motorcycle license plate;

14 16. World War II Veteran License Plates - such plates shall be
15 designed to honor honorably discharged former members of the United
16 States Armed Forces who are residents of this state and who can be
17 verified by the ~~Oklahoma~~ Military Department of the State of
18 Oklahoma, the Department of Veterans Affairs or the Armed Forces of
19 the United States as having served on federal active duty anytime
20 during the period from September 16, 1940, to December 7, 1945. The
21 former members may apply for a World War II Veteran license plate
22 for vehicles with a rated carrying capacity of one (1) ton or less.

23 The license plate shall have the legend "Oklahoma" and shall
24 contain, in the center of the plate, either the Thunderbird Insignia

1 of the 45th Infantry Division in the prescribed red and gold
2 coloring or the emblem of the Army, Navy, U.S. Army Air Corps,
3 Marines or Coast Guard according to the branch of service to which
4 the member belonged. For the purpose of license plate
5 identification, the plate shall contain four digits, two digits at
6 the left and two digits at the right of the insignia or emblem.
7 Centered on the bottom of the license plate shall be the words
8 "WORLD WAR II";

9 17. Korean War Veteran License Plates - such plates shall be
10 designed to honor honorably discharged former members of the United
11 States Armed Forces who are residents of this state and who can be
12 verified by the ~~Oklahoma~~ Military Department of the State of
13 Oklahoma, the Department of Veterans Affairs or the Armed Forces of
14 the United States as having served on federal active duty anytime
15 during the period from June 27, 1950, to January 31, 1955, both
16 dates inclusive. The former members may apply for a Korean War
17 Veteran license plate for vehicles with a rated carrying capacity of
18 one (1) ton or less.

19 The license plate shall have the legend "OKLAHOMA" and shall
20 contain, in the center of the plate, either the Thunderbird Insignia
21 of the 45th Infantry Division in the prescribed red and gold
22 coloring or the emblem of the Army, Navy, Air Force, Marines or
23 Coast Guard according to the branch of service to which the member
24 belonged. For the purpose of license plate identification, the

1 plate shall contain four digits, two digits at the left and two
2 digits at the right of the insignia or emblem. Centered on the
3 bottom of the license plate shall be the word "KOREA";

4 18. Municipal Official License Plates - such plates shall be
5 designed for persons elected to a municipal office in this state and
6 shall designate the name of the municipality and the district or
7 ward in which the municipal official serves. The plates shall only
8 be produced upon application;

9 19. Red Cross Volunteer License Plates - such plates shall be
10 designed to honor American Red Cross volunteers and staff who are
11 residents of this state. Such persons must present an
12 identification card issued by the American Red Cross and bearing a
13 photograph of the person. The license plate shall be designed with
14 the assistance of the American Red Cross and shall have the legend
15 "Oklahoma OK!" in the color Pantone 186C Red. Below the legend the
16 symbol of the American Red Cross and no more than three letters and
17 three numbers shall be in the color Pantone 186C Red. Below the
18 symbol and letters and numbers shall be the words "American Red
19 Cross" in black. The plates shall not be subject to the design
20 requirements of any other license plates prescribed by law other
21 than the space for the placement of the yearly decals for each
22 succeeding year of registration after the initial issue;

23 20. Desert Storm License Plates - such plates shall be designed
24 and issued to any honorably discharged or present member of the

1 United States Armed Forces who served in the Persian Gulf Crisis and
2 the Desert Storm operation. Such persons may apply for a Desert
3 Storm license plate for each vehicle with a rated carrying capacity
4 of one (1) ton or less;

5 21. Military Reserve Unit License Plates - such plates shall be
6 designed and issued to any honorably discharged or present member of
7 a reserve unit of the United States Armed Forces. Such persons may
8 apply for a Military Reserve Unit license plate for each vehicle
9 with a rated carrying capacity of one (1) ton or less;

10 22. Oklahoma City Bombing Victims and Survivors License Plates
11 - such plates shall be designed and issued to any victim or survivor
12 of the bombing attack on the Alfred P. Murrah Federal Building in
13 downtown Oklahoma City on April 19, 1995;

14 23. Civil Air Patrol License Plates - such plates shall be
15 designed and issued to any person who is a member of the Civil Air
16 Patrol. Such persons may apply for a Civil Air Patrol license plate
17 for each vehicle with a rated carrying capacity of one (1) ton or
18 less upon proof of membership in the Civil Air Patrol. The license
19 plate shall be designed in consultation with the Civil Air Patrol;

20 24. Ninety-Nines License Plates - such plates shall be designed
21 and issued to members of the Ninety-Nines. Persons applying for
22 such license plate must show proof of membership in the Ninety-
23 Nines. The license plates shall be designed in consultation with
24 the Ninety-Nines;

1 25. Combat Infantryman Badge License Plates - such plates shall
2 be designed to honor recipients of the Combat Infantryman Badge.
3 The plate shall have the legend "Oklahoma OK". Below the legend
4 shall be the Combat Infantryman Badge and three numbers. Below the
5 badge and the numbers shall be the words "Combat Infantryman Badge".
6 Such persons may apply for a Combat Infantryman Badge license plate
7 for each vehicle with a rated carrying capacity of one (1) ton or
8 less;

9 26. Somalia Combat Veterans License Plates - such plates shall
10 be designed and issued to any honorably discharged or present member
11 of the United States Armed Forces who saw combat in the United
12 Nations relief effort. Such persons may apply for a Somalia Combat
13 Veteran license plate for each vehicle with a rated carrying
14 capacity of one (1) ton or less;

15 27. Police Chaplain License Plates - such plates shall be
16 designed and issued to members of the International Conference of
17 Police Chaplains (ICPC) who have completed the ICPC requirements for
18 basic certification as a police chaplain. The license plates shall
19 be designed in consultation with the ICPC;

20 28. Joint Service Commendation Medal License Plates - such
21 plates shall be designed and issued to any resident of this state
22 who has been awarded the Joint Service Commendation Medal by the
23 United States Secretary of Defense;

1 29. Merchant Marine License Plates - such plates shall be
2 designed, subject to criteria to be presented to the Tax Commission
3 by the Oklahoma Department of Veterans Affairs, and issued to any
4 person who during combat was a member of the Merchant Marines as
5 certified by the Oklahoma Department of Veterans Affairs. Such
6 license plate may be issued for each vehicle with a rated carrying
7 capacity of one (1) ton or less;

8 30. Legislative License Plates - such plates shall be designed
9 for persons elected to the Oklahoma Legislature and shall designate
10 the house of the Legislature in which the legislator serves and the
11 district number;

12 31. Disabled Veterans License Plates - such plates shall be
13 designed for persons presenting proper certification from the United
14 States Department of Veterans Affairs or the Armed Forces of the
15 United States certifying such veteran has a service-connected
16 disability rating of fifty percent (50%) or more, regardless which
17 agency pays the disability benefits, or that such veteran has been
18 awarded a vehicle by the United States government or receives a
19 grant from the United States Department of Veterans Affairs for the
20 purchase of an automobile due to a service-connected disability
21 rating or due to the loss of use of a limb or an eye. Such persons
22 may apply to the Tax Commission for a disabled veterans license
23 plate or to a motor license agent for a regular license plate for no
24 more than two vehicles with each vehicle having a rated carrying

1 capacity of one (1) ton or less. The surviving spouse of any
2 deceased disabled veteran, if the spouse has not since remarried, or
3 if remarried, the remarriage is terminated by death, divorce, or
4 annulment, or a surviving spouse in receipt of Dependency and
5 Indemnity Compensation from the United States Department of Veterans
6 Affairs, may apply for a disabled veterans license plate for one
7 vehicle with a rated carrying capacity of one (1) ton or less. The
8 fee provided by this section for the special license plate
9 authorized by this paragraph shall be in addition to all other
10 registration fees provided by law, except the registration fees
11 levied by Section 1132 of this title. The total expense of this
12 license plate shall not exceed Five Dollars (\$5.00).

13 If the person qualifies for a disabled veterans license plate
14 and is also eligible for a physically disabled placard under the
15 provisions of Section 15-112 of this title, the person shall be
16 eligible to receive a disabled veterans license plate that also
17 displays the international accessibility symbol, which is a stylized
18 human figure in a wheelchair. Upon the death of the disabled
19 veteran with a disabled veterans license plate with the
20 international accessibility symbol, the plate shall be returned to
21 the Tax Commission;

22 32. United States Air Force Association License Plates - such
23 plates shall be designed for members of the United States Air Force
24 Association. Persons applying for such license plate must show

1 proof of membership in the Association. The license plates shall be
2 designed in consultation with the Association;

3 33. Oklahoma Military Academy Alumni License Plates - such
4 plates shall be designed and issued to any resident of this state
5 who is an alumnus of the Oklahoma Military Academy. Such persons
6 may apply for an Oklahoma Military Academy Alumnus license plate for
7 each vehicle with a rated carrying capacity of one (1) ton or less.
8 The license plates shall be designed in consultation with the
9 Oklahoma Military Academy and shall contain the shield of the
10 Academy;

11 34. Amateur Radio Operator License Plates - such plates shall
12 be designed and issued to any person, holding a valid operator's
13 license, technician class or better, issued by the Federal
14 Communications Commission, and who is also the owner of a motor
15 vehicle currently registered in Oklahoma, in which has been
16 installed amateur mobile transmitting and receiving equipment.
17 Eligible persons shall be entitled to two special vehicle
18 identification plates as herein provided. Application for such
19 identification plates shall be on a form prescribed by the Tax
20 Commission and the plates issued to such applicant shall have
21 stamped thereon the word "Oklahoma" and bear the official call
22 letters of the radio station assigned by the Federal Communications
23 Commission to the individual amateur operator thereof. All
24 applications for such plates must be made to the Tax Commission on

1 or before the first day of October of any year for such plates for
2 the following calendar year and must be accompanied by the fee
3 required in this section together with a certificate, or such other
4 evidence as the Tax Commission may require, of proof that applicant
5 has a valid technician class or better amateur operator's license
6 and proof of applicant's ownership of a vehicle in which radio
7 receiving and transmitting equipment is installed. Applicants shall
8 only be entitled to one set of special identification plates in any
9 one (1) year, and such calendar year shall be stamped thereon. The
10 right to such special identification plates herein provided for
11 shall continue until the amateur radio operator's license of the
12 person to whom such plates are issued expires or is revoked;

13 35. American Legion License Plates - such plates shall be
14 designed for members of the American Legion. Persons applying for
15 such license plate must show proof of membership. The license
16 plates shall be designed in consultation with the American Legion of
17 Oklahoma;

18 36. Deputy Sheriff License Plates - such plates shall be
19 designed for any currently employed or retired county sheriff or
20 deputy sheriff. County sheriffs or deputy sheriffs may apply for
21 such plates for vehicles with a rated capacity of one (1) ton or
22 less upon proof of employment by or retirement from a county
23 sheriff's office by either an identification card or letter from the
24 county sheriff or a government-sponsored retirement board from which

1 the county sheriff or deputy sheriff may be receiving a pension.
2 Retirees who are eligible for such plates shall provide proof of
3 eligibility upon initial application but shall not be required to
4 provide proof of eligibility annually. The license plates shall be
5 designed in consultation with the county sheriff offices of this
6 state;

7 37. Gold Star Surviving Spouse License Plates - such plates
8 shall be designed to honor the surviving spouses and children of
9 qualified veterans. As used in this paragraph, "qualified veteran"
10 shall mean:

- 11 a. any person honorably discharged from any branch of the
12 United States Armed Forces or as a member of the
13 Oklahoma National Guard, who died as a direct result
14 of the performance of duties for any branch of the
15 United States Armed Forces or Oklahoma National Guard
16 while on active military duty, or
- 17 b. any person honorably discharged from any branch of the
18 United States Armed Forces or as a member of the
19 Oklahoma National Guard, who died as a result of
20 injury, illness or disease caused by the performance
21 of such duties while on active duty, whether the death
22 occurred while on active duty or after the honorable
23 discharge of such person.

1 The fee provided by this section for the special license plate
2 authorized by this paragraph shall be in addition to all other
3 registration fees provided by law, except the registration fees
4 levied by Section 1132 of this title;

5 38. Korea Defense Service Medal License Plates - such plates
6 shall be designed and issued to any resident of this state who has
7 been awarded the Korea Defense Service Medal by the United States
8 Secretary of Defense. Such persons may apply for a Korea Defense
9 Service Medal license plate for each vehicle with a rated carrying
10 capacity of one (1) ton or less;

11 39. 180th Infantry License Plates - such plates shall be
12 designed for members and prior members of the 180th Infantry.
13 Persons applying for such license plate must obtain and provide
14 proof of their membership from the 180th Infantry Association. The
15 license plates shall be designed in consultation with the 180th
16 Infantry;

17 40. Operation Iraqi Freedom Veteran License Plates - such
18 plates shall be designed and issued to any honorably discharged or
19 present member of the United States Armed Forces who served in
20 Operation Iraqi Freedom. Such person may apply for an Operation
21 Iraqi Freedom Veteran license plate for each vehicle with a rated
22 carrying capacity of one (1) ton or less, or for a motorcycle;
23 provided, the license plate for motorcycles may be of similar design
24

1 to the license plate for motor vehicles or may be a new design in
2 order to meet space requirements for a motorcycle license plate;

3 41. United States Air Force Academy Alumni License Plates -
4 such plates shall be designed and issued to any resident of this
5 state who is an alumnus of the United States Air Force Academy.
6 Such persons may apply for a United States Air Force Academy Alumnus
7 license plate for each vehicle with a rated carrying capacity of one
8 (1) ton or less;

9 42. Operation Enduring Freedom Veteran License Plate - such
10 plates shall be designed and issued to any honorably discharged or
11 present member of the United States Armed Forces who served in
12 Operation Enduring Freedom on or after September 11, 2001. The
13 license plate shall be designed in consultation with the Military
14 Department of the State of Oklahoma. Such person may apply for an
15 Operation Enduring Freedom Veteran license plate for each vehicle
16 with a rated carrying capacity of one (1) ton or less, or for a
17 motorcycle; provided, the license plate for motorcycles may be of
18 similar design to the license plate for motor vehicles or may be a
19 new design in order to meet space requirements for a motorcycle
20 license plate;

21 43. Military Multi-Decoration License Plate - such plates shall
22 be designed and issued to any honorably discharged or present member
23 of the United States Armed Forces who qualifies for more than one
24 military decoration license plate pursuant to the provisions of this

1 section. The Tax Commission shall develop and implement a system
2 whereby the designs of the eligible license plates can be included
3 together on a single license plate. Such person may apply for a
4 Military Multi-Decoration license plate for each vehicle with a
5 rated carrying capacity of one (1) ton or less;

6 44. Global War on Terror Expeditionary License Plate - such
7 plates shall be designed and issued to any honorably discharged or
8 present member of the United States Armed Forces who has earned a
9 Global War on Terror Expeditionary decoration. The license plate
10 shall be designed in consultation with the United States Institute
11 of Heraldry and the Military Department of the State of Oklahoma.
12 Such person may apply for a Global War on Terror Expeditionary
13 license plate for each vehicle with a rated carrying capacity of one
14 (1) ton or less;

15 45. Legion of Merit Medal Recipient License Plates - such
16 plates shall be designed for any resident of this state presenting
17 proper certification from the United States Department of Veterans
18 Affairs or the Armed Forces of the United States certifying that
19 such resident has been awarded the Legion of Merit military
20 decoration. Such persons may apply for a Legion of Merit recipient
21 license plate for vehicles having a rated carrying capacity of one
22 (1) ton or less. The license plate shall be designed in
23 consultation with the Military Department of the State of Oklahoma;
24

1 46. 1-179th License Plates - such plates shall be designed for
2 members, prior members and members of the household of a member or
3 former member of the 1-179th Infantry. Persons applying for such
4 license plate must obtain and provide proof of their membership
5 association with the 1-179th Infantry Association. The license
6 plate shall be designed in consultation with the 1-179th Infantry;

7 47. 2-179th License Plates - such plates shall be designed for
8 members, prior members and members of the household of a member or
9 former member of the 2-179th Infantry. Persons applying for such
10 license plate must obtain and provide proof of their membership
11 association with the 2-179th Infantry Association. The license
12 plate shall be designed in consultation with the 2-179th Infantry;

13 48. Combat Action Ribbon Recipient License Plates - such plates
14 shall be designed to honor recipients of the Combat Action Ribbon
15 who present proper certification from the United States Department
16 of the Navy. The license plate shall include the Combat Action
17 Ribbon earned by the recipient. Such persons may apply for a Combat
18 Action Ribbon Recipient license plate for vehicles having a rated
19 carrying capacity of one (1) ton or less;

20 49. Oklahoma Submarine Veterans License Plate - such plates
21 shall be designed for any resident of this state who is a United
22 States submarine veteran and presents either a Department of Defense
23 form 214 or other documentation certifying such service. Such
24 persons may apply for an Oklahoma Submarine Veterans license plate

1 for vehicles having a rated capacity of one (1) ton or less. The
2 license plate design shall include both gold and silver dolphins to
3 represent both officer and enlisted service members;

4 50. United States Navy Seabees and Civil Engineer Corps License
5 Plate - such plates shall be designed and issued to any honorably
6 discharged or present member of the United States Navy Seabees or
7 Civil Engineer Corps. Such persons may apply for a United States
8 Navy Seabees and Civil Engineer Corps license plate for vehicles
9 having a rated carrying capacity of one (1) ton or less. The
10 license plate shall be designed in consultation with the Military
11 Department of the State of Oklahoma;

12 51. Combat Action Badge Recipient License Plate - such plates
13 shall be designed to honor recipients of the Combat Action Badge who
14 present proper certification from the United States Army. The
15 license plate shall include the Combat Action Badge earned by the
16 recipient. Such persons may apply for a Combat Action Badge
17 Recipient license plate for vehicles having a rated carrying
18 capacity of one (1) ton or less, or for a motorcycle; provided, the
19 license plate for motorcycles may be of similar design to the
20 license plate for motor vehicles or may be a new design in order to
21 meet space requirements for a motorcycle license plate;

22 52. Iraq Combat Veteran License Plate - such plates shall be
23 designed and issued to any honorably discharged or present member of
24 the United States Armed Forces who saw combat in Operation Iraqi

Freedom. Such persons may apply for an Iraq Combat Veteran license plate for each vehicle with a rated carrying capacity of one (1) ton or less, or for a motorcycle; provided, the license plate for motorcycles may be of similar design to the license plate for motor vehicles or may be a new design in order to meet space requirements for a motorcycle license plate;

53. Afghanistan Combat Veteran License Plate - such plates shall be designed and issued to any honorably discharged or present member of the United States Armed Forces who saw combat in Operation Enduring Freedom. Such persons may apply for an Afghanistan Combat Veteran license plate for each vehicle with a rated carrying capacity of one (1) ton or less, or for a motorcycle; provided, the license plate for motorcycles may be of similar design to the license plate for motor vehicles or may be a new design in order to meet space requirements for a motorcycle license plate;

54. Special Forces Association License Plates - such plates shall be designed and issued to any honorably discharged or present member of the Army Special Forces qualified and authorized to wear upon the person's United States military uniform the Army Special Forces Tab. Persons applying for the Special Forces Association license plate must provide a copy of the orders awarding the Special Forces Tab or authorizing its wear upon a United States military uniform. The license plate shall be designed in consultation with the Special Forces Association, Chapter 32-50. The Tax Commission

1 shall produce up to two distinct designs for the Special Forces
2 Association license plate. Qualified persons may select one design
3 at the time of application. The plates shall be issued to any
4 qualified person in any combination of numbers and letters from one
5 to a maximum of seven, as for personalized license plates;

6 55. Veterans of the United States Armed Forces License Plates -
7 such plates shall be designed for veterans of the United States
8 Armed Forces, and shall identify the branch of service, carry the
9 emblem and name of either the Army, Navy, Air Force, Marines or
10 Coast Guard, according to the branch of service to which the member
11 belonged, and shall reflect veteran status. Former members who have
12 been dishonorably discharged shall not be eligible for such plates.
13 Persons applying for such license plates must show proof of past
14 military service by presenting a valid United States Department of
15 Defense Form (DD)214 upon initial application but shall not be
16 required to provide proof of eligibility annually; and

17 56. Navy Chief License Plates - such plates shall be designed
18 and issued to any resident of this state who has achieved the rank
19 of E7 through E9 in the United States Navy and presents proper
20 certification that the resident has achieved such rank and was
21 either honorably discharged or is an active or retired member of the
22 United States Navy. Such persons may apply for a Navy Chief license
23 plate for vehicles having a rated carrying capacity of one (1) ton
24 or less, or for a motorcycle; provided, the license plate for

1 motorcycles may be of similar design to the license plate for motor
2 vehicles or may be a new design in order to meet space requirements
3 for a motorcycle license plate; and

4 57. Air Medal License Plate - such plates shall be designed and
5 issued to any resident of this state who has earned the Air Medal
6 and presents proper certification that the resident has been awarded
7 such medal. The license plate shall include an image of the Air
8 Medal earned by the recipient. Such persons may apply for an Air
9 Medal license plate for vehicles having a rated carrying capacity of
10 one (1) ton or less, or for a motorcycle; provided, the license
11 plate for motorcycles may be of similar design to the license plate
12 for motor vehicles or may be a new design in order to meet space
13 requirements for a motorcycle license plate.

14 C. Unless otherwise provided by this section, the fee for such
15 plates shall be Eight Dollars (\$8.00) and shall be in addition to
16 all other registration fees provided by the Oklahoma Vehicle License
17 and Registration Act. Such fees shall be deposited in the Oklahoma
18 Tax Commission Reimbursement Fund to be used for the administration
19 of the Oklahoma Vehicle License and Registration Act.

20 SECTION 3. AMENDATORY 47 O.S. 2021, Section 1135.5, as
21 last amended by Section 6, Chapter 543, O.S.L. 2021, is amended to
22 read as follows:

23 Section 1135.5 A. The Oklahoma Tax Commission is hereby
24 authorized to design and issue appropriate official special license

1 plates to persons wishing to demonstrate support and provide
2 financial assistance as provided by this section.

3 Special license plates shall not be transferred to any other
4 person but shall be removed from the vehicle upon transfer of
5 ownership and retained. The special license plate may then be used
6 on another vehicle but only after such other vehicle has been
7 registered for the current year with a motor license agent.

8 Special license plates shall be renewed each year by the Tax
9 Commission or a motor license agent, unless authorized by the Tax
10 Commission to be renewed for a period greater than one (1) year.
11 The Tax Commission shall notify by mail all persons issued special
12 license plates. The notice shall contain all necessary information
13 and shall contain instructions for the renewal procedure upon
14 presentation to a motor license agent or the Tax Commission. The
15 license plates shall be issued on a staggered system.

16 The Tax Commission is hereby directed to develop and implement a
17 system whereby motor license agents are permitted to accept
18 applications for special license plates authorized under this
19 section. The motor license agent shall confirm the applicant's
20 eligibility, if applicable, collect and deposit any amount
21 specifically authorized by law, accept and process the necessary
22 information directly into such system and generate a receipt
23 accordingly. For performance of these duties, motor license agents
24 shall retain the fee provided in Section 1141.1 of this title for

1 registration of a motor vehicle. The motor license agent fees for
2 acceptance of applications and renewals shall be paid out of the
3 Oklahoma Tax Commission Reimbursement Fund.

4 If fewer than one hundred of any type of special license plates
5 authorized prior to January 1, 2004, are issued prior to January 1,
6 2006, the Tax Commission shall discontinue issuance and renewal of
7 that type of special license plate. Any such authorized special
8 license plate registrant shall be allowed to display the license
9 plate upon the designated vehicle until the registration expiration
10 date. After such time the expired special license plate shall be
11 removed from the vehicle.

12 For special license plates authorized on or after July 1, 2004,
13 no special license plates shall be developed or issued by the Tax
14 Commission until the Commission receives one hundred prepaid
15 applications therefor. The prepaid applications must be received by
16 the Tax Commission within one hundred eighty (180) days of the
17 effective date of the authorization or the authority to issue shall
18 be null and void. In the event one hundred prepaid applications are
19 not received by the Tax Commission within such prescribed time
20 period any payment so received shall be refunded accordingly.

21 B. The special license plates provided by this section are as
22 follows:

23 1. University or College Supporter License Plate - such plates
24 shall be designed and issued to any person wishing to demonstrate

1 support to any state-supported or private university or college. As
2 provided in this section, an amount of the fee collected shall be
3 apportioned as provided in Section 1104.1 of this title;

4 2. Environmental Awareness License Plate - such plates shall be
5 designed, subject to the criteria to be presented to the Tax
6 Commission by the Department of Environmental Quality in
7 consultation with the Oklahoma Arts Council, and issued to any
8 person wishing to demonstrate support to implement the statewide
9 general public environmental education program created pursuant to
10 the provisions of the Oklahoma Environmental Quality Code. Such
11 plates shall be designed and issued to any person in any combination
12 of numbers and letters from one to a maximum of seven, as for
13 personalized license plates. A dealer's license plate issued
14 pursuant to Section 1116.1 or 1128 of this title may be designated
15 an Environmental Awareness License Plate upon payment of the fee
16 imposed by this section and any other registration fees required by
17 the Oklahoma Vehicle License and Registration Act. As provided in
18 this section, an amount of the fee collected shall be apportioned
19 pursuant to Section 1104.2 of this title;

20 3. Firefighter License Plate - such plates shall be designed
21 for any career or retired firefighter, volunteer or paid.
22 Firefighters may apply for firefighter plates for up to four
23 vehicles with a rated capacity of one (1) ton or less or for a
24 motorcycle upon proof of a fire department membership by either an

1 identification card or letter from the chief of the fire department.
2 Retirees who are eligible for such plates shall provide proof of
3 eligibility upon initial application, but shall not be required to
4 provide proof of eligibility annually. The surviving spouse of any
5 deceased firefighter, if the spouse has not since remarried, may
6 apply for a firefighter license plate for one vehicle with a rated
7 carrying capacity of one (1) ton or less or for a motorcycle upon
8 proof that the deceased firefighter was a member of a fire
9 department by either an identification card or letter from the chief
10 of the fire department. The license plate shall be designed in
11 consultation with the Oklahoma Firefighters Association.

12 As provided in this section, an amount of the fee collected
13 shall be deposited to the Oklahoma State Firemen's Museum Building &
14 Memorial Fund for support of the Oklahoma Firefighters Museum and
15 the Oklahoma Fallen and Living Firefighters Memorial;

16 4. Wildlife Conservation License Plate - such plates shall be
17 designed, subject to the criteria to be presented to the Tax
18 Commission by the Oklahoma Department of Wildlife Conservation in
19 consultation with the Oklahoma Arts Council, and issued to any
20 person wishing to demonstrate support for wildlife conservation in
21 this state through the Wildlife Diversity Fund, provided for in
22 Section 3-310 of Title 29 of the Oklahoma Statutes. Such plates may
23 be designed and issued to any person as for personalized license
24 plates.

1 As provided in this section, an amount of the fee collected
2 shall be apportioned pursuant to subsection D of Section 3-310 of
3 Title 29 of the Oklahoma Statutes;

4 5. Child Abuse Prevention License Plate - such plates shall be
5 designed, subject to the criteria to be presented to the Tax
6 Commission by the Office of Child Abuse Prevention in the State
7 Department of Health and the Oklahoma Committee to Prevent Child
8 Abuse, and issued to any person wishing to demonstrate support for
9 the prevention of child abuse.

10 As provided in this section, an amount of the fee collected
11 shall be deposited in the Child Abuse Prevention Fund;

12 6. United States Olympic Committee Supporter License Plate -
13 such plates shall be designed and issued to any person wishing to
14 demonstrate support for the United States Olympic Committee. The
15 plates shall be issued to any person in any combination of numbers
16 and letters from one to a maximum of seven, as for personalized
17 license plates. The plate shall contain the official United States
18 Olympic Committee logo. The Tax Commission shall be authorized, if
19 necessary, to enter into a licensing agreement with the United
20 States Olympic Committee for any licensing fees which may be
21 required in order to use the United States Olympic Committee logo or
22 design. The licensing agreement shall provide for a payment of not
23 more than Twenty-five Dollars (\$25.00) for each license plate
24 issued;

1 7. Oklahoma History License Plate - such plates shall be
2 designed and issued to any person wishing to demonstrate interest in
3 Oklahoma history. As provided in this section, an amount of the fee
4 collected shall be deposited to the Oklahoma Historical Society
5 Revolving Fund to be used for educational purposes;

6 8. Historic Route 66 License Plate - such:

7 a. vehicle plates shall be designed to honor historic
8 Route 66, also known as the "Mother Road". As
9 provided in this section, an amount of the fee
10 collected for each vehicle license plate shall be
11 apportioned to the Oklahoma Historical Society
12 Revolving Fund to be distributed to the Route 66
13 Museum located in Clinton, Oklahoma, and

14 b. motorcycle plates shall be designed in consultation
15 with the Oklahoma Route 66 Association, Inc. The
16 Oklahoma Tax Commission shall be authorized to enter
17 into a licensing agreement with the Oklahoma Route 66
18 Association, Inc., for any licensing fees which may be
19 required in order to use the Oklahoma Route 66
20 Association, Inc., logo or design. The licensing
21 agreement shall provide for a payment to the Oklahoma
22 Route 66 Association, Inc., of not more than Twenty
23 Dollars (\$20.00) for each motorcycle license plate
24 issued;

1 9. Heart of the Heartland License Plate - such plates shall be
2 designed and issued to any person wishing to honor the victims of
3 the terrorist bombing attack on the Alfred P. Murrah Federal
4 Building in downtown Oklahoma City on April 19, 1995. As provided
5 in this section, an amount of the fee collected shall be deposited
6 in the Heart of the Heartland Scholarship Fund, as established in
7 Section 2282 of Title 70 of the Oklahoma Statutes;

8 10. Emergency Medical Technician License Plate - such plates
9 shall be designed and issued to any person who is an emergency
10 medical technician. Such persons may apply for an emergency medical
11 technician license plate for each vehicle with a rated carrying
12 capacity of one (1) ton or less upon proof of an emergency medical
13 technician's license. The license plate shall be designed in
14 consultation with the state association of emergency medical
15 technicians. As provided in this section, an amount of the fee
16 collected shall be apportioned to the Emergency Medical Personnel
17 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63
18 of the Oklahoma Statutes;

19 11. Fight Breast Cancer License Plate - such plates shall be
20 designed to demonstrate support for the prevention and treatment of
21 breast cancer in this state. As provided in this section, an amount
22 of the fee collected shall be apportioned to the Breast Cancer Act
23 Revolving Fund;
24

1 12. Crime Victims Awareness License Plate - such plates shall
2 be designed and issued to any person wishing to demonstrate
3 awareness of and support for victims of crimes. The license plates
4 shall be designed in consultation with the Oklahoma Crime Victims
5 Centre. As provided in this section, an amount of the fee collected
6 shall be apportioned to the Attorney General's Revolving Fund for
7 the Office of the Attorney General, which is hereby directed to use
8 such funds to contract with a statewide nonprofit organization to
9 provide services to crime victims;

10 13. Oklahoma Safe Kids Association License Plate - such plates
11 shall be designed and issued to any person wishing to demonstrate
12 support and awareness of the Oklahoma Safe Kids Association. The
13 license plate shall be designed in consultation with the Oklahoma
14 Safe Kids Association. As provided in this section, an amount of
15 the fee collected shall be deposited in the Children's Hospital -
16 Oklahoma Safe Kids Association Revolving Fund to be distributed to
17 the Oklahoma Safe Kids Association program;

18 14. Four-H Club License Plate - such plates shall be designed,
19 subject to criteria to be presented to the Tax Commission by the
20 Four-H Foundation, and issued to any person wishing to demonstrate
21 support of the Four-H Club. Such plates may be designed and issued
22 to any person as for personalized license plates. As provided in
23 this section, an amount of the fee collected shall be apportioned to
24

1 the OSU Extension Service License Plate Revolving Fund created in
2 Section 1104.4 of this title;

3 15. Agricultural Awareness License Plate - such plates shall be
4 designed, subject to criteria to be presented to the Tax Commission,
5 by the Oklahoma Department of Agriculture, Food, and Forestry in
6 consultation with the Oklahoma Arts Council, and issued to any
7 person wishing to demonstrate support of the Department's Ag in the
8 Classroom Education Program. As provided in this section, an amount
9 of the fee collected shall be apportioned as provided in Section
10 1104.3 of this title;

11 16. Oklahoma Statehood Centennial License Plate - such plates
12 shall be designed and issued to any person wishing to commemorate
13 the centennial of Oklahoma's admission to statehood in 1907. The
14 license plates shall be designed in consultation with the Oklahoma
15 Capitol Complex and Centennial Commemoration Commission. As
16 provided in this section, an amount of the fee collected shall be
17 deposited in the Oklahoma Department of Commerce Revolving Fund
18 created in Section 5012 of Title 74 of the Oklahoma Statutes;

19 17. Support Education License Plate - such plates shall be
20 designed, subject to criteria to be presented to the Tax Commission
21 by the State Department of Education in consultation with the
22 Oklahoma Arts Council, and issued to any person wishing to
23 demonstrate support for education in this state. All motor license
24 agents shall display a sample of the Support Education License plate

1 in the area of the business accessed by the public. Twenty-three
2 Dollars (\$23.00) of the fee collected shall be apportioned as
3 follows:

4 a. five percent (5%) shall be deposited to the Education
5 Reform Revolving Fund,

6 b. five percent (5%) shall be deposited to the Higher
7 Education Revolving Fund,

8 c. five percent (5%) shall be deposited to the State
9 Career Technology Fund, and

10 d. eighty-five percent (85%) shall be deposited to the
11 Teachers' Retirement Benefit Fund as set forth in
12 Section 17-108 of Title 70 of the Oklahoma Statutes.

13 However, when the Teachers' Retirement Benefit Fund attains a

17 shall contain the official Boy Scouts of America logo. The Tax
18 Commission shall be authorized, if necessary, to enter into a
19 licensing agreement with the Boy Scouts of America for any licensing
20 fees which may be required in order to use the Boy Scouts of America
21 logo or design. The licensing agreement shall provide for a payment
22 to the Boy Scouts of America of not more than Twenty Dollars
23 (\$20.00) for each license plate issued;

1 20. Urban Forestry and Beautification License Plate - such
2 plates shall be designed, subject to criteria to be presented to the
3 Tax Commission, by the Oklahoma Department of Agriculture, Food, and
4 Forestry in consultation with nonprofit organizations in this state
5 that develop and operate programs to encourage urban forestry and
6 beautification, and issued to any person wishing to demonstrate
7 support of such programs. As provided in this section, an amount of
8 the fee collected shall be apportioned as provided in Section 1104.5

10 21. Oklahoma State Parks Supporter License Plate - such plates
11 shall be designed, subject to criteria to be presented to the Tax
12 Commission by the Oklahoma Tourism and Recreation Department, and
13 issued to any person wishing to demonstrate support for the Oklahoma
14 state parks system. Twenty-three Dollars (\$23.00) of the fee
15 collected shall be deposited in the Oklahoma Tourism and Recreation
16 Department Revolving Fund. Such money shall be designated for and
17 may only be expended for the support of Oklahoma state parks;

18 22. Adoption Creates Families License Plate - such plates shall
19 be issued to any person wishing to demonstrate support of pregnant
20 women who are committed to placing their children for adoption and
21 wishing to provide assistance to guardians, adoptive parents and

23 children in permanent, safe homes. The license plates shall be
24 designed and final terminology delivered in consultation with the

Oklahoma Adoption Coalition and the Department of Human Services.
Twenty-five Dollars (\$25.00) of the fee collected shall be deposited
in a revolving fund established in the State Treasury for and to be
used by the Department of Human Services for the implementation of
the Investing in Stronger Oklahoma Families Act specifically for
created families;

23. Choose Life License Plate - such plates shall be designed,
subject to criteria presented to the Tax Commission, by Choose Life,
Inc., and issued to any person who wishes to demonstrate support of
organizations that encourage adoption as a positive choice for women
with unplanned pregnancies. As provided in this section, an amount
of the fee collected shall be deposited in the Choose Life
Assistance Program Revolving Fund established in Section 1104.6 of
this title;

24. Future Farmers of America License Plate - such plates shall
be designed and issued to persons wishing to demonstrate support for
the Oklahoma FFA (formerly known as Future Farmers of America). The
license plates shall be designed in consultation with the Oklahoma
FFA Foundation Board of Directors. As provided in this section, an
amount of the fee collected shall be apportioned as provided in
Section 1104.7 of this title;

25. Lions Club License Plate - such plates shall be designed
and issued to persons wishing to demonstrate support for the Lions
Club of Oklahoma. The plates shall be issued to any person in any

1 combination of numbers and letters from one to a maximum of seven,
2 as for personalized license plates. The license plates shall be
3 designed in consultation with the Oklahoma Lions Service Foundation
4 and shall contain the official logo of the International Association
5 of Lions Clubs. The Tax Commission shall be authorized to enter
6 into a licensing agreement with the Oklahoma Lions Service
7 Foundation. The licensing agreement shall provide for a payment to
8 the Oklahoma Lions Service Foundation of not more than Ten Dollars
9 (\$10.00) for each license plate issued;

10 26. Color Oklahoma License Plate - such plates shall be
11 designed, subject to criteria to be presented to the Tax Commission
12 by the Oklahoma Native Plant Society, and issued to any person
13 wishing to demonstrate support for preserving and planting
14 wildflowers and native plants in Oklahoma and to promote Oklahoma's
15 wildflower heritage through education. As provided in this section,
16 an amount of the fee collected shall be apportioned as provided in
17 Section 1104.8 of this title;

18 27. Girl Scouts of the United States of America Supporter
19 License Plate - such plates shall be designed and issued to any
20 person wishing to demonstrate support for the Girl Scouts of the
21 United States of America. The plates shall be issued to any person
22 in any combination of numbers and letters from one to a maximum of
23 seven, as for personalized license plates. The plate shall contain
24 the official Girl Scouts of the United States of America logo. The

1 Tax Commission shall be authorized, if necessary, to enter into a
2 licensing agreement with the Girl Scouts of the United States of
3 America for any licensing fees which may be required in order to use
4 the Girl Scouts of the United States of America logo or design. The
5 licensing agreement shall provide for a payment to the Girl Scouts
6 of Magic Empire Council, acting on behalf of all Oklahoma Girl Scout
7 councils, of not more than Twenty Dollars (\$20.00) for each license
8 plate issued;

9 28. Oklahoma City Memorial Marathon License Plate - such plates
10 shall be designed and issued to any person wishing to demonstrate
11 support for the Oklahoma City Memorial Marathon. The plate shall be
12 designed in consultation with the Oklahoma City Memorial Marathon.
13 The Tax Commission shall be authorized to enter into a licensing
14 agreement with the Oklahoma City Memorial Marathon for any licensing
15 fees which may be required in order to use the Oklahoma City
16 Memorial Marathon logo or design. The licensing agreement shall
17 provide for a payment to the Oklahoma City Memorial Marathon of not
18 more than Twenty Dollars (\$20.00) for each license plate issued;

14 Dollars (\$20.00) of the fee collected shall be designated by the
15 purchaser of the plate to be deposited in the Oklahoma Pet
16 Overpopulation Fund created in Section 2368.13 of Title 68 of the
17 Oklahoma Statutes or the Animal Friendly Revolving Fund created in
18 Section 1104.10 of this title;

19 32. Patriot License Plate - such plates shall be designed in
20 consultation with the Military Department of Oklahoma and issued to

20 issued to any person wishing to demonstrate support for the Oklahoma

22 the Oklahoma Zoological Society, Inc. As provided in this section,
23 an amount of the fee collected shall be deposited in the Oklahoma

1 Zoological Society Revolving Fund created in Section 1104.13 of this

3 38. March of Dimes License Plate - such plates shall be issued
4 to persons wishing to demonstrate support for the March of Dimes
5 mission to improve the health of babies by preventing birth defects,
6 premature birth and infant mortality. The license plates shall be
7 designed in consultation with the Oklahoma Chapter March of Dimes.
8 As provided in this section, an amount of the fee collected shall be
9 deposited in the Oklahoma Prevent Birth Defects, Premature Birth and
10 Infant Mortality Fund established in Section 1104.14 of this title;

11 39. Support Our Troops Supporter License Plate - such plates
12 shall be designed and issued to any person wishing to demonstrate
13 support for Support Our Troops Incorporated. The plates shall be
14 issued to any person in any combination of numbers and letters from
15 one to a maximum of six. The plate shall contain the official
16 Support Our Troops Incorporated logo which includes the mark
17 "Support Our Troops" across the bottom of the plate. The Tax
18 Commission, if necessary, may enter into a licensing agreement with
19 Support Our Troops Incorporated for any licensing fees which may be
20 required in order to use the Support Our Troops Incorporated logo or
21 design. The licensing agreement shall provide for a payment to
22 Support Our Troops Incorporated of Twenty-five Dollars (\$25.00) for
23 each license plate issued;

1 40. Folds of Honor Supporter License Plate - such plates shall
2 be authorized to be designed and issued to any person wishing to
3 demonstrate support for the Oklahoma City Chapter of Folds of Honor
4 Incorporated, a nonprofit charitable organization exempt from
5 taxation pursuant to the provisions of the Internal Revenue Code, 26
6 U.S.C., Section 501(c)(3), providing educational scholarships to
7 spouses and children of America's fallen and disabled military
8 service members. The plates shall be issued to any person in any
9 combination of numbers and letters from one to a maximum of six.
10 Such person may apply for a Folds of Honor Supporter license plate
11 for a motorcycle; provided, the license plate for motorcycles may be

10 SECTION 5. NEW LAW A new section of law to be codified
11 in the Oklahoma Statutes as Section 1104.33 of Title 47, unless
12 there is created a duplication in numbering, reads as follows:

13 A. Twenty Dollars (\$20.00) of the fee authorized by Section
14 1135.5 of Title 47 of the Oklahoma Statutes for the Diabetes
15 Awareness license plates shall be deposited to the Diabetes
16 Awareness License Plate Revolving Fund created in subsection B of
17 this section.

18 B. There is hereby created in the State Treasury a revolving
19 fund for the State Department of Health to be designated the
20 "Diabetes Awareness License Plate Revolving Fund". The fund shall
21 consist of all monies received pursuant to subsection A of this
22 section. All monies accruing to the credit of the fund are hereby
23 appropriated and may be budgeted and expended by the State
24 Department of Health for grants to Diabetes Solutions of Oklahoma to

1 raise awareness and provide resources, as well as promote acceptance
2 and inclusion for people with diabetes. Expenditures from the fund
3 shall be made upon warrants issued by the State Treasurer against
4 claims filed as prescribed by law with the Director of the Office of
5 Management and Enterprise Services for approval and payment.

6 SECTION 6. AMENDATORY 47 O.S. 2021, Section 1135.2, as
7 last amended by Section 4, Chapter 543, O.S.L. 2021, is amended to
8 read as follows:

9 Section 1135.2. A. The Oklahoma Tax Commission is hereby
10 authorized to design and issue appropriate official special license
11 plates to persons in recognition of their service or awards as
12 provided by this section.

13 Special license plates shall not be transferred to any other
14 person but shall be removed from the vehicle upon transfer of
15 ownership and retained. The special license plate may then be used
16 on another vehicle but only after such other vehicle has been
17 registered for the current year.

18 Special license plates shall be renewed each year by the Tax
19 Commission or a motor license agent. The Tax Commission shall
20 annually notify by mail all persons issued special license plates.
21 The notice shall contain all necessary information and shall contain
22 instructions for the renewal procedure upon presentation to a motor
23 license agent or the Tax Commission. The license plates shall be

1 issued on a staggered system except for legislative plates and
2 amateur radio operator license plates.

4 system whereby motor license agents are permitted to accept

2 death, divorce, or annulment, may apply for a prisoner of war
3 license plate for one vehicle with a rated carrying capacity of one
4 (1) ton or less. The fee provided by this section for the special
5 license plate authorized by this paragraph shall be in addition to
6 all other registration fees provided by law, except the registration
7 fees levied by Section 1132 of this title;

8 2. National Guard License Plates - such plates shall be
9 designed for active or retired members of the Oklahoma National
10 Guard. Retirees who are eligible for such plates shall provide
11 proof of eligibility upon initial application, but shall not be
12 required to provide proof of eligibility annually;

13 3. Air National Guard License Plates - such plates shall be
14 designed for active or retired members of the Oklahoma Air National
15 Guard. Retirees who are eligible for such plates shall provide
16 proof of eligibility upon initial application, but shall not be
17 required to provide proof of eligibility annually;

18 4. United States Armed Forces License Plates - such plates
19 shall be designed for active, retired, former or reserve members of
20 the United States Armed Forces, and shall identify which branch of
21 service, and carry the emblem and name of either the Army, Navy, Air
22 Force, Marines or Coast Guard, according to the branch of service to
23 which the member belongs or did belong. Former members who have
24 been dishonorably discharged shall not be eligible for such plates.

1 Persons applying for such license plate must show proof of present

6 shall not be required to provide proof of eligibility annually;

7 5. Congressional Medal of Honor Recipient License Plates - such

17 terminated by death, divorce, or annulment, and each parent of the
18 missing person may apply for a missing in action license plate upon
19 presenting proper certification that the person is missing in action

23 action license plate for each vehicle with a rated carrying capacity

1 7. Purple Heart Recipient License Plates - such plates shall be

13 on Law Enforcement Education and Training. Police officers may
14 apply for police officer license plates for vehicles with a rated

24 States Armed Forces who are residents of this state and who can be

1 verified by the ~~Oklahoma~~ Military Department of the State of
2 Oklahoma, the Department of Veterans Affairs or the Armed Forces of
3 the United States as having served on federal active duty anytime
4 during the period from June 27, 1950, to January 31, 1955, both
5 dates inclusive. The former members may apply for a Korean War
6 Veteran license plate for vehicles with a rated carrying capacity of
7 one (1) ton or less.

8 The license plate shall have the legend "OKLAHOMA" and shall
9 contain, in the center of the plate, either the Thunderbird Insignia
10 of the 45th Infantry Division in the prescribed red and gold
11 coloring or the emblem of the Army, Navy, Air Force, Marines or
12 Coast Guard according to the branch of service to which the member
13 belonged. For the purpose of license plate identification, the
14 plate shall contain four digits, two digits at the left and two
15 digits at the right of the insignia or emblem. Centered on the
16 bottom of the license plate shall be the word "KOREA";

17 18. Municipal Official License Plates - such plates shall be
18 designed for persons elected to a municipal office in this state and
19 shall designate the name of the municipality and the district or
20 ward in which the municipal official serves. The plates shall only
21 be produced upon application;

22 19. Red Cross Volunteer License Plates - such plates shall be
23 designed to honor American Red Cross volunteers and staff who are
24 residents of this state. Such persons must present an

1 identification card issued by the American Red Cross and bearing a
2 photograph of the person. The license plate shall be designed with
3 the assistance of the American Red Cross and shall have the legend
4 "Oklahoma OK!" in the color Pantone 186C Red. Below the legend the
5 symbol of the American Red Cross and no more than three letters and
6 three numbers shall be in the color Pantone 186C Red. Below the
7 symbol and letters and numbers shall be the words "American Red
8 Cross" in black. The plates shall not be subject to the design
9 requirements of any other license plates prescribed by law other
10 than the space for the placement of the yearly decals for each
11 succeeding year of registration after the initial issue;

12 20. Desert Storm License Plates - such plates shall be designed
13 and issued to any honorably discharged or present member of the
14 United States Armed Forces who served in the Persian Gulf Crisis and
15 the Desert Storm operation. Such persons may apply for a Desert
16 Storm license plate for each vehicle with a rated carrying capacity
17 of one (1) ton or less;

18 21. Military Reserve Unit License Plates - such plates shall be
19 designed and issued to any honorably discharged or present member of
20 a reserve unit of the United States Armed Forces. Such persons may
21 apply for a Military Reserve Unit license plate for each vehicle
22 with a rated carrying capacity of one (1) ton or less;

23 22. Oklahoma City Bombing Victims and Survivors License Plates
24 - such plates shall be designed and issued to any victim or survivor

1 of the bombing attack on the Alfred P. Murrah Federal Building in
2 downtown Oklahoma City on April 19, 1995;

3 23. Civil Air Patrol License Plates - such plates shall be
4 designed and issued to any person who is a member of the Civil Air
5 Patrol. Such persons may apply for a Civil Air Patrol license plate
6 for each vehicle with a rated carrying capacity of one (1) ton or
7 less upon proof of membership in the Civil Air Patrol. The license
8 plate shall be designed in consultation with the Civil Air Patrol;

9 24. Ninety-Nines License Plates - such plates shall be designed
10 and issued to members of the Ninety-Nines. Persons applying for
11 such license plate must show proof of membership in the Ninety-
12 Nines. The license plates shall be designed in consultation with
13 the Ninety-Nines;

14 25. Combat Infantryman Badge License Plates - such plates shall
15 be designed to honor recipients of the Combat Infantryman Badge.
16 The plate shall have the legend "Oklahoma OK". Below the legend
17 shall be the Combat Infantryman Badge and three numbers. Below the
18 badge and the numbers shall be the words "Combat Infantryman Badge".
19 Such persons may apply for a Combat Infantryman Badge license plate
20 for each vehicle with a rated carrying capacity of one (1) ton or
21 less;

22 26. Somalia Combat Veterans License Plates - such plates shall
23 be designed and issued to any honorably discharged or present member
24 of the United States Armed Forces who saw combat in the United

1 Nations relief effort. Such persons may apply for a Somalia Combat
2 Veteran license plate for each vehicle with a rated carrying
3 capacity of one (1) ton or less;

4 27. Police Chaplain License Plates - such plates shall be
5 designed and issued to members of the International Conference of
6 Police Chaplains (ICPC) who have completed the ICPC requirements for
7 basic certification as a police chaplain. The license plates shall
8 be designed in consultation with the ICPC;

9 28. Joint Service Commendation Medal License Plates - such
10 plates shall be designed and issued to any resident of this state
11 who has been awarded the Joint Service Commendation Medal by the
12 United States Secretary of Defense;

13 29. Merchant Marine License Plates - such plates shall be
14 designed, subject to criteria to be presented to the Tax Commission
15 by the Oklahoma Department of Veterans Affairs, and issued to any
16 person who during combat was a member of the Merchant Marines as
17 certified by the Oklahoma Department of Veterans Affairs. Such
18 license plate may be issued for each vehicle with a rated carrying
19 capacity of one (1) ton or less;

20 30. Legislative License Plates - such plates shall be designed
21 for persons elected to the Oklahoma Legislature and shall designate
22 the house of the Legislature in which the legislator serves and the
23 district number;

1 31. Disabled Veterans License Plates - such plates shall be
2 designed for persons presenting proper certification from the United
3 States Department of Veterans Affairs or the Armed Forces of the
4 United States certifying such veteran has a service-connected
5 disability rating of fifty percent (50%) or more, regardless which
6 agency pays the disability benefits, or that such veteran has been
7 awarded a vehicle by the United States government or receives a
8 grant from the United States Department of Veterans Affairs for the
9 purchase of an automobile due to a service-connected disability
10 rating or due to the loss of use of a limb or an eye. Such persons
11 may apply to the Tax Commission for a disabled veterans license
12 plate or to a motor license agent for a regular license plate for no
13 more than two vehicles with each vehicle having a rated carrying
14 capacity of one (1) ton or less. The surviving spouse of any
15 deceased disabled veteran, if the spouse has not since remarried, or
16 if remarried, the remarriage is terminated by death, divorce, or
17 annulment, or a surviving spouse in receipt of Dependency and
18 Indemnity Compensation from the United States Department of Veterans
19 Affairs, may apply for a disabled veterans license plate for one
20 vehicle with a rated carrying capacity of one (1) ton or less. The
21 fee provided by this section for the special license plate
22 authorized by this paragraph shall be in addition to all other
23 registration fees provided by law, except the registration fees
24

1 levied by Section 1132 of this title. The total expense of this
2 license plate shall not exceed Five Dollars (\$5.00).

3 If the person qualifies for a disabled veterans license plate
4 and is also eligible for a physically disabled placard under the
5 provisions of Section 15-112 of this title, the person shall be
6 eligible to receive a disabled veterans license plate that also
7 displays the international accessibility symbol, which is a stylized
8 human figure in a wheelchair. Upon the death of the disabled
9 veteran with a disabled veterans license plate with the
10 international accessibility symbol, the plate shall be returned to
11 the Tax Commission;

12 32. United States Air Force Association License Plates - such
13 plates shall be designed for members of the United States Air Force
14 Association. Persons applying for such license plate must show
15 proof of membership in the Association. The license plates shall be
16 designed in consultation with the Association;

17 33. Oklahoma Military Academy Alumni License Plates - such
18 plates shall be designed and issued to any resident of this state
19 who is an alumnus of the Oklahoma Military Academy. Such persons
20 may apply for an Oklahoma Military Academy Alumnus license plate for
21 each vehicle with a rated carrying capacity of one (1) ton or less.
22 The license plates shall be designed in consultation with the
23 Oklahoma Military Academy and shall contain the shield of the
24 Academy;

1 34. Amateur Radio Operator License Plates - such plates shall
2 be designed and issued to any person, holding a valid operator's
3 license, technician class or better, issued by the Federal
4 Communications Commission, and who is also the owner of a motor
5 vehicle currently registered in Oklahoma, in which has been
6 installed amateur mobile transmitting and receiving equipment.
7 Eligible persons shall be entitled to two special vehicle
8 identification plates as herein provided. Application for such
9 identification plates shall be on a form prescribed by the Tax
10 Commission and the plates issued to such applicant shall have
11 stamped thereon the word "Oklahoma" and bear the official call
12 letters of the radio station assigned by the Federal Communications
13 Commission to the individual amateur operator thereof. All
14 applications for such plates must be made to the Tax Commission on
15 or before the first day of October of any year for such plates for
16 the following calendar year and must be accompanied by the fee
17 required in this section together with a certificate, or such other
18 evidence as the Tax Commission may require, of proof that applicant
19 has a valid technician class or better amateur operator's license
20 and proof of applicant's ownership of a vehicle in which radio
21 receiving and transmitting equipment is installed. Applicants shall
22 only be entitled to one set of special identification plates in any
23 one (1) year, and such calendar year shall be stamped thereon. The
24 right to such special identification plates herein provided for

1 shall continue until the amateur radio operator's license of the
2 person to whom such plates are issued expires or is revoked;

3 35. American Legion License Plates - such plates shall be
4 designed for members of the American Legion. Persons applying for
5 such license plate must show proof of membership. The license
6 plates shall be designed in consultation with the American Legion of
7 Oklahoma;

8 36. Deputy Sheriff License Plates - such plates shall be
9 designed for any currently employed or retired county sheriff or
10 deputy sheriff. County sheriffs or deputy sheriffs may apply for
11 such plates for vehicles with a rated capacity of one (1) ton or
12 less upon proof of employment by or retirement from a county
13 sheriff's office by either an identification card or letter from the
14 county sheriff or a government-sponsored retirement board from which
15 the county sheriff or deputy sheriff may be receiving a pension.
16 Retirees who are eligible for such plates shall provide proof of
17 eligibility upon initial application but shall not be required to
18 provide proof of eligibility annually. The license plates shall be
19 designed in consultation with the county sheriff offices of this
20 state;

21 37. Gold Star Surviving Spouse License Plates - such plates
22 shall be designed to honor the surviving spouses and children of
23 qualified veterans. As used in this paragraph, "qualified veteran"
24 shall mean:

1 a. any person honorably discharged from any branch of the
2 United States Armed Forces or as a member of the
3 Oklahoma National Guard, who died as a direct result
4 of the performance of duties for any branch of the
5 United States Armed Forces or Oklahoma National Guard
6 while on active military duty, or

7 b. any person honorably discharged from any branch of the
8 United States Armed Forces or as a member of the
9 Oklahoma National Guard, who died as a result of
10 injury, illness or disease caused by the performance
11 of such duties while on active duty, whether the death
12 occurred while on active duty or after the honorable
13 discharge of such person.

14 The fee provided by this section for the special license plate
15 authorized by this paragraph shall be in addition to all other
16 registration fees provided by law, except the registration fees
17 levied by Section 1132 of this title;

18 38. Korea Defense Service Medal License Plates - such plates
19 shall be designed and issued to any resident of this state who has
20 been awarded the Korea Defense Service Medal by the United States
21 Secretary of Defense. Such persons may apply for a Korea Defense
22 Service Medal license plate for each vehicle with a rated carrying
23 capacity of one (1) ton or less;

1 39. 180th Infantry License Plates - such plates shall be
2 designed for members and prior members of the 180th Infantry.
3 Persons applying for such license plate must obtain and provide
4 proof of their membership from the 180th Infantry Association. The
5 license plates shall be designed in consultation with the 180th
6 Infantry;

7 40. Operation Iraqi Freedom Veteran License Plates - such
8 plates shall be designed and issued to any honorably discharged or
9 present member of the United States Armed Forces who served in
10 Operation Iraqi Freedom. Such person may apply for an Operation
11 Iraqi Freedom Veteran license plate for each vehicle with a rated
12 carrying capacity of one (1) ton or less, or for a motorcycle;
13 provided, the license plate for motorcycles may be of similar design
14 to the license plate for motor vehicles or may be a new design in
15 order to meet space requirements for a motorcycle license plate;

16 41. United States Air Force Academy Alumni License Plates -
17 such plates shall be designed and issued to any resident of this
18 state who is an alumnus of the United States Air Force Academy.
19 Such persons may apply for a United States Air Force Academy Alumnus
20 license plate for each vehicle with a rated carrying capacity of one
21 (1) ton or less;

22 42. Operation Enduring Freedom Veteran License Plate - such
23 plates shall be designed and issued to any honorably discharged or
24 present member of the United States Armed Forces who served in

1 Operation Enduring Freedom on or after September 11, 2001. The
2 license plate shall be designed in consultation with the Military
3 Department of the State of Oklahoma. Such person may apply for an
4 Operation Enduring Freedom Veteran license plate for each vehicle
5 with a rated carrying capacity of one (1) ton or less, or for a
6 motorcycle; provided, the license plate for motorcycles may be of
7 similar design to the license plate for motor vehicles or may be a
8 new design in order to meet space requirements for a motorcycle
9 license plate;

10 43. Military Multi-Decoration License Plate - such plates shall
11 be designed and issued to any honorably discharged or present member
12 of the United States Armed Forces who qualifies for more than one
13 military decoration license plate pursuant to the provisions of this
14 section. The Tax Commission shall develop and implement a system
15 whereby the designs of the eligible license plates can be included
16 together on a single license plate. Such person may apply for a
17 Military Multi-Decoration license plate for each vehicle with a
18 rated carrying capacity of one (1) ton or less;

19 44. Global War on Terror Expeditionary License Plate - such
20 plates shall be designed and issued to any honorably discharged or
21 present member of the United States Armed Forces who has earned a
22 Global War on Terror Expeditionary decoration. The license plate
23 shall be designed in consultation with the United States Institute
24 of Heraldry and the Military Department of the State of Oklahoma.

1 Such person may apply for a Global War on Terror Expeditionary
2 license plate for each vehicle with a rated carrying capacity of one
3 (1) ton or less;

4 45. Legion of Merit Medal Recipient License Plates - such
5 plates shall be designed for any resident of this state presenting
6 proper certification from the United States Department of Veterans
7 Affairs or the Armed Forces of the United States certifying that
8 such resident has been awarded the Legion of Merit military
9 decoration. Such persons may apply for a Legion of Merit recipient
10 license plate for vehicles having a rated carrying capacity of one
11 (1) ton or less. The license plate shall be designed in
12 consultation with the Military Department of the State of Oklahoma;

13 46. 1-179th License Plates - such plates shall be designed for
14 members, prior members and members of the household of a member or
15 former member of the 1-179th Infantry. Persons applying for such
16 license plate must obtain and provide proof of their membership
17 association with the 1-179th Infantry Association. The license
18 plate shall be designed in consultation with the 1-179th Infantry;

19 47. 2-179th License Plates - such plates shall be designed for
20 members, prior members and members of the household of a member or
21 former member of the 2-179th Infantry. Persons applying for such
22 license plate must obtain and provide proof of their membership
23 association with the 2-179th Infantry Association. The license
24 plate shall be designed in consultation with the 2-179th Infantry;

1 48. Combat Action Ribbon Recipient License Plates - such plates
2 shall be designed to honor recipients of the Combat Action Ribbon
3 who present proper certification from the United States Department
4 of the Navy. The license plate shall include the Combat Action
5 Ribbon earned by the recipient. Such persons may apply for a Combat
6 Action Ribbon Recipient license plate for vehicles having a rated
7 carrying capacity of one (1) ton or less;

8 49. Oklahoma Submarine Veterans License Plate - such plates
9 shall be designed for any resident of this state who is a United
10 States submarine veteran and presents either a Department of Defense
11 form 214 or other documentation certifying such service. Such
12 persons may apply for an Oklahoma Submarine Veterans license plate
13 for vehicles having a rated capacity of one (1) ton or less. The
14 license plate design shall include both gold and silver dolphins to
15 represent both officer and enlisted service members;

16 50. United States Navy Seabees and Civil Engineer Corps License
17 Plate - such plates shall be designed and issued to any honorably
18 discharged or present member of the United States Navy Seabees or
19 Civil Engineer Corps. Such persons may apply for a United States
20 Navy Seabees and Civil Engineer Corps license plate for vehicles
21 having a rated carrying capacity of one (1) ton or less. The
22 license plate shall be designed in consultation with the Military
23 Department of the State of Oklahoma;

1 51. Combat Action Badge Recipient License Plate - such plates
2 shall be designed to honor recipients of the Combat Action Badge who
3 present proper certification from the United States Army. The
4 license plate shall include the Combat Action Badge earned by the
5 recipient. Such persons may apply for a Combat Action Badge
6 Recipient license plate for vehicles having a rated carrying
7 capacity of one (1) ton or less, or for a motorcycle; provided, the
8 license plate for motorcycles may be of similar design to the
9 license plate for motor vehicles or may be a new design in order to
10 meet space requirements for a motorcycle license plate;

11 52. Iraq Combat Veteran License Plate - such plates shall be
12 designed and issued to any honorably discharged or present member of
13 the United States Armed Forces who saw combat in Operation Iraqi
14 Freedom. Such persons may apply for an Iraq Combat Veteran license
15 plate for each vehicle with a rated carrying capacity of one (1) ton
16 or less, or for a motorcycle; provided, the license plate for
17 motorcycles may be of similar design to the license plate for motor
18 vehicles or may be a new design in order to meet space requirements
19 for a motorcycle license plate;

20 53. Afghanistan Combat Veteran License Plate - such plates
21 shall be designed and issued to any honorably discharged or present
22 member of the United States Armed Forces who saw combat in Operation
23 Enduring Freedom. Such persons may apply for an Afghanistan Combat
24 Veteran license plate for each vehicle with a rated carrying

1 capacity of one (1) ton or less, or for a motorcycle; provided, the
2 license plate for motorcycles may be of similar design to the
3 license plate for motor vehicles or may be a new design in order to
4 meet space requirements for a motorcycle license plate;

5 54. Special Forces Association License Plates - such plates
6 shall be designed and issued to any honorably discharged or present
7 member of the Army Special Forces qualified and authorized to wear
8 upon the person's United States military uniform the Army Special
9 Forces Tab. Persons applying for the Special Forces Association
10 license plate must provide a copy of the orders awarding the Special
11 Forces Tab or authorizing its wear upon a United States military
12 uniform. The license plate shall be designed in consultation with
13 the Special Forces Association, Chapter 32-50. The Tax Commission
14 shall produce up to two distinct designs for the Special Forces
15 Association license plate. Qualified persons may select one design
16 at the time of application. The plates shall be issued to any
17 qualified person in any combination of numbers and letters from one
18 to a maximum of seven, as for personalized license plates;

19 55. Veterans of the United States Armed Forces License Plates -
20 such plates shall be designed for veterans of the United States
21 Armed Forces, and shall identify the branch of service, carry the
22 emblem and name of either the Army, Navy, Air Force, Marines or
23 Coast Guard, according to the branch of service to which the member
24 belonged, and shall reflect veteran status. Former members who have

1 | been dishonorably discharged shall not be eligible for such plates.
2 | Persons applying for such license plates must show proof of past
3 | military service by presenting a valid United States Department of
4 | Defense Form (DD)214 upon initial application but shall not be
5 | required to provide proof of eligibility annually; ~~and~~

6 | 56. Navy Chief License Plates - such plates shall be designed
7 | and issued to any resident of this state who has achieved the rank
8 | of E7 through E9 in the United States Navy and presents proper
9 | certification that the resident has achieved such rank and was
10 | either honorably discharged or is an active or retired member of the
11 | United States Navy. Such persons may apply for a Navy Chief license
12 | plate for vehicles having a rated carrying capacity of one (1) ton
13 | or less, or for a motorcycle; provided, the license plate for
14 | motorcycles may be of similar design to the license plate for motor
15 | vehicles or may be a new design in order to meet space requirements
16 | for a motorcycle license plate; and

17 | 57. Air Medal License Plates - such plates shall be designed
18 | and issued to any resident of this state who has earned the Air
19 | Medal and presents proper certification that the resident has been
20 | awarded such medal. The license plate shall include an image of the
21 | Air Medal earned by the recipient. Such persons may apply for an
22 | Air Medal license plate for vehicles having a rated carrying
23 | capacity of one (1) ton or less, or for a motorcycle; provided, the
24 | license plate for motorcycles may be of similar design to the

1 license plate for motor vehicles or may be a new design in order to
2 meet space requirements for a motorcycle license plate.

3 C. Unless otherwise provided by this section, the fee for such
4 plates shall be Eight Dollars (\$8.00) and shall be in addition to
5 all other registration fees provided by the Oklahoma Vehicle License
6 and Registration Act. Such fees shall be deposited in the Oklahoma
7 Tax Commission Reimbursement Fund to be used for the administration
8 of the Oklahoma Vehicle License and Registration Act.

9 SECTION 7. AMENDATORY 47 O.S. 2021, Section 1135.5, as
10 last amended by Section 6, Chapter 543, O.S.L. 2021, is amended to
11 read as follows:

12 Section 1135.5. A. The Oklahoma Tax Commission is hereby
13 authorized to design and issue appropriate official special license
14 plates to persons wishing to demonstrate support and provide
15 financial assistance as provided by this section.

16 Special license plates shall not be transferred to any other
17 person but shall be removed from the vehicle upon transfer of
18 ownership and retained. The special license plate may then be used
19 on another vehicle but only after such other vehicle has been
20 registered for the current year with a motor license agent.

21 Special license plates shall be renewed each year by the Tax
22 Commission or a motor license agent, unless authorized by the Tax
23 Commission to be renewed for a period greater than one (1) year.
24 The Tax Commission shall notify by mail all persons issued special

1 license plates. The notice shall contain all necessary information
2 and shall contain instructions for the renewal procedure upon
3 presentation to a motor license agent or the Tax Commission. The
4 license plates shall be issued on a staggered system.

5 The Tax Commission is hereby directed to develop and implement a
6 system whereby motor license agents are permitted to accept
7 applications for special license plates authorized under this
8 section. The motor license agent shall confirm the applicant's
9 eligibility, if applicable, collect and deposit any amount
10 specifically authorized by law, accept and process the necessary
11 information directly into such system and generate a receipt
12 accordingly. For performance of these duties, motor license agents
13 shall retain the fee provided in Section 1141.1 of this title for
14 registration of a motor vehicle. The motor license agent fees for
15 acceptance of applications and renewals shall be paid out of the
16 Oklahoma Tax Commission Reimbursement Fund.

17 If fewer than one hundred of any type of special license plates
18 authorized prior to January 1, 2004, are issued prior to January 1,
19 2006, the Tax Commission shall discontinue issuance and renewal of
20 that type of special license plate. Any such authorized special
21 license plate registrant shall be allowed to display the license
22 plate upon the designated vehicle until the registration expiration
23 date. After such time the expired special license plate shall be
24 removed from the vehicle.

1 For special license plates authorized on or after July 1, 2004,
2 no special license plates shall be developed or issued by the Tax
3 Commission until the Commission receives one hundred prepaid
4 applications therefor. The prepaid applications must be received by
5 the Tax Commission within one hundred eighty (180) days of the
6 effective date of the authorization or the authority to issue shall
7 be null and void. In the event one hundred prepaid applications are
8 not received by the Tax Commission within such prescribed time
9 period any payment so received shall be refunded accordingly.

10 B. The special license plates provided by this section are as
11 follows:

12 1. University or College Supporter License Plate - such plates
13 shall be designed and issued to any person wishing to demonstrate
14 support to any state-supported or private university or college. As
15 provided in this section, an amount of the fee collected shall be
16 apportioned as provided in Section 1104.1 of this title;

17 2. Environmental Awareness License Plate - such plates shall be
18 designed, subject to the criteria to be presented to the Tax
19 Commission by the Department of Environmental Quality in
20 consultation with the Oklahoma Arts Council, and issued to any
21 person wishing to demonstrate support to implement the statewide
22 general public environmental education program created pursuant to
23 the provisions of the Oklahoma Environmental Quality Code. Such
24 plates shall be designed and issued to any person in any combination

1 of numbers and letters from one to a maximum of seven, as for
2 personalized license plates. A dealer's license plate issued
3 pursuant to Section 1116.1 or 1128 of this title may be designated
4 an Environmental Awareness License Plate upon payment of the fee
5 imposed by this section and any other registration fees required by
6 the Oklahoma Vehicle License and Registration Act. As provided in
7 this section, an amount of the fee collected shall be apportioned
8 pursuant to Section 1104.2 of this title;

9 3. Firefighter License Plate - such plates shall be designed
10 for any career or retired firefighter, volunteer or paid.
11 Firefighters may apply for firefighter plates for up to four
12 vehicles with a rated capacity of one (1) ton or less or for a
13 motorcycle upon proof of a fire department membership by either an
14 identification card or letter from the chief of the fire department.
15 Retirees who are eligible for such plates shall provide proof of
16 eligibility upon initial application, but shall not be required to
17 provide proof of eligibility annually. The surviving spouse of any
18 deceased firefighter, if the spouse has not since remarried, may
19 apply for a firefighter license plate for one vehicle with a rated
20 carrying capacity of one (1) ton or less or for a motorcycle upon
21 proof that the deceased firefighter was a member of a fire
22 department by either an identification card or letter from the chief
23 of the fire department. The license plate shall be designed in
24 consultation with the Oklahoma Firefighters Association.

1 As provided in this section, an amount of the fee collected
2 shall be deposited to the Oklahoma State Firemen's Museum Building &
3 Memorial Fund for support of the Oklahoma Firefighters Museum and
4 the Oklahoma Fallen and Living Firefighters Memorial;

5 4. Wildlife Conservation License Plate - such plates shall be
6 designed, subject to the criteria to be presented to the Tax
7 Commission by the Oklahoma Department of Wildlife Conservation in
8 consultation with the Oklahoma Arts Council, and issued to any
9 person wishing to demonstrate support for wildlife conservation in
10 this state through the Wildlife Diversity Fund, provided for in
11 Section 3-310 of Title 29 of the Oklahoma Statutes. Such plates may
12 be designed and issued to any person as for personalized license
13 plates.

14 As provided in this section, an amount of the fee collected
15 shall be apportioned pursuant to subsection D of Section 3-310 of
16 Title 29 of the Oklahoma Statutes;

17 5. Child Abuse Prevention License Plate - such plates shall be
18 designed, subject to the criteria to be presented to the Tax
19 Commission by the Office of Child Abuse Prevention in the State
20 Department of Health and the Oklahoma Committee to Prevent Child
21 Abuse, and issued to any person wishing to demonstrate support for
22 the prevention of child abuse.

23 As provided in this section, an amount of the fee collected
24 shall be deposited in the Child Abuse Prevention Fund;

1 6. United States Olympic Committee Supporter License Plate -
2 such plates shall be designed and issued to any person wishing to
3 demonstrate support for the United States Olympic Committee. The
4 plates shall be issued to any person in any combination of numbers
5 and letters from one to a maximum of seven, as for personalized
6 license plates. The plate shall contain the official United States
7 Olympic Committee logo. The Tax Commission shall be authorized, if
8 necessary, to enter into a licensing agreement with the United
9 States Olympic Committee for any licensing fees which may be
10 required in order to use the United States Olympic Committee logo or
11 design. The licensing agreement shall provide for a payment of not
12 more than Twenty-five Dollars (\$25.00) for each license plate
13 issued;

14 7. Oklahoma History License Plate - such plates shall be
15 designed and issued to any person wishing to demonstrate interest in
16 Oklahoma history. As provided in this section, an amount of the fee
17 collected shall be deposited to the Oklahoma Historical Society
18 Revolving Fund to be used for educational purposes;

19 8. Historic Route 66 License Plate - such:

20 a. vehicle plates shall be designed to honor historic
21 Route 66, also known as the "Mother Road". As
22 provided in this section, an amount of the fee
23 collected for each vehicle license plate shall be
24 apportioned to the Oklahoma Historical Society

1 Revolving Fund to be distributed to the Route 66
2 Museum located in Clinton, Oklahoma, and

3 b. motorcycle plates shall be designed in consultation
4 with the Oklahoma Route 66 Association, Inc. The
5 Oklahoma Tax Commission shall be authorized to enter
6 into a licensing agreement with the Oklahoma Route 66
7 Association, Inc., for any licensing fees which may be
8 required in order to use the Oklahoma Route 66
9 Association, Inc., logo or design. The licensing
10 agreement shall provide for a payment to the Oklahoma
11 Route 66 Association, Inc., of not more than Twenty
12 Dollars (\$20.00) for each motorcycle license plate
13 issued;

14 9. Heart of the Heartland License Plate - such plates shall be
15 designed and issued to any person wishing to honor the victims of
16 the terrorist bombing attack on the Alfred P. Murrah Federal
17 Building in downtown Oklahoma City on April 19, 1995. As provided
18 in this section, an amount of the fee collected shall be deposited
19 in the Heart of the Heartland Scholarship Fund, as established in
20 Section 2282 of Title 70 of the Oklahoma Statutes;

21 10. Emergency Medical Technician License Plate - such plates
22 shall be designed and issued to any person who is an emergency
23 medical technician. Such persons may apply for an emergency medical
24 technician license plate for each vehicle with a rated carrying

1 capacity of one (1) ton or less upon proof of an emergency medical
2 technician's license. The license plate shall be designed in
3 consultation with the state association of emergency medical
4 technicians. As provided in this section, an amount of the fee
5 collected shall be apportioned to the Emergency Medical Personnel
6 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63
7 of the Oklahoma Statutes;

8 11. Fight Breast Cancer License Plate - such plates shall be
9 designed to demonstrate support for the prevention and treatment of
10 breast cancer in this state. As provided in this section, an amount
11 of the fee collected shall be apportioned to the Breast Cancer Act
12 Revolving Fund;

13 12. Crime Victims Awareness License Plate - such plates shall
14 be designed and issued to any person wishing to demonstrate
15 awareness of and support for victims of crimes. The license plates
16 shall be designed in consultation with the Oklahoma Crime Victims
17 Centre. As provided in this section, an amount of the fee collected
18 shall be apportioned to the Attorney General's Revolving Fund for
19 the Office of the Attorney General, which is hereby directed to use
20 such funds to contract with a statewide nonprofit organization to
21 provide services to crime victims;

22 13. Oklahoma Safe Kids Association License Plate - such plates
23 shall be designed and issued to any person wishing to demonstrate
24 support and awareness of the Oklahoma Safe Kids Association. The

1 license plate shall be designed in consultation with the Oklahoma
2 Safe Kids Association. As provided in this section, an amount of
3 the fee collected shall be deposited in the Children's Hospital -
4 Oklahoma Safe Kids Association Revolving Fund to be distributed to
5 the Oklahoma Safe Kids Association program;

6 14. Four-H Club License Plate - such plates shall be designed,
7 subject to criteria to be presented to the Tax Commission by the
8 Four-H Foundation, and issued to any person wishing to demonstrate
9 support of the Four-H Club. Such plates may be designed and issued
10 to any person as for personalized license plates. As provided in
11 this section, an amount of the fee collected shall be apportioned to
12 the OSU Extension Service License Plate Revolving Fund created in
13 Section 1104.4 of this title;

14 15. Agricultural Awareness License Plate - such plates shall be
15 designed, subject to criteria to be presented to the Tax Commission,
16 by the Oklahoma Department of Agriculture, Food, and Forestry in
17 consultation with the Oklahoma Arts Council, and issued to any
18 person wishing to demonstrate support of the Department's Ag in the
19 Classroom Education Program. As provided in this section, an amount
20 of the fee collected shall be apportioned as provided in Section
21 1104.3 of this title;

22 16. Oklahoma Statehood Centennial License Plate - such plates
23 shall be designed and issued to any person wishing to commemorate
24 the centennial of Oklahoma's admission to statehood in 1907. The

1 license plates shall be designed in consultation with the Oklahoma
2 Capitol Complex and Centennial Commemoration Commission. As
3 provided in this section, an amount of the fee collected shall be
4 deposited in the Oklahoma Department of Commerce Revolving Fund
5 created in Section 5012 of Title 74 of the Oklahoma Statutes;

6 17. Support Education License Plate - such plates shall be
7 designed, subject to criteria to be presented to the Tax Commission
8 by the State Department of Education in consultation with the
9 Oklahoma Arts Council, and issued to any person wishing to
10 demonstrate support for education in this state. All motor license
11 agents shall display a sample of the Support Education License plate
12 in the area of the business accessed by the public. Twenty-three
13 Dollars (\$23.00) of the fee collected shall be apportioned as
14 follows:

- 15 a. five percent (5%) shall be deposited to the Education
16 Reform Revolving Fund,
- 17 b. five percent (5%) shall be deposited to the Higher
18 Education Revolving Fund,
- 19 c. five percent (5%) shall be deposited to the State
20 Career Technology Fund, and
- 21 d. eighty-five percent (85%) shall be deposited to the
22 Teachers' Retirement Benefit Fund as set forth in
23 Section 17-108 of Title 70 of the Oklahoma Statutes.

1 However, when the Teachers' Retirement Benefit Fund attains a
2 seventy percent (70%) funded ratio based on an annual actuarial
3 valuation as required by law, the amount of the fee shall be
4 apportioned equally pursuant to subparagraphs a, b and c of this
5 paragraph;

6 18. Retired Oklahoma Highway Patrol Officers License Plate -
7 such plates shall be designed and issued to any retired officer of
8 the Oklahoma Highway Patrol. The license plate shall have the
9 legend "Oklahoma" and shall contain, in the center of the plate, the
10 Highway Patrol Officers patch using the same colors and pattern as
11 used in the patch. Centered on the bottom of the license plate
12 shall be the word "Retired". The letters "TRP" shall be used in
13 combination with three numbers on either side of the insignia or
14 emblem. The color of the letters and numbers shall be brown.
15 Retirees who are eligible for such plates shall provide proof of
16 eligibility upon initial application, but shall not be required to
17 provide proof of eligibility annually. The surviving spouse of any
18 deceased retired officer of the Oklahoma Highway Patrol, if the
19 spouse has not since remarried, or if remarried, the remarriage is
20 terminated by death, divorce, or annulment, may apply for a Retired
21 Oklahoma Highway Patrol Officers license plate. As provided in this
22 section, an amount of the fee collected shall be deposited into the
23 Law Enforcement Retirement Fund;

1 19. Boy Scouts of America Supporter License Plate - such plates
2 shall be designed and issued to any person wishing to demonstrate
3 support for the Boy Scouts of America. The plates shall be issued
4 to any person in any combination of numbers and letters from one to
5 a maximum of seven, as for personalized license plates. The plate
6 shall contain the official Boy Scouts of America logo. The Tax
7 Commission shall be authorized, if necessary, to enter into a
8 licensing agreement with the Boy Scouts of America for any licensing
9 fees which may be required in order to use the Boy Scouts of America
10 logo or design. The licensing agreement shall provide for a payment
11 to the Boy Scouts of America of not more than Twenty Dollars
12 (\$20.00) for each license plate issued;

13 20. Urban Forestry and Beautification License Plate - such
14 plates shall be designed, subject to criteria to be presented to the
15 Tax Commission, by the Oklahoma Department of Agriculture, Food, and
16 Forestry in consultation with nonprofit organizations in this state
17 that develop and operate programs to encourage urban forestry and
18 beautification, and issued to any person wishing to demonstrate
19 support of such programs. As provided in this section, an amount of
20 the fee collected shall be apportioned as provided in Section 1104.5
21 of this title;

22 21. Oklahoma State Parks Supporter License Plate - such plates
23 shall be designed, subject to criteria to be presented to the Tax
24 Commission by the Oklahoma Tourism and Recreation Department, and

1 issued to any person wishing to demonstrate support for the Oklahoma
2 state parks system. Twenty-three Dollars (\$23.00) of the fee
3 collected shall be deposited in the Oklahoma Tourism and Recreation
4 Department Revolving Fund. Such money shall be designated for and
5 may only be expended for the support of Oklahoma state parks;

6 22. Adoption Creates Families License Plate - such plates shall
7 be issued to any person wishing to demonstrate support of pregnant
8 women who are committed to placing their children for adoption and
9 wishing to provide assistance to guardians, adoptive parents and
10 other created families to assist in the adoption and placement of
11 children in permanent, safe homes. The license plates shall be
12 designed and final terminology delivered in consultation with the
13 Oklahoma Adoption Coalition and the Department of Human Services.
14 Twenty-five Dollars (\$25.00) of the fee collected shall be deposited
15 in a revolving fund established in the State Treasury for and to be
16 used by the Department of Human Services for the implementation of
17 the Investing in Stronger Oklahoma Families Act specifically for
18 created families;

19 23. Choose Life License Plate - such plates shall be designed,
20 subject to criteria presented to the Tax Commission, by Choose Life,
21 Inc., and issued to any person who wishes to demonstrate support of
22 organizations that encourage adoption as a positive choice for women
23 with unplanned pregnancies. As provided in this section, an amount
24 of the fee collected shall be deposited in the Choose Life

1 Assistance Program Revolving Fund established in Section 1104.6 of
2 this title;

3 24. Future Farmers of America License Plate - such plates shall
4 be designed and issued to persons wishing to demonstrate support for
5 the Oklahoma FFA (formerly known as Future Farmers of America). The
6 license plates shall be designed in consultation with the Oklahoma
7 FFA Foundation Board of Directors. As provided in this section, an
8 amount of the fee collected shall be apportioned as provided in
9 Section 1104.7 of this title;

10 25. Lions Club License Plate - such plates shall be designed
11 and issued to persons wishing to demonstrate support for the Lions
12 Club of Oklahoma. The plates shall be issued to any person in any
13 combination of numbers and letters from one to a maximum of seven,
14 as for personalized license plates. The license plates shall be
15 designed in consultation with the Oklahoma Lions Service Foundation
16 and shall contain the official logo of the International Association
17 of Lions Clubs. The Tax Commission shall be authorized to enter
18 into a licensing agreement with the Oklahoma Lions Service
19 Foundation. The licensing agreement shall provide for a payment to
20 the Oklahoma Lions Service Foundation of not more than Ten Dollars
21 (\$10.00) for each license plate issued;

22 26. Color Oklahoma License Plate - such plates shall be
23 designed, subject to criteria to be presented to the Tax Commission
24 by the Oklahoma Native Plant Society, and issued to any person

1 wishing to demonstrate support for preserving and planting
2 wildflowers and native plants in Oklahoma and to promote Oklahoma's
3 wildflower heritage through education. As provided in this section,
4 an amount of the fee collected shall be apportioned as provided in
5 Section 1104.8 of this title;

6 27. Girl Scouts of the United States of America Supporter
7 License Plate - such plates shall be designed and issued to any
8 person wishing to demonstrate support for the Girl Scouts of the
9 United States of America. The plates shall be issued to any person
10 in any combination of numbers and letters from one to a maximum of
11 seven, as for personalized license plates. The plate shall contain
12 the official Girl Scouts of the United States of America logo. The
13 Tax Commission shall be authorized, if necessary, to enter into a
14 licensing agreement with the Girl Scouts of the United States of
15 America for any licensing fees which may be required in order to use
16 the Girl Scouts of the United States of America logo or design. The
17 licensing agreement shall provide for a payment to the Girl Scouts
18 of Magic Empire Council, acting on behalf of all Oklahoma Girl Scout
19 councils, of not more than Twenty Dollars (\$20.00) for each license
20 plate issued;

21 28. Oklahoma City Memorial Marathon License Plate - such plates
22 shall be designed and issued to any person wishing to demonstrate
23 support for the Oklahoma City Memorial Marathon. The plate shall be
24 designed in consultation with the Oklahoma City Memorial Marathon.

1 The Tax Commission shall be authorized to enter into a licensing
2 agreement with the Oklahoma City Memorial Marathon for any licensing
3 fees which may be required in order to use the Oklahoma City
4 Memorial Marathon logo or design. The licensing agreement shall
5 provide for a payment to the Oklahoma City Memorial Marathon of not
6 more than Twenty Dollars (\$20.00) for each license plate issued;

7 29. Oklahoma Scenic Rivers License Plate - such plates shall be
8 designed to demonstrate support for the Oklahoma Scenic Rivers. The
9 plates shall be designed in consultation with the Oklahoma Scenic
10 Rivers Commission. Twenty-five Dollars (\$25.00) of the fee shall be
11 apportioned to the Oklahoma Scenic Rivers Commission;

12 30. Fight Cancer License Plate - such plates shall be designed
13 to demonstrate support for the Oklahoma Central Cancer Registry.
14 The plate shall contain the American Cancer Society logo. The
15 American Cancer Society logo shall be used in accordance with the
16 American Cancer Society's branding guidelines and shall only be
17 utilized to support the Oklahoma Central Cancer Registry. Twenty
18 Dollars (\$20.00) of the fee shall be apportioned to the Oklahoma
19 Central Cancer Registry Revolving Fund;

20 31. Animal Friendly License Plate - such plates shall be
21 designed and issued to any person wishing to demonstrate support for
22 controlling the overpopulation of dogs and cats through educational
23 and sterilization efforts. The plates shall be designed in
24 consultation with the Veterinary Medical Association. Twenty

1 Dollars (\$20.00) of the fee collected shall be designated by the
2 purchaser of the plate to be deposited in the Oklahoma Pet
3 Overpopulation Fund created in Section 2368.13 of Title 68 of the
4 Oklahoma Statutes or the Animal Friendly Revolving Fund created in
5 Section 1104.10 of this title;

6 32. Patriot License Plate - such plates shall be designed in
7 consultation with the Military Department of Oklahoma and issued to
8 any person wishing to demonstrate support for Oklahoma residents who
9 are members of the Oklahoma National Guard and deployed on active
10 duty. The plates shall be issued to any person in any combination
11 of numbers and letters from one to a maximum of seven, as for
12 personalized license plates. As provided in this section, a portion
13 of the fee collected shall be deposited in the Patriot License Plate
14 Revolving Fund created in Section 1104.11 of this title;

15 33. Global War on Terrorism License Plate - such plate shall be
16 designed in consultation with the Military Department of Oklahoma
17 and issued to any person wishing to demonstrate support for Oklahoma
18 residents who are members of the Armed Forces of the United States
19 or Oklahoma National Guard that have served in the Global War on
20 Terrorism. The plate shall be issued to any person in any
21 combination of numbers and letters from one to a maximum of six. As
22 provided in this section, a portion of the fee collected shall be
23 deposited in the Oklahoma National Guard Museum Fund created in
24 Section 235.1 of Title 44 of the Oklahoma Statutes;

1 34. Boys and Girls Clubs of America Supporter License Plate -
2 such plates shall be designed and issued to any person wishing to
3 demonstrate support for the Boys and Girls Clubs of America. The
4 plates shall be issued to any person in any combination of numbers
5 and letters from one to a maximum of seven, as for personalized
6 license plates. The plate shall contain the official Boys and Girls
7 Clubs of America logo. The Tax Commission, if necessary, may enter
8 into a licensing agreement with the Boys and Girls Clubs of America
9 for any licensing fees which may be required in order to use the
10 Boys and Girls Clubs of America logo or design. The licensing
11 agreement shall provide for a payment to the Boys and Girls Clubs of
12 America of not more than Twenty Dollars (\$20.00) for each license
13 plate issued;

14 35. Oklahoma Quarter Horse License Plate - such plates shall be
15 designed and issued to any person wishing to demonstrate support for
16 the American Quarter Horse in Oklahoma. The plate shall be designed
17 in consultation with the Oklahoma Quarter Horse Association. As
18 provided in this section, a portion of the fee collected shall be
19 deposited in the Oklahoma Quarter Horse Revolving Fund created in
20 Section 1104.12 of this title;

21 36. Oklahoma Association for the Deaf License Plate - such
22 plates shall be designed in consultation with the Oklahoma
23 Association for the Deaf and issued to any person wishing to
24 demonstrate support for Oklahoma residents who are deaf. The plates

1 shall be issued to any person in any combination of numbers and
2 letters from one to a maximum of seven, as for personalized license
3 plates. As provided in this section, a portion of the fee collected
4 shall be deposited in the Oklahoma Association for the Deaf License
5 Plate Revolving Fund created in Section 1104.15 of this title;

6 37. Oklahoma City Zoo License Plate - such plates shall be
7 issued to any person wishing to demonstrate support for the Oklahoma
8 City Zoo. The license plates shall be designed in consultation with
9 the Oklahoma Zoological Society, Inc. As provided in this section,
10 an amount of the fee collected shall be deposited in the Oklahoma
11 Zoological Society Revolving Fund created in Section 1104.13 of this
12 title;

13 38. March of Dimes License Plate - such plates shall be issued
14 to persons wishing to demonstrate support for the March of Dimes
15 mission to improve the health of babies by preventing birth defects,
16 premature birth and infant mortality. The license plates shall be
17 designed in consultation with the Oklahoma Chapter March of Dimes.
18 As provided in this section, an amount of the fee collected shall be
19 deposited in the Oklahoma Prevent Birth Defects, Premature Birth and
20 Infant Mortality Fund established in Section 1104.14 of this title;

21 39. Support Our Troops Supporter License Plate - such plates
22 shall be designed and issued to any person wishing to demonstrate
23 support for Support Our Troops Incorporated. The plates shall be
24 issued to any person in any combination of numbers and letters from

one to a maximum of six. The plate shall contain the official Support Our Troops Incorporated logo which includes the mark "Support Our Troops" across the bottom of the plate. The Tax Commission, if necessary, may enter into a licensing agreement with Support Our Troops Incorporated for any licensing fees which may be required in order to use the Support Our Troops Incorporated logo or design. The licensing agreement shall provide for a payment to Support Our Troops Incorporated of Twenty-five Dollars (\$25.00) for each license plate issued;

40. Folds of Honor Supporter License Plate - such plates shall be authorized to be designed and issued to any person wishing to demonstrate support for the Oklahoma City Chapter of Folds of Honor Incorporated, a nonprofit charitable organization exempt from taxation pursuant to the provisions of the Internal Revenue Code, 26 U.S.C., Section 501(c)(3), providing educational scholarships to spouses and children of America's fallen and disabled military service members. The plates shall be issued to any person in any combination of numbers and letters from one to a maximum of six. Such person may apply for a Folds of Honor Supporter license plate for a motorcycle; provided, the license plate for motorcycles may be of similar design to the license plate for motor vehicles or may be a new design in order to meet space requirements for a motorcycle license plate. The plate shall be designed in consultation with the Oklahoma City Chapter of Folds of Honor Incorporated and shall

1 contain the official Folds of Honor Incorporated logo which includes
2 the mark "Folds of Honor" across the bottom of the plate. The Tax
3 Commission, if necessary, may enter into a licensing agreement with
4 Folds of Honor Incorporated for any licensing fees which may be
5 required in order to use the Folds of Honor Incorporated logo or
6 design. The licensing agreement shall provide for a payment to
7 Folds of Honor Incorporated of Twenty-five Dollars (\$25.00) for each
8 license plate issued. Subject to the provisions of subsection A of
9 this section, the Folds of Honor Supporter License Plate is hereby
10 reauthorized effective November 1, 2019;

11 41. Downed Bikers Association License Plate - such plates shall
12 be designed and issued to any person wishing to demonstrate support
13 for the Downed Bikers Association, a nonprofit charitable
14 organization exempt from taxation pursuant to the provisions of the
15 Internal Revenue Code, 26 U.S.C., Section 501(c)(3), which provides
16 emotional and financial support for downed bikers. The license
17 plate shall be designed in consultation with the Central Oklahoma
18 Chapter of the Downed Bikers Association and shall contain any
19 official logo or design of the organization. The Tax Commission, if
20 necessary, may enter into a licensing agreement with the Downed
21 Bikers Association for any licensing fees which may be required in
22 order to use the organization's logo or design. The licensing
23 agreement shall provide for a payment to the Downed Bikers
24

1 Association of not more than Twenty Dollars (\$20.00) for each
2 license plate;

3 42. Armed Forces Veterans Motorcycle License Plate - such
4 plates shall be designed for use on a motorcycle in consultation
5 with A Brotherhood Aiming Toward Education of Oklahoma, Inc.
6 (ABATE), and issued to any honorably discharged former member of the
7 United States Armed Forces wishing to demonstrate support for the
8 Oklahoma National Guard Museum. Persons applying for such license
9 plate must show proof of past military service. As provided in this
10 section, a portion of the fee collected shall be deposited in the
11 Oklahoma National Guard Museum Fund created in Section 235.1 of
12 Title 44 of the Oklahoma Statutes;

13 43. Buffalo Soldier License Plate - such plates shall be issued
14 to any person wishing to honor and celebrate the history and
15 contribution of the Buffalo Soldiers. The license plates shall be
16 designed in consultation with the Lawton-Fort Sill Chapter of the
17 Buffalo Soldiers 9th and 10th (Horse) Cavalry Association. As
18 provided in this section, an amount of the fee collected shall be
19 deposited in the Buffalo Soldier License Plate Revolving Fund
20 created in Section 1104.16 of this title;

21 44. Prevent Blindness Oklahoma License Plate - such plates
22 shall be issued to any person wishing to provide financial support
23 for vision screening of school age children in this state. The
24 license plates shall be designed in consultation with Prevent

1 Blindness Oklahoma. As provided in this section, an amount of the
2 fee collected shall be deposited in the Prevent Blindness Oklahoma
3 License Plate Revolving Fund created in Section 1104.17 of this
4 title;

5 45. Oklahoma State Capitol Restoration License Plate - such
6 plates shall be designed and issued to any person wishing to
7 demonstrate support for restoration of the Oklahoma State Capitol
8 building. The license plates shall be designed in consultation with

1 permits or a new design in order to meet the space requirements of a
2 motorcycle license plate. The Tax Commission, if necessary, may
3 enter into a licensing agreement with the Downed Bikers Association
4 for any licensing fees which may be required in order to use the
5 organization's logo or design. The licensing agreement shall
6 provide for a payment to the Downed Bikers Association of not more
7 than Twenty Dollars (\$20.00) for each license plate;

8 89. Eagle Scout License Plate - such plates shall be designed
9 to demonstrate support for Eagle Scouts and shall include the Eagle
10 Scout logo. Plates may be issued to any person who can show proof
11 of having obtained the rank of Eagle Scout. The Oklahoma Tax
12 Commission shall be authorized to enter into a licensing agreement
13 with the various Oklahoma local councils for any licensing fees
14 which may be required in order to use the applicable logo or design.
15 The licensing agreement shall provide for a payment of not more than
16 Twenty Dollars (\$20.00) for each license plate issued to the
17 specific Oklahoma local area Council designated by the applicant;

18 90. Extraordinary Educators License Plate - such plates shall
19 be designed and issued to any person wishing to provide financial
20 support for common education in Oklahoma. Such plates shall be
21 designed in consultation with the State Department of Education.
22 The plates shall be issued to any person in any combination of
23 numbers and letters from one to a maximum of seven, as for
24 personalized license plates. As provided in this section, an amount

1 of the fee collected shall be deposited in the Extraordinary
2 Educators License Plate Revolving Fund created in Section 1104.32 of
3 this title;

4 91. Former Oklahoma Legislator License Plate - such plates
5 shall be designed and issued to any person who previously served as
6 a member of the Oklahoma House of Representatives or Oklahoma State
7 Senate. The license plates shall be designed in consultation with
8 the Oklahoma Historical Society. As provided in this section, an
9 amount of the fee collected shall be deposited in the Oklahoma
10 Historical Society Capital Improvement and Operations Revolving Fund
11 created in Section 1.10a of Title 53 of the Oklahoma Statutes. The
12 Tax Commission shall create and maintain a list of former members of
13 the Oklahoma House of Representatives and Oklahoma State Senate
14 eligible to be issued such plates; provided, that no former member
15 of the Oklahoma House of Representatives and Oklahoma State Senate
16 shall be eligible to possess more than two of such plates at any one
17 time. The Tax Commission shall confer as needed with the Chief
18 Clerk of the Oklahoma House of Representatives and the Secretary of
19 the Oklahoma State Senate to confirm that such list is complete and
20 accurate;

21 92. Monarch Butterfly License Plate - such plates shall be
22 designed and issued to any person wishing to demonstrate support for
23 the operations of the Nature Conservancy of Oklahoma. Such plates
24 shall be designed in consultation with the Oklahoma Chapter of the

1 Nature Conservancy. The Tax Commission shall be authorized to enter
2 into a licensing agreement with the Nature Conservancy of Oklahoma
3 for any licensing fees which may be required in order to use the
4 foundation's logo or design. The plates shall be issued to any
5 person in any combination of numbers and letters from one to a
6 maximum of seven, as for personalized license plates. The licensing
7 agreement shall provide for a payment to the Nature Conservancy of
8 Oklahoma of not more than Twenty Dollars (\$20.00) for each license
9 plate issued;

10 93. Oklahoma Tennis Foundation License Plate - such plates
11 shall be designed and issued to any person wishing to demonstrate
12 support for the Oklahoma Tennis Foundation. The license plates
13 shall be designed in consultation with the Oklahoma Tennis
14 Foundation. The Tax Commission shall be authorized to enter into a
15 licensing agreement with the Oklahoma Tennis Foundation for any
16 licensing fees which may be required in order to use the
17 foundation's logo or design. The licensing agreement shall provide
18 for a payment to the Oklahoma Tennis Foundation of not more than
19 Twenty Dollars (\$20.00) for each license plate issued;

20 94. Oklahoma Veterans of Foreign Wars License Plate - such
21 plates shall be designed to honor the Oklahoma Veterans of Foreign
22 Wars and shall be issued to any resident of this state upon proof of
23 membership in the Oklahoma Veterans of Foreign Wars organization.
24 The license plates shall be designed in consultation with the

1 Oklahoma Veterans of Foreign Wars organization. The Tax Commission
2 shall be authorized to enter into a licensing agreement with the
3 Oklahoma Veterans of Foreign Wars organization for any licensing
4 fees which may be required in order to use the organization's logo
5 or design. The licensing agreement shall provide for a payment to
6 the Oklahoma Veterans of Foreign Wars organization of not more than
7 Twenty Dollars (\$20.00) for each license plate issued. The Tax
8 Commission shall reinstate any Veterans of Foreign Wars license
9 plates issued prior to November 1, 2021, and shall reimburse any
10 individual who held a Veterans of Foreign Wars License Plate on
11 October 31, 2021, for fees incurred for the replacement of such
12 plate;

13 95. Oklahoma Women Veterans Organization License Plate - such
14 plates shall be designed and issued to any female veteran of any
15 branch of the United States Armed Forces wishing to demonstrate
16 support for the Oklahoma Women Veterans Organization. The license
17 plates shall be designed in consultation with the Oklahoma Women
18 Veterans Organization. The Tax Commission shall be authorized to
19 enter into a licensing agreement with the Oklahoma Women Veterans
20 Organization for any licensing fees which may be required in order
21 to use the organization's logo or design. The licensing agreement
22 shall provide for a payment to the Oklahoma Women Veterans
23 Organization of not more than Twenty Dollars (\$20.00) for each
24 license plate issued;

1 96. FIRST (For Inspiration and Recognition of Science and
2 Technology) License Plate - such plates shall be issued to any
3 person wishing to demonstrate support for FIRST Robotics Programs.
4 The license plates shall be designed in consultation with the
5 administration of FIRST. The Oklahoma Tax Commission shall be
6 authorized to enter into a licensing agreement with FIRST for any
7 licensing fees which may be required in order to use the FIRST logo
8 or design. The licensing agreement shall provide for a payment to
9 FIRST of not more than Twenty Dollars (\$20.00) for each license
10 plate issued;

11 97. Pittsburg State University License Plate - such plates
12 shall be designed and issued to any person wishing to demonstrate
13 support for the Pittsburg State University. The license plates
14 shall be designed in consultation with Pittsburg State University.
15 The Tax Commission shall be authorized to enter into a licensing
16 agreement with Pittsburg State University for any licensing fees
17 which may be required in order to use the school foundation's logo
18 or design. The licensing agreement shall provide for a payment to
19 the Pittsburg State University of not more than Twenty Dollars
20 (\$20.00) for each license plate issued;

21 98. Historic Greenwood District License Plate - such plates
22 shall be issued to persons wishing to demonstrate support for the
23 Historic Greenwood District Juneteenth Festival held in the Historic
24 Greenwood District in Tulsa, Oklahoma. The plates shall be issued

1 to any person in any combination of numbers and letters from one to
2 a maximum of seven, as for personalized license plates. The license
3 plates shall be designed in consultation with the Black Wall Street
4 Chamber of Commerce. The Tax Commission shall be authorized to
5 enter into a licensing agreement with the Historic Greenwood
6 District Juneteenth Festival for any licensing fees which may be
7 required in order to use the Festival's logo or design. For each
8 license plate issued, the licensing agreement shall provide for a
9 payment of Twenty-five Dollars (\$25.00) of the fee collected to the
10 Historic Greenwood District Juneteenth Festival and an additional
11 Two Dollars (\$2.00) of the fee collected shall be deposited in the
12 Public School Classroom Support Revolving Fund, for expenditure as
13 provided in Section 1-123 of Title 70 of the Oklahoma Statutes;

14 99. Oklahoma Veterans of Foreign Wars Auxiliary License Plate -
15 such plates shall be designed to honor the Oklahoma Veterans of
16 Foreign Wars Auxiliary and issued to any resident of this state upon
17 proof of membership in the Oklahoma Veterans of Foreign Wars
18 Auxiliary organization in this state. The license plates shall be
19 designed in consultation with the Oklahoma Veterans of Foreign Wars
20 Auxiliary organization. The Tax Commission shall be authorized to
21 enter into a licensing agreement with the Oklahoma Veterans of
22 Foreign Wars Auxiliary organization for any licensing fees which may
23 be required in order to use the organization's logo or design. The
24 licensing agreement shall provide for a payment to the Oklahoma

1 Veterans of Foreign Wars Auxiliary organization of not more than
2 Twenty Dollars (\$20.00) for each license plate issued;

3 100. Transportation to Transportation License Plate - such
4 plates shall be designed and issued to persons wishing to support
5 county roads and bridges. The license plates shall be designed in
6 consultation with the Association of County Commissioners of
7 Oklahoma. Twenty Dollars (\$20.00) of the fee collected shall be
8 paid to the county treasurer for the county in which the license
9 plate was purchased to be credited to the County Highway Fund
10 created pursuant to Section 1503 of Title 69 of the Oklahoma
11 Statutes;

12 101. Blue Star Mothers License Plate - such plates shall be
13 designed and issued to any person showing proof of membership in an
14 Oklahoma Chapter of Blue Star Mothers of America, Inc. The license
15 plates shall be designed in consultation with Blue Star Mothers of
16 America, Inc., Oklahoma Chapter One. The Tax Commission shall be
17 authorized to enter into a licensing agreement with Blue Star
18 Mothers of America, Inc., Oklahoma Chapter One for any licensing
19 fees which may be required in order to use the Blue Star Mothers of
20 America logo or design. The licensing agreement shall provide for a
21 payment to Blue Star Mothers of America, Inc., Oklahoma Chapter One
22 of not more than Twenty Dollars (\$20.00) for each license plate
23 issued;

1 102. Stillwater Public Schools License Plate - such plates
2 shall be designed and issued to any person wishing to demonstrate
3 support for the Stillwater School District. The license plates
4 shall be designed in consultation with the administration of the
5 Stillwater School District. The Tax Commission shall be authorized
6 to enter into a licensing agreement with the Stillwater School
7 District for any licensing fees which may be required in order to
8 use the school district's logo or design. The licensing agreement
9 shall provide for a payment to the Stillwater School District of not
10 more than Twenty Dollars (\$20.00) for each license plate issued;

11 103. Oklahoma Golf License Plate - such plates shall be
12 designed and issued to any person wishing to demonstrate support for
13 the sport of golf in Oklahoma. The license plates shall be designed
14 in consultation with the South Central Section of the Professional
15 Golfers' Association of America and issued to any person wishing to
16 demonstrate support for the sport of golf in Oklahoma. The Tax
17 Commission shall be authorized to enter into a licensing agreement
18 with the South Central Section of the Professional Golfers'
19 Association of America for any licensing fees which may be required
20 in order to use the organization's logo or design. The licensing
21 agreement shall provide for a payment to the South Central Section
22 of the Professional Golfers' Association of America of not more than
23 Twenty Dollars (\$20.00) for each license plate issued;

1 104. Paramedic License Plate - such plates shall be designed
2 and issued to any person who is a paramedic. Such persons may apply
3 for a paramedic license plate for each vehicle with a rated carrying
4 capacity of one (1) ton or less upon proof of a paramedic license.
5 The license plates shall be designed in consultation with the
6 Oklahoma State University-Oklahoma City Paramedicine Program and the
7 Oklahoma Emergency Medical Technicians Association. The Tax
8 Commission shall be authorized to enter into a licensing agreement
9 with the Oklahoma Emergency Medical Technicians Association for any
10 licensing fees which may be required in order to use the
11 Association's logo or design. The licensing agreement shall provide
12 for deposit to the Emergency Medical Personnel Death Benefit
13 Revolving Fund created in Section 1-2505.2 of Title 63 of the
14 Oklahoma Statutes of not more than Twenty Dollars (\$20.00) for each
15 license plate issued;

16 105. National Defense Service Medal License Plate - such plates
17 shall be designed and issued to those persons who have received the
18 National Defense Service Medal and wish to demonstrate support for
19 the Oklahoma Department of Veterans Affairs. The license plates
20 shall be designed in consultation with the Oklahoma Department of
21 Veterans Affairs. The Tax Commission shall be authorized to enter
22 into a licensing agreement with the Oklahoma Department of Veterans
23 Affairs for any licensing fees which may be required in order to use
24 the Department's logo or design. The licensing agreement shall

1 provide for a payment to the Oklahoma Department of Veterans Affairs
2 of not more than Twenty Dollars (\$20.00) for each license plate
3 issued;

4 106. University of Oklahoma RUF/NEKS License Plate - such
5 plates shall be designed and issued to any past or present member of
6 the University of Oklahoma RUF/NEKS upon providing proof of
7 membership in the organization as may be required by the Tax
8 Commission. The license plates shall be designed in consultation
9 with the University of Oklahoma RUF/NEKS. The Tax Commission shall
10 be authorized to enter into a licensing agreement with the
11 University of Oklahoma RUF/NEKS for any licensing fees which may be
12 required in order to use the organization's logo or design. The
13 licensing agreement shall provide for a payment to the University of
14 Oklahoma RUF/NEKS Scholarship Fund of not more than Twenty Dollars
15 (\$20.00) for each license plate issued;

16 107. Tulsa Community College License Plate - such plates shall
17 be issued to persons wishing to support Tulsa Community College.
18 The plates shall be designed in consultation with Tulsa Community
19 College. The Tax Commission shall be authorized to enter into a
20 licensing agreement with Tulsa Community College for any licensing
21 fees which may be required in order to use the organization's logo
22 or design. The licensing agreement shall provide for a payment to
23 Tulsa Community College of not more than Twenty Dollars (\$20.00) for
24 each license plate issued;

1 108. Guthrie Street Kings License Plate - such plates shall be
2 designed and issued to any person wishing to demonstrate support for
3 the Guthrie Street Kings. The license plates shall be designed in
4 consultation with the Guthrie Street Kings. The Tax Commission
5 shall be authorized to enter into a licensing agreement with the
6 Guthrie Street Kings for any licensing fees which may be required in
7 order to use the organization's logo or design. The licensing
8 agreement shall provide for a payment to the Guthrie Street Kings of
9 not more than Twenty Dollars (\$20.00) for each license plate issued;

10 109. Epilepsy Foundation License Plate - such plates shall be
11 designed and issued to any person wishing to demonstrate support for
12 the Epilepsy Foundation. The license plates shall be designed in
13 consultation with the Epilepsy Foundation of Oklahoma. The Tax
14 Commission shall be authorized to enter into licensing agreements
15 with the Epilepsy Foundation for any licensing fees which may be
16 required in order to use the organization's logo or design. The
17 licensing agreement shall provide for a payment to the Epilepsy
18 Foundation of not more than Twenty Dollars (\$20.00) for each license
19 plate issued; and

20 110. America First License Plate - such plates shall be
21 designed and issued to any person wishing to demonstrate support for
22 the proclamation of "America First". The license plates shall be
23 designed in consultation with Warriors for Freedom and the Honoring
24 America's Warriors Foundations. The Tax Commission shall be

1 authorized to enter into licensing agreements with the Warriors for
2 Freedom and Honoring America's Warriors Foundations for any
3 licensing fees which may be required in order to use the
4 Foundations' logos or designs. The licensing agreements shall
5 provide for a payment to the Honoring America's Warriors Foundation
6 of not more than Ten Dollars (\$10.00) and a payment to the Warriors
7 for Freedom Foundation of not more than Ten Dollars (\$10.00) for
8 each license plate issued; and

9 111. Diabetes Awareness License Plate - such plates shall be
10 designed and issued to any person wishing to provide financial
11 support for Diabetes Solutions of Oklahoma. The license plates
12 shall be designed in consultation with Diabetes Solutions of
13 Oklahoma. The Tax Commission shall be authorized to enter into
14 licensing agreements with Diabetes Solutions of Oklahoma for any
15 licensing fees which may be required in order to use the Diabetes
16 Solutions of Oklahoma logos or designs. The licensing agreements
17 shall provide for a deposit to the Diabetes Awareness License Plate
18 Revolving Fund established in Section 1 of this act.

19 C. The fee for such plates shall be Thirty-five Dollars
20 (\$35.00) per year of renewal and shall be in addition to all other
21 registration fees provided by the Oklahoma Vehicle License and
22 Registration Act. The fee shall be apportioned as follows:

23 1. Twenty Dollars (\$20.00) per year of renewal or any other
24 amount as provided in this title of the fee shall be apportioned as

1 provided or deposited in a fund as specified within the paragraph
2 authorizing the special license plate;

3 2. Eight Dollars (\$8.00) per year of renewal of the fee shall
4 be deposited in the Oklahoma Tax Commission Reimbursement Fund to be
5 used for the administration of the Oklahoma Vehicle License and
6 Registration Act; and

7 3. Any remaining amounts of the fee shall be apportioned as
8 provided in Section 1104 of this title.

9 SECTION 8. This act shall become effective November 1, 2022.
