14	Section 3601.1. A. For purposes of Sections 3601.1 through
15	3603 of this title, the term "employee" means a full-time employee
16	or any number of part-time employees whose combined weekly hours of
17	employment equal those of a full-time employee, but shall not
18	include temporary employees working on a seasonal basis between May
19	1 and October 31.
20	B. Beginning July 1, 2008, the maximum number of full-time-
21	equivalent employees for each of the following agencies, boards,
22	commissions, departments, or programs shall not exceed the numbers
23	specified in this section, except as may be authorized pursuant to
24	the provisions of Section 3603 of this title.
