6 An Act relating to elections; amending 26 O.S. 2021,
7 Section 5-105, which relates to candidate voter
8 registration; removing deadlines for certain voter
9 registration for candidates filing for office in
10 certain elections; providing an effective date; and
11 declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

12 SECTION 1. AMENDATORY 26 O.S. 2021, Section 5-105, is
13 amended to read as follows:

14 Section 5-105. A. ~~Except as provided in subsection C of this~~
15 ~~section, to~~ To file as a candidate for nomination by a political
16 party to any state or county office, a person must have been a
17 registered voter of that party for the six-month period immediately
18 preceding the first day of the filing period prescribed by law and,
19 under oath, so state. Provided, this requirement shall not apply to
20 a candidate for the nomination of a political party which attains
21 recognition less than six (6) months preceding the first day of the
22 filing period required by law. However, the candidate shall be
23 required to have registered with the newly recognized party within
24 fifteen (15) days after such party recognition.

1 B. ~~Except as provided in subsection C of this section, to~~ To
2 file as an independent candidate for any state or county office, a
3 person must have been registered to vote as an independent for the
4 six-month period immediately preceding the first day of the filing
5 period prescribed by law and, under oath, so state.

6 ~~C. To file as a candidate in 2022 for nomination by a political~~
7 ~~party for State Senator, State Representative, or County~~
8 ~~Commissioner for any regular or special election to be held after~~
9 ~~April 5, 2022, a person must have been a registered voter of the~~
10 ~~political party no later than December 31, 2021. To file as an~~
11 ~~independent candidate in 2022 for State Senator, State~~
12 ~~Representative, or County Commissioner for any regular or special~~
13 ~~election to be held after April 5, 2022, a person must have been~~
14 ~~registered to vote as an independent no later than December 31,~~
15 ~~2021.~~

16 SECTION 2. This act shall become effective July 1, 2022.

17 SECTION 3. It being immediately necessary for the preservation
18 of the public peace, health or safety, an emergency is hereby
19 declared to exist, by reason whereof this act shall take effect and
20 be in full force from and after its passage and approval.
