12	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
13	SECTION 1. AMENDATORY 19 O.S. 2011, Section 339, as last
14	amended by Section 1, Chapter 396, O.S.L. 2019 (19 O.S. Supp. 2020,
15	Section 339), is amended to read as follows:
16	Section 339. A. The board of county commissioners shall have
17	power:
18	1. To make all orders respecting the real property of the
19	county, to sell the public grounds of the county and to purchase
20	other grounds in lieu thereof; and for the purpose of carrying out
21	the provisions of this section it shall be sufficient to convey all
22	the interests of the county in those grounds when an order made for
23	the sale and a deed is executed in the name of the county by the
24	chair of the board of county commissioners, reciting the order, and

signed by the chair and acknowledged by the county clerk for and on
 behalf of the county;

3 2. To audit the accounts of all officers having the care,
4 management, collection or disbursement of any money belonging to the
5 county or appropriated for its benefit;

3. To construct and repair bridges and to open, lay out and
vacate highways; provided, however, that when any state institution,
school or department shall own, lease or otherwise control land on
both sides of any established highway, the governing board or body
of the same shall have the power to vacate, alter or relocate the
highway adjoining the property in the following manner:

12 If it should appear that it would be to the best use and interest of the institution, school or department to vacate, alter 13 or relocate such highway, the governing board or body shall notify 14 the board of county commissioners, in writing, of their intention to 15 hold a public hearing and determine whether to vacate, alter or 16 relocate the highway, setting forth the location and terminals of 17 the road, and all data concerning the proposed right-of-way if 18 changed or relocated, and shall give fifteen (15) days' notice of 19 the hearing by publication in some newspaper in the county or 20 counties in which the road is located, and the hearing shall be held 21 at the county seat of the county in which the road is located, and 22 if a county line road, may be heard in either county. At the 23 hearing testimony may be taken, and any protests or suggestions 24

1 shall be received as to the proposed measure, and at the conclusion thereof if the governing board or body shall find that it would be 2 3 to the best use and interest of the institution, school or department, and the public generally, they may make an appropriate 4 5 order either vacating, altering or relocating the highway, which order shall be final if approved by the board of county 6 commissioners. The institution, school or department may by 7 agreement share the cost of changing any such road. No property 8 9 owner shall be denied access to a public highway by the order;

4. To recommend or sponsor an employee or prospective employee for job-related training and certification in an area that may require training or certification to comply with state or federal law as such training or certification is provided by the Department of Transportation, the Federal Highway Administration, or any other state agency, technology center school, or university;

5. To approve a continuing education program for full-time 16 county employees with at least five (5) consecutive years of service 17 to the county. Such programs shall consist of courses offered by 18 colleges and universities that are members of The Oklahoma State 19 System of Higher Education. Such programs shall require that 20 employees maintain at least an A or B average in order to qualify 21 for one hundred percent (100%) reimbursement. Employees who 22 maintain passing or satisfactory grades shall qualify for seventy-23 five percent (75%) reimbursement under such programs. 24 Such programs

1 shall require that documentation from colleges and universities 2 regarding courses completed, credits earned and tuition charged be submitted to a board of county commissioners within ninety (90) days 3 after the completion of courses. General applications and request 4 5 forms for such programs shall be submitted to a board of county 6 commissioners or an appropriate human resources department prior to the conclusion of a county's current fiscal year. Employees who 7 elect to participate in such programs shall continue to meet the 8 9 full responsibilities of their positions, and participation shall 10 not interfere with availability for scheduled work or negatively 11 affect work performance. In order to be eligible for participation 12 in such programs, employees shall not have been formally disciplined within one (1) year prior to submitting their program application. 13 A board of county commissioners shall be authorized to establish a 14 program requiring a one-year commitment of service to the county 15 from individuals who participate in such programs. Under such 16 programs, employees shall only be eligible to receive tuition 17 reimbursements in exchange for employment with the county lasting at 18 least one (1) year; 19

Until January 1, 1983, to furnish necessary blank books,
 plats, blanks and stationery for the clerk of the district court,
 county clerk, register of deeds, county treasurer and county judge,
 sheriff, county surveyor and county attorney, justices of the peace,
 and constables, to be paid for out of the county treasury; also a

fireproof vault sufficient in which to keep all the books, records,
 vouchers and papers pertaining to the business of the county;

7. To set off, organize and change the boundaries of townships
and to designate and give names therefor; provided, that the
boundaries of no township shall be changed within six (6) months
next preceding a general election;

8. To lease tools, apparatus, machinery or equipment of the
county to another political subdivision or a state agency. The
Association of County Commissioners of Oklahoma and the Oklahoma
State University Center for Local Government Technology together
shall establish a system of uniform rates for the leasing of such
tools, apparatus, machinery and equipment;

9. To jointly, with other counties, buy heavy equipment and to
 14 loan or lease such equipment across county lines;

15 10. To develop personnel policies for the county with the approval of a majority of all county elected officers, as evidenced in the minutes of a meeting of the board of county commissioners or 18 the county budget board;

19 11. To purchase, rent, or lease-purchase uniforms, safety
20 devices and equipment for the officers and employees of the county.
21 The county commissioners may pay for any safety training or safety
22 devices and safety equipment out of the general county funds or any
23 county highway funds available to the county commissioners;

1 12. To provide incentive awards for safety-related job 2 performance. However, no employee shall be recognized more than 3 once per calendar year and the award shall not exceed the value of 4 Two Hundred Fifty Dollars (\$250.00); further, no elected official 5 shall be eligible to receive a safety award;

6 13. To provide for payment of notary commissions, filing fees,7 and the cost of notary seals and bonds;

8 14. To do and perform other duties and acts that the board of 9 county commissioners may be required by law to do and perform;

10 15. To make purchases at a public auction pursuant to the 11 county purchasing procedures in subsection D of Section 1505 of this 12 title;

13 16. To deposit interest income from highway funds in the 14 general fund of the county;

15 17. To submit sealed bids for the purchase of equipment from16 this state, or any agency or political subdivision of this state;

18. To utilize county-owned equipment, labor and supplies at 17 their disposal on property owned by the county, public schools, two-18 year colleges or technical branches of colleges that are members of 19 The Oklahoma State System of Higher Education, the state and 20 municipalities according to the provisions of Section 36-113 of 21 Title 11 of the Oklahoma Statutes. Cooperative agreements may be 22 general in terms of routine maintenance or specific in terms of 23 construction and agreed to and renewed on an annual basis. 24 Work

performed pursuant to Section 36-113 of Title 11 of the Oklahoma
 Statutes shall comply with the provisions of this section;

3 19. To enter into intergovernmental cooperative agreements with 4 the federally recognized Indian tribes within this state to address 5 issues of construction and maintenance of streets, roads, bridges 6 and highways exclusive of the provisions of Section 1221 of Title 74 7 of the Oklahoma Statutes;

8 20. To execute hold harmless agreements with the lessor in the 9 manner provided by subsection B of Section 636.5 of Title 69 of the 10 Oklahoma Statutes when leasing or lease-purchasing equipment;

11 21. To accept donations of right-of-way or right-of-way 12 easements pursuant to Section 381 et seq. of Title 60 of the 13 Oklahoma Statutes;

14 22. To establish by resolution the use of per diem for specific 15 purposes in accordance with the limitations provided by Sections 16 500.8 and 500.9 of Title 74 of the Oklahoma Statutes;

17 23. To apply to the Department of Environmental Quality for a
18 waste tire permit to bale waste tires for use in approved
19 engineering projects;

20 24. To enter into the National Association of Counties (NACo)
21 Prescription Drug Discount Program;

22 25. To work with federal, state, municipal, and public school
23 district properties in an effort to minimize cost to such entities;

26. To provide incentive awards to employees for participating
 in voluntary wellness programs which result in improved health.
 Incentive awards may be created by the Wellness Council set forth in
 Section 1302 of this title;

5 27. To establish a county employee benefit program to encourage outstanding performance in the workplace. Monies may be expended 6 for the purchase of recognition awards for presentation to an 7 employee or members of a work unit. Recognition awards may be 8 9 presented at a formal or informal ceremony, banquet, reception or 10 luncheon, the cost of which may be expended from monies available in the county department's or division's operating fund; and 11 12 28. To trade in equipment to a vendor or on statewide contract by acquiring used equipment values pursuant to subsection B of 13

14 Section 421.1 of this title.

B. The county commissioners of a county or, in counties where there is a county budget board, the county budget board may designate money from general county funds for the designated purpose of drug enforcement and drug abuse prevention programs within the county.

20 C. When any lease or lease purchase is made on behalf of the 21 county by the board pursuant to the provisions of this section, the 22 county shall be allowed to have trade in values for transactions 23 involving The Oklahoma Central Purchasing Act.

1 In order to timely comply with the Oklahoma Vehicle License D. 2 and Registration Act with regard to county vehicles, the board of 3 county commissioners may, by resolution, create a petty cash The board of county commissioners may request a purchase 4 account. 5 order for petty cash in an amount necessary to pay the expense of license and registration fees for county motor vehicles. Any 6 7 balance in the petty cash account after the license and registration fees have been paid shall be returned to the account or fund from 8 9 which the funds originated. The county purchasing agent shall be 10 the custodian of the petty cash account, and the petty cash account shall be subject to audit. 11

12 Ε. When the board of county commissioners approves an express trust, pursuant to Sections 176 through 180.4 of Title 60 of the 13 Oklahoma Statutes, for the purpose of operating a county jail, the 14 trustees of the public trust may appoint commissioned peace 15 officers, certified by the Council on Law Enforcement Education and 16 Training, to provide security for inmates that are required to be 17 transported outside of the detention facility, and investigate 18 violations of law within the detention facility. Other personnel 19 necessary to operate the jail may be employed and trained or 20 certified as may be required by applicable state or federal law. 21 SECTION 2. This act shall become effective November 1, 2021. 22 23
