AMENDATORY 51 O.S. 2021, Section 24A.3, is 13 amended to read as follows: Section 24A.3. As used in the Oklahoma Open Records Act: 14 1. "Record" means all documents, including, but not limited to, 15 any book, paper, photograph, microfilm, data files created by or 16 used with computer software, computer tape, disk, record, sound 17 recording, film recording, video record or other material regardless 18 of physical form or characteristic, created by, received by, under 19 the authority of, or coming into the custody, control or possession 20 of public officials, public bodies, or their representatives in 21 connection with the transaction of public business, the expenditure 22 of public funds or the administering of public property. "Record" 23

does not mean:

- 1 a. computer software,
 - b. nongovernment personal effects,
 - c. unless public disclosure is required by other laws or regulations, vehicle movement records of the Oklahoma Transportation Authority obtained in connection with the Authority's electronic toll collection system,
 - d. personal financial information, credit reports or other financial data obtained by or submitted to a public body for the purpose of evaluating credit worthiness, obtaining a license, permit, or for the purpose of becoming qualified to contract with a public body,
 - e. any digital audio/video recordings of the toll collection and safeguarding activities of the Oklahoma Transportation Authority,
 - f. any personal information provided by a guest at any facility owned or operated by the Oklahoma Tourism and Recreation Department or the Board of Trustees of the Quartz Mountain Arts and Conference Center and Nature Park to obtain any service at the facility or by a purchaser of a product sold by or through the Oklahoma Tourism and Recreation Department or the Quartz Mountain Arts and Conference Center and Nature Park,

- g. a Department of Defense Form 214 (DD Form 214) filed
 with a county clerk, including any DD Form 214 filed
 before July 1, 2002, or
 - h. except as provided for in Section 2-110 of Title 47 of the Oklahoma Statutes,
 - (1) any record in connection with a Motor Vehicle

 Report issued by the Department of Public Safety,

 as prescribed in Section 6-117 of Title 47 of the

 Oklahoma Statutes, or
 - (2) personal information within driver records, as
 defined by the Driver's Privacy Protection Act,

"Public body" shall include, but not be limited to, any office, department, board, bureau, commission, agency, trusteeship, authority, council, committee, trust or any entity created by a trust, county, city, village, town, township, district, school district, fair board, court, executive office, advisory group, task force, study group, or any subdivision thereof, supported in whole or in part by public funds or entrusted with the expenditure of public funds or administering or operating public property, and all committees, or subcommittees thereof. Except for the records required by Section 24A.4 of this title, "public body" does not mean

- 1 | judges, justices, the Council on Judicial Complaints, the
- 2 Legislature, or legislators. "Public body" shall not include an
- 3 organization that is exempt from federal income tax under Section
- 4 | 501(c)(3) of the Internal Revenue Code of 1986, as amended, and
- 5 | whose sole beneficiary is a college or university, or an affiliated
- 6 entity of the college or university, that is a member of The
- 7 Oklahoma State System of Higher Education. Such organization shall
- 8 | not receive direct appropriations from the Oklahoma Legislature.

 - a. a member, officer, or employee of the Oklahoma State
