17	Appeals may be taken by the defendant, as a matter of right from any
18	judgment against him the defendant, which shall be taken as herein
19	provided; and, upon the appeal, any decision of the court or
20	intermediate order made in the progress of the case may be reviewed;
21	provided further, all appeals taken from any conviction on a plea of
22	guilty shall be taken by petition for writ of certiorari to the

(b) <u>B.</u> The procedure for the filing of an appeal in the Court
of Criminal Appeals shall be as provided in the Rules of the Court

D. The defendant may appeal to the Court of Criminal Appeals
from the denial of a pretrial motion seeking immunity from
prosecution pursuant to subsection F of Section 1289.25 of Title 21
of the Oklahoma Statutes within ten (10) days of the denial of the
motion. Priority shall be given to appeals taken pursuant to this

1 subsection and an order staying proceedings shall be entered pending the outcome of the appeal. If an appeal is not brought within ten 2 (10) days of the denial, the defendant waives appellate review of 3 his or her claim of immunity from prosecution and subsequent motions 4 5 and appeals pursuant to this subsection shall be dismissed. SECTION 2. AMENDATORY 22 O.S. 2021, Section 1053, is 6 amended to read as follows: 7 Section 1053. Appeals to the Court of Criminal Appeals may be 8 9 taken by the state or a municipality in the following cases and no 10 other only: 1. Upon judgment for the defendant on quashing or setting aside 11 an indictment or information; 12 2. Upon an order of the court arresting the judgment; 13 Upon a question reserved by the state or a municipality; 3. 14 4. Upon judgment for the defendant on a motion to quash for 15 insufficient evidence in a felony matter; 16 5. Upon a pretrial order, decision, or judgment suppressing or 17 excluding evidence where appellate review of the issue would be in 18 the best interests of justice; and 19 6. Upon a pretrial order, decision or judgment suppressing or 20 excluding evidence in cases alleging violation of any provisions of 21 Section 13.1 of Title 21 of the Oklahoma Statutes; and 22 7. Upon an order, decision or judgment finding that a defendant 23 is immune from or not subject to criminal prosecution. 24
