6 An Act relating to veterans affairs; amending 26 O.S.
7 2021, Sections 4-120.3, 14-101.1, 14-115, and 14-
8 115.5, which relate to deceased persons voting
9 registration, absentee ballot harvesting, voters
10 confined to veterans centers, and composition of
11 absentee voting boards; amending 43A O.S. 2021,
12 Section 6-102, which relates to transfer of patient
13 to federal agencies for care and treatment; amending
14 62 O.S. 2021, Section 46.1, which relates to the
15 transfer of surplus funds accruing to the General
16 Revenue Fund; amending 63 O.S. 2021, Section 1-1903,
17 which relates to licensure requirements; amending 72
18 O.S. 2021, Sections 63.5, 202, 221, 221.1, 221.2,
19 221.2A, 221.5, 226, 229, 229.1, and 240, which relate
20 to payment for care and maintenance of veterans,
21 spouses, widows, and widowers, management of Oklahoma
22 Veterans Centers, establishment of sites, purpose,
23 administration, and control, transfer of operations
24 and administration, continuation of operation,
Oklahoma Veterans Center facility at Lawton,
individual purchasing entity status, Oklahoma
Veterans Centers at Clinton and Talihina,
construction of a long-term care facility to assume
the operations at the Oklahoma Veterans Center at
Talihina, and petty cash funds; amending 73 O.S.
2021, Section 301, which relates to the authority to
acquire real property; changing name; updating
statutory language; updating statutory references;
and declaring an emergency.

22 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

23 SECTION 1. AMENDATORY 26 O.S. 2021, Section 4-120.3, is
24 amended to read as follows:

1 Section 4-120.3. A. The State Department of Health shall each
2 month transmit to the Secretary of the State Election Board a
3 certified list of all deaths of residents that have occurred within
4 the state for the immediately preceding month. The Secretary of the
5 State Election Board shall transmit such list to the secretary of
6 the county election board who shall then use the list to ascertain
7 those voters who are deceased, and shall remove such deceased
8 person's name from the central registry and voter registration
9 database within thirty (30) days from the date the list was received
10 by the county election board. Such list shall be used only for the
11 purposes hereinbefore described.

12 B. The registration of a deceased voter may be canceled by the
13 secretary of a county election board upon the receipt of a certified
14 copy of a death certificate from any person or upon the execution by
15 the next of kin of such deceased voter of a form and upon the nature
16 of proof of the fact thereof as prescribed by the Secretary of the
17 State Election Board. Such form must be executed in person by the
18 deceased voter's next of kin at the county election board office, in
19 which case it shall be witnessed by the secretary or other
20 designated employees, at the deceased voter's precinct polling place
21 or at the next of kin's precinct polling place in the same county on
22 the day of any election, in which case it shall be witnessed by the
23 inspector of such precinct, or the form may be personally signed by
24 the next of kin, such signature to be notarized by a notary public

1 or witnessed by two persons whose signatures and addresses shall
2 appear on the form, and returned to the county election board.

3 C. The administrator of a nursing facility, as defined in
4 Section 1-1902 of Title 63 of the Oklahoma Statutes, or the
5 administrator of a ~~veterans center~~ State Veterans Home established
6 pursuant to Title 72 of the Oklahoma Statutes, also may execute a
7 form prescribed by the Secretary of the State Election Board to
8 notify the secretary of the county election board of the death of a
9 nursing facility resident who is a registered voter. The
10 administrator's signature on such form shall be witnessed by a
11 member of the nursing home absentee voting board, shall be notarized
12 or shall be witnessed by two persons whose signatures and addresses
13 shall appear on the form.

14 D. A funeral director, as defined in Section 396.2 of Title 59
15 of the Oklahoma Statutes, may execute a form prescribed by the
16 Secretary of the State Election Board to notify the secretary of the
17 county election board of the death of a resident of the county. The
18 funeral director's signature on such form either shall be notarized
19 or shall be witnessed by two persons whose signatures and addresses
20 shall appear on the form. Upon receipt of such form or any notice
21 setting forth substantially the same facts and witnessed or
22 notarized as provided in this section, the secretary of the county
23 election board shall be authorized to cancel the voter registration
24 of such deceased person.

1 E. The registration of a deceased voter who was a member of the
2 Oklahoma National Guard or the ~~armed forces~~ Armed Forces of the
3 United States and who died in the line of duty may be canceled by
4 the secretary of a county election board upon the receipt of
5 notification of the voter's death from the Oklahoma National Guard
6 or the ~~armed forces~~ Armed Forces of the United States. The
7 Secretary of the State Election Board may prescribe the forms of
8 such notification to be accepted by the county election board in
9 order to cause the registration of the voter to be canceled. The
10 Secretary shall further request the Oklahoma National Guard and the
11 ~~armed forces~~ Armed Forces of the United States to provide
12 notifications to the county election board as provided for in this
13 section.

14 F. The Secretary of the State Election Board is authorized to
15 obtain official death records from the Social Security
16 Administration and from other states. The Secretary of the State
17 Election Board may compare such death records against the state's
18 voter registration database. Any possible match of a death record
19 to a registered voter shall be transmitted to the secretary of the
20 county election board in the county in which the voter is
21 registered. The secretary of the county election board shall
22 ascertain any voter who is deceased, and shall remove such deceased
23 person's name from the central registry and voter registration
24 database.

1 SECTION 2. AMENDATORY 26 O.S. 2021, Section 14-101.1, is
2 amended to read as follows:

3 Section 14-101.1. A. For the purposes of this section,
4 "absentee ballot harvesting" means:

5 1. Collecting or obtaining an absentee ballot from another
6 person with the intent to submit, transmit or return the ballot to
7 election officials on behalf of that person;

8 2. Submitting, returning or transmitting an absentee ballot to
9 election officials on behalf of another person;

10 3. Collecting or obtaining an absentee ballot from another
11 person under a false pretense or promise of transmitting, returning
12 or submitting it to election officials on behalf of that person;

13 4. Requesting or receiving an absentee ballot on behalf of
14 another person;

15 5. Partially or fully completing an application for an absentee
16 ballot on behalf of another person without that person's prior
17 consent; or

18 6. Notarizing or witnessing more absentee ballots than allowed
19 by law.

20 B. Absentee ballot harvesting shall be unlawful at any election
21 conducted by a county election board, the State Election Board or
22 any political subdivision of this state; provided, the following
23 shall not be deemed to be ballot harvesting:
24

1 1. A voter's assistant or agent acting pursuant to law as
2 otherwise allowed by Title 26 of the Oklahoma Statutes;

3 2. An absentee voting board member, as described in Title 26 of
4 the Oklahoma Statutes, who assists a voter confined to a nursing
5 home or ~~veterans center~~ State Veterans Home pursuant to law;

6 3. An employee of the Federal Voting Assistance Program, the
7 United States Department of Defense or the Oklahoma National Guard
8 who assists a uniformed-services voter in returning or transmitting
9 an absentee ballot;

10 4. A spouse, relative in the first or second degree of
11 consanguinity or affinity or cohabitant of a voter who forwards an
12 absentee ballot to the voter when absent from the home;

13 5. A voter's spouse who, with the voter's consent, returns the
14 voter's absentee ballot by mail; or

15 6. An official action by an election official that is required
16 or authorized by law.

17 SECTION 3. AMENDATORY 26 O.S. 2021, Section 14-115, is
18 amended to read as follows:

19 Section 14-115. A. If the secretary of a county election board
20 receives a request from an incapacitated elector confined to a
21 nursing facility, as defined in Section 1-1902 of Title 63 of the
22 Oklahoma Statutes, or a ~~veterans center~~ State Veterans Home
23 established pursuant to Title 72 of the Oklahoma Statutes within the
24

1 county of the jurisdiction of the secretary, the secretary shall
2 cause to be implemented the following procedures:

3 1. On the Thursday, Friday, Saturday or Monday preceding the
4 election, the absentee voting board shall deliver to each registered
5 voter who is confined to a nursing facility, as defined in Section
6 1-1902 of Title 63 of the Oklahoma Statutes, or a ~~veterans center~~
7 State Veterans Home established pursuant to Title 72 of the Oklahoma
8 Statutes and who requested ballots for an incapacitated voter the
9 ballots and materials as may be necessary to vote same.

10 2. The voter must mark the ballots in the manner hereinbefore
11 provided in the presence of the absentee voting board, but in such a
12 manner as to make it impossible for any person other than the voter
13 to ascertain how the ballots are marked. Insofar as is possible,
14 the voting procedure shall be the same as if the voter were casting
15 a vote in person at a precinct.

16 3. The voter shall then seal the ballots in the plain opaque
17 envelope and shall seal the plain opaque envelope in the envelope
18 bearing an affidavit. The voter must complete the affidavit, and
19 the signature of the voter on same must be witnessed by both members
20 of the absentee voting board.

21 4. The envelope bearing an affidavit then must be sealed in the
22 return envelope, which shall be returned by the absentee voting
23 board to the secretary of the county election board on the same day
24 the affidavit was executed.

1 5. Ballots cast in such manner shall be counted in the same
2 manner as regular mail absentee ballots.

3 B. The voter may request the assistance of the absentee voting
4 board members to mark a ballot, complete the affidavit or seal the
5 envelopes as described in this section.

6 C. 1. An administrator or employee of a nursing facility or
7 ~~veterans center~~ State Veterans Home who attempts to coerce or
8 influence the vote of a person residing in or confined to that
9 facility shall be deemed to be in violation of Section 16-109 of
10 this title.

11 2. An administrator or employee of a nursing facility or
12 ~~veterans center~~ State Veterans Home who prevents or attempts to
13 prevent a person residing in or confined to that facility from
14 voting pursuant to this section shall be deemed to be in violation
15 of Section 16-113 of this title.

16 SECTION 4. AMENDATORY 26 O.S. 2021, Section 14-115.5, is
17 amended to read as follows:

18 Section 14-115.5. A. To carry out the provisions of Sections
19 14-115 and 14-115.4 of this title, the secretary of the county
20 election board shall designate one or more absentee voting boards,
21 to be composed of two (2) members each, with each member to be of a
22 different political affiliation.

23 B. No later than June 1 in each even-numbered year, the chair
24 of the county central committees of the two political parties having

1 the highest number of registered voters in the county shall each
2 submit a list of ten names to the secretary. Such lists shall
3 contain names of registered voters of the county, who shall meet the
4 same eligibility requirements for precinct officials as described in
5 Section 2-131 of this title.

6 C. The secretary shall utilize such lists in designating
7 membership on the absentee voting board or boards, unless all
8 persons on such lists are ineligible, unable or unwilling to serve.
9 In the event the chair of the county central committee of a
10 political party fails to submit a list as herein provided, the
11 secretary shall appoint membership to such board or boards from the
12 ranks of registered voters of such party within the county.
13 Provided further, that in the event the list of names of either or
14 both parties is exhausted and additional absentee voting boards are
15 needed, the secretary shall appoint additional members to such
16 boards from the ranks of such party or parties in the county.

17 D. Members of an absentee voting board shall be compensated at
18 the same rate as a precinct judge or clerk.

19 E. One member of each such board serving a nursing home,
20 ~~veterans center~~ State Veterans Home or convalescent hospital, shall
21 be allowed mileage reimbursement at the rate prescribed for travel
22 by state employees according to the State Travel Reimbursement Act.

23 SECTION 5. AMENDATORY 43A O.S. 2021, Section 6-102, is
24 amended to read as follows:

1 Section 6-102. A. 1. Upon receipt of a certificate of the
2 United States Public Health Service or any agency of the United
3 States Government or a ~~veterans center in the state~~ State Veterans
4 Home that facilities are available for the care or treatment of any
5 person who has been admitted to a facility within the Department of
6 Mental Health and Substance Abuse Services in accordance with the
7 provisions of this title and that such person is eligible for care
8 or treatment, the Commissioner of Mental Health and Substance Abuse
9 Services, upon recommendation by the person in charge of the
10 facility in which the consumer is located, may transfer the consumer
11 to:

- 12 a. the United States Public Health Service or other
13 agency of the United States Government, or
- 14 b. a ~~veterans center in the state~~ State Veterans Home or
15 other agency of the state for care and treatment.

16 2. If the consumer has been admitted under involuntary court-
17 ordered commitment proceedings, the Commissioner shall notify the
18 committing court of any transfer when it has been effected.

19 3. Any consumer transferred as provided in this section shall
20 be deemed to be committed to the United States Public Health Service
21 or other agency of the United States Government or a ~~veterans center~~
22 ~~in the state~~ State Veterans Home or other agency of the state
23 pursuant to the original commitment the same as if the person had
24 been originally committed.

1 B. 1. In the event that a consumer transferred under
2 provisions of this section subsequently becomes ineligible for
3 continued services, or if required services cannot be provided by
4 the entity or facility where the consumer is committed and residing,
5 the Commissioner shall upon notification accept the return of the
6 consumer to the appropriate facility of the Department.

7 2. If the consumer has been admitted under this title, the
8 Commissioner shall notify the committing court of the transfer when
9 it has been effected.

10 3. Any consumer transferred as provided in this section shall
11 be deemed to be committed to the Department pursuant to the original
12 commitment the same as if the person had been originally committed.

13 SECTION 6. AMENDATORY 62 O.S. 2021, Section 46.1, is
14 amended to read as follows:

15 Section 46.1. A. On July 1, 2005, or as soon thereafter as
16 feasible, the Office of Management and Enterprise Services shall
17 transfer any surplus funds which accrue to the General Revenue Fund
18 of ~~the State of Oklahoma~~ this state for the fiscal year ending June
19 30, 2005, over and above that which is placed in the Constitutional
20 Reserve Fund pursuant to Section 23 of Article X of the Constitution
21 of the State of Oklahoma for the fiscal year ending June 30, 2005,
22 to the following funds and in the specified amounts:

23 1. Fifty percent (50%) to the Oklahoma Dynamic Economy and
24 Budget Security Fund established in Section 46.2 of this title; and

1 2. Fifty percent (50%) to the Oklahoma Taxpayer Relief
2 Revolving Fund established in Section 2355.2 of Title 68 of the
3 Oklahoma Statutes.

4 B. On July 1, 2006, or as soon thereafter as feasible, the
5 Office of Management and Enterprise Services shall transfer the
6 following amounts of surplus funds which accrue to the General
7 Revenue Fund of ~~the State of Oklahoma~~ this state for the fiscal year
8 ending June 30, 2006, over and above that which is placed in the
9 Constitutional Reserve Fund pursuant to Section 23 of Article X of
10 the Constitution of the State of Oklahoma for the fiscal year ending
11 June 30, 2006:

12 1. The first Eighty-five Million Five Hundred Thousand Dollars
13 (\$85,500,000.00) to the State Regents Revolving Fund of the Oklahoma
14 State Regents for Higher Education, to be used for operations of The
15 Oklahoma State System of Higher Education;

16 2. Contingent upon passage and approval of Enrolled House Bill
17 No. 1169 of the 2nd Extraordinary Session of the 50th Oklahoma
18 Legislature, the next Forty-five Million Dollars (\$45,000,000.00) to
19 the Oklahoma Opportunity Fund created in Section 48 of this title;

20 3. Contingent upon passage and approval of Enrolled Senate Bill
21 No. 99 of the 2nd Extraordinary Session of the 50th Oklahoma
22 Legislature, the next One Hundred Fifty Million Dollars
23 (\$150,000,000.00) to the Economic Development Generating Excellence
24 (EDGE) Fund created in Section 47 of this title;

1 4. The next Twenty-five Million Dollars (\$25,000,000.00) to the
2 County Bridges and Road Improvement Fund, to be expended for repair,
3 renovation, rehabilitation, or replacement of county bridges;

4 5. The next Seven Million Dollars (\$7,000,000.00) to the
5 Oklahoma Department of Veterans Affairs Revolving Fund, to be used
6 for expenses associated with the ~~veterans center~~ State Veterans Home
7 in Sulphur;

8 6. The next Five Million Dollars (\$5,000,000.00) to the Rural
9 Fire Equipment Grant Revolving Fund of the Oklahoma Department of
10 Agriculture, Food, and Forestry;

11 7. The next Eighty Million Dollars (\$80,000,000.00) to the
12 Comprehensive University Capital Projects Revolving Fund created in
13 Section 2, Chapter 84, O.S.L. 2006;

14 8. The next Eight Million Dollars (\$8,000,000.00) to the
15 Tourism Equipment Revolving Fund of the Oklahoma Tourism and
16 Recreation Department, to be used for operations, capital
17 improvements and maintenance of state parks; ~~and~~

18 9. The next Fifteen Million Dollars (\$15,000,000.00) to the
19 State Emergency Fund created in Section 139.42 of this title;

20 10. The next Nine Hundred Thousand Dollars (\$900,000.00) to the
21 Oklahoma Tax Commission Fund created pursuant to Section 221 of this
22 title for the implementation of a digital license plate system;

23 11. The next Thirty-five Million Dollars (\$35,000,000.00) to
24 the Oklahoma Firefighters Pension and Retirement System in order to

1 replace monies that would otherwise have been apportioned over a
2 period of years pursuant to paragraph 1 of subsection C of Section
3 312.1 of Title 36 of the Oklahoma Statutes if such modified
4 apportionment is enacted pursuant to legislation passed during the
5 2nd Extraordinary Session of the 50th Oklahoma Legislature. If such
6 modification to the apportionment is not enacted as a result of the
7 passage of such legislation, the sum specified by this paragraph
8 shall not be transferred to the Oklahoma Firefighters Pension and
9 Retirement System; and

10 12. The next Nine Hundred Thousand Dollars (\$900,000.00) to the
11 Oklahoma Tax Commission Fund created pursuant to Section 221 of this
12 title for the acquisition of a main frame computer.

13 The transfers authorized pursuant to the provisions of
14 paragraphs 1 through 12 of this subsection shall not be subject to
15 fiscal year 2007 agency category or budget limits.

16 SECTION 7. AMENDATORY 63 O.S. 2021, Section 1-1903, is
17 amended to read as follows:

18 Section 1-1903. A. No person shall establish, operate, or
19 maintain in this state any nursing facility without first obtaining
20 a license as required by the Nursing Home Care Act.

21 B. The Nursing Home Care Act shall not apply to residential
22 care homes, assisted living facilities or adult companion homes
23 which are operated in conjunction with a nursing facility, a home or
24 facility approved and annually reviewed by the United States

1 Department of Veterans Affairs as a medical foster home in which
2 care is provided exclusively to three or fewer veterans, or to
3 hotels, motels, boarding houses, rooming houses, or other places
4 that furnish board or room to their residents.

5 C. Each ~~Oklahoma Veterans Center~~ State Veterans Home nursing
6 facility licensed pursuant to the provisions of this section shall
7 be regulated as an existing nursing facility for the purposes of
8 meeting state and federal standards.

9 D. Certificate of need review shall not be required for any
10 addition, deletion, modification or new construction of current or
11 future State Veterans ~~Center~~ Home nursing facilities.

12 E. The Nursing Home Care Act shall not authorize any person to
13 engage in any manner in the practice of the healing arts or the
14 practice of medicine, as defined by law.

15 F. The Nursing Home Care Act shall not apply to a facility
16 which is not charging or receiving periodic compensation for
17 services rendered, and not receiving any county, state, or federal
18 assistance.

19 SECTION 8. AMENDATORY 72 O.S. 2021, Section 63.5, is
20 amended to read as follows:

21 Section 63.5. The Oklahoma Veterans Commission is hereby
22 authorized to make collections from eligible patients and members
23 for care and maintenance. Payments shall be established in the
24 following manner:

1 1. All sources of personal income, except wages of a working
2 spouse, except as provided in this section, shall be considered when
3 computing care and maintenance charges, including pensions and
4 awards for aid and attendance from the Veterans Administration;

5 2. Care and maintenance charges shall be computed in a manner
6 to maximize the Veterans Administration pension and compensation
7 benefits to which the veteran is entitled and shall allow a veteran
8 to retain not less than One Hundred Fifty Dollars (\$150.00) per
9 month of total monthly income;

10 3. The care and maintenance charge shall not exceed the full
11 cost of care minus the Veterans Administration per diem payment;

12 4. Spouses, widows and widowers of eligible war veterans are
13 authorized to be admitted and maintained in the ~~Oklahoma veterans~~
14 ~~centers~~ State Veterans Homes. The facilities admitting and
15 maintaining spouses, widows and widowers shall make collections from
16 the spouses, widows and widowers first and to the fullest extent
17 from sources of income other than pension and compensation paid by
18 the Veterans Administration; and

19 5. The claim of the state for such care and maintenance shall
20 constitute a valid indebtedness against any such patient or member
21 and the patient's estate and shall not be barred by any statute of
22 limitations except as otherwise allowed by the Oklahoma Indigent
23 Health Care Act. At the death of the patient or member, this claim
24 shall be allowed and paid as other lawful claims against the estate.

1 Provided, no admission of a veteran of a period of war, as
2 referenced in 38 U.S.C., Section 1521 or detention of a patient in
3 ~~an Oklahoma veterans center~~ a State Veterans Home shall be limited
4 or conditioned in any manner by the lack of ability to pay of a
5 patient or member, the patient's estate, or any relative of the
6 patient or member. Any monies collected by the provisions of this
7 section shall be deposited in the Oklahoma Department of Veterans
8 Affairs Revolving Fund.

9 SECTION 9. AMENDATORY 72 O.S. 2021, Section 202, is
10 amended to read as follows:

11 Section 202. The ~~Oklahoma Veterans Centers~~ State Veterans Homes
12 shall be under the management and control of the Oklahoma Department
13 of Veterans Affairs which shall:

14 1. Make all necessary rules, regulations and procedures for the
15 operation and management of ~~veterans centers~~ State Veterans Homes
16 operated by the Oklahoma Department of Veterans Affairs;

17 2. Ensure compliance with all federal and state statutes and
18 rules which are applicable to the operation of long-term care
19 facilities;

20 3. Appoint and fix the duties and compensation of ~~veterans~~
21 ~~center~~ State Veterans Homes administrators and other necessary
22 employees;

23 4. Provide necessary clothing, food, and care to all residents,
24 including medications and proper medical care;

1 5. Provide for the burial of deceased residents who have no
2 surviving relatives or whose relatives do not claim their bodies;
3 and

4 6. Assure the protection of the rights of all residents,
5 including the right to be free of neglect and abuse.

6 SECTION 10. AMENDATORY 72 O.S. 2021, Section 221, is
7 amended to read as follows:

8 Section 221. There is hereby established at Sulphur, Oklahoma,
9 on the site of the Oklahoma State Veterans Hospital, and at Ardmore,
10 Oklahoma, on the site of the Oklahoma State Veterans Home
11 Facilities, and at Norman, Oklahoma, on the site of the Veterans
12 Ward of the Griffin Memorial Hospital, further described as follows:

13 Starting at the Southeast corner of the Northeast Quarter (NE
14 1/4) of Section twenty-nine (29), Township nine (9) North, Range two
15 (2) West, of the Indian Meridian; thence North seventeen hundred
16 (1700) feet to a point on the East boundary of Section twenty-nine
17 (29), Township nine (9) North, Range two (2) West; thence West six
18 hundred (600) feet; thence South eight hundred fifty (850) feet;
19 thence West three hundred twenty-five (325) feet; thence South four
20 hundred (400) feet; thence in a Southwest direction five hundred
21 forty (540) feet to a point on the South boundary of the Northeast
22 Quarter (NE 1/4) of Section twenty-nine (29), Township nine (9)
23 North, Range two (2) West of the Indian Meridian; thence East a
24

1 distance of one thousand two hundred twenty-three (1,223) feet to
2 the point of beginning;
3 facilities to be known as the ~~Oklahoma Veterans Centers~~ State
4 Veterans Homes (for the purpose of securing special treatment or
5 hospitalization the adjoining facilities of Griffin Memorial
6 Hospital shall be considered an integral part of the ~~Oklahoma~~
7 ~~Veterans Centers~~ State Veterans Homes at Norman, and may be utilized
8 to care for eligible veterans), which shall be available for care of
9 war veterans discharged other than under dishonorable conditions.
10 Further provided such centers shall be under the administration and
11 control of the Oklahoma Veterans Commission.

12 SECTION 11. AMENDATORY 72 O.S. 2021, Section 221.1, is
13 amended to read as follows:

14 Section 221.1. Effective July 1, 1979, the responsibility for
15 the operation and administration of the ~~Oklahoma Veterans Center~~
16 State Veterans Home, Norman, Oklahoma, shall be assumed by the
17 Oklahoma Department of Veterans Affairs. Thereafter, the ~~Oklahoma~~
18 ~~Veterans Center~~ State Veterans Home, Norman, shall operate as a

15 The funds allocated in subparagraph bb of this paragraph shall be
16 spent for capital projects which are important to the furtherance of
17 state functions, as directed by the Governor.

18 B. The Authority may hold title to the real and personal
19 property and improvements until such time as any obligations issued
20 for this purpose are retired or defeated and may lease the real
21 property and improvements to the agencies indicated herein. Upon
22 final redemption or defeasance of the obligations created pursuant
23 to this section, title to the real and personal property and
24

1 improvements shall be transferred from the Oklahoma Capitol
2 Improvement Authority, to the agencies indicated herein.

3 C. For the purpose of paying the costs for acquisition and
4 construction of the real property and improvements and personal
5 property and making the repairs, refurbishments, and improvements to
6 real and personal property, and providing funding for the projects
7 authorized in subsection A of this section, and for the purpose
8 authorized in subsection D of this section, the Authority is hereby
9 authorized to borrow monies on the credit of the income and revenues
10 to be derived from the leasing of such real and personal property
11 and improvements and, in anticipation of the collection of such
12 income and revenues, to issue negotiable obligations in a total
13 amount not to exceed Three Hundred Twenty-five Million Dollars
14 (\$325,000,000.00) whether issued in one or more series. The Office
15 of Management and Enterprise Services is authorized and directed to
16 expend funds from the Capital Improvement Revolving Fund in amounts
17 sufficient to make required payments pursuant to such obligations
18 during the fiscal year ending June 30, 1999. For subsequent fiscal
19 years, it is the intent of the Legislature to appropriate to the
20 indicated state agencies sufficient monies to make rental payments
21 for the purposes of retiring the obligations created pursuant to
22 this section. Provided, the Authority shall not issue any
23 obligations pursuant to this section for the purpose of providing
24 funding for the projects authorized in paragraph 16 of subsection A

1 of this section prior to January 1, 2001. For the fiscal year
2 ending June 30, 2002, and thereafter, it is the intent of the
3 Legislature to appropriate to the agencies administering the
4 projects sufficient monies to make rental payments for the purpose
5 of retiring the obligations created pursuant to this section.

6 D. To the extent funds are available from the proceeds of the
7 borrowing authorized by subsection C of this section, the Oklahoma
8 Capitol Improvement Authority shall provide for the payment of
9 professional fees and associated costs related to the projects
10 authorized in subsection A of this section.

11 E. The Authority may issue obligations in one or more series
12 and in conjunction with other issues of the Authority. The
13 Authority is authorized to hire bond counsel, financial consultants,
14 and such other professionals as it may deem necessary to provide for
15 the efficient sale of the obligations and may utilize a portion of
16 the proceeds of any borrowing to create such reserves as may be
17 deemed necessary and to pay costs associated with the issuance and
18 administration of such obligations.

19 F. The obligations authorized under this section may be sold at
20 either competitive or negotiated sale, as determined by the
21 Authority, and in such form and at such prices as may be authorized
22 by the Authority. The Authority may enter into agreements with such
23 credit enhancers and liquidity providers as may be determined
24 necessary to efficiently market the obligations. The obligations

1 may mature and have such provisions for redemption as shall be
2 determined by the Authority, but in no event shall the final
3 maturity of such obligations occur later than thirty (30) years from
4 the first principal maturity date.

5 G. Any interest earnings on funds or accounts created for the
6 purposes of this section may be utilized as partial payment of the
7 annual debt service or for the purposes directed by the Authority.

10 profit derived from the sale thereof, shall not be subject to

13 I. The Authority may direct the investment of all monies in any
14 funds or accounts created in connection with the offering of the
15 obligations authorized under this section. Such investments shall
16 be made in a manner consistent with the investment guidelines of the
17 State Treasurer. The Authority may place additional restrictions on
18 the investment of such monies if necessary to enhance the
19 marketability of the obligations.

20 J. Insofar as they are not in conflict with the provisions of
21 this section, the provisions of Section 151 et seq. of this title
22 shall apply to this section.

23 K. To the extent that the provisions of paragraph 3 of
24 subsection K of Section 85.4 of Title 74 of the Oklahoma Statutes

1 would otherwise be applicable, such provisions shall be inapplicable
2 to assets acquired, for ownership or for use, through the proceeds
3 from the obligations authorized by paragraph 16 of subsection A of
4 this section.

5 L. The Legislature finds that several functions of state
6 government are properly performed through the delivery of state
7 services by use of political subdivisions. In order to facilitate
8 the delivery of essential state services and in furtherance of state
9 governmental functions by the construction, acquisition or
10 improvement of assets which may be located within the corporate
11 limits of a municipality of ~~the State of Oklahoma~~ this state or
12 which may be located in unincorporated areas of the state and
13 subject to the jurisdiction of a board of county commissioners, but
14 which nonetheless serve an important function of state government,
15 ~~the State of Oklahoma~~ this state finds that the use of the proceeds
16 from the issuance of obligations pursuant to this section
17 effectuates the performance of essential state governmental
18 functions, including, but not limited to:

- 19 1. Fire protection services;
- 20 2. Roads, bridges and highways located either partially within
21 or completely within the corporate limits of a municipality or in an
22 unincorporated area of the state;
- 23 3. Historic preservation;
- 24 4. Recreational facilities;

- 1 5. Air transportation infrastructure;
- 2 6. Facilities for the housing and care of the elderly;
- 3 7. Juvenile delinquency prevention and treatment facilities;
- 4 8. Agricultural and horticultural event facilities;
- 5 9. Health care facilities, including, but not limited to, facilities
6 facilities the primary purpose of which is the treatment or
7 prevention of communicable diseases or illness;
- 8 10. Promotion of tourism;
- 9 11. Promotion of economic development and business site
10 selection; and
- 11 12. Public safety.

12 M. Notwithstanding any other provision of law to the contrary,
13 each and every agency, board, commission, department or other entity
14 of state government as identified in paragraph 16 of subsection A of
15 this section shall have the authority to acquire or to transfer such
16 property, whether real or personal, tangible or intangible, as may
17 be required to fully fund the projects and to acquire or improve the
18 assets for which the proceeds from the obligations authorized by
19 this section are available.

20 SECTION 20. It being immediately necessary for the preservation
21 of the public peace, health or safety, an emergency is hereby
22 declared to exist, by reason whereof this act shall take effect and
23 be in full force from and after its passage and approval.
