6 An Act relating to the practice of dentistry;  
7 amending 59 O.S. 2011, Section 328.21, as last  
8 amended by Section 3, Chapter 397, O.S.L. 2019 (59  
9 O.S. Supp. 2020, Section 328.21), which relates to  
10 application for license; broadening accepted  
11 examinations; amending 59 O.S. 2011, Section 328.23a,  
12 as amended by Section 10, Chapter 229, O.S.L. 2015  
13 (59 O.S. Supp. 2020, Section 328.23a), which relates  
14 to special volunteer license; modifying certain  
15 requirement; amending 59 O.S. 2011, Section 328.25,  
16 as last amended by Section 11, Chapter 363, O.S.L.  
17 2019 (59 O.S. Supp. 2020, Section 328.25), which  
18 relates to oral maxillofacial surgery assistant  
19 permits; modifying certain continuing education  
20 requirements; updating statutory reference; amending  
21 Section 19, Chapter 229, O.S.L. 2015 (59 O.S. Supp.  
22 2020, Section 328.31b), which relates to patient  
23 record keeping requirements; modifying certain  
24 records requirement; amending 59 O.S. 2011, Section  
328.32, as last amended by Section 34, Chapter 161,  
O.S.L. 2020 (59 O.S. Supp. 2020, Section 328.32),  
which relates to grounds for penalties; modifying  
certain grounds; adding reference; amending 59 O.S.

328.36a, which relates to laboratory prescriptions;  
modifying time period of certain requirement;  
allowing certain referrals; amending 59 O.S. 2011,  
Section 328.41, as last amended by Section 9, Chapter  
397, O.S.L. 2019 (59 O.S. Supp. 2020, Section  
328.41), which relates to continuing education  
requirements; modifying requirements; amending 59  
O.S. 2011, Section 328.48, which relates to annual  
statements of receipts and expenditures; updating

1 term; providing for certain electronic transmission;  
2 repealing 59 O.S. 2011, Section 328.29, which relates  
3 to unlawful practices for dental hygienists;  
4 repealing 59 O.S. 2011, Section 328.41, as last  
5 amended by Section 4, Chapter 428, O.S.L. 2019 (59  
6 O.S. Supp. 2020, Section 328.41), which relates to  
7 dentistry; and providing an effective date.

8 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

9 SECTION 1. AMENDATORY 59 O.S. 2011, Section 328.21, as  
10 last amended by Section 3, Chapter 397, O.S.L. 2019 (59 O.S. Supp.  
11 2020, Section 328.21), is amended to read as follows:

12 Section 328.21. A. No person shall practice dentistry or  
13 dental hygiene without first applying for and obtaining a license  
14 from the Board of Dentistry.

15 B. Application shall be made to the Board in writing and shall  
16 be accompanied by the fee established by the rules of the Board,  
17 together with satisfactory proof that the applicant:

18 1. Is of good moral character;

19 2. Is twenty-one (21) years of age, or over, at the time of  
20 making application to practice dentistry or eighteen (18) years of  
21 age, or over, if the applicant is to practice dental hygiene;

22 3. Has passed a written theoretical examination and a clinical  
23 examination approved by the Board; and

24 4. Has passed a written jurisprudence examination over the  
rules and laws affecting dentistry in this state.

1 C. An application from a candidate who desires to secure a  
2 license from the Board to practice dentistry or dental hygiene in  
3 this state shall be accompanied by satisfactory proof that the  
4 applicant:

5 1. Is a graduate of an accredited dental college, if the  
6 applicant is to practice dentistry;

7 2. Is a graduate of an accredited dental hygiene program, if  
8 the applicant is to practice dental hygiene; and

9 3. Has passed all portions of the National Board Dental  
10 Examination or the National Board Dental Hygiene Examination.

11 D. Pursuant to Section 328.15 of this title, the Board may  
12 affiliate as a member state, and accept regional exams including,  
13 but not limited to, the Western Regional Examination Board (WREB),  
14 Central Regional Dental Testing Service (CRDTS), the Commission on  
15 Dental Competency Assessments (CDCA) or another regional exam that  
16 includes the following requirements:

17 a. for dental licensing the following components:

- 18 (1) a fixed prosthetic component of the preparation  
19 of an anterior all porcelain crown and the  
20 preparation of a three-unit posterior bridge,  
21 (2) a periodontal component on a live patient,  
22 (3) an endodontic component,  
23 (4) an anterior class III and posterior class II  
24 restorative component on a live patient,

1 (5) a diagnosis and treatment planning section as  
2 approved by the Board, as specified in Section  
3 328.15 of this title, and

4 (6) the Board may determine equivalencies based on  
5 components of other exams for the purpose of  
6 credentialing, or

7 b. for dental hygienists licensing the following  
8 components:

9 (1) clinical patient treatments with an evaluation of  
10 specific clinical skills as well as the  
11 candidate's compliance with professional  
12 standards during the treatment as approved by the  
13 Board in Section 325.15 of this title and shall  
14 include:

15 (a) extra/intra oral assessment,

16 (b) periodontal probing, and

17 (c) scaling/subgingival calculus removal and  
18 supragingival deposit removal.

19 E. When the applicant and the accompanying proof are found  
20 satisfactory, the Board shall notify the applicant to appear for the  
21 jurisprudence examination at the time and place to be fixed by the  
22 Board. A dental student or a dental hygiene student in their last  
23 semester of a dental or dental hygiene program, having met all other  
24 requirements, may make application and take the jurisprudence

1 examination with a letter from the dean of the dental school or  
2 director of the hygiene program stating that the applicant is a  
3 candidate for graduation within the next six (6) months.

4 F. The Board shall require every applicant for a license to  
5 practice dentistry or dental hygiene to submit, for the files of the  
6 Board, a copy of a dental degree or dental hygiene degree, an  
7 official transcript, a recent photograph duly identified and  
8 attested, and any other information as required by the Board.

9 G. Any applicant who fails to pass the jurisprudence  
10 examination may apply for a second examination, in which case the  
11 applicant shall pay a reexamination fee as established by the  
12 statutes or rules of the State Dental Act.

13 H. Any applicant who fails to pass the clinical examination as  
14 described in paragraph 4 of subsection C of this section may be  
15 given credit for such subjects as the Board may allow, but such  
16 credits shall be extended only to the succeeding examinations. If  
17 the applicant fails to pass a second examination, before further re-  
18 examination, the Board may require evidence of additional education,  
19 as specified by the Board. After a third examination, the Board may  
20 deny the applicant another examination.

21 I. A dentist or dental hygienist currently licensed in another  
22 state having met the qualifications in paragraphs 1 through 3 of  
23 subsections B and C of this section may apply for a license by  
24 credentials upon meeting the following:

1        1. A dentist holding a general dentist license in good standing  
2 and having practiced for at least five hundred (500) hours within  
3 the previous five (5) years immediately prior to application and  
4 having passed a regional examination substantially equivalent to the  
5 requirements for this state may apply for licensure by credentials;

6        2. A dental hygienist holding a dental hygiene license in good  
7 standing and having practiced for at least four hundred twenty (420)  
8 hours within the previous five (5) years immediately prior to  
9 application and having passed a regional examination substantially  
10 equivalent to the requirements for Oklahoma may apply for licensure  
11 by credentials. Applicants for credentialing must include:

12            a. a letter of good standing from all states ever  
13                licensed, and

14            b. any other requirements as set forth by the rules;

15        3. An applicant applying for a dental or dental hygiene license  
16 by credentials shall only be required to pass the jurisprudence  
17 portion of the examination requirements as set forth in paragraph 4  
18 of subsection C of this section; or

19        4. A dental hygienist applying for credentialing for advanced  
20 procedures by providing proof of passage of the advanced procedure  
21 in a WREB, CDCA or CRDTS exam.

22        J. There shall be two types of advanced procedure available for  
23 dental hygienists upon completion of a CODA approved program or  
24 course that has been approved by the Board:

1        1. Administration of nitrous oxide; and

2        2. Administration of local anesthesia.

3        K. All licensees and permit holders shall display their current  
4 permit or license in a visible place within the dental office or  
5 treatment facility.

6        SECTION 2.        AMENDATORY        59 O.S. 2011, Section 328.23a, as  
7 amended by Section 10, Chapter 229, O.S.L. 2015 (59 O.S. Supp. 2020,  
8 Section 328.23a), is amended to read as follows:

9        Section 328.23a. A. There is established a special volunteer  
10 license for dentists and a special volunteer license for dental  
11 hygienists who are retired from active practice or out-of-state  
12 licensees in active practice who are in the Oklahoma Medical Reserve  
13 Corps or assisting with emergency management, emergency operations,  
14 or hazard mitigation in response to any emergency, man-made  
15 disaster, or natural disaster, or participating in public health  
16 initiatives, disaster drills, and community service events that are  
17 endorsed by a city, county, or state health department in the state  
18 and wish to donate their expertise for the dental care and treatment  
19 of indigent and needy persons of the state. The special volunteer  
20 license shall be:

21        1. Issued by the Board of Dentistry to eligible persons;

22        2. Issued without the payment of an application fee, license  
23 fee or renewal fee;

1        3. Issued or renewed without any continuing education  
2 requirements for a period less than one (1) calendar year; and

3        4. Issued for one (1) calendar year or part thereof.

4        B. A dentist or dental hygienist must meet the following  
5 requirements to be eligible for a special volunteer license:

6        1. Completion of a special volunteer dental or dental hygiene  
7 license application, including documentation of the dentist's dental  
8 or dental hygiene school graduation and practice history;

9        2. Documentation that the dentist or dental hygienist has been  
10 previously issued a full and unrestricted license to practice  
11 dentistry or dental hygiene in ~~Oklahoma~~ this state or in another  
12 state of the United States and that he or she has never been the  
13 subject of any reportable medical or dental disciplinary action in  
14 any jurisdiction. If the dentist or dental hygienist is licensed in  
15 more than one state and any license of the licensee is suspended,  
16 revoked, or subject to any agency order limiting or restricting  
17 practice privileges, or has been voluntarily terminated under threat  
18 of sanction, the dentist or dental hygienist shall be ineligible to  
19 receive a special volunteer license;

20        3. Acknowledgement and documentation that the dentist's or  
21 dental hygienist's practice under the special volunteer license will  
22 be exclusively and totally devoted to providing dental care to needy  
23 and indigent persons in ~~Oklahoma~~ this state;



1        4. Acknowledgement and documentation that the dentist or dental  
2 hygienist will not receive or have the expectation to receive any  
3 payment or compensation, either direct or indirect, for any dental  
4 services rendered under the special volunteer license; and

5        5. A listing of all locations and dates that the person will be  
6 completing volunteer work under the special volunteer license.

7        C. The Board of Dentistry shall have jurisdiction over  
8 dentists, dental hygienists, dental assistants, and dental  
9 technicians who volunteer their professional services in the state.  
10 Dental assistants and dental technicians shall work under the direct  
11 supervision of a dentist.

12        D. Dental assistants may be issued a volunteer permit at the  
13 request of an entity that provides dental services to the needy.  
14 Volunteers in a volunteer initiative who are not dentists or dental  
15 hygienists shall be named and provided on a list to the Board by the  
16 entity hosting the volunteer initiative with any other requirements  
17 as set forth by the Board. The Board shall provide written  
18 documentation to the host entity designating all persons who may  
19 participate in the volunteer initiative, including authorization of  
20 the timetable requested by the host entity for granting licensure  
21 exemption. Any person working under a volunteer dental assistant  
22 permit shall not receive payment or compensation for any services  
23 rendered under the volunteer dental assistant permit. Volunteer  
24

1 dental assistant permits shall be limited to specific dates and  
2 locations of services to be provided.

3 E. All persons providing care shall do so under the provisions  
4 specified in Section 328.1 et seq. of this title or rules  
5 promulgated by the Board. Only those functions authorized by law or  
6 administrative rule shall be performed by the named person approved  
7 by the Board.

8 F. Volunteers shall not use sedation or general anesthesia  
9 during volunteer procedures.

10 G. Volunteers shall use a form to be provided by the Board for  
11 any patient with clear instructions for any and all follow-up care.

12 H. At any time, the Board shall revoke a volunteer license  
13 based on documentation of failure to participate according to state  
14 laws or administrative rules.

15 I. A special volunteer license shall be restricted to services  
16 provided at the locations listed on the application or for a  
17 specific not-for-profit treatment provider group as approved by the  
18 Board.

19 SECTION 3. AMENDATORY 59 O.S. 2011, Section 328.25, as  
20 last amended by Section 11, Chapter 363, O.S.L. 2019 (59 O.S. Supp.  
21 2020, Section 328.25), is amended to read as follows:

22 Section 328.25. A. No person shall practice as an oral  
23 maxillofacial surgery assistant without having obtained a permit as  
24 an oral maxillofacial surgery assistant from the Board of Dentistry.

1       B. Any person seeking to obtain an oral maxillofacial surgery  
2 assistant permit must have a supervising oral maxillofacial surgeon  
3 with a current Oklahoma license and complete the requirements set  
4 forth by the Board.

5       C. The application shall be made to the Board in writing and  
6 shall be accompanied by the fee established by the Board, together  
7 with the satisfactory proof that the applicant:

8       1. Passes a background check with criteria established by the  
9 Board; and

10       2. Has completed all of the training requirements for the oral  
11 maxillofacial surgery assistant permit as established by the Board.

12       D. An oral maxillofacial surgery assistant permit shall be  
13 considered a temporary training permit until all of the training  
14 requirements, as established by the Board for each oral  
15 maxillofacial surgery assistant, have been completed and approved by  
16 the Board.

17       E. A temporary training permit for each oral maxillofacial  
18 surgery assistant shall not be extended beyond two (2) years.

19       F. All oral maxillofacial surgery assistants are required to be  
20 under direct supervision or direct visual supervision at all times  
21 by a licensed oral maxillofacial surgeon.

22       G. If an oral maxillofacial surgery assistant is not currently  
23 employed by an oral maxillofacial surgeon, the oral maxillofacial  
24 surgery assistant permit shall automatically revert to a dental

1 assistant permit as set forth in Section 328.24 of this title and  
2 may be eligible for an expanded function assisting a dentist who  
3 holds a parenteral or pediatric anesthesia permit; provided, only  
4 the dentist may administer anesthesia and assess the patient's level  
5 of sedation. The oral maxillofacial surgery assistant permit may be  
6 reinstated upon employment under a licensed oral maxillofacial  
7 surgeon.

8 H. Any oral maxillofacial surgeon shall notify the Board within  
9 thirty (30) days of an oral maxillofacial surgery assistant no  
10 longer under his or her supervision.

11 I. An applicant for an oral maxillofacial surgery assistant  
12 permit shall provide satisfactory proof of:

13 1. Successful completion of the Dental Anesthesia Assistant  
14 National Certification Examination (DAANCE) provided by the American  
15 Association of Oral Maxillofacial Surgeons (AAOMS) or another  
16 program or examination as approved by the Board;

17 2. A valid BLS certification;

18 3. Employment and completion of a minimum of six (6) months of  
19 training under the direct supervision of a licensed oral  
20 maxillofacial surgeon prior to starting DAANCE or another program or  
21 examination as approved by the Board;

22 4. A standardized course approved by the Board including a  
23 minimum of four (4) hours of didactic training that must include  
24 anatomy, intravenous access or phlebotomy, technique, risks and

1 complications, and hands-on experience starting and maintaining  
2 intravenous lines on a human or simulator/manikin, and pharmacology;

3 5. Completion of an infection-control course as approved by the  
4 Board.

5 J. An oral maxillofacial surgery assistant who has completed  
6 all the requirements shall receive a permit to practice as an oral  
7 maxillofacial surgery assistant within a dental office, surgery  
8 center, dental ambulatory surgery center or hospital.

9 K. Oral maxillofacial surgery assistants shall be required to  
10 complete ~~twelve (12)~~ eight (8) hours of continuing education every  
11 ~~three (3)~~ two (2) years in classes approved by AAOMS that are  
12 certified by the American Dental Association CERP program or another  
13 program approved by the Board. The continuing education requirement  
14 shall include at least one (1) hour on infection control.

15 L. The anesthesia committee provided pursuant to Section 328.17  
16 of this title may make a recommendation to the Board for an oral  
17 maxillofacial surgery assistant holding a temporary training permit  
18 to substitute training received from another state university,  
19 dental school or technical training institute or training acquired  
20 in a surgery center or hospital while working under the authority of  
21 a licensed physician, to qualify as a partial substitute for the  
22 requirements to attain an oral maxillofacial surgery assistant  
23 permit.

1 M. An oral maxillofacial surgery assistant may only accept  
2 delegation from an oral and maxillofacial surgeon:

3 1. Under direct supervision:

4 a. initiate and discontinue an intravenous line for a  
5 patient being prepared to receive intravenous  
6 medications, sedation or general anesthesia, or

7 b. draw up and prepare medications;

8 2. Under direct visual supervision:

9 a. follow instructions of the oral surgeon while acting  
10 as an accessory hand on behalf of the oral surgeon  
11 that is administering the medication and actively  
12 treating the patient. For the purposes of this  
13 section, "administer" means to have the sole  
14 responsibility for anesthesia care, including  
15 determining medicines to be used and the dosage,  
16 timing, route of delivery and administration of  
17 medication and the assessment of the level of  
18 anesthesia and monitoring the physiological results of  
19 such care; provided, only an oral surgeon or dentist  
20 possessing a current general anesthesia permit may  
21 administer or assess the level of sedation or general  
22 anesthesia and monitor the results of such care,  
23 b. follow instructions of the oral surgeon to adjust the  
24 rate of intravenous fluids to maintain or keep the

1 line patent or open and adjust an electronic device to  
2 provide medications such as an infusion pump, and  
3 c. assist the oral surgeon by reading, recording vital  
4 signs of a patient receiving deep sedation or general  
5 anesthesia; provided, only an oral surgeon may assess  
6 the level of sedation; and

7 3. Only an oral surgeon shall be responsible to diagnose,  
8 treat, monitor, determine and administer the selection of the drug,  
9 dosage, and timing of all anesthetic medications and care of the  
10 patient through the perioperative period shall rest solely with the  
11 supervising oral and maxillofacial surgeon.

12 4. Nothing in ~~this act~~ the State Dental Act shall be construed  
13 as to allow an oral surgery assistant or dental assistant to  
14 administer anesthesia care to a patient.

15 SECTION 4. AMENDATORY Section 19, Chapter 229, O.S.L.  
16 2015 (59 O.S. Supp. 2020, Section 328.31b), is amended to read as  
17 follows:

18 Section 328.31b. A. Every dental office or treatment facility,  
19 whether individual, group or multi-doctor practice operating under a  
20 name, trade name or other professional entity shall maintain written  
21 records on each patient treated at the facility and shall make these  
22 records available to the Board and other regulatory entities or be  
23 subject to the penalties as set forth in Section 328.44 of this  
24 title.

1 B. Each licensed dentist shall maintain written records on each  
2 patient that shall contain, at a minimum, the following information  
3 about the patient:

4 1. A health history listing known illnesses, other treating  
5 physicians, and current medications prescribed;

6 2. Results of clinical examination and tests conducted,  
7 including the identification, or lack thereof, of any oral pathology  
8 or diseases;

9 3. Treatment plan proposed by the dentist;

10 4. Treatment rendered to the patient. The patient record shall  
11 clearly identify the dentist and the dental hygienist providing the  
12 treatment with the dentist, specialty or dental hygienist license  
13 number. The patient record shall include documentation of any  
14 medications prescribed, administered or dispensed to the patient;

15 5. Whenever patient records are released or transferred, the  
16 dentist releasing or transferring the records shall maintain either  
17 the original records or copies thereof and a notation shall be made  
18 in the retained records indicating to whom the records were released  
19 or transferred; and

20 6. All claims being submitted for insurance must be signed,  
21 stamped or have an electronic signature by the treating dentist.

22 C. Patient records may be kept in an electronic data format,  
23 provided that the dentist maintains a backup copy of information  
24 stored in the data processing system using disk, tape or other



1 electronic back-up system and that backup is updated on a regular  
2 basis, at least weekly, to assure that data is not lost due to  
3 system failure. Any electronic data system shall be capable of  
4 producing a hard copy on demand.

5 D. All patient records shall be maintained for seven (7) years  
6 from the date of treatment.

7 E. Each licensed dentist shall retain a copy of each entry in  
8 his or her patient appointment book or such other log, calendar,  
9 book, file or computer data used in lieu of an appointment book for  
10 a period of no less than seven (7) years from the date of each entry  
11 thereon.

12 SECTION 5. AMENDATORY 59 O.S. 2011, Section 328.32, as  
13 last amended by Section 34, Chapter 161, O.S.L. 2020 (59 O.S. Supp.  
14 2020, Section 328.32), is amended to read as follows:

15 Section 328.32. A. The following acts or occurrences by a  
16 dentist shall constitute grounds for which the penalties specified  
17 in Section 328.44a of this title may be imposed by order of the  
18 Board of Dentistry or be the basis for denying a new applicant any  
19 license or permit issued by the Board:

20 1. Pleading guilty or nolo contendere to, or being convicted  
21 of, a felony, a misdemeanor involving moral turpitude, any crime in  
22 which an individual would be required to be a registered sex  
23 offender under Oklahoma law, any violent crime, Medicaid fraud,  
24

1 insurance fraud, identity theft, embezzlement or a violation of  
2 federal or state controlled dangerous substances laws;

3 2. Presenting to the Board a false diploma, license, or  
4 certificate, or one obtained by fraud or illegal means, or providing  
5 other false information on an application or renewal;

6 3. Being, by reason of persistent inebriety or addiction to  
7 drugs, incompetent to continue the practice of dentistry;

8 4. Publishing a false, fraudulent, or misleading advertisement  
9 or statement;

10 5. Authorizing or aiding an unlicensed person to practice  
11 dentistry, to practice dental hygiene, or to perform a function for  
12 which a permit from the Board is required;

13 6. Authorizing or aiding a dental hygienist to perform any  
14 procedure prohibited by the State Dental Act or the rules of the  
15 Board;

16 7. Authorizing or aiding a dental assistant or oral  
17 maxillofacial surgery assistant to perform any procedure prohibited  
18 by the State Dental Act or the rules of the Board;

19 8. Failing to pay fees as required by the State Dental Act or  
20 the rules of the Board;

21 9. Failing to complete continuing education requirements;

22 10. Representing himself or herself to the public as a  
23 specialist in a dental specialty without holding a dental specialty  
24 license therefor;

1 11. Representing himself or herself to the public as a  
2 specialist whose practice is limited to a dental specialty, when  
3 such representation is false, fraudulent, or misleading;

4 12. Endangering the health of patients by reason of having a  
5 highly communicable disease and continuing to practice dentistry  
6 without taking appropriate safeguards;

7 13. Practicing dentistry in an unsafe or unsanitary manner or  
8 place, including but not limited to repeated failures to follow  
9 Centers for Disease Control and Prevention (CDC) or Occupational  
10 Safety and Health Administration (OSHA) guidelines;

11 14. Being shown to be mentally unsound;

12 15. Being shown to be grossly immoral and that such condition  
13 represents a threat to patient care or treatment;

14 16. Being incompetent to practice dentistry while delivering  
15 care to a patient;

16 17. Committing gross negligence in the practice of dentistry;

17 18. Committing repeated acts of negligence in the practice of  
18 dentistry;

19 19. Offering to effect or effecting a division of fees, or  
20 agreeing to split or divide a fee for dental services with any  
21 person, in exchange for the person bringing or referring a patient;

22 20. Being involuntarily committed to an institution for  
23 treatment for substance abuse, until recovery or remission;

1       21. Using or attempting to use the services of a dental  
2 laboratory or dental laboratory technician without issuing a  
3 laboratory prescription, except as provided in subsection C of  
4 Section 328.36 of this title;

5       22. Aiding, abetting, or encouraging a dental hygienist  
6 employed by the dentist to make use of an oral prophylaxis list, or  
7 the calling by telephone or by use of letters transmitted through  
8 the mails to solicit patronage from patients formerly served in the  
9 office of any dentist formerly employing such hygienist;

10       23. Having more than the equivalent of three full-time dental  
11 hygienists for each dentist actively practicing in the same dental  
12 office;

13       24. Allowing a person not holding a permit or license issued by  
14 the Board to assist in the treatment of a patient without having a  
15 license or permit issued by the Board;

16       25. Knowingly patronizing or using the services of a dental

22 provision of the State Dental Act or the rules of the Board;

23       27. Willfully disclosing information protected by the Health  
24 Information Portability and Accountability Act, P.L. 104-191;

1        28. Writing a false, unnecessary, or excessive prescription for  
2 any drug or narcotic which is a controlled dangerous substance under  
3 either federal or state law, or prescribing, dispensing or  
4 administering opioid drugs in excess of the maximum limits  
5 authorized in Section 2-309I of Title 63 of the Oklahoma Statutes;

6        29. Prescribing or administering any drug or treatment without  
7 having established a valid dentist-patient relationship;

8        30. Using or administering nitrous oxide gas in a dental office  
9 in an inappropriate or unauthorized manner;

10       31. Engaging in nonconsensual physical contact with a patient  
11 which is sexual in nature, or engaging in a verbal communication  
12 which is intended to be sexually demeaning to a patient;

13       32. Practicing dentistry without displaying, at the dentist's  
14 primary place of practice, the license issued to the dentist by the  
15 Board to practice dentistry and the current renewal certificate;

16       33. Being dishonest in a material way with a patient;

17       34. Failing to retain all patient records for at least seven  
18 (7) years from the date of the last treatment as provided by Section  
19 328.31b of this title, except that the failure to retain records  
20 shall not be a violation of the State Dental Act if the dentist  
21 shows that the records were lost, destroyed, or removed by another,  
22 without the consent of the dentist;

23       35. Failing to retain the dentist's copy of any laboratory  
24 prescription for at least ~~three (3)~~ seven years, except that the

1 failure to retain records shall not be a violation of the State  
2 Dental Act if the dentist shows that the records were lost,  
3 destroyed, or removed by another, without the consent of the  
4 dentist;

5 36. Allowing any corporation, organization, group, person, or  
6 other legal entity, except another dentist or a professional entity  
7 that is in compliance with the registration requirements of  
8 subsection B of Section 328.31 of this title, to direct, control, or  
9 interfere with the dentist's clinical judgment. Clinical judgment  
10 shall include, but not be limited to, such matters as selection of a  
11 course of treatment, control of patient records, policies and  
12 decisions relating to pricing, credit, refunds, warranties and  
13 advertising, and decisions relating to office personnel and hours of  
14 practice. Nothing in this paragraph shall be construed to:

- 15 a. limit a patient's right of informed consent, or
- 16 b. prohibit insurers, preferred provider organizations  
17 and managed care plans from operating pursuant to the  
18 applicable provisions of the Oklahoma Insurance Code  
19 and the Public Health Code;

20 37. Violating the state dental act of another state resulting  
21 in a plea of guilty or nolo contendere, conviction or suspension or  
22 revocation or other sanction by another state board, of the license  
23 of the dentist under the laws of that state;

1        38. Violating or attempting to violate the provisions of the  
2 State Dental Act or the rules of the Board, a state or federal  
3 statute or rule relating to scheduled drugs, fraud, a violent crime  
4 or any crime for which the penalty includes the requirement of  
5 registration as a sex offender in Oklahoma as a principal, accessory  
6 or accomplice;

7        39. Failing to comply with the terms and conditions of an order  
8 imposing suspension of a license or placement on probation issued  
9 pursuant to Section 328.44a of this title;

10       40. Failing to cooperate during an investigation or providing  
11 false information, verbally or in writing, to the Board, the Board's  
12 investigator or an agent of the Board;

13       41. Having multiple administrative or civil actions reported to  
14 the National Practitioner Databank; or

15       42. Failing to complete an approved two-hour course on opioid  
16 and scheduled drug prescribing within one (1) year of obtaining a  
17 license or a violation of a law related to controlled dangerous  
18 substances including prescribing laws pursuant to Section 2-309D of  
19 Title 63 of the Oklahoma Statutes.

20       B. The provisions of the State Dental Act shall not be  
21 construed to prohibit any dentist from displaying or otherwise  
22 advertising that the dentist is also currently licensed, registered,  
23 certified, or otherwise credentialed pursuant to the laws of this  
24 state or a nationally recognized credentialing board, if authorized

1 by the laws of the state or credentialing board to display or  
2 otherwise advertise as a licensed, registered, certified, or  
3 credentialed dentist.

4 SECTION 6. AMENDATORY 59 O.S. 2011, Section 328.33, as  
5 last amended by Section 5, Chapter 113, O.S.L. 2016 (59 O.S. Supp.

5        9. Being incompetent in the practice of dental hygiene;

6        10. Committing willful negligence in the practice of dental  
7 hygiene;

8        11. Being involuntarily committed for treatment for drug  
9 addiction to a facility, either public or private, and until the  
10 dental hygienist has been proven cured;

11       12. Practicing or attempting to practice dental hygiene in any  
12 place or in any manner other than as authorized by Section 328.34 of  
13 this title;

14       13. Claim the use of any secret or patented methods or  
15 treatments with materials not approved by the Food and Drug  
16 Administration;

17       14. Make statements or advertise as having ability to diagnose  
18 or prescribe for any treatment;

19       15. Perform any services in the mouth other than those  
20 authorized by the Board of Dentistry pursuant to authority conferred  
21 by the State Dental Act;

22       16. Attempt to conduct a practice of dental hygiene in any  
23 place or in any manner other than as authorized by Section 328.34 of  
24 this title;

1        17. Attempt to use in any manner whatsoever any oral  
2 prophylaxis list, call list, records, reprints or copies of same or  
3 information gathered therefrom, or the names of patients whom he or  
4 she has formerly treated when serving as an employee in the office  
5 of a dentist for whom he or she was formerly employed;

6        18. Fail to keep prominently displayed in the office of the  
7 dentist for whom he or she is employed his or her current valid

9       SECTION 7.       AMENDATORY       59 O.S. 2011, Section 328.36a, is

11       Section 328.36a. A. A dentist may utilize a dental laboratory  
12 technician and a dental laboratory to perform or provide dental  
13 laboratory technology. Except as provided in subsection C of  
14 Section 328.36 of this title, a dentist who utilizes the services of  
15 a dental laboratory technician or dental laboratory shall furnish a  
16 laboratory prescription for each patient for whom a work product is  
17 prescribed.

18       B. Laboratory prescriptions issued by a dentist shall be on  
19 forms containing the minimum information required by subsection D of  
20 this section and shall be produced or printed by each dentist. Such  
21 forms shall be provided by the Board of Dentistry or downloaded from  
22 the Board's website. All forms shall be completed in full and  
23 signed by the prescribing dentist. The owner of a dental laboratory  
24 shall retain each original laboratory prescription received from a

1 prescribing dentist and produce the document for inspection and  
2 copying by a member of the Board or by an agent or employee of the

5 the duplicate copy of each laboratory prescription and produce the

14 laboratory technician or dental laboratory without a laboratory  
15 prescription and corresponding number on the model, restoration,

18 shall be returned by the dental laboratory technician or dental  
19 laboratory to the prescribing dentist or the dental office of the

4        3. A description of the work to be completed with diagrams, if

6        4. A description of the type of materials to be used;

7        5. The actual date on which the authorization or prescription

9        6. The signature in ink or by electronic method of the dentist  
10 issuing the prescription and the state license number and address of  
11 such dentist; and

13 returned to the issuing dentist that shall disclose all information

16        E. The Board shall make readily available a sample form on the  
17 Board's website for use by any licensee at no cost.

18        F. A dentist may produce, transfer and retain copies of the  
19 form electronically.

20        G. A dentist may refer a patient to a dental laboratory for the  
21 purpose of selecting the shading or matching shades of a prosthetic  
22 device being prepared for the dentist to deliver to the patient.  
23 The dentist must maintain a copy of the prescription written for the  
24 lab.

1       SECTION 8.       AMENDATORY       59 O.S. 2011, Section 328.41, as  
2 last amended by Section 9, Chapter 397, O.S.L. 2019 (59 O.S. Supp.

5 of each year, every dentist, dental hygienist, dental assistant,

23 maxillofacial surgery assistant in writing by certified mail to the  
24 last-known mailing address of the dentist, dental hygienist, dental

1 assistant, or oral maxillofacial surgery assistant as reflected in

3 D. Any dentist, dental hygienist, dental assistant, or oral

16 SECTION 9. AMENDATORY 59 O.S. 2011, Section 328.48, is

19 annually, to have prepared a statement showing the total amount of  
20 receipts and expenditures of the Board for the preceding twelve (12)  
21 months. The statement shall be properly certified under oath by the
