6 An Act relating to the Oklahoma Vehicle License and  
7 Registration Act; amending 47 O.S. 2011, Sections  
8 1116, 1132, as amended by Section 2, Chapter 337,  
9 O.S.L. 2012, 1135.1, as amended by Section 1, Chapter  
10 26, O.S.L. 2016, 1135.2, as last amended by Section  
11 1, Chapter 434, O.S.L. 2019, 1135.3, as last amended  
12 by Section 2, Chapter 434, O.S.L. 2019, 1135.4, as  
13 amended by Section 3, Chapter 69, O.S.L. 2018,  
14 1135.5, as last amended by Section 3, Chapter 434,  
15 O.S.L. 2019, 1135.6, 1135.7, as amended by Section 5,  
16 Chapter 69, O.S.L. 2018 and 1141.1, as amended by  
17 Section 4, Chapter 158, O.S.L. 2012 (47 O.S. Supp.  
18 2020, Sections 1132, 1135.1, 1135.2, 1135.3, 1135.4,  
19 1135.5, 1135.7 and 1141.1), which relate to issuance  
20 of special or personalized license plates;  
21 authorizing combination of registration periods after  
22 specified date; requiring related rulemaking by  
23 Oklahoma Tax Commission; requiring single remittance  
24 of specified fees and single registration period for  
specified special or personalized license plates  
after specified date; requiring related rulemaking by  
Oklahoma Tax Commission; construing provision with  
respect to apportionment; deleting obsolete language;  
providing for motor license agent fee when single fee  
is remitted for registration and special or  
personalized license plate; modifying reference;  
updating statutory references; and providing an  
effective date.

22 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

23 SECTION 1. AMENDATORY 47 O.S. 2011, Section 1116, is  
24 amended to read as follows:

1       Section 1116. A. Twelve registration periods shall be  
2 established for vehicles required to be registered on a staggered  
3 basis. The registration periods shall start on the first day of  
4 each calendar month and shall end on the last day of that month.  
5 Unless otherwise provided, all such vehicles where the date of  
6 execution of transfer of ownership occurs in this state at any time  
7 during a calendar month shall be subject to registration and payment  
8 of the fee for the registration period commencing the first day of  
9 the month of such date of execution of transfer.

10       B. A person who registers more than one vehicle may have all of  
11 such vehicles initially registered at the same time or at separate  
12 times. Any person who obtains a vehicle may, upon registration,  
13 have the registration period adjusted to allow future registration  
14 of all such vehicles at the same period or at a different period.

15       C. On and after January 1, 2022, if a special or personalized  
16 license plate is issued pursuant to this title for a vehicle which  
17 is subject to the requirements of Section 1132 of this title, the  
18 registration periods for the vehicle may be combined into a single  
19 registration period. The Oklahoma Tax Commission shall determine,  
20 by rule, a method for adjusting the twelve-month period.

21       SECTION 2.       AMENDATORY       47 O.S. 2011, Section 1132, as  
22 amended by Section 2, Chapter 337, O.S.L. 2012 (47 O.S. Supp. 2020,  
23 Section 1132), is amended to read as follows:  
24

1       Section 1132. A. For all vehicles, unless otherwise  
2 specifically provided by the Oklahoma Vehicle License and  
3 Registration Act, a registration fee shall be assessed at the time  
4 of initial registration by the owner and annually thereafter, for  
5 the use of the avenues of public access within this state in the  
6 following amounts:

7       1. For the first through the fourth year of registration in  
8 this state or any other state, Eighty-five Dollars (\$85.00);

9       2. For the fifth through the eighth year of registration in  
10 this state or any other state, Seventy-five Dollars (\$75.00);

11       3. For the ninth through the twelfth year of registration in  
12 this state or any other state, Fifty-five Dollars (\$55.00);

13       4. For the thirteenth through the sixteenth year of  
14 registration in this state or any other state, Thirty-five Dollars  
15 (\$35.00); and

16       5. For the seventeenth and any following year of registration  
17 in this state or any other state, Fifteen Dollars (\$15.00).

18       The registration fee provided for in this subsection shall be in  
19 lieu of all other taxes, general or local, unless otherwise  
20 specifically provided.

21       On and after January 1, 2022, if a special or personalized  
22 license plate is issued pursuant to Sections 1135.1 through 1135.7  
23 of this title, any registration fee required for such plate and the  
24 fee required pursuant to this subsection shall be remitted at the

1 same time and subject to a single registration period. The Oklahoma  
2 Tax Commission shall determine, by rule, a method for making  
3 required fee adjustments when a special or personalized license  
4 plate is obtained during a twelve-month period for which a  
5 registration fee has already been remitted pursuant to this  
6 subsection. The combination of fees in a single remittance shall  
7 not alter the apportionment otherwise provided for by law.

8       B. For all-terrain vehicles and motorcycles used exclusively  
9 for use off roads or highways purchased on or after July 1, 2005,  
10 and for all-terrain vehicles and motorcycles used exclusively for  
11 use off roads or highways purchased prior to July 1, 2005, which the  
12 owner chooses to register pursuant to the provisions of Section  
13 1115.3 of this title, an initial and nonrecurring registration fee  
14 of Eleven Dollars (\$11.00) shall be assessed at the time of initial  
15 registration by the owner. Nine Dollars (\$9.00) of the registration  
16 fee shall be deposited in the Oklahoma Tax Commission Reimbursement  
17 Fund. Two Dollars (\$2.00) of the registration fee shall be retained  
18 by the motor license agent. The fees required by subsection A of  
19 this section shall not be required for all-terrain vehicles or  
20 motorcycles used exclusively off roads and highways.

21       C. For utility vehicles used exclusively for use off roads or  
22 highways purchased on or after July 1, 2008, and for utility  
23 vehicles used exclusively for use off roads or highways purchased  
24 prior to July 1, 2008, which the owner chooses to register pursuant

1 to the provisions of Section 1115.3 of this title, an initial and  
2 nonrecurring registration fee of Eleven Dollars (\$11.00) shall be  
3 assessed at the time of initial registration by the owner. Nine  
4 Dollars (\$9.00) of the registration fee shall be deposited in the  
5 Oklahoma Tax Commission Reimbursement Fund. Two Dollars (\$2.00) of  
6 the registration fee shall be retained by the motor license agent.  
7 The fees required by subsection A of this section shall not be  
8 required for utility vehicles used exclusively off roads and  
9 highways.

10 D. There shall be a credit allowed with respect to the fee for  
11 registration of a new vehicle which is a replacement for:

12 1. A new original vehicle which is stolen from the  
13 purchaser/registrant within ninety (90) days of the date of purchase  
14 of the original vehicle as certified by a police report or other  
15 documentation as required by the Oklahoma Tax Commission; or

16 2. A defective new original vehicle returned by the  
17 purchaser/registrant to the seller within six (6) months of the date  
18 of purchase of the defective new original vehicle as certified by  
19 the manufacturer.

20 The credit shall be in the amount of the fee for registration  
21 which was paid for the new original vehicle and shall be applied to  
22 the registration fee for the replacement vehicle. In no event will  
23 the credit be refunded.

1 E. Upon every transfer or change of ownership of a vehicle, the  
2 new owner shall obtain title for and, except in the case of salvage  
3 vehicles and manufactured homes, register the vehicle within thirty  
4 (30) days of change of ownership and pay a transfer fee of Fifteen  
5 Dollars (\$15.00) in addition to any other fees provided for in ~~this~~  
6 ~~act~~ the Oklahoma Vehicle License and Registration Act. No new decal  
7 shall be issued to the registrant. Thereafter, the owner shall  
8 register the vehicle annually on the anniversary date of its initial  
9 registration in this state and shall pay the fees provided in  
10 subsection A of this section and receive a decal evidencing such  
11 payment. Provided, used motor vehicle dealers shall be exempt from  
12 the provisions of this section.

13 F. In the event a new or used vehicle is not registered, titled  
14 and tagged within thirty (30) days from the date of transfer of  
15 ownership, the penalty for the failure of the owner of the vehicle  
16 to register the vehicle within thirty (30) days shall be One Dollar  
17 (\$1.00) per day, provided that in no event shall the penalty exceed  
18 One Hundred Dollars (\$100.00). No penalty shall be waived by the  
19 Oklahoma Tax Commission or any motor license agent except as  
20 provided in subsection C of Section 1127 of this title. Of each  
21 dollar penalty collected pursuant to this subsection:

22 1. Twenty-one cents (\$0.21) shall be apportioned as provided in  
23 Section 1104 of this title;  
24

1        2. Twenty-one cents (\$0.21) shall be retained by the motor  
2 license agent; and

3        3. Fifty-eight cents (\$0.58) shall be deposited in the General  
4 Revenue Fund.

5        SECTION 3.        AMENDATORY        47 O.S. 2011, Section 1135.1, as  
6 amended by Section 1, Chapter 26, O.S.L. 2016 (47 O.S. Supp. 2020,  
7 Section 1135.1), is amended to read as follows:

8        Section 1135.1. A. The Oklahoma Tax Commission is hereby  
9 authorized to design and issue appropriate official special license  
10 plates to persons as provided by this section.

11        Special license plates shall not be transferred to any other  
12 person but shall be removed from the vehicle upon transfer of  
13 ownership and retained. The special license plate may then be used  
14 on another vehicle but only after such other vehicle has been  
15 registered for the current year.

16        Except as provided in subsection B of this section, special  
17 license plates shall be renewed each year by the Tax Commission or a  
18 motor license agent. The Tax Commission shall annually notify by  
19 mail all persons issued special license plates. The notice shall  
20 contain all necessary information and shall contain instructions for  
21 the renewal procedure upon presentation to a motor license agent or  
22 the Tax Commission. The license plates shall be issued on a  
23 staggered system. The motor license agent fees shall be paid out of  
24 the Oklahoma Tax Commission Reimbursement Fund.

1       On and after January 1, 2022, if a special license plate is  
2 issued pursuant to this section, any registration fee required for  
3 such plate pursuant to this section and the fee required pursuant to  
4 Section 1132 of this title shall be remitted at the same time and  
5 subject to a single registration period. The Oklahoma Tax  
6 Commission shall determine, by rule, a method for making required  
7 fee and registration period adjustments if a special license plate  
8 is obtained during a twelve-month period for which a registration  
9 fee has already been remitted pursuant to Section 1132 of this  
10 title. The combination of fees in a single remittance shall not  
11 alter the apportionment otherwise provided for in this section.

12       B. The special license plates provided by this section are as  
13 follows:

14       1. Political Subdivision Plates - such plates shall be designed  
15 for any vehicle owned by any political subdivision of this state  
16 having obtained a proper Oklahoma certificate of title. Such  
17 political subdivisions shall file an annual report with the Tax  
18 Commission stating the agency where such vehicle is located. Such  
19 license plates shall be permanent in nature and designed in such a  
20 manner as to remain with the vehicle for the duration of the life  
21 span of the vehicle or until the title is transferred to an owner  
22 who is not a political subdivision.



1       The registration fee shall be Eight Dollars (\$8.00) and shall be  
2 in addition to all other registration fees provided by law, except  
3 the registration fees levied by Section 1132 of this title;

4       2. Tax-Exempt or Nonprofit License Plates - such plates shall  
5 be designed for:

- 6           a. any motor bus, manufactured home, or mobile chapel and  
7 power unit owned and operated by a religious  
8 corporation or society of this state holding a valid  
9 exemption from taxation issued pursuant to Section  
10 501(a) of the Internal Revenue Code, 26 U.S.C.,  
11 Section 501(a), and listed as an exempt organization  
12 in Section 501(c) (3) of the Internal Revenue Code, as  
13 amended, 26 U.S.C., Section 501(c) (3), and that is  
14 used by the corporation or society solely for the  
15 furtherance of its religious functions,
- 16           b. any vehicle owned and operated only by nonprofit  
17 organizations devoted exclusively to youth programs  
18 including, but not limited to, the Girl Scouts and Boy  
19 Scouts of America,
- 20           c. any vehicle, except passenger automobiles, owned or  
21 operated by nonprofit organizations actually involved  
22 in programs for the employment of the handicapped and  
23 used exclusively in the transportation of goods or  
24 materials for such organization,

- 1           d.   any vehicle owned and operated by a nonprofit  
2               organization that provides older persons  
3               transportation to and from medical, dental and  
4               religious services and relief from business and social  
5               isolation,
- 6           e.   any vehicle owned and operated by a private nonprofit  
7               organization that:
- 8               (1)   warehouses and distributes surplus foods to other  
9                    nonprofit agencies and organizations, and
- 10              (2)   holds a valid exemption from taxation issued  
11                pursuant to Section 501(c) of the Internal  
12                Revenue Code, as amended, 26 U.S.C., Section  
13                501(c), and listed as an exempt organization in  
14                Section 501(c)(3) of the Internal Revenue Code,  
15                as amended, and
- 16              (3)   uses such vehicle exclusively for the  
17                transportation of such surplus foods,
- 18           f.   any vehicle which:
- 19               (1)   is owned and operated by a private, nonprofit  
20                    organization which is exempt from taxation  
21                    pursuant to the provisions of Section 501(c)(3)  
22                    of the Internal Revenue Code, 26 U.S.C., Section  
23                    501(c)(3), and which is primarily funded by a  
24

1                   fraternal or civic service organization with at  
2                   least one hundred local chapters or clubs, and  
3           (2) is designed and used to provide mobile health  
4                   screening services to the general public at no  
5                   cost to the recipient, and for which no  
6                   reimbursement of any kind is received from any  
7                   health insurance provider, health maintenance  
8                   organization or governmental program, or

9           g. any vehicle owned and operated by the Civil Air  
10           Patrol, a congressionally chartered corporation that  
11           also serves an auxiliary of the United States Air  
12           Force and which is exempt from taxation pursuant to  
13           the provisions of Section 501(c)(3) of the Internal  
14           Revenue Code, 26 U.S.C., Section 501(c)(3), and is  
15           used exclusively for its corporate missions of  
16           aerospace education, cadet programs and emergency  
17           services. Such license plates shall be permanent in  
18           nature and designed in such a manner as to remain with  
19           the vehicle for the duration of the life span of the  
20           vehicle or until the title to such vehicle is  
21           transferred to an owner who is not subject to this  
22           exemption. Such vehicles shall be exempt from the  
23           registration fees levied under Section 1132 of this  
24           title, except that an initial registration fee of

1                   Twenty-five Dollars (\$25.00) shall apply to each  
2                   vehicle.

3           Any person claiming to be eligible for a tax-exempt or nonprofit  
4 license plate under the provisions of this paragraph must have the  
5 name of the tax-exempt or nonprofit organization prominently  
6 displayed upon the outside of the vehicle, except those vehicles  
7 registered pursuant to the provisions of subparagraph b of this  
8 paragraph, unless such display is prohibited by federal or state law  
9 or by state agency rules. No vehicle shall be licensed as a tax-  
10 exempt or nonprofit vehicle unless the vehicle has affixed on each  
11 side thereof, in letters not less than two (2) inches high and two  
12 (2) inches wide, the name of the tax-exempt or nonprofit  
13 organization or the insignia or other symbol of such organization  
14 which shall be of sufficient size, shape and color as to be readily  
15 legible during daylight hours from a distance of fifty (50) feet  
16 while the vehicle is not in motion.

17           Except as provided in subparagraph g of this paragraph, the  
18 registration fee shall be Eight Dollars (\$8.00) and shall be in  
19 addition to all other registration fees provided by law, except the  
20 registration fees levied by Section 1132 of this title;

21           3. Physically Disabled License Plates - such plates shall be  
22 designed for persons who are eligible for a physically disabled  
23 placard under the provisions of Section 15-112 of this title. It  
24 shall prominently display the international accessibility symbol,

1 which is a stylized human figure in a wheelchair. The Tax  
2 Commission shall also design physically disabled license plates for  
3 motorcycles owned by persons who are eligible for a physically  
4 disabled placard pursuant to the provisions of Section 15-112 of  
5 this title. Upon the death of the physically disabled person, the  
6 disabled license plate shall be returned to the Tax Commission.  
7 There shall be no fee for such plate in addition to the rate  
8 provided by the Oklahoma Vehicle License and Registration Act for  
9 the registration of the vehicle. For an additional fee of Ten  
10 Dollars (\$10.00), a person eligible for a physically disabled  
11 license plate shall have the option of purchasing a duplicate  
12 physically disabled special license plate which shall be securely  
13 attached to the front of the vehicle. The original physically  
14 disabled special license plate shall be securely attached to the  
15 rear of the vehicle at all times.

16 Any person who is eligible for a physically disabled license  
17 plate and whose vehicle has had modifications because of the  
18 physical disability of the owner or of a family member within the  
19 second degree of consanguinity of the owner, may register the  
20 vehicle for a flat fee of Twenty-five Dollars (\$25.00). This fee  
21 shall be in lieu of all other registration fees provided by the  
22 Oklahoma Vehicle License and Registration Act;

23 4. Indian Tribal License Plates - such plates shall be designed  
24 for any vehicle of a native American Indian Tribal Association

1 exempted in Sections 201 through 204 of Public Law 97-473 and used  
2 by the tribal association exclusively for the furtherance of its  
3 tribal functions.

4 The registration fee shall be Eight Dollars (\$8.00) and shall be  
5 in addition to all other registration fees provided by law, except  
6 the registration fees levied by Section 1132 of this title;

7 5. Hearing Impaired License Plates - such plates shall be  
8 designed for persons who are hearing impaired. Such persons may  
9 apply for a hearing-impaired license plate for each vehicle with a  
10 rated carrying capacity of one (1) ton or less upon the presentment  
11 of an application on a form furnished by the Tax Commission and  
12 certified by a physician holding a valid license to practice  
13 pursuant to the licensing provisions of Title 59 of the Oklahoma  
14 Statutes, attesting that the person is hearing impaired. The  
15 license plate shall be designed so that such persons may be readily  
16 identified as being hearing impaired. There shall be no additional  
17 fee for the plate, but all other registration fees provided by the  
18 Oklahoma Vehicle License and Registration Act shall apply;

19 6. Antique or Classic Vehicles License Plates - such plates  
20 shall be designed and issued for any vehicle twenty-five (25) years  
21 of age or older, based upon the date of manufacture thereof and  
22 which travels on the highways of this state primarily incidental to  
23 historical or exhibition purposes only.

1       The registration fee shall be Eight Dollars (\$8.00) and shall be  
2 in addition to all other registration fees provided by law, except  
3 the registration fees levied by Section 1132 of this title. Any  
4 person registering an antique or classic vehicle may elect to have  
5 the vehicle registered for a ten-year period. The registration fee  
6 for the elected ten-year registration shall be Seventy-five Dollars  
7 (\$75.00). The motor license agent registering the antique or  
8 classic vehicle for a ten-year period shall receive one hundred  
9 percent (100%) of the fees the motor license agent would have  
10 otherwise received pursuant to subsection A of Section 1141.1 of  
11 this title if the antique or classic vehicle had been registered on  
12 an annual basis; and

13       7. Honorary Consul License Plates - such plates shall be  
14 designed to include the words "Honorary Consul" and issued to  
15 persons who are honorary consuls authorized by the United States to  
16 perform consular duties. Persons applying for such license plates  
17 must show proof of standing as an honorary consul. The fee for such  
18 plate shall be Eight Dollars (\$8.00) and shall be in addition to all  
19 other registration fees required by the Oklahoma Vehicle License and  
20 Registration Act. The owner of the vehicle that possesses such  
21 license plates shall return the special license plates to the  
22 Oklahoma Tax Commission if the owner disposes of the vehicle during  
23 the registration year or ceases to be authorized to perform consular  
24 duties.

1 C. Special license plates provided by this section shall be  
2 designed in such a manner as to identify the use or ownership of the  
3 vehicle. Use of any vehicle possessing a special license plate  
4 provided by this section for any purpose not specified herein shall  
5 be grounds for revocation of the special license plate and  
6 registration certificate.

7 D. The fees provided by this section shall be deposited in the  
8 Oklahoma Tax Commission Reimbursement Fund.

9 SECTION 4. AMENDATORY 47 O.S. 2011, Section 1135.2, as  
10 last amended by Section 1, Chapter 434, O.S.L. 2019 (47 O.S. Supp.  
11 2020, Section 1135.2), is amended to read as follows:

12 Section 1135.2. A. The Oklahoma Tax Commission is hereby  
13 authorized to design and issue appropriate official special license  
14 plates to persons in recognition of their service or awards as  
15 provided by this section.

16 Special license plates shall not be transferred to any other  
17 person but shall be removed from the vehicle upon transfer of  
18 ownership and retained. The special license plate may then be used  
19 on another vehicle but only after such other vehicle has been  
20 registered for the current year.

21 Special license plates shall be renewed each year by the Tax  
22 Commission or a motor license agent. The Tax Commission shall  
23 annually notify by mail all persons issued special license plates.  
24 The notice shall contain all necessary information and shall contain



1 instructions for the renewal procedure upon presentation to a motor  
2 license agent or the Tax Commission. The license plates shall be  
3 issued on a staggered system except for legislative plates and  
4 amateur radio operator license plates.

5 On and after January 1, 2022, if a special license plate is  
6 issued pursuant to this section, any registration fee required for  
7 such plate pursuant to this section and the fee required pursuant to  
8 Section 1132 of this title shall be remitted at the same time and  
9 subject to a single registration period. The Oklahoma Tax  
10 Commission shall determine, by rule, a method for making required  
11 fee and registration period adjustments if a special license plate  
12 is obtained during a twelve-month period for which a registration  
13 fee has already been remitted pursuant to Section 1132 of this  
14 title. The combination of fees in a single remittance shall not  
15 alter the apportionment otherwise provided for in this section.

16 The Tax Commission is hereby directed to develop and implement a  
17 system whereby motor license agents are permitted to accept  
18 applications for special license plates authorized under this  
19 section. The motor license agent shall confirm the applicant's  
20 eligibility, if applicable, collect and deposit any amount  
21 specifically authorized by law, accept and process the necessary  
22 information directly into such system and generate a receipt  
23 accordingly. For performance of these duties, motor license agents  
24 shall retain the fee provided in Section 1141.1 of this title for

1 registration of a motor vehicle. The motor license agent fees for  
2 acceptance of applications and renewals shall be paid out of the  
3 Oklahoma Tax Commission Reimbursement Fund.

4 B. The special license plates provided by this section are as  
5 follows:

6 1. Prisoner of War License Plates - such plates shall be  
7 designed for honorably discharged or present members of the United  
8 States Armed Forces and civilians who were former prisoners of war  
9 held by a foreign country and who can provide proper certification  
10 of that status. Such persons may apply for a prisoner of war  
11 license plate for no more than two vehicles with each vehicle having  
12 a rated carrying capacity of one (1) ton or less. The surviving  
13 spouse of any deceased former prisoner of war, if the spouse has not  
14 since remarried, or if remarried, the remarriage is terminated by  
15 death, divorce, or annulment, may apply for a prisoner of war  
16 license plate for one vehicle with a rated carrying capacity of one  
17 (1) ton or less. The fee provided by this section for the special  
18 license plate authorized by this paragraph shall be in addition to  
19 all other registration fees provided by law, except the registration  
20 fees levied by Section 1132 of this title;

21 2. National Guard License Plates - such plates shall be  
22 designed for active or retired members of the Oklahoma National  
23 Guard. Retirees who are eligible for such plates shall provide  
24

1 proof of eligibility upon initial application, but shall not be  
2 required to provide proof of eligibility annually;

3 3. Air National Guard License Plates - such plates shall be  
4 designed for active or retired members of the Oklahoma Air National  
5 Guard. Retirees who are eligible for such plates shall provide  
6 proof of eligibility upon initial application, but shall not be  
7 required to provide proof of eligibility annually;

8 4. United States Armed Forces - such plates shall be designed  
9 for active, retired, former or reserve members of the United States  
10 Armed Forces, and shall identify which branch of service, and carry  
11 the emblem and name of either the Army, Navy, Air Force, Marines or  
12 Coast Guard, according to the branch of service to which the member  
13 belongs or did belong. Former members who have been dishonorably  
14 discharged shall not be eligible for such plates. Persons applying  
15 for such license plate must show proof of present or past military  
16 service by presenting a valid Uniformed Services Identity Card or  
17 the United States Department of Defense Form (DD)214. Retired or  
18 former members who are eligible for such plates shall provide proof  
19 of eligibility upon initial application, but shall not be required  
20 to provide proof of eligibility annually;

21 5. Congressional Medal of Honor Recipient License Plates - such  
22 plates shall be designed for any resident of this state who has been  
23 awarded the Congressional Medal of Honor. Such persons may apply  
24 for a Congressional Medal of Honor recipient license plate for each

1 vehicle with a rated carrying capacity of one (1) ton or less.

2 There shall be no registration fee for the issuance of this plate;

3 6. Missing In Action License Plates - such plates shall be  
4 designed to honor members of the United States Armed Forces who are  
5 missing in action. The spouse of such missing person, if the spouse  
6 has not since remarried, or if remarried, the remarriage is  
7 terminated by death, divorce, or annulment, and each parent of the  
8 missing person may apply for a missing in action license plate upon  
9 presenting proper certification that the person is missing in action  
10 and that the person making the application is the qualifying spouse  
11 or the parent of the missing person. The qualifying spouse and each  
12 parent of the missing person may each apply for the missing in  
13 action license plate for each vehicle with a rated carrying capacity  
14 of one (1) ton or less;

15 7. Purple Heart Recipient License Plates - such plates shall be  
16 designed for any resident of this state presenting proper  
17 certification from the United States Department of Veterans Affairs  
18 or the Armed Forces of the United States certifying that such  
19 resident has been awarded the Purple Heart military decoration.  
20 Such persons may apply for a Purple Heart recipient license plate  
21 for vehicles having a rated carrying capacity of one (1) ton or  
22 less. The surviving spouse of any deceased veteran who has been  
23 awarded the Purple Heart military decoration, if such spouse has not  
24 since remarried, or if remarried, the remarriage has been terminated

1 by death, divorce or annulment, may apply for such plate for one  
2 vehicle with a rated carrying capacity of one (1) ton or less. The  
3 license plate created by this paragraph shall be exempt from the fee  
4 provided by this section for special license plates;

5 8. Pearl Harbor Survivor License Plates - such plates shall be  
6 designed for any resident of this state who can be verified by the  
7 United States Department of Veterans Affairs or the Armed Forces of  
8 the United States as being:

9 a. a member of the United States Armed Forces on December  
10 7, 1941,

11 b. stationed on December 7, 1941, during the hours of  
12 7:55 a.m. to 9:45 a.m. Hawaii time at Pearl Harbor,  
13 the island of Oahu, or offshore at a distance not to  
14 exceed three (3) miles, and

15 c. a recipient of an honorable discharge from the United  
16 States Armed Forces.

17 Such person may apply for a Pearl Harbor Survivor license plate  
18 for each vehicle with a rated carrying capacity of one (1) ton or  
19 less;

20 9. Iwo Jima License Plates - such plates shall be designed for  
21 any resident of this state who can be verified by the United States  
22 Department of Veterans Affairs or the Armed Forces of the United  
23 States as being:  
24

- a. a member of the United States Armed Forces in February of 1945,
- b. stationed in February of 1945 on or in the immediate vicinity of the island of Iwo Jima, and
- c. a recipient of an honorable discharge from the United States Armed Forces.

Such person may apply for an Iwo Jima license plate for each vehicle with a rated carrying capacity of one (1) ton or less.

Such license plate shall have the legend "Oklahoma OK" and shall contain three letters and three numbers. Between the letters and numbers shall be a logo of the flag-raising at Iwo Jima. Below the letters, logo and numbers, the plate shall contain the words "FEB." at the left, "Iwo Jima" in the center and "1945" at the right. Such plates shall not be subject to the design requirements of any other license plates prescribed by law other than the space for the placement of the yearly decals for each succeeding year of registration after the initial issue;

10. D-Day Survivor License Plates - such plates shall be designed for any resident of this state who can be verified by the United States Department of Veterans Affairs or the Armed Forces of the United States as being:

- a. a member of the United States Armed Forces on June 6, 1944,

- 1           b.    a participant in the Allied invasion of the coast of  
2                Normandy on June 6, 1944; provided, if such  
3                participation cannot be verified by the United States  
4                Department of Veterans Affairs or the Armed Forces of  
5                the United States, the Tax Commission may, in its  
6                discretion, accept evidence of such participation from  
7                the person applying for the license plate, and  
8           c.    a recipient of an honorable discharge from the United  
9                States Armed Forces.

10       Such person may apply for a D-Day Survivor license plate for  
11 each vehicle with a rated carrying capacity of one (1) ton or less;

12       11. Killed in Action License Plates - such plates shall be  
13 designed to honor members of the United States Armed Forces who were  
14 killed in action. The spouse of the deceased person, if the spouse  
15 has not remarried, or if remarried, the remarriage is terminated by  
16 death, divorce, or annulment, may apply for a killed in action  
17 license plate upon presenting proper certification that the person  
18 was killed in action and that the person making the application is  
19 the qualifying spouse of the deceased person. The qualifying spouse  
20 may apply for a killed in action license plate for no more than two  
21 vehicles with each vehicle with a rated carrying capacity of one (1)  
22 ton or less. The fee provided by this section for the special  
23 license plate authorized by this paragraph shall be in addition to  
24

1 all other registration fees provided by law, except the registration  
2 fees levied by Section 1132 of this title;

3 12. Gold Star Parents License Plates - such plates shall be  
4 designed to honor members of the United States Armed Forces who were  
5 killed during a war. The parents of the deceased person may apply  
6 for a gold star license plate upon presenting proper certification  
7 that the person was killed during a war and that the person making  
8 the application is the parent of the deceased person. The parent  
9 may apply for a gold star parent license plate for no more than two  
10 vehicles with each vehicle having a rated carrying capacity of one  
11 (1) ton or less. The fee provided by this section for the special  
12 license plate authorized by this paragraph shall be in addition to  
13 all other registration fees provided by law, except the registration  
14 fees levied by Section 1132 of this title;

15 13. Military Decoration License Plates - such plates shall be  
16 designed for any resident of this state who has been awarded the  
17 Distinguished Service Medal, the Distinguished Service Cross, the  
18 Distinguished Flying Cross, the Bronze Star military decoration or  
19 the Silver Star military decoration. Such persons may apply for a  
20 military decoration license plate for each vehicle with a rated  
21 carrying capacity of one (1) ton or less;

22 14. Vietnam Veteran License Plates - such plates shall be  
23 designed for honorably discharged or present members of the United  
24 States Armed Forces who served in the Vietnam Conflict. Such



1 persons may apply for a Vietnam veteran license plate for each  
2 vehicle with a rated carrying capacity of one (1) ton or less;

3 15. Police Officer License Plates - such plates shall be  
4 designed for any currently employed, reserve or retired municipal  
5 police officer or full-time, reserve or retired university police  
6 officer certified by the Council on Law Enforcement Education and  
7 Training or common education police officer certified by the Council  
8 on Law Enforcement Education and Training. Police officers may  
9 apply for police officer license plates for vehicles with a rated  
10 capacity of one (1) ton or less or for a motorcycle upon proof of  
11 employment by or retirement from a municipal, university or common  
12 education police department by either an identification card or  
13 letter from the chief of the police department or the Oklahoma  
14 Police Pension and Retirement Board. Retirees who are eligible for  
15 such plates shall provide proof of eligibility upon initial  
16 application, but shall not be required to provide proof of  
17 eligibility annually. The license plates shall be designed in  
18 consultation with municipal police departments of this state;  
19 provided, the license plate for motorcycles may be of similar design  
20 to the license plate for motor vehicles or may be a new design in  
21 order to meet space requirements for a motorcycle license plate;

22 16. World War II Veteran License Plates - such plates shall be  
23 designed to honor honorably discharged former members of the United  
24 States Armed Forces who are residents of this state and who can be

1 verified by the Oklahoma Military Department, the Department of  
2 Veterans Affairs or the Armed Forces of the United States as having  
3 served on federal active duty anytime during the period from  
4 September 16, 1940, to December 7, 1945. The former members may  
5 apply for a World War II Veteran license plate for vehicles with a  
6 rated carrying capacity of one (1) ton or less.

7 The license plate shall have the legend "Oklahoma" and shall  
8 contain, in the center of the plate, either the Thunderbird Insignia  
9 of the 45th Infantry Division in the prescribed red and gold  
10 coloring or the emblem of the Army, Navy, U.S. Army Air Corps,  
11 Marines or Coast Guard according to the branch of service to which  
12 the member belonged. For the purpose of license plate  
13 identification, the plate shall contain four digits, two digits at  
14 the left and two digits at the right of the insignia or emblem.  
15 Centered on the bottom of the license plate shall be the words  
16 "WORLD WAR II";

17 17. Korean War Veteran License Plates - such plates shall be  
18 designed to honor honorably discharged former members of the United  
19 States Armed Forces who are residents of this state and who can be  
20 verified by the Oklahoma Military Department, the Department of  
21 Veterans Affairs or the Armed Forces of the United States as having  
22 served on federal active duty anytime during the period from June  
23 27, 1950, to January 31, 1955, both dates inclusive. The former  
24

1 members may apply for a Korean War Veteran license plate for  
2 vehicles with a rated carrying capacity of one (1) ton or less.

3 The license plate shall have the legend "OKLAHOMA" and shall  
4 contain, in the center of the plate, either the Thunderbird Insignia  
5 of the 45th Infantry Division in the prescribed red and gold  
6 coloring or the emblem of the Army, Navy, Air Force, Marines or  
7 Coast Guard according to the branch of service to which the member  
8 belonged. For the purpose of license plate identification, the  
9 plate shall contain four digits, two digits at the left and two  
10 digits at the right of the insignia or emblem. Centered on the  
11 bottom of the license plate shall be the word "KOREA";

12 18. Municipal Official License Plates - such plates shall be  
13 designed for persons elected to a municipal office in this state and  
14 shall designate the name of the municipality and the district or  
15 ward in which the municipal official serves. The plates shall only  
16 be produced upon application;

17 19. Red Cross Volunteer License Plates - such plates shall be  
18 designed to honor American Red Cross volunteers and staff who are  
19 residents of this state. Such persons must present an  
20 identification card issued by the American Red Cross and bearing a  
21 photograph of the person. The license plate shall be designed with  
22 the assistance of the American Red Cross and shall have the legend  
23 "Oklahoma OK!" in the color Pantone 186C Red. Below the legend the  
24 symbol of the American Red Cross and no more than three letters and

1 three numbers shall be in the color Pantone 186C Red. Below the  
2 symbol and letters and numbers shall be the words "American Red  
3 Cross" in black. The plates shall not be subject to the design  
4 requirements of any other license plates prescribed by law other  
5 than the space for the placement of the yearly decals for each  
6 succeeding year of registration after the initial issue;

7 20. Desert Storm License Plates - such plates shall be designed  
8 and issued to any honorably discharged or present member of the  
9 United States Armed Forces who served in the Persian Gulf Crisis and  
10 the Desert Storm operation. Such persons may apply for a Desert  
11 Storm license plate for each vehicle with a rated carrying capacity  
12 of one (1) ton or less;

13 21. Military Reserve Unit License Plates - such plates shall be  
14 designed and issued to any honorably discharged or present member of  
15 a reserve unit of the United States Armed Forces. Such persons may  
16 apply for a Military Reserve Unit license plate for each vehicle  
17 with a rated carrying capacity of one (1) ton or less;

18 22. Oklahoma City Bombing Victims and Survivors License Plates  
19 - such plates shall be designed and issued to any victim or survivor  
20 of the bombing attack on the Alfred P. Murrah Federal Building in  
21 downtown Oklahoma City on April 19, 1995;

22 23. Civil Air Patrol License Plates - such plates shall be  
23 designed and issued to any person who is a member of the Civil Air  
24 Patrol. Such persons may apply for a Civil Air Patrol license plate

1 for each vehicle with a rated carrying capacity of one (1) ton or  
2 less upon proof of membership in the Civil Air Patrol. The license  
3 plate shall be designed in consultation with the Civil Air Patrol;

4 24. Ninety-Nines License Plates - such plates shall be designed  
5 and issued to members of the Ninety-Nines. Persons applying for  
6 such license plate must show proof of membership in the Ninety-  
7 Nines. The license plates shall be designed in consultation with  
8 the Ninety-Nines;

9 25. Combat Infantryman Badge License Plates - such plates shall  
10 be designed to honor recipients of the Combat Infantryman Badge.  
11 The plate shall have the legend "Oklahoma OK". Below the legend  
12 shall be the Combat Infantryman Badge and three numbers. Below the  
13 badge and the numbers shall be the words "Combat Infantryman Badge".  
14 Such persons may apply for a Combat Infantryman Badge license plate  
15 for each vehicle with a rated carrying capacity of one (1) ton or  
16 less;

17 26. Somalia Combat Veterans License Plates - such plates shall  
18 be designed and issued to any honorably discharged or present member  
19 of the United States Armed Forces who saw combat in the United  
20 Nations relief effort. Such persons may apply for a Somalia Combat  
21 Veteran license plate for each vehicle with a rated carrying  
22 capacity of one (1) ton or less;

23 27. Police Chaplain License Plates - such plates shall be  
24 designed and issued to members of the International Conference of

1 Police Chaplains (ICPC) who have completed the ICPC requirements for  
2 basic certification as a police chaplain. The license plates shall  
3 be designed in consultation with the ICPC;

4 28. Joint Service Commendation Medal License Plates - such  
5 plates shall be designed and issued to any resident of this state  
6 who has been awarded the Joint Service Commendation Medal by the  
7 United States Secretary of Defense;

8 29. Merchant Marine License Plates - such plates shall be  
9 designed, subject to criteria to be presented to the Tax Commission  
10 by the Oklahoma Department of Veterans Affairs, and issued to any  
11 person who during combat was a member of the Merchant Marines as  
12 certified by the Oklahoma Department of Veterans Affairs. Such  
13 license plate may be issued for each vehicle with a rated carrying  
14 capacity of one (1) ton or less;

15 30. Legislative License Plates - such plates shall be designed  
16 for persons elected to the Oklahoma Legislature and shall designate  
17 the house of the Legislature in which the legislator serves and the  
18 district number;

19 31. Disabled Veterans License Plates - such plates shall be  
20 designed for persons presenting proper certification from the United  
21 States Department of Veterans Affairs or the Armed Forces of the  
22 United States certifying such veteran has a service-connected  
23 disability rating of fifty percent (50%) or more, regardless which  
24 agency pays the disability benefits, or that such veteran has been

1 awarded a vehicle by the United States government or receives a  
2 grant from the United States Department of Veterans Affairs for the  
3 purchase of an automobile due to a service-connected disability  
4 rating or due to the loss of use of a limb or an eye. Such persons  
5 may apply to the Tax Commission for a disabled veterans license  
6 plate or to a motor license agent for a regular license plate for no  
7 more than two vehicles with each vehicle having a rated carrying  
8 capacity of one (1) ton or less. The surviving spouse of any  
9 deceased disabled veteran, if the spouse has not since remarried, or  
10 if remarried, the remarriage is terminated by death, divorce, or  
11 annulment, or a surviving spouse in receipt of Dependency and  
12 Indemnity Compensation from the United States Department of Veterans  
13 Affairs, may apply for a disabled veterans license plate for one  
14 vehicle with a rated carrying capacity of one (1) ton or less. The  
15 fee provided by this section for the special license plate  
16 authorized by this paragraph shall be in addition to all other  
17 registration fees provided by law, except the registration fees  
18 levied by Section 1132 of this title. The total expense of this  
19 license plate shall not exceed Five Dollars (\$5.00).

20 If the person qualifies for a disabled veterans license plate  
21 and is also eligible for a physically disabled placard under the  
22 provisions of Section 15-112 of this title, the person shall be  
23 eligible to receive a disabled veterans license plate that also  
24 displays the international accessibility symbol, which is a stylized

1 human figure in a wheelchair. Upon the death of the disabled  
2 veteran with a disabled veterans license plate with the  
3 international accessibility symbol, the plate shall be returned to  
4 the Tax Commission;

5 32. United States Air Force Association License Plates - such  
6 plates shall be designed for members of the United States Air Force  
7 Association. Persons applying for such license plate must show  
8 proof of membership in the Association. The license plates shall be  
9 designed in consultation with the Association;

10 33. Oklahoma Military Academy Alumni License Plates - such  
11 plates shall be designed and issued to any resident of this state  
12 who is an alumnus of the Oklahoma Military Academy. Such persons  
13 may apply for an Oklahoma Military Academy Alumnus license plate for  
14 each vehicle with a rated carrying capacity of one (1) ton or less.  
15 The license plates shall be designed in consultation with the  
16 Oklahoma Military Academy and shall contain the shield of the  
17 Academy;

18 34. Amateur Radio Operator License Plates - such plates shall  
19 be designed and issued to any person, holding a valid operator's  
20 license, technician class or better, issued by the Federal  
21 Communications Commission, and who is also the owner of a motor  
22 vehicle currently registered in Oklahoma, in which has been  
23 installed amateur mobile transmitting and receiving equipment.  
24 Eligible persons shall be entitled to two special vehicle



1 identification plates as herein provided. Application for such  
2 identification plates shall be on a form prescribed by the Tax  
3 Commission and the plates issued to such applicant shall have  
4 stamped thereon the word "Oklahoma" and bear the official call  
5 letters of the radio station assigned by the Federal Communications  
6 Commission to the individual amateur operator thereof. All  
7 applications for such plates must be made to the Tax Commission on  
8 or before the first day of October of any year for such plates for  
9 the following calendar year and must be accompanied by the fee  
10 required in this section together with a certificate, or such other  
11 evidence as the Tax Commission may require, of proof that applicant  
12 has a valid technician class or better amateur operator's license  
13 and proof of applicant's ownership of a vehicle in which radio  
14 receiving and transmitting equipment is installed. Applicants shall  
15 only be entitled to one set of special identification plates in any  
16 one (1) year, and such calendar year shall be stamped thereon. The  
17 right to such special identification plates herein provided for  
18 shall continue until the amateur radio operator's license of the  
19 person to whom such plates are issued expires or is revoked;

20 35. American Legion License Plates - such plates shall be  
21 designed for members of the American Legion. Persons applying for  
22 such license plate must show proof of membership. The license  
23 plates shall be designed in consultation with the American Legion of  
24 Oklahoma;

1        36. Deputy Sheriff License Plates - such plates shall be  
2 designed for any currently employed or retired county sheriff or  
3 deputy sheriff. County sheriffs or deputy sheriffs may apply for  
4 such plates for vehicles with a rated capacity of one (1) ton or  
5 less upon proof of employment by or retirement from a county  
6 sheriff's office by either an identification card or letter from the  
7 county sheriff or a government-sponsored retirement board from which  
8 the county sheriff or deputy sheriff may be receiving a pension.  
9 Retirees who are eligible for such plates shall provide proof of  
10 eligibility upon initial application, but shall not be required to  
11 provide proof of eligibility annually. The license plates shall be  
12 designed in consultation with the county sheriff offices of this  
13 state;

14        37. Gold Star Surviving Spouse License Plates - such plates  
15 shall be designed to honor the surviving spouses and children of  
16 qualified veterans. As used in this paragraph, "qualified veteran"  
17 shall mean:

- 18            a. any person honorably discharged from any branch of the  
19                United States Armed Forces or as a member of the  
20                Oklahoma National Guard, who died as a direct result  
21                of the performance of duties for any branch of the  
22                United States Armed Forces or Oklahoma National Guard  
23                while on active military duty, or  
24

1           b.   any person honorably discharged from any branch of the  
2               United States Armed Forces or as a member of the  
3               Oklahoma National Guard, who died as a result of  
4               injury, illness or disease caused by the performance  
5               of such duties while on active duty, whether the death  
6               occurred while on active duty or after the honorable  
7               discharge of such person.

8           The fee provided by this section for the special license plate  
9           authorized by this paragraph shall be in addition to all other  
10          registration fees provided by law, except the registration fees  
11          levied by Section 1132 of this title;

12          38.   Korea Defense Service Medal License Plates - such plates  
13          shall be designed and issued to any resident of this state who has  
14          been awarded the Korea Defense Service Medal by the United States  
15          Secretary of Defense.   Such persons may apply for a Korea Defense  
16          Service Medal license plate for each vehicle with a rated carrying  
17          capacity of one (1) ton or less;

18          39.   180th Infantry License Plates - such plates shall be  
19          designed for members and prior members of the 180th Infantry.  
20          Persons applying for such license plate must obtain and provide  
21          proof of their membership from the 180th Infantry Association.   The  
22          license plates shall be designed in consultation with the 180th  
23          Infantry;

1        40.    Operation Iraqi Freedom Veteran License Plates - such  
2 plates shall be designed and issued to any honorably discharged or  
3 present member of the United States Armed Forces who served in  
4 Operation Iraqi Freedom.    Such person may apply for an Operation  
5 Iraqi Freedom Veteran license plate for each vehicle with a rated  
6 carrying capacity of one (1) ton or less, or for a motorcycle;  
7 provided, the license plate for motorcycles may be of similar design  
8 to the license plate for motor vehicles or may be a new design in  
9 order to meet space requirements for a motorcycle license plate;

10       41.    United States Air Force Academy Alumni License Plates -  
11 such plates shall be designed and issued to any resident of this  
12 state who is an alumnus of the United States Air Force Academy.  
13 Such persons may apply for a United States Air Force Academy Alumnus  
14 license plate for each vehicle with a rated carrying capacity of one  
15 (1) ton or less;

16       42.    Operation Enduring Freedom Veteran License Plate - such  
17 plates shall be designed and issued to any honorably discharged or  
18 present member of the United States Armed Forces who served in  
19 Operation Enduring Freedom on or after September 11, 2001.    The  
20 license plate shall be designed in consultation with the Military  
21 Department of the State of Oklahoma.    Such person may apply for an  
22 Operation Enduring Freedom Veteran license plate for each vehicle  
23 with a rated carrying capacity of one (1) ton or less, or for a  
24 motorcycle; provided, the license plate for motorcycles may be of

1 similar design to the license plate for motor vehicles or may be a  
2 new design in order to meet space requirements for a motorcycle  
3 license plate;

4 43. Military Multi-Decoration License Plate - such plates shall  
5 be designed and issued to any honorably discharged or present member  
6 of the United States Armed Forces who qualifies for more than one  
7 military decoration license plate pursuant to the provisions of this  
8 section. The Tax Commission shall develop and implement a system  
9 whereby the designs of the eligible license plates can be included  
10 together on a single license plate. Such person may apply for a  
11 Military Multi-Decoration license plate for each vehicle with a  
12 rated carrying capacity of one (1) ton or less;

13 44. Global War on Terror Expeditionary License Plate - such  
14 plates shall be designed and issued to any honorably discharged or  
15 present member of the United States Armed Forces who has earned a  
16 Global War on Terror Expeditionary decoration. The license plate  
17 shall be designed in consultation with the United States Institute  
18 of Heraldry and the Military Department of the State of Oklahoma.  
19 Such person may apply for a Global War on Terror Expeditionary  
20 license plate for each vehicle with a rated carrying capacity of one  
21 (1) ton or less;

22 45. Legion of Merit Medal Recipient License Plates - such  
23 plates shall be designed for any resident of this state presenting  
24 proper certification from the United States Department of Veterans

1 Affairs or the Armed Forces of the United States certifying that  
2 such resident has been awarded the Legion of Merit military  
3 decoration. Such persons may apply for a Legion of Merit recipient  
4 license plate for vehicles having a rated carrying capacity of one  
5 (1) ton or less. The license plate shall be designed in  
6 consultation with the Military Department of the State of Oklahoma;

7 46. 1-179th License Plates - such plates shall be designed for  
8 members, prior members and members of the household of a member or  
9 former member of the 1-179th Infantry. Persons applying for such  
10 license plate must obtain and provide proof of their membership  
11 association with the 1-179th Infantry Association. The license  
12 plate shall be designed in consultation with the 1-179th Infantry;

13 47. 2-179th License Plates - such plates shall be designed for  
14 members, prior members and members of the household of a member or  
15 former member of the 2-179th Infantry. Persons applying for such  
16 license plate must obtain and provide proof of their membership  
17 association with the 2-179th Infantry Association. The license  
18 plate shall be designed in consultation with the 2-179th Infantry;

19 48. Combat Action Ribbon Recipient License Plates - such plates  
20 shall be designed to honor recipients of the Combat Action Ribbon  
21 who present proper certification from the United States Department  
22 of the Navy. The license plate shall include the Combat Action  
23 Ribbon earned by the recipient. Such persons may apply for a Combat  
24

1 Action Ribbon Recipient license plate for vehicles having a rated  
2 carrying capacity of one (1) ton or less;

3 49. Oklahoma Submarine Veterans License Plate - such plates  
4 shall be designed for any resident of this state who is a United  
5 States submarine veteran and presents either a Department of Defense  
6 form 214 or other documentation certifying such service. Such  
7 persons may apply for an Oklahoma Submarine Veterans license plate  
8 for vehicles having a rated capacity of one (1) ton or less. The  
9 license plate design shall include both gold and silver dolphins to  
10 represent both officer and enlisted service members;

11 50. United States Navy Seabees and Civil Engineer Corps License  
12 Plate - such plates shall be designed and issued to any honorably  
13 discharged or present member of the United States Navy Seabees or  
14 Civil Engineer Corps. Such persons may apply for a United States  
15 Navy Seabees and Civil Engineer Corps license plate for vehicles  
16 having a rated carrying capacity of one (1) ton or less. The  
17 license plate shall be designed in consultation with the Military  
18 Department of the State of Oklahoma;

19 51. Combat Action Badge Recipient License Plate - such plates  
20 shall be designed to honor recipients of the Combat Action Badge who  
21 present proper certification from the United States Army. The  
22 license plate shall include the Combat Action Badge earned by the  
23 recipient. Such persons may apply for a Combat Action Badge  
24 Recipient license plate for vehicles having a rated carrying

1 capacity of one (1) ton or less, or for a motorcycle; provided, the  
2 license plate for motorcycles may be of similar design to the  
3 license plate for motor vehicles or may be a new design in order to  
4 meet space requirements for a motorcycle license plate;

5 52. Iraq Combat Veteran License Plate - such plates shall be  
6 designed and issued to any honorably discharged or present member of  
7 the United States Armed Forces who saw combat in Operation Iraqi  
8 Freedom. Such persons may apply for an Iraq Combat Veteran license  
9 plate for each vehicle with a rated carrying capacity of one (1) ton  
10 or less, or for a motorcycle; provided, the license plate for  
11 motorcycles may be of similar design to the license plate for motor  
12 vehicles or may be a new design in order to meet space requirements  
13 for a motorcycle license plate;

14 53. Afghanistan Combat Veteran License Plate - such plates  
15 shall be designed and issued to any honorably discharged or present  
16 member of the United States Armed Forces who saw combat in Operation  
17 Enduring Freedom. Such persons may apply for an Afghanistan Combat  
18 Veteran license plate for each vehicle with a rated carrying  
19 capacity of one (1) ton or less, or for a motorcycle; provided, the  
20 license plate for motorcycles may be of similar design to the  
21 license plate for motor vehicles or may be a new design in order to  
22 meet space requirements for a motorcycle license plate; and

23 54. Special Forces Association - such plates shall be designed  
24 and issued to any honorably discharged or present member of the Army



1 Special Forces qualified and authorized to wear upon the person's  
2 United States military uniform the Army Special Forces Tab. Persons  
3 applying for the Special Forces Association license plate must  
4 provide a copy of the orders awarding the Special Forces Tab or  
5 authorizing its wear upon a United States military uniform. The  
6 license plate shall be designed in consultation with the Special  
7 Forces Association, Chapter 32-50. The Tax Commission shall produce  
8 up to two distinct designs for the Special Forces Association  
9 license plate. Qualified persons may select one design at the time  
10 of application. The plates shall be issued to any qualified person  
11 in any combination of numbers and letters from one to a maximum of  
12 seven, as for personalized license plates.

13 C. Unless otherwise provided by this section, the fee for such  
14 plates shall be Eight Dollars (\$8.00) and shall be in addition to  
15 all other registration fees provided by the Oklahoma Vehicle License  
16 and Registration Act. Such fees shall be deposited in the Oklahoma  
17 Tax Commission Reimbursement Fund to be used for the administration  
18 of the Oklahoma Vehicle License and Registration Act.

19 SECTION 5. AMENDATORY 47 O.S. 2011, Section 1135.3, as  
20 last amended by Section 2, Chapter 434, O.S.L. 2019 (47 O.S. Supp.  
21 2020, Section 1135.3), is amended to read as follows:

22 Section 1135.3. A. The Oklahoma Tax Commission is hereby  
23 authorized to design and issue appropriate official special license  
24 plates to persons wishing to demonstrate support, interest, or

1 membership to or for an organization, occupation, cause or other  
2 subject as provided by this section.

3 Special license plates shall not be transferred to any other  
4 person but shall be removed from the vehicle upon transfer of  
5 ownership and retained. The special license plate may then be used  
6 on another vehicle but only after such other vehicle has been  
7 registered for the current year.

8 Special license plates shall be renewed each year by the Tax  
9 Commission or a motor license agent, unless authorized by the Tax  
10 Commission to be renewed for a period greater than one (1) year.  
11 The Tax Commission shall notify by mail all persons issued special  
12 license plates. The notice shall contain all necessary information  
13 and shall contain instructions for the renewal procedure upon  
14 presentation to a motor license agent or the Tax Commission. The  
15 license plates shall be issued on a staggered system.

16 On and after January 1, 2022, if a special license plate is  
17 issued pursuant to this section, any registration fee required for  
18 such plate pursuant to this section and the fee required pursuant to  
19 Section 1132 of this title shall be remitted at the same time and  
20 subject to a single registration period. The Oklahoma Tax  
21 Commission shall determine, by rule, a method for making required  
22 fee and registration period adjustments if a special license plate  
23 is obtained during a twelve-month period for which a registration  
24 fee has already been remitted pursuant to Section 1132 of this

1 title. The combination of fees in a single remittance shall not  
2 alter the apportionment otherwise provided for in this section.

3 The Tax Commission is hereby directed to develop and implement a  
4 system whereby motor license agents are permitted to accept  
5 applications for special license plates authorized under this  
6 section. The motor license agent shall confirm the applicant's  
7 eligibility, if applicable, collect and deposit any amount  
8 specifically authorized by law, accept and process the necessary  
9 information directly into such system and generate a receipt  
10 accordingly. For performance of these duties, motor license agents  
11 shall retain the fee provided in Section 1141.1 of this title for  
12 registration of a motor vehicle. The motor license agent fees for  
13 acceptance of applications and renewals shall be paid out of the  
14 Oklahoma Tax Commission Reimbursement Fund.

15 If fewer than one hundred of any type of special license plates  
16 authorized prior to January 1, 2004, are issued prior to January 1,  
17 2006, the Tax Commission shall discontinue issuance and renewal of  
18 that type of special license plate. Any such authorized special  
19 license plate registrant shall be allowed to display the license  
20 plate upon the designated vehicle until the registration expiration  
21 date. After such time the expired special license plate shall be  
22 removed from the vehicle.

23 Except as otherwise provided in law, for special license plates  
24 authorized on or after July 1, 2004, no special license plates shall

1 be developed or issued by the Tax Commission until the Commission  
2 receives one hundred (100) prepaid applications therefor. The  
3 prepaid applications must be received by the Tax Commission within  
4 one hundred eighty (180) days of the effective date of the  
5 authorization or the authority to issue shall be null and void. In  
6 the event one hundred (100) prepaid applications are not received by  
7 the Tax Commission within such prescribed time period any payment so  
8 received shall be refunded accordingly.

9 B. The special license plates provided by this section are as

1 a Masonic Fraternity of Oklahoma. Such persons may apply for a  
2 Masonic Fraternity license plate for each vehicle with a rated  
3 carrying capacity of one (1) ton or less upon proof of a Masonic  
4 Fraternity membership or upon the presentment of an application for  
5 a Masonic Fraternity license plate authorized and approved by the  
6 Grand Lodge of Oklahoma. The license plates shall be designed in  
7 consultation with the Masonic Fraternities of Oklahoma and shall  
8 contain the Masonic emblem;

9 5. Shriner's Hospitals for Burned and Crippled Children License  
10 Plate - such plates shall be designed to demonstrate support for  
11 Shriner's Hospitals for Burned and Crippled Children and shall be  
12 issued to any resident of this state who is a member of a Shriner's  
13 Temple in Oklahoma. The license plate shall be designed in  
14 consultation with the Shriner's Temples in Oklahoma and shall  
15 contain the Shriner's emblem;

16 6. Balloonists License Plate - such plates shall be designed  
17 and issued to any person wishing to demonstrate support for hot air  
18 ballooning in this state;

19 7. Order of the Eastern Star License Plate - such plates shall  
20 be designed and issued to any resident of this state who is a member  
21 of an Order of the Eastern Star. Such persons may apply for an  
22 Order of the Eastern Star license plate for each vehicle with a  
23 rated carrying capacity of one (1) ton or less upon proof of an  
24 Order of the Eastern Star membership or upon the presentment of an

1 application for an Order of the Eastern Star license plate  
2 authorized and approved by the organization. The license plate  
3 shall be designed in consultation with the Order of the Eastern Star  
4 and shall contain the Order of the Eastern Star emblem;

5 8. Knights of Columbus License Plate - such plates shall be  
6 designed and issued to any resident of this state who is a member of  
7 the Knights of Columbus. Such persons may apply for a Knights of  
8 Columbus license plate for each vehicle with a rated carrying  
9 capacity of one (1) ton or less upon proof of a Knights of Columbus  
10 membership or upon the presentment of an application for a Knights  
11 of Columbus license plate authorized and approved by the  
12 organization. The license plate shall be designed in consultation  
13 with the Knights of Columbus and shall contain the Knights of  
14 Columbus emblem;

15 9. Jaycees License Plate - such plates shall be designed and  
16 issued to members of the Jaycees. Persons applying for such license  
17 plate must show proof of membership in the Jaycees. The license  
18 plates shall be designed in consultation with the Jaycees;

19 10. Kiwanis International License Plate - such plates shall be  
20 designed and issued to members of Kiwanis International. Persons  
21 applying for such license plate must show proof of membership in  
22 Kiwanis International. The license plates shall be designed in  
23 consultation with Kiwanis International;

24

1        11. Certified Public Accountants License Plate - such plates  
2 shall be designed and issued to any resident of this state who is a  
3 Certified Public Accountant. Such persons may apply for a Certified  
4 Public Accountant license plate for each vehicle with a rated  
5 carrying capacity of one (1) ton or less upon proof of status as a  
6 Certified Public Accountant. The license plates shall be designed  
7 in consultation with the Oklahoma Society of Certified Public  
8 Accountants;

9        12. Civil Emergency Management License Plate - such plates  
10 shall be designed and issued to persons wishing to demonstrate  
11 support for the state civil emergency management system. Persons  
12 applying for such license plate must show proof of official  
13 affiliation by presenting a nonexpired proof of employment,  
14 affiliation or retirement in the form of an identification card or  
15 letter on official letterhead from a municipal, county or state  
16 emergency management department head;

17        13. Civilian Conservation Corps License Plate - such plates

5 plates shall be designed in consultation with the five Rotarian

7 15. Benevolent Protective Order of Elks License Plate - such  
8 plates shall be designed, subject to criteria to be presented to the  
9 Tax Commission, by the Benevolent Protective Order of Elks, and  
10 issued to any resident of this state who is a member of the  
11 Benevolent Protective Order of Elks;

12 16. Humane Society License Plate - such plates shall be  
13 designed and issued to any person wishing to demonstrate support for  
14 the Humane Society of the United States. The plates shall be issued  
15 to any person in any combination of numbers and letters from one to  
16 a maximum of seven, as for personalized license plates. The plate  
17 shall contain the official Humane Society logo;

18 17. Oklahoma Mustang Club License Plate - such plates shall be  
19 designed, subject to criteria to be presented to the Tax Commission,  
20 by the Oklahoma Mustang Club, and issued to any resident of this  
21 state who is a member of the Oklahoma Mustang Club. Such persons  
22 may apply for an Oklahoma Mustang Club license plate upon  
23 presentment of proof of membership in the Oklahoma Mustang Club.

11 for the Millwood School District. The license plate shall be  
12 designed in consultation with representatives of the Millwood School  
13 District;

14       63. Booker T. Washington High School License Plate - such  
15 plates shall be issued to persons wishing to demonstrate support for  
16 Booker T. Washington High School and shall be designed in  
17 consultation with the Booker T. Washington High School National  
18 Alumni Association;

19       64. Oklahoma Current State Flag License Plate - such plates  
20 shall be designed to include the current Oklahoma state flag and  
21 issued to any person wishing to demonstrate support for the current  
22 Oklahoma state flag. The plates shall be designed in consultation  
23 with the Friends of the Oklahoma History Center;

1        65. Oklahoma Original State Flag License Plate - such plates  
2 shall be designed to include the original Oklahoma state flag and  
3 issued to any person wishing to demonstrate support for the original  
4 Oklahoma state flag. The plates shall be designed in consultation  
5 with the Friends of the Oklahoma History Center. The plates shall  
6 be issued to any person in any combination of numbers and letters  
7 from one to a maximum of seven, as for personalized plates. Subject  
8 to the provisions of subsection A of this section, the Oklahoma  
9 Original State Flag license plate is hereby reauthorized effective  
10 November 1, 2015;

11        66. Tulsa 66ers License Plate - such plates shall be designed  
12 and issued to any person wishing to demonstrate support for the  
13 Tulsa 66ers. The plates shall be designed in consultation with the  
14 Tulsa 66ers Organization;

15        67. Frederick Bombers License Plate - such plates shall be  
16 issued to persons wishing to demonstrate support for the Frederick  
17 School District and shall be designed in consultation with  
18 representatives of the Frederick School District;

19        68. 911 Dispatcher License Plate - such plates shall be issued  
20 to persons wishing to demonstrate support for 911 dispatchers.  
21 Persons applying for such license plate must show proof of current  
22 employment as a 911 dispatcher or sign an attestation that they are  
23 a currently employed or retired 911 dispatcher;

1        69. Oklahoma Fosters License Plate - such plates shall be  
2 issued to persons wishing to demonstrate support for the Oklahoma  
3 Fosters Initiative and shall be designed in consultation with the  
4 Oklahoma Fosters Initiative;

5        70. Red Dirt Jeeps License Plate - such plates shall be  
6 designed and issued to any person wishing to demonstrate support for  
7 Red Dirt Jeeps and such plates shall be designed in consultation  
8 with Red Dirt Jeeps, L.L.C.;

9        71. Sons of the American Revolution License Plate - such plates  
10 shall be issued to persons wishing to demonstrate support for the  
11 Sons of the American Revolution for a vehicle or motorcycle in any  
12 combination of numbers and letters from one to a maximum of seven,  
13 as for personalized plates. Such plates shall be designed in  
14 consultation with the Oklahoma Society of the Sons of the American  
15 Revolution. The license plate for a motorcycle may be of similar  
16 design as space permits or a new design in order to meet the space  
17 requirements of a motorcycle license plate;

18        72. Daughters of the American Revolution License Plate - such  
19 plates shall be issued to persons wishing to demonstrate support for  
20 the Daughters of the American Revolution for a vehicle or motorcycle  
21 in any combination of numbers and letters from one to a maximum of  
22 seven, as for personalized plates. Such plates shall be designed in  
23 consultation with the Oklahoma Society of the Daughters of the  
24 American Revolution. The license plate for a motorcycle may be of

1 similar design as space permits or a new design in order to meet the  
2 space requirements of a motorcycle license plate;

3 73. Air Medal License Plate - such plates shall be designed and  
4 issued to Air Medal recipients. An individual requesting the plate  
5 is required, at the time of application, to show proof he or she is  
6 a recipient of the Air Medal or sign an attestation stating that he  
7 or she is a medal recipient. The plates shall be designed to  
8 include the Air Medal emblem and shall include the words "Air Medal"  
9 on the plate;

10 74. Oklahoma Institute for Child Advocacy License Plate - such  
11 plates shall be designed and issued to any person wishing to  
12 demonstrate support for the Oklahoma Institute for Child Advocacy.  
13 The plates shall be issued to any person in any combination of  
14 numbers and letters from one to a maximum of seven, as for  
15 personalized license plates. The plates shall contain the official  
16 Oklahoma Institute for Child Advocacy logo;

17 75. The Pride of Oklahoma Marching Band License Plate - such  
18 plates shall be designed and issued to any person wishing to  
19 demonstrate support for the Pride of Oklahoma marching band. The  
20 plates shall be designed in consultation with the University of  
21 Oklahoma;

22 76. The Spirit of Oklahoma State Marching Band License Plate -  
23 such plates shall be designed and issued to any person wishing to  
24 demonstrate support for the Spirit of Oklahoma State marching band.

1 The plates shall be designed in consultation with Oklahoma State  
2 University;

3 77. Southeast Spartans License Plate - such plates shall be  
4 designed and issued to any person wishing to demonstrate support for  
5 Southeast High School Spartans and such plates shall be designed in  
6 consultation with the Southeast High School Alumni Association;

7 78. Catoosa High School License Plate - such plates shall be  
8 designed and issued to any person wishing to demonstrate support for  
9 Catoosa High School located in Catoosa. The plates shall bear the  
10 image of the Catoosa High School mascot and be designed in  
11 consultation with representatives of Catoosa High School;

12 79. Toastmasters International License Plate - such plates  
13 shall be issued to persons wishing to demonstrate support for  
14 Toastmasters International and shall be designed in consultation  
15 with District 16 of Toastmasters International;

16 80. Millwood High School Alumni License Plate - such plates  
17 shall be designed and issued to any person wishing to demonstrate  
18 support for Millwood High School Alumni. The license plate shall be  
19 designed in consultation with representatives of the Millwood High  
20 School Alumni Association;

21 81. Patriot Guard Riders License Plate - such plates shall be  
22 issued to persons wishing to demonstrate support for Patriot Guard  
23 Riders and shall be designed in consultation with the Patriot Guard  
24 Riders of Oklahoma; and

1        82. Bixby School District License Plate - such plates shall be  
2 designed and issued to any person wishing to demonstrate support for  
3 the Bixby School District. The license plate shall be designed in  
4 consultation with representatives of the Bixby School District.

5        C. The fee for such plates shall be Fifteen Dollars (\$15.00)  
6 per year of renewal and shall be in addition to all other  
7 registration fees provided by the Oklahoma Vehicle License and  
8 Registration Act. Unless otherwise provided in this section, the  
9 fee shall be apportioned as follows: Eight Dollars (\$8.00) per year  
10 of renewal of the special license plate fee shall be deposited in  
11 the Oklahoma Tax Commission Reimbursement Fund to be used for the  
12 administration of the Oklahoma Vehicle License and Registration Act  
13 and the remaining Seven Dollars (\$7.00) per year of renewal of the  
14 special license plate fee shall be apportioned as provided in  
15 Section 1104 of this title.

16        SECTION 6.        AMENDATORY        47 O.S. 2011, Section 1135.4, as  
17 amended by Section 3, Chapter 69, O.S.L. 2018 (47 O.S. Supp. 2020,  
18 Section 1135.4), is amended to read as follows:

19        Section 1135.4. A. The Oklahoma Tax Commission is hereby  
20 authorized to design and issue personalized license plates. The  
21 personalized license plates shall be issued on a staggered system  
22 except for vintage decals.

23        Personalized special license plates shall not be transferred to  
24 any other person but shall be removed from the vehicle upon transfer

1 of ownership and retained. The personalized special license plate  
2 may then be used on another vehicle but only after such other  
3 vehicle has been registered for the current year.

4 Personalized special license plates shall be renewed each year  
5 by the Tax Commission or a motor license agent, unless authorized by  
6 the Tax Commission to be renewed for a period greater than one (1)  
7 year. The Tax Commission shall notify by mail all persons issued  
8 special license plates. The notice shall contain all necessary  
9 information and shall contain instructions for the renewal procedure  
10 upon presentation to a motor license agent or the Tax Commission.  
11 The motor license agent fees for renewals shall be paid out of the  
12 Oklahoma Tax Commission Reimbursement Fund.

13 On and after January 1, 2022, if a personalized license plate is  
14 issued pursuant to this section, any registration fee required for  
15 such plate pursuant to this section and the fee required pursuant to  
16 Section 1132 of this title shall be remitted at the same time and  
17 subject to a single registration period. The Oklahoma Tax  
18 Commission shall determine, by rule, a method for making required  
19 fee and registration period adjustments if a special license plate  
20 is obtained during a twelve-month period for which a registration  
21 fee has already been remitted pursuant to Section 1132 of this  
22 title. The combination of fees in a single remittance shall not  
23 alter the apportionment otherwise provided for in this section.

24 B. Such plates shall be designed and issued for the following:



1        1. Any person in any combination of numbers or letters from one  
2 to a maximum of seven;

3        2. Persons eligible for two or more of the military decoration  
4 special license plates provided for in this title. Such plates may  
5 be issued in any combination of emblems. However, such plates shall  
6 only display up to three emblems and shall also display any  
7 combination of letters or numbers from one to a maximum of three;

8        3. Motorcycles in any combination of numbers or letters from  
9 one to a maximum of six;

10       4. Persons eligible for Korean War Veteran license plates  
11 provided for in this title. Such plates may display any combination  
12 of letters or numbers up to three on each side of the insignia or  
13 emblem;

14       5. Persons eligible for World War II Veteran license plates  
15 provided for in this title. Such plates may display any combination  
16 of letters or numbers up to three on each side of the insignia or  
17 emblem; and

18       6. Persons owning vehicles which are twenty-one (21) years and  
19 older are qualified to submit for approval by the Tax Commission or  
20 a motor license agent a vintage but expired official Oklahoma  
21 license plate which is twenty-one (21) years and older. Upon  
22 approval of such personalized plate, the owner shall be issued the  
23 annual registration decal which the Tax Commission or agent shall  
24 direct to be affixed.

1 C. The fee for such plates shall be Twenty Dollars (\$20.00) per  
2 year of renewal and shall be in addition to all other registration  
3 fees provided by the Oklahoma Vehicle License and Registration Act.  
4 Eight Dollars (\$8.00) per year of renewal of the personalized tag  
5 fee shall be deposited in the Oklahoma Tax Commission Reimbursement  
6 Fund to be used for the administration of the Oklahoma Vehicle  
7 License and Registration Act. Twelve Dollars (\$12.00) per year of  
8 renewal of the personalized tag fee shall be apportioned as provided  
9 in Section 1104 of this title.

10 SECTION 7. AMENDATORY 47 O.S. 2011, Section 1135.5, as  
11 last amended by Section 3, Chapter 434, O.S.L. 2019 (47 O.S. Supp.  
12 2020, Section 1135.5), is amended to read as follows:

13 Section 1135.5. A. The Oklahoma Tax Commission is hereby  
14 authorized to design and issue appropriate official special license  
15 plates to persons wishing to demonstrate support and provide  
16 financial assistance as provided by this section.

17 Special license plates shall not be transferred to any other  
18 person but shall be removed from the vehicle upon transfer of  
19 ownership and retained. The special license plate may then be used  
20 on another vehicle but only after such other vehicle has been  
21 registered for the current year with a motor license agent.

22 Special license plates shall be renewed each year by the Tax  
23 Commission or a motor license agent, unless authorized by the Tax  
24 Commission to be renewed for a period greater than one (1) year.

1 The Tax Commission shall notify by mail all persons issued special  
2 license plates. The notice shall contain all necessary information  
3 and shall contain instructions for the renewal procedure upon  
4 presentation to a motor license agent or the Tax Commission. The  
5 license plates shall be issued on a staggered system.

6 On and after January 1, 2022, if a special license plate is  
7 issued pursuant to this section, any registration fee required for  
8 such plate pursuant to this section and the fee required pursuant to  
9 Section 1132 of this title shall be remitted at the same time and  
10 subject to a single registration period. The Oklahoma Tax  
11 Commission shall determine, by rule, a method for making required  
12 fee and registration period adjustments if a special license plate  
13 is obtained during a twelve-month period for which a registration  
14 fee has already been remitted pursuant to Section 1132 of this  
15 title. The combination of fees in a single remittance shall not  
16 alter the apportionment otherwise provided for in this section.

17 The Tax Commission is hereby directed to develop and implement a  
18 system whereby motor license agents are permitted to accept  
19 applications for special license plates authorized under this  
20 section. The motor license agent shall confirm the applicant's  
21 eligibility, if applicable, collect and deposit any amount  
22 specifically authorized by law, accept and process the necessary  
23 information directly into such system and generate a receipt  
24 accordingly. For performance of these duties, motor license agents

1 shall retain the fee provided in Section 1141.1 of this title for  
2 registration of a motor vehicle. The motor license agent fees for  
3 acceptance of applications and renewals shall be paid out of the  
4 Oklahoma Tax Commission Reimbursement Fund.

5 If fewer than one hundred of any type of special license plates  
6 authorized prior to January 1, 2004, are issued prior to January 1,  
7 2006, the Tax Commission shall discontinue issuance and renewal of  
8 that type of special license plate. Any such authorized special  
9 license plate registrant shall be allowed to display the license  
10 plate upon the designated vehicle until the registration expiration  
11 date. After such time the expired special license plate shall be  
12 removed from the vehicle.

13 For special license plates authorized on or after July 1, 2004,  
14 no special license plates shall be developed or issued by the Tax  
15 Commission until the Commission receives one hundred prepaid  
16 applications therefor. The prepaid applications must be received by  
17 the Tax Commission within one hundred eighty (180) days of the  
18 effective date of the authorization or the authority to issue shall  
19 be null and void. In the event one hundred prepaid applications are  
20 not received by the Tax Commission within such prescribed time  
21 period any payment so received shall be refunded accordingly.

22 B. The special license plates provided by this section are as  
23 follows:  
24

1        1. University or College Supporter License Plate - such plates  
2 shall be designed and issued to any person wishing to demonstrate  
3 support to any state-supported or private university or college. As  
4 provided in this section, an amount of the fee collected shall be  
5 apportioned as provided in Section 1104.1 of this title;

6        2. Environmental Awareness License Plate - such plates shall be  
7 designed, subject to the criteria to be presented to the Tax  
8 Commission by the Department of Environmental Quality in  
9 consultation with the Oklahoma Arts Council, and issued to any  
10 person wishing to demonstrate support to implement the statewide  
11 general public environmental education program created pursuant to  
12 the provisions of the Oklahoma Environmental Quality Code. Such  
13 plates shall be designed and issued to any person in any combination  
14 of numbers and letters from one to a maximum of seven, as for  
15 personalized license plates. A dealer's license plate issued  
16 pursuant to Section 1116.1 or 1128 of this title may be designated  
17 an Environmental Awareness License Plate upon payment of the fee  
18 imposed by this section and any other registration fees required by  
19 the Oklahoma Vehicle License and Registration Act. As provided in  
20 this section, an amount of the fee collected shall be apportioned  
21 pursuant to Section 1104.2 of this title;

22        3. Firefighter License Plate - such plates shall be designed  
23 for any career or retired firefighter, volunteer or paid.  
24 Firefighters may apply for firefighter plates for up to four

1 vehicles with a rated capacity of one (1) ton or less or for a  
2 motorcycle upon proof of a fire department membership by either an  
3 identification card or letter from the chief of the fire department.  
4 Retirees who are eligible for such plates shall provide proof of  
5 eligibility upon initial application, but shall not be required to  
6 provide proof of eligibility annually. The surviving spouse of any  
7 deceased firefighter, if the spouse has not since remarried, may  
8 apply for a firefighter license plate for one vehicle with a rated  
9 carrying capacity of one (1) ton or less or for a motorcycle upon  
10 proof that the deceased firefighter was a member of a fire  
11 department by either an identification card or letter from the chief  
12 of the fire department. The license plate shall be designed in  
13 consultation with the Oklahoma Firefighters Association.

14 As provided in this section, an amount of the fee collected  
15 shall be deposited to the Oklahoma State Firemen's Museum Building &  
16 Memorial Fund for support of the Oklahoma Firefighters Museum and  
17 the Oklahoma Fallen and Living Firefighters Memorial;

18 4. Wildlife Conservation License Plate - such plates shall be  
19 designed, subject to the criteria to be presented to the Tax  
20 Commission by the Oklahoma Department of Wildlife Conservation in  
21 consultation with the Oklahoma Arts Council, and issued to any  
22 person wishing to demonstrate support for wildlife conservation in  
23 this state through the Wildlife Diversity Fund, provided for in  
24 Section 3-310 of Title 29 of the Oklahoma Statutes. Such plates may

1 be designed and issued to any person as for personalized license  
2 plates.

3 As provided in this section, an amount of the fee collected  
4 shall be apportioned pursuant to subsection D of Section 3-310 of  
5 Title 29 of the Oklahoma Statutes;

6 5. Child Abuse Prevention License Plate - such plates shall be  
7 designed, subject to the criteria to be presented to the Tax  
8 Commission by the Office of Child Abuse Prevention in the State  
9 Department of Health and the Oklahoma Committee to Prevent Child  
10 Abuse, and issued to any person wishing to demonstrate support for  
11 the prevention of child abuse.

12 As provided in this section, an amount of the fee collected  
13 shall be deposited in the Child Abuse Prevention Fund;

14 6. United States Olympic Committee Supporter License Plate -  
15 such plates shall be designed and issued to any person wishing to  
16 demonstrate support for the United States Olympic Committee. The  
17 plates shall be issued to any person in any combination of numbers  
18 and letters from one to a maximum of seven, as for personalized  
19 license plates. The plate shall contain the official United States  
20 Olympic Committee logo. The Tax Commission shall be authorized, if  
21 necessary, to enter into a licensing agreement with the United  
22 States Olympic Committee for any licensing fees which may be  
23 required in order to use the United States Olympic Committee logo or  
24 design. The licensing agreement shall provide for a payment of not

1 more than Twenty-five Dollars (\$25.00) for each license plate  
2 issued;

3 7. Oklahoma History License Plate - such plates shall be  
4 designed and issued to any person wishing to demonstrate interest in  
5 Oklahoma history. As provided in this section, an amount of the fee  
6 collected shall be deposited to the Oklahoma Historical Society  
7 Revolving Fund to be used for educational purposes;

8 8. Historic Route 66 License Plate - such:

9 a. vehicle plates shall be designed to honor historic  
10 Route 66, also known as the "Mother Road". As  
11 provided in this section, an amount of the fee  
12 collected for each vehicle license plate shall be  
13 apportioned to the Oklahoma Historical Society  
14 Revolving Fund to be distributed to the Route 66  
15 Museum located in Clinton, Oklahoma, and

16 b. motorcycle plates shall be designed in consultation  
17 with the Oklahoma Route 66 Association, Inc. The  
18 Oklahoma Tax Commission shall be authorized to enter  
19 into a licensing agreement with the Oklahoma Route 66  
20 Association, Inc., for any licensing fees which may be  
21 required in order to use the Oklahoma Route 66  
22 Association, Inc., logo or design. The licensing  
23 agreement shall provide for a payment to the Oklahoma  
24 Route 66 Association, Inc., of not more than Twenty



1                   Dollars (\$20.00) for each motorcycle license plate  
2                   issued;

3           9.   Heart of the Heartland License Plate - such plates shall be  
4 designed and issued to any person wishing to honor the victims of  
5 the terrorist bombing attack on the Alfred P. Murrah Federal  
6 Building in downtown Oklahoma City on April 19, 1995. As provided  
7 in this section, an amount of the fee collected shall be deposited  
8 in the Heart of the Heartland Scholarship Fund, as established in  
9 Section 2282 of Title 70 of the Oklahoma Statutes;

10          10.   Emergency Medical Technician License Plate - such plates  
11 shall be designed and issued to any person who is an emergency  
12 medical technician. Such persons may apply for an emergency medical  
13 technician license plate for each vehicle with a rated carrying  
14 capacity of one (1) ton or less upon proof of an emergency medical  
15 technician's license. The license plate shall be designed in  
16 consultation with the state association of emergency medical  
17 technicians. As provided in this section, an amount of the fee  
18 collected shall be apportioned to the Emergency Medical Personnel  
19 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63  
20 of the Oklahoma Statutes;

21          11.   Fight Breast Cancer License Plate - such plates shall be  
22 designed to demonstrate support for the prevention and treatment of  
23 breast cancer in this state. As provided in this section, an amount  
24

1 of the fee collected shall be apportioned to the Breast Cancer Act  
2 Revolving Fund;

3 12. Crime Victims Awareness License Plate - such plates shall  
4 be designed and issued to any person wishing to demonstrate  
5 awareness of and support for victims of crimes. The license plates  
6 shall be designed in consultation with the Oklahoma Crime Victims  
7 Centre. As provided in this section, an amount of the fee collected  
8 shall be apportioned to the Attorney General's Revolving Fund for  
9 the Office of the Attorney General, which is hereby directed to use  
10 such funds to contract with a statewide nonprofit organization to  
11 provide services to crime victims;

12 13. Oklahoma Safe Kids Association License Plate - such plates  
13 shall be designed and issued to any person wishing to demonstrate  
14 support and awareness of the Oklahoma Safe Kids Association. The  
15 license plate shall be designed in consultation with the Oklahoma  
16 Safe Kids Association. As provided in this section, an amount of  
17 the fee collected shall be deposited in the Children's Hospital -  
18 Oklahoma Safe Kids Association Revolving Fund to be distributed to  
19 the Oklahoma Safe Kids Association program;

20 14. Four-H Club License Plate - such plates shall be designed,  
21 subject to criteria to be presented to the Tax Commission by the  
22 Four-H Foundation, and issued to any person wishing to demonstrate  
23 support of the Four-H Club. Such plates may be designed and issued  
24 to any person as for personalized license plates. As provided in

1 this section, an amount of the fee collected shall be apportioned to  
2 the OSU Extension Service License Plate Revolving Fund created in  
3 Section 1104.4 of this title;

4 15. Agricultural Awareness License Plate - such plates shall be  
5 designed, subject to criteria to be presented to the Tax Commission,  
6 by the Oklahoma Department of Agriculture, Food, and Forestry in  
7 consultation with the Oklahoma Arts Council, and issued to any  
8 person wishing to demonstrate support of the Department's Ag in the  
9 Classroom Education Program. As provided in this section, an amount  
10 of the fee collected shall be apportioned as provided in Section  
11 1104.3 of this title;

12 16. Oklahoma Statehood Centennial License Plate - such plates  
13 shall be designed and issued to any person wishing to commemorate  
14 the centennial of Oklahoma's admission to statehood in 1907. The  
15 license plates shall be designed in consultation with the Oklahoma  
16 Capitol Complex and Centennial Commemoration Commission. As  
17 provided in this section, an amount of the fee collected shall be  
18 deposited in the Oklahoma Capitol Complex and Centennial  
19 Commemoration Commission Revolving Fund created in Section 98.5 of  
20 Title 73 of the Oklahoma Statutes;

21 17. Support Education License Plate - such plates shall be  
22 designed, subject to criteria to be presented to the Tax Commission  
23 by the State Department of Education in consultation with the  
24 Oklahoma Arts Council, and issued to any person wishing to

1 demonstrate support for education in this state. All motor license  
2 agents shall display a sample of the Support Education License plate  
3 in the area of the business accessed by the public. Twenty-three  
4 Dollars (\$23.00) of the fee collected shall be apportioned as  
5 follows:

- 6 a. five percent (5%) shall be deposited to the Education  
7 Reform Revolving Fund,
- 8 b. five percent (5%) shall be deposited to the Higher  
9 Education Revolving Fund,
- 10 c. five percent (5%) shall be deposited to the State  
11 Career Technology Fund, and
- 12 d. eighty-five percent (85%) of the fee shall be  
13 deposited to the Teachers' Retirement Benefit Fund as  
14 set forth in Section 17-108 of Title 70 of the  
15 Oklahoma Statutes.

16 However, when the Teachers' Retirement Benefit Fund attains a  
17 seventy percent (70%) funded ratio based on an annual actuarial  
18 valuation as required by law, the amount of the fee shall be

21 18. Retired Oklahoma Highway Patrol Officers License Plate -  
22 such plates shall be designed and issued to any retired officer of  
23 the Oklahoma Highway Patrol. The license plate shall have the  
24 legend "Oklahoma" and shall contain, in the center of the plate, the

1 Highway Patrol Officers patch using the same colors and pattern as  
2 used in the patch. Centered on the bottom of the license plate  
3 shall be the word "Retired". The letters "TRP" shall be used in  
4 combination with three numbers on either side of the insignia or  
5 emblem. The color of the letters and numbers shall be brown.  
6 Retirees who are eligible for such plates shall provide proof of  
7 eligibility upon initial application, but shall not be required to

23 registration fees provided by the Oklahoma Vehicle License and  
24 Registration Act. The fee shall be apportioned as follows:



1        1. Twenty Dollars (\$20.00) per year of renewal or any other  
2 amount as provided in this title of the fee shall be apportioned as  
3 provided or deposited in a fund as specified within the paragraph  
4 authorizing the special license plate;

5        2. Eight Dollars (\$8.00) per year of renewal of the fee shall  
6 be deposited in the Oklahoma Tax Commission Reimbursement Fund to be  
7 used for the administration of the Oklahoma Vehicle License and  
8 Registration Act; and

9        3. Any remaining amounts of the fee shall be apportioned as  
10 provided in Section 1104 of this title.

11        SECTION 8.        AMENDATORY        47 O.S. 2011, Section 1135.6, is  
12 amended to read as follows:

13        Section 1135.6. The Oklahoma Tax Commission is hereby  
14 authorized to design and issue National Association for Stock Car  
15 Auto Racing Driver ("NASCAR") Theme License Plates. Such plates  
16 shall be designed and issued to any person wishing to demonstrate  
17 interest in NASCAR auto racing. The plates shall be of such design  
18 as the supplier of the license plates in consultation with the  
19 Oklahoma Tax Commission may prescribe. The fee for such plate shall  
20 be Forty Dollars (\$40.00) and shall be in addition to all other  
21 registration fees required by the Oklahoma Vehicle License and  
22 Registration Act. On and after January 1, 2022, if a special  
23 license plate is issued pursuant to this section, any registration  
24 fee required for such plate pursuant to this section and the fee

1 required pursuant to Section 1132 of this title shall be remitted at  
2 the same time and subject to a single registration period. The  
3 Oklahoma Tax Commission shall determine, by rule, a method for  
4 making required fee and registration period adjustments if a special  
5 license plate is obtained during a twelve-month period for which a  
6 registration fee has already been remitted pursuant to Section 1132  
7 of this title. The combination of fees in a single remittance shall  
8 not alter the apportionment otherwise provided for in this section.

9 The Tax Commission shall be authorized to enter into a licensing  
10 agreement with the supplier of such NASCAR Driver license plates or  
11 other entity for any required licensing fees. The licensing  
12 agreement shall provide for a payment of not more than Twenty-five  
13 Percent (25%) of the fee authorized for each license plate issued.  
14 Five Dollars (\$5.00) of the forty-dollar fee shall be apportioned to  
15 the General Revenue Fund. The remaining amount of such fee shall be  
16 deposited in the Oklahoma Tax Commission Reimbursement Fund.

17 For license plates numbered zero (0) through one hundred (100)  
18 displaying a particular NASCAR Driver theme, the Oklahoma Tax  
19 Commission may establish an auction or similar procedure for the  
20 purpose of determining the order in which such distinctive license  
21 plates are sold and the amount of the additional fee for the  
22 distinctive license plates. This amount shall be due at the time  
23 the original application is submitted to the Tax Commission and  
24

Forty Dollars (\$40.00) thereafter annually at the time of renewal registration.

SECTION 9. AMENDATORY 47 O.S. 2011, Section 1135.7, as amended by Section 5, Chapter 69, O.S.L. 2018 (47 O.S. Supp. 2020, Section 1135.7), is amended to read as follows:

Section 1135.7. A. The Oklahoma Tax Commission or private vendor with whom the Commission has contracted is authorized to design and issue special license plates to any person that applies to the Tax Commission or private vendor for the creation of a special license plate and meets the minimum standards and qualifications specified in this section.

B. If the following standards and guidelines are satisfied, the Tax Commission shall authorize the issuance of a special license plate to the person making application for the special license plate:

1. The license plate is to:

a. show membership in or affiliation with an organization, or

b. demonstrate support for an organization, group or cause;

2. The license plate does not advertise or endorse a product, brand, or service that is provided for sale;

3. The license plate does not promote any philosophy based on prejudice or that is contrary to state civil rights laws; and

1        4. Two hundred prepaid applications for the special license  
2 plate are received by the Tax Commission or private vendor.

3        C. The fee for special license plates shall be determined in  
4 accordance with Section ~~1 of this act~~ 1135.9 of this title. If the  
5 special license plate does not provide financial assistance the fee  
6 shall be no less than Fifteen Dollars (\$15.00) per year of renewal  
7 and shall be in addition to all other registration fees provided by  
8 the Oklahoma Vehicle License and Registration Act. Unless otherwise  
9 provided in this section, Fifteen Dollars (\$15.00) of the fee shall  
10 be apportioned as follows: Eight Dollars (\$8.00) of the special  
11 license plate fee shall be deposited in the Oklahoma Tax Commission  
12 Reimbursement Fund to be used for the administration of the Oklahoma  
13 Vehicle License and Registration Act and the remaining amounts of  
14 the special license plate fee shall be apportioned as provided in  
15 Section 1104 of this title.

16        D. The fee for special license plates that provide financial  
17 assistance shall be determined in accordance with Section ~~1 of this~~  
18 ~~act~~ 1135.9 of this title. Provided, the fee shall be no less than  
19 Thirty-five Dollars (\$35.00) and shall be in addition to all other  
20 registration fees provided by the Oklahoma Vehicle License and  
21 Registration Act. Thirty-five Dollars (\$35.00) per year of renewal  
22 of the fee shall be apportioned as follows:

23        1. Twenty Dollars (\$20.00) of the fee shall be apportioned to  
24 the License Plate Special Program Assistance Revolving Fund created

1 in Section 1135.8 of this title to be used in the manner detailed in  
2 the application for the special license plate;

3 2. Eight Dollars (\$8.00) of the fee shall be deposited in the  
4 Oklahoma Tax Commission Reimbursement Fund to be used for the  
5 administration of the Oklahoma Vehicle License and Registration Act;  
6 and

7 3. Any remaining amounts of the fee shall be apportioned as  
8 provided in Section 1104 of this title.

9 E. If a person applies for a special license plate that  
10 provides financial assistance, the application shall designate a  
11 state agency to be responsible for expending the funds generated by  
12 the special license plate and the application shall designate a  
13 specific public purpose for which the funds are to be used. The  
14 application shall include an acknowledgment from the designated  
15 state agency of their agreement with acceptance of the designated  
16 funds.

17 F. Special license plates shall not be transferred to any other  
18 person but shall be removed from the vehicle upon transfer of  
19 ownership and retained. The special license plate may then be used  
20 on another vehicle but only after such other vehicle has been  
21 registered for the current year.

22 Special license plates shall be renewed each year by the Tax  
23 Commission or a motor license agent, unless authorized by the Tax  
24 Commission to be renewed for a period greater than one (1) year.

1 The Tax Commission shall notify all persons issued special license  
2 plates of the renewal procedures prior to the expiration of the  
3 special license plate. The notice shall contain all necessary  
4 information and shall contain instructions for the renewal procedure  
5 upon presentation to a motor license agent or the Tax Commission.  
6 The license plates shall be issued on a staggered system.

7 On and after January 1, 2022, if a special license plate is  
8 issued pursuant to this section, any registration fee required for  
9 such plate and the fee required pursuant to Section 1132 of this  
10 title shall be remitted at the same time and subject to a single  
11 registration period. The Oklahoma Tax Commission shall determine,  
12 by rule, a method for making required fee and registration period  
13 adjustments if a special license plate is obtained during a twelve-  
14 month period for which registration has already been remitted  
15 pursuant to Section 1132 of this title. The combination of fees in  
16 a single remittance shall not alter the apportionment otherwise  
17 provided for in this section.

18 The Tax Commission is hereby directed to develop and implement a  
19 system whereby motor license agents are permitted to accept  
20 applications for special license plates authorized under this  
21 section. The motor license agent shall confirm the applicant's  
22 eligibility, if applicable, collect and deposit any amount  
23 specifically authorized by law, accept and process the necessary  
24 information directly into such system and generate a receipt

1 accordingly. For performance of these duties, motor license agents  
2 shall retain the fee provided in Section 1141.1 of this title for  
3 registration of a motor vehicle. The motor license agent fees for  
4 acceptance of applications and renewals shall be paid out of the  
5 Oklahoma Tax Commission Reimbursement Fund.

6 G. All special plates issued by the Tax Commission prior to ~~the~~  
7 ~~effective date of this act~~ November 1, 2005, shall not be subject to  
8 the requirements and qualifications outlined in this section.

9 H. As used in this section, "person" includes an individual,  
10 group, organization or not-for-profit corporation that is recognized  
11 as such by the Internal Revenue Service.

12 SECTION 10. AMENDATORY 47 O.S. 2011, Section 1141.1, as  
13 amended by Section 4, Chapter 158, O.S.L. 2012 (47 O.S. Supp. 2020,  
14 Section 1141.1), is amended to read as follows:

15 Section 1141.1. A. Each motor license agent shall be entitled  
16 to retain the following amounts from the taxes and fees collected by  
17 such agent to be used to fund the operation of the office of such  
18 motor license agent subject to the provisions of Sections 1140  
19 through 1147 of this title:

20 1. ~~Beginning July 1, 2005, Two Dollars and eighty-one cents~~  
21 ~~(\$2.81) for each vehicle registered and for each special license~~  
22 ~~plate issued pursuant to the Oklahoma Vehicle License and~~  
23 ~~Registration Act. Beginning July 1, 2006, and thereafter through~~  
24 December 31, 2021, Three Dollars and fifty-six cents (\$3.56) for

each vehicle registered and for each special license plate issued pursuant to the Oklahoma Vehicle License and Registration Act;

2. Beginning on or after January 1, 2022, and for all subsequent years, if a special or personalized license plate is issued pursuant to Sections 1135.1 through 1135.7 of this title and remittance is combined with the registration required pursuant to Section 1132 of this title, Seven Dollars and twelve cents (\$7.12);

3. One Dollar and twenty-five cents (\$1.25) for each certificate of title issued for boats and motors pursuant to the Oklahoma Statutes;

~~3.~~ 4. For each certificate of registration issued for boats and motors pursuant to the Oklahoma Statutes, an amount determined pursuant to the provisions of subsection B of this section;

4. 5. Two Dollars and twenty-five cents (\$2.25) for each certificate of title issued pursuant to the Oklahoma Vehicle License and Registration Act. Provided, the fee retention amount for certificates of title issued pursuant to the provisions of subsection H of Section 1105 of this title, in which an insurer pays the optional twenty-two-dollar-fee amount, is Four Dollars and fifty cents (\$4.50);

~~5.~~ 6. Beginning October 1, 2000, three percent (3%) of the vehicle excise tax collected pursuant to Section 2103 of Title 68 of the Oklahoma Statutes. Beginning July 1, 2001, each motor license agent shall be entitled to retain three and one hundred twenty-five



1 one-thousandths percent (3.125%) of the vehicle excise tax collected  
2 pursuant to Section 2103 of Title 68 of the Oklahoma Statutes.

3 Beginning July 1, 2002, and for all subsequent years, each motor  
4 license agent shall be entitled to retain three and twenty-five one-  
5 hundredths percent (3.25%) of the vehicle excise tax collected  
6 pursuant to Section 2103 of Title 68 of the Oklahoma Statutes.

7 However, beginning July 1, 2003, the Legislature shall annually  
8 review the percentage to be retained by the motor license agents  
9 pursuant to this paragraph to determine whether such percentage  
10 should be adjusted;

11 ~~6.~~ 7. Four percent (4%) of the excise tax collected on the  
12 transfer of boats and motors pursuant to the Oklahoma Statutes;

13 ~~7.~~ 8. Two Dollars (\$2.00) for each driver license, endorsement,  
14 identification license, or renewal or duplicate issued pursuant to  
15 Section 6-101 et seq. of this title;

16 ~~8.~~ 9. Two Dollars (\$2.00) for the recording of security  
17 interests as provided in Section 1110 of this title;

18 ~~9.~~ 10. Two Dollars (\$2.00) for each inspection conducted  
19 pursuant to subsection L of Section 1105 of this title;

20 ~~10.~~ 11. Three Dollars (\$3.00) for each inspection conducted  
21 pursuant to subsection M of Section 1105 of this title;

22 ~~11.~~ 12. One Dollar (\$1.00) for each certificate of ownership  
23 filed pursuant to subsection R of Section 1105 of this title;

~~12.~~ 13. One Dollar (\$1.00) for each temporary permit issued pursuant to Section 1124 of this title;

~~13.~~ 14. One Dollar and fifty cents (\$1.50) for processing each proof of financial responsibility, driver license information, insurance verification information, and other additional information as provided in Section 7-602 of this title;

~~14.~~ 15. The mailing fees and registration fees provided in Sections 1131 and 1140 of this title;

~~15.~~ 16. The notary fee provided in Section 1143 of this title;

~~16.~~ 17. Three Dollars (\$3.00) for each lien entry form completed and recorded on a certificate of title pursuant to subsection G of Section 1105 of this title;

~~17.~~ 18. Seven Dollars (\$7.00) for each notice of transfer as provided by subsection B of Section 1107.4 of this title;

~~18.~~ 19. Seven Dollars (\$7.00) for each certificate of title or each certificate of registration issued for repossessed vehicles pursuant to Section 1126 of this title;

~~19.~~ 20. Any amount specifically authorized by law to be retained by the motor license agent for the furnishing of a summary of a traffic record; and

~~20.~~ 21. Beginning July 1, 2009, each motor license agent shall also be entitled to a portion of the penalties for delinquent registration or payment of excise tax as provided for in subsection C of Section 1115, subsection F of Section 1132 and subsection C of

1 Section 1151 of this title and of subsection A of Section 2103 of  
2 Title 68 of the Oklahoma Statutes.

3 The balance of the funds collected shall be remitted to the  
4 Oklahoma Tax Commission as provided in Section 1142 of this title to  
5 be apportioned pursuant to Section 1104 of this title.

6 B. For each certificate of registration issued for boats and  
7 motors, each motor license agent shall be entitled to retain the  
8 greater of One Dollar and twenty-five cents (\$1.25) or an amount to  
9 be determined by the Tax Commission according to the provisions of  
10 this subsection. At the end of fiscal year 1997 and each fiscal  
11 year thereafter, the Tax Commission shall compute the average amount  
12 of registration fees for all boats and motors registered in this  
13 state during the fiscal year and shall multiply the result by six  
14 and twenty-two one-hundredths percent (6.22%). The resulting  
15 product shall be the amount which may be retained by each motor  
16 license agent for each certificate of registration for boats and  
17 motors issued during the following calendar year.

18 SECTION 11. This act shall become effective January 1, 2022.
