The Secretary of State shall refer to the people for 14 their approval or rejection, as and in the manner provided by law, 15 the following proposed amendment to the Oklahoma Constitution by 16 17 adding a new Section 6 to Article III to read as follows: Section 6. Each voter shall present proof of identity when 18 voting at any election authorized by law and conducted in accordance 19 with the requirements of the Constitution and laws of this state. 20 Proof of identity shall be required for voting in person, by 21 absentee or mail ballot, and by any other method of voting or 22 casting a ballot authorized by law. The Legislature shall enact 23 24

9	This measure adds Section 6 to Article 3 of the Oklahoma
10	Constitution to require proof of identity to vote in any
11	election authorized by law and conducted in accordance with the
12	requirements of the Constitution and state law. The measure
13	requires proof of identity for all authorized methods of voting.
14	The measure requires the Legislature to enact laws to specify
15	requirements for proof of identity for voting.
