Notwithstanding any other provisions of this section, for 10 the fiscal year beginning July 1, 2003, the first One Hundred 11 Thousand Dollars (\$100,000.00) of the monies collected or received 12 by the Tax Commission pursuant to the registration of motorcycles 13 and mopeds in this state shall be placed to the credit of the 14 Oklahoma Tax Commission Revolving Fund.

SECTION 2. This act shall become effective July 1, 2022.
SECTION 3. It being immediately necessary for the preservation
of the public peace, health or safety, an emergency is hereby
declared to exist, by reason whereof this act shall take effect and
be in full force from and after its passage and approval.
