1 ENGROSSED HOUSE CONCURRENT RESOLUTION NO. 1005 By: McCall of the House 3 and Treat of the Senate 4 5 6 7 A Concurrent Resolution relating to the economic contributions and value of Taiwan; findings; distribution. 8 9 10 11 WHEREAS, the long-standing bonds of friendship between the United 12 States and Taiwan, embodied in the Taiwan Relations Act of 1979, 13 continue to yield important economic, strategic, and cultural 14 benefits; and 15 WHEREAS, Taiwan ranks as the United States' 9th largest trading 16 partner, and in 2020, bilateral trade in goods reached \$90.9 17 billion; the 7th largest export market for U.S. agricultural 18 products in 2019, Taiwan's biennial agricultural trade goodwill 19 missions result in multibillion-dollar supply deals, and its 20 annually dispatched delegations to the SelectUSA Investment Summit 21 boost investment; Taiwan's recent action to lift restrictions on 22 U.S. beef and pork beginning January 2021 will help enhance 23 bilateral trade; and 24

WHEREAS, the robust U.S.-Taiwan trade and investment partnership provides a solid foundation for a mutually beneficial bilateral trade agreement (BTA) to spur job creation, further expand the global market, and secure international supply chains; Taiwan is well positioned to play an important role augmenting the revitalization of the global supply chain as part of the postpandemic economic recovery; and WHEREAS, Taiwan is committed to helping address global challenges, from humanitarian crises to nontraditional security threats; moreover, it has emerged as an important partner in pandemic prevention, providing 54 million surgical masks and other PPE to more than 80 countries around the world, including 100,000 surgical masks to the State of Oklahoma; the Taiwan Model has achieved world renown for its effective pandemic prevention and containment, bolstering unprecedented international support for Taiwan's bid to participate in the World Health Assembly (WHA); and WHEREAS, Taiwanese officials and civil society groups partner with the United States on a range of issues to promote our common values of freedom, democracy and human rights; in March, Taiwan joined with the United States to establish the Partnership against Coronavirus, building on the cooperative tradition of prior joint partnerships such as the Global Cooperation and Training Framework (GCTF), which advances Taiwanese leadership in such arenas as democratization, human rights, women's empowerment and public health; and
