An Act relating to the Oklahoma Department of Commerce; making appropriations to certain revolving funds under the control of the Oklahoma Department of Commerce; identifying sources; establishing amounts; requiring and limiting expenditure for certain purposes; and providing for noncodification.

SUBJECT: Oklahoma Department of Commerce

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law not to be codified in the Oklahoma Statutes reads as follows:

There is hereby appropriated to the Pandemic Relief Primary Source Revolving Fund, created in Enrolled House Bill No. 1021 of the 2nd Extraordinary Session of the 58th Oklahoma Legislature, from any monies not otherwise appropriated from the Statewide Recovery Fund of the State Treasury created in Enrolled House Bill No. 3349 of the 2nd Session of the 58th Oklahoma Legislature, the sum of Sixty Million Dollars (\$60,000,000.00) to be administered in accordance with the provisions of Enrolled House Bill No. 1021 of the 2nd Extraordinary Session of the 58th Oklahoma Legislature.

SECTION 2. NEW LAW A new section of law not to be codified in the Oklahoma Statutes reads as follows:

There is hereby appropriated to the Pandemic Relief Secondary Source Revolving Fund, created in Enrolled House Bill No. 1021 of the 2nd Extraordinary Session of the 58th Oklahoma Legislature, from any monies not otherwise appropriated from the Progressing Rural Economic Prosperity Fund of the State Treasury created in Enrolled House Bill No. 4456 of the 2nd Session of the 58th Oklahoma Legislature, the sum of Forty-six Million Two Hundred Thousand Dollars (\$46,200,000.00) to be administered in accordance with the provisions of Enrolled House Bill No. 1021 of the 2nd Extraordinary Session of the 58th Oklahoma Legislature.

SECTION 3. NEW LAW A new section of law not to be codified in the Oklahoma Statutes reads as follows:

There is hereby appropriated to the Workforce Coordination Revolving Fund, created in Enrolled House Bill No. 1021 of the 2nd Extraordinary Session of the 58th Oklahoma Legislature, from any monies not otherwise appropriated from the Statewide Recovery Fund of the State Treasury created in Enrolled House Bill No. 3349 of the 2nd Session of the 58th Oklahoma Legislature, the sum of Five Million Dollars (\$5,000,000.00) to be administered in accordance with the provisions of Enrolled House Bill No. 1021 of the 2nd Extraordinary Session of the 58th Oklahoma Legislature.
