FLOOR SUBSTITUTE

An Act relating to economic development; requiring Oklahoma Department of Commerce to make certain business recruiting information available; providing for confidential information; providing for required content; requiring updates to information; requiring Oklahoma Department of Commerce to prepare report related to business recruiting activity; prescribing content of report; providing for codification; providing an effective date; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 5003.51 of Title 74, unless there is created a duplication in numbering, reads as follows:

A. The Oklahoma Department of Commerce shall post a public dashboard related to its business recruiting efforts with an

1 emphasis on possible business site location or relocation decisions
2 within the state.

3 B. The information on the dashboard shall not disclose the
4 identity of any person or firm with whom or with which the
5 Department of Commerce is communicating regarding possible business
6 site location or relocation; provided, however, the Department shall
7 include information on the dashboard regarding possible locations or
8 relocations for a business site location decision organized by
9 county indicating active projects by time and length under
10 consideration to be updated on the dashboard no less often than
11 every thirty (30) days in all cases.

12 C. A county, city or town, or instrumentalities, authorities,
13 agents or other authorized persons acting on behalf of a county,
14 city or town, may contact the Oklahoma Department of Commerce in
15 order to submit an application for economic development-related
16 services that might be offered to a prospective business enterprise
17 using the information from the dashboard.

18 D. The information on the dashboard required by this section
19 shall be updated by the Department when material changes occur that
20 indicate that a business will not locate in a county or that a
21 county has been excluded from consideration or no less often than
22 every thirty (30) days in all cases.

23 E. The Oklahoma Department of Commerce shall prepare an annual
24 report summarizing business recruiting activity during the preceding

1 calendar year or fiscal year which shall separately describe
2 projects led by the Department of Commerce, projects assisted by the
3 Department of Commerce and general projects taking place within the
4 state.

5 SECTION 2. This act shall become effective July 1, 2021.

6 SECTION 3. It being immediately necessary for the preservation
7 of the public peace, health or safety, an emergency is hereby
8 declared to exist, by reason whereof this act shall take effect and
9 be in full force from and after its passage and approval.
