10 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

11 SECTION 1. AMENDATORY 62 O.S. 2021, Section 34.301, is  
12 amended to read as follows:

13 Section 34.301 A. This act shall be known and may be cited as  
14 the "Civil Service and Human Capital Modernization Act".

15 B. The Human Capital Management Division and the Civil Service  
16 Division of the Office of Management and Enterprise Services shall:

17 1. Establish and maintain a State Employee Dispute Resolution  
18 Program, which may include mediation, to provide dispute resolution  
19 services for state agencies and state employees. Actions agreed to  
20 through the State Employee Dispute Resolution Program shall be  
21 consistent with applicable laws and rules and shall not alter,  
22 reduce or modify any existing right or authority as provided by  
23 statute or rule;  
24

1        2. Establish rules pursuant to the Administrative Procedures  
2 Act as may be necessary to perform the duties and functions of this  
3 act, including creating an Office of Veterans Placement to offer  
4 counseling, assessment and assistance to veterans seeking state  
5 employment;

6        3. Receive and only act on complaints by state employees  
7 arising from disciplinary action;

8        4. Use administrative law judges as independent contractors or  
9 administrative law judges provided by the Office of Attorney General  
10 to exercise the provisions of this act;

11        5. Submit quarterly reports on workload statistics to the  
12 Governor, the Speaker of the Oklahoma House of Representatives and  
13 the President Pro Tempore of the Oklahoma State Senate containing  
14 the following information:

15            a. the number of cases, complaints and requests for  
16                hearings filed, disposed of and pending with the  
17                Division for each month of the quarter, and

18            b. a numerical breakdown of the methods of disposition of  
19                such cases, complaints and requests for hearing.

20 Quarterly reports shall be submitted within thirty (30) days  
21 following the last day of the month of the appropriate quarter; and

22        6. Create a confidential whistleblower program and serve as the  
23 chief administrator of such program whereby a state employee may  
24 confidentially report claims of agency or employee mismanagement as

1 well as criminal misuse of state funds or property. Mismanagement  
2 includes fraudulent activity or abuse or violation of a well-  
3 established, articulated, clear, and compelling public policy. The  
4 Office of the Attorney General shall have the authority to  
5 investigate and determine whether to prosecute such whistleblower  
6 claims. The Attorney General shall also have the power to refer  
7 such claims to the appropriate district attorney.

8 C. Complaints shall be filed with the ~~Human Capital Management~~  
9 Civil Service Division within ~~five (5)~~ ten (10) business days of the  
10 date of when such action occurred and hearings shall take place  
11 within ~~twenty-five (25)~~ thirty (30) business days ~~of~~ from the ~~action~~  
12 filing of the complaint.

13 D. Employees filing a complaint with the ~~Human Capital~~  
14 ~~Management~~ Civil Service Division shall prove that there was no  
15 reasonable basis for the disciplinary action by the state agency.  
16 The review of the merits of the complaint shall be limited to the  
17 employee disciplinary file directly at issue. Complaints relating  
18 to punitive transfers ~~or written reprimands~~ shall be administered  
19 through mediation first and shall only proceed to a hearing if  
20 mediation is unsuccessful. Employees who were offered a relocation  
21 incentive as set forth in administrative rule shall not be deemed as  
22 being subject to a punitive transfer. Complaints relating to  
23 written reprimands shall be administered through mediation  
24

1 exclusively. Mediation may also be available for other disciplinary  
2 actions.

3 E. Claimants shall be permitted to secure and utilize  
4 representation during the adverse action process.

5 F. The presiding officer of any proceeding before the ~~Human~~  
6 ~~Capital Management~~ Civil Service Division may require payment of  
7 reasonable attorney fees and costs to the prevailing party if the  
8 position of the nonprevailing party was without reasonable basis or  
9 was frivolous.

10 G. For purposes of this section, "disciplinary actions" means  
11 termination, suspension without pay, involuntary demotion, punitive  
12 transfers or written reprimand.

13 H. Nothing in this section shall apply to:

14 1. Persons employed by the Governor, Lieutenant Governor,  
15 Oklahoma House of Representatives, Oklahoma State Senate,  
16 Legislative Service Bureau, or the Legislative Office of Fiscal  
17 Transparency;

18 2. Elected officials;

19 3. Political appointees;

20 4. District attorneys, assistant district attorneys or other  
21 employees of the district attorney's office;

22 5. The state judiciary or persons employed by the state  
23 judiciary; ~~or~~

24

1       6. Not more than five percent (5%) of an agency's employees  
2 designated as executive management as determined by the agency  
3 director;

4       7. Temporary employees employed to work less than one thousand  
5 (1,000) hours in any twelve-month period;

6       8. Seasonal employees employed to work less than one thousand  
7 six hundred (1,600) hours in any twelve-month period;

8       9. Employees in a trial period; or

9       10. State employees whose employment status is otherwise  
10 provided by law.

11       I. Except as provided by subsection H of this section,  
12 effective January 1, 2022, all state employee positions shall be  
13 administered by the Human Capital Management Division of the Office  
14 of Management and Enterprise Services, without reference to prior  
15 classified or unclassified status.

16       J. Under the administration and oversight of the Human Capital  
17 Management Division as set forth in subsection I of this section,  
18 state agencies shall continue to be responsible for developing and  
19 conducting policies and procedures for human resource activities,  
20 including, but not limited to, recruitment, retention, promotion,  
21 market-based pay analysis, training and development. In addition,  
22 state agencies shall develop procedures for screening, hiring and  
23 disciplinary actions of state employees subject to guidance and  
24 approval by the Division.

1       K. The Civil Service Division is authorized to employ attorneys  
2 or contract with private attorneys to serve as legal counsel to the  
3 Civil Service Division. The attorneys shall be authorized to appear  
4 for and represent the Civil Service Division in all litigation that  
5 may arise from the discharge of its duties, including the  
6 representation the Civil Service Division when its decisions are  
7 appealed to higher courts. Attorneys employed by the Office of  
8 Management and Enterprise Services to represent the Civil Service  
9 Division shall represent the Civil Service Division notwithstanding  
10 its representation of the Office of Management and Enterprise  
11 Services in the same or related matters pending before the Civil  
12 Service Division or before any court. The Office of Management and  
13 Enterprise Services shall establish internal administrative  
14 procedures to ensure that all departments within the Office of  
15 Management and Enterprise Services are provided independent legal  
16 representation, and such simultaneous representation shall not, of  
17 itself, be deemed to constitute a conflict of interest.

18       L. The Civil Service Division shall be exempt from the  
19 requirements set forth in Section 20i of Title 74 of the Oklahoma  
20 statutes when carrying out the duties and functions of this act.

21      ~~6. "Classified service" means state employees and positions~~  
22      ~~under the jurisdiction of the Oklahoma Merit System of Personnel~~

2 ~~recording. The copy may be provided in an electronic format~~  
3 ~~generated from technology having electrical, digital, magnetic,~~

5       ~~8. "Entrance examination" means any employment test used by the~~  
6 ~~Office of Management and Enterprise Services to rank the names of~~  
7 ~~applicants who possess the minimum requirements of education,~~

9 ~~register of eligibles established by the Office of Management and~~

13 ~~Oklahoma Merit Protection Commission pursuant to the Oklahoma~~  
14 ~~Personnel Act;~~

15 ~~19. "Noncompetitive appointment" means the appointment of a~~  
16 ~~person to a noncompetitive job level within a job family;~~

17 ~~20. "Noncompetitive job" means an unskilled or semiskilled job~~  
18 ~~designated by the Office of Management and Enterprise Services as~~  
19 ~~noncompetitive. Noncompetitive jobs do not require written~~

5       SECTION 3.       AMENDATORY       74 O.S. 2021, Section 840-1.6, is  
6 amended to read as follows:

7       Section 840-1.6 A. The internal administrative organization of  
8 the Office of Management and Enterprise Services shall be determined  
9 by the Director of the Office of Management and Enterprise Services  
10 in such a manner as to promote the efficient and effective  
11 enforcement of ~~the Oklahoma Personnel Act~~ this act.

12       B. The Director of the Office of Management and Enterprise  
13 Services may employ attorneys, accountants and other personnel as  
14 the Director deems necessary to carry out the duties imposed upon  
15 the Office.

16       ~~C. Employees of the Office shall be subject to the Merit System~~  
17 ~~of Personnel Administration, unless otherwise exempted by Section~~  
18 ~~840-5.5 of this title.~~

19       SECTION 4.       AMENDATORY       74 O.S. 2021, Section 840-1.6A, is  
20 amended to read as follows:

21       Section 840-1.6A The Office of Personnel Management Division of  
22 the Office of State Finance ~~is hereby~~ was consolidated into and  
23 renamed the Office of Management and Enterprise Services. Where the  
24 term "Office of Personnel Management" is used within the Oklahoma

1 Statutes, it shall mean the Office of Management and Enterprise  
2 Services. The chief administrative officer shall be the Director of  
3 the Office of Management and Enterprise Services. In addition to  
4 the other duties imposed by law, the Director shall:

5 1. Be responsible for the development of an efficient and  
6 effective system of personnel administration that meets the  
7 management needs of the various agencies;

8 2. Organize the Office to provide both service and regulatory  
9 functions that are effective and efficient in meeting the management  
10 needs of various state agencies. The Director is directed to  
11 establish an agency service function to assist agencies with human  
12 resource needs based upon the administrative capacity and resources  
13 of the various agencies;

14 3. Prepare, maintain, and revise a ~~classified~~ system of  
15 employment designed to ensure the impartial consideration of  
16 applicants for employment and to protect state employees from  
17 arbitrary dismissal or unfair treatment;

18 4. Develop and maintain a classification and compensation  
19 system for all ~~classified~~ positions in the executive branch of state  
20 government including those established by the Oklahoma Constitution;

21 5. Conduct an analysis of the rates of pay prevailing in the  
22 state in the public and private sectors for comparable jobs and  
23 report the findings to the Governor, the President Pro Tempore of  
24 the Senate, and the Speaker of the House of Representatives no later



1 than December 1 of each year. Such analysis shall include all forms  
2 of compensation including fringe benefits. Information solicited by  
3 the Office of Management and Enterprise Services from public and  
4 private sector employers for such analysis, including but not  
5 limited to salaries, benefits, and compensation policies and  
6 procedures, shall be confidential and shall not be subject to  
7 disclosure under the Oklahoma Open Records Act;

8 6. ~~Develop a program for the recruitment of qualified persons,~~  
9 ~~including the administration of valid job-related nondiscriminatory~~  
10 ~~selection procedures providing for competitive examinations and~~  
11 ~~other job-related assessments. As part of the recruitment program~~  
12 ~~established by this section, the Director may identify positions or~~  
13 ~~job family levels for expedited recruitment. Such expedited~~  
14 ~~recruitment jobs may include only those jobs where education,~~  
15 ~~experience or certification requirements substantially limit the~~  
16 ~~pool of available applicants. Applicants who have been certified by~~  
17 ~~the Office of Management and Enterprise Services as meeting the~~  
18 ~~minimum qualifications for such jobs may be referred to agencies~~

16 within The Oklahoma State System of Higher Education. Employees

18 initial training program within one (1) year after assuming the

If an agency discovers overpayment or underpayment errors through an internal audit, the agency shall recover overpayments from the employee or disburse underpayment amounts in accordance with this section. Prior to initiation of recovery of overpayments from an employee, the agency shall provide the employee with adequate notice and an opportunity to respond.

C. The Director of the Office of Management and Enterprise Services shall not approve any payroll claim for payment for any agency for which a notification of an unresolved audit exception pursuant to this section has been filed, unless the person named in the audit exception has been removed from the payroll by the certifying agency, the overpayment has been converted by the agency, or the exception has been withdrawn or waived in writing by the Office of Management and Enterprise Services.

D. Any sum on a payroll claim found to have been paid in excess of the actual amount due and owing may be recovered from the payee through the following procedures:

1. Upon the determination that an error in payroll amount has been made, the agency which certified the claim or claims shall notify the payee in writing within ten (10) days from said determination. The notice to the payee shall contain:

a. the amounts paid in error,

- b. the dates of said payments,
- c. the options available for repayment, and
- d. the right of the payee to protest the findings.

Said notice shall also provide space for the payee to indicate an election of a repayment option or to protest the findings. Said election shall be required within thirty (30) days after the notification;

2. If the payee is, at the time of said notification, an officer or employee of the agency seeking repayment, options available for repayment shall be by:

- a. lump-sum cash repayment,
- b. reduction of the corrected current salary or miscellaneous payroll deduction in a lump sum or in installments over a term not to exceed the term in which the erroneous payments were made,
- c. reduction in accrued annual leave by an amount of time at the then current correct salary level equal in value to the total of the amount or amounts to be repaid, or

6 with the schedule outlined below. Leave shall be accrued based upon  
7 hours worked, paid leave, and holidays, but excluding overtime, not  
8 to exceed the total possible work hours for the pay period. Years  
9 of service shall be based on cumulative periods of employment  
10 calculated in the manner that cumulative service is determined for  
11 longevity purposes pursuant to Section 840-2.18 of this title.

12 Employees may accumulate more than the maximum annual leave  
13 accumulation limits shown in the schedule below provided that such

Following an emergency declaration as described in Section 683.8 of Title 63 of the Oklahoma Statutes, the accumulation limits for annual leave shall temporarily increase and shall carryover to the end of the fiscal year following the year in which the emergency declaration ended.

All annual leave that accrued or expired during the period of the emergency declarations issued by the Governor in 2020 and 2021 in response to the novel coronavirus (COVID-19) shall carry over to the end of the fiscal year following the year in which the emergency declaration ended regardless of regulatory provisions that establish



1 a maximum amount of annual leave that may be accumulated by an  
2 employee of the State of Oklahoma. Expired annual leave governed by  
3 this subsection shall be reinstated as of the effective date of this  
4 act, and accumulation limits for annual leave shall not apply to  
5 amounts accrued or reinstated pursuant to this subsection.

6 Eligibility for reinstatement of annual leave is limited to  
7 employees currently employed by the State of Oklahoma on the

2 prevent or discourage an appointing authority from disciplining or  
3 terminating an employee due to abuse of leave benefits or  
4 absenteeism. Appointing authorities are encouraged to consider  
5 attendance of employees in making decisions regarding promotions,  
6 pay increases, and discipline.

7        C. Upon the transfer of a function in state government to an  
8 entity outside state government, employees may, with the agreement  
9 of the outside entity, waive any payment for leave accumulations to  
10 which the employee is entitled and authorize the transfer of the  
11 leave accumulations or a portion thereof to the outside entity.

12        SECTION 18.        AMENDATORY        74 O.S. 2021, Section 840-2.21,

9 D. An employee on leave without pay pursuant to the provisions  
10 of this section shall have the right to be returned to his or her

13 the good of the state to fill the position during the period the  
14 employee is on leave without pay the employee filling the position  
15 shall vacate the position upon the return of the employee on leave

1. The Leave of Last Resort Bank shall be funded by voluntary donations of annual and sick leave from employees retiring from or leaving state service.
