15	SECTION 1. AMENDATORY 47 O.S. 2011, Section 1135.7, as
16	amended by Section 5, Chapter 69, O.S.L. 2018 (47 O.S. Supp. 2020,
17	Section 1135.7), is amended to read as follows:
18	Section 1135.7. A. The Oklahoma Tax Commission or private
19	vendor with whom the Commission has contracted is authorized to
20	design and issue special license plates to any person that applies
21	to the Tax Commission or private vendor for the creation of a
22	special license plate and meets the minimum standards and
23	qualifications specified in this section.

1 в. If the following standards and guidelines are satisfied, the Tax Commission shall authorize the issuance of a special license 2 plate to the person making application for the special license 3 plate: 4 5 1. The license plate is to: show membership in or affiliation with an 6 a. organization, or 7 demonstrate support for an organization, group or 8 b. 9 cause; The license plate does not advertise or endorse a product, 10 2. brand, or service that is provided for sale; 11 12 3. The license plate does not promote any philosophy based on prejudice or that is contrary to state civil rights laws; and 13 Two hundred prepaid applications for the special license 4. 14 plate are received by the Tax Commission or private vendor. 15 The fee for special license plates shall be determined in 16 С. accordance with Section 1 of this act 1135.9 of this title. If the 17 special license plate does not provide financial assistance the fee 18 shall be no less than Fifteen Dollars (\$15.00) per year of renewal 19 and shall be in addition to all other registration fees provided by 20 the Oklahoma Vehicle License and Registration Act. Unless otherwise 21 provided in this section, Fifteen Dollars (\$15.00) of the fee shall 22 be apportioned as follows: Eight Dollars (\$8.00) of the special 23 license plate fee shall be deposited in the Oklahoma Tax Commission 24

Reimbursement Fund to be used for the administration of the Oklahoma
 Vehicle License and Registration Act and the remaining amounts of
 the special license plate fee shall be apportioned as provided in
 Section 1104 of this title.

5 D. For special license plates that provide financial assistance
6 created pursuant to the provisions of this section, the Tax
7 Commission shall be authorized to enter into a licensing agreement

8 with an organization for any licensing fees that may be required to 9 use the organization's logo or design.

<u>E.</u> The fee for special license plates that provide financial assistance shall be determined in accordance with Section 1 of this act <u>1135.9 of this title</u>. Provided, the fee shall be no less than Thirty-five Dollars (\$35.00) and shall be in addition to all other registration fees provided by the Oklahoma Vehicle License and Registration Act. Thirty-five Dollars (\$35.00) per year of renewal of the fee shall be apportioned as follows:

1. a. Twenty Dollars (\$20.00) of the fee shall be 17 apportioned to the License Plate Special Program 18 Assistance Revolving Fund created in Section 1135.8 of 19 this title to be used in the manner detailed in the 20 application for the special license plate;, except as 21 provided in subparagraph b of this paragraph. 22 If the Tax Commission has entered into a licensing 23 b. agreement with an organization for the use of its 24

1 design or logo pursuant to Chapter 74 of Title 47 of 2 the Oklahoma Statutes, an amount to be determined in the licensing agreement, but not to exceed twenty 3 4 (\$20) dollars per license plate issued, shall be 5 transferred monthly to that organization as payment of licensing fees and no fee shall be apportioned to the 6 License Plate Special Program Assistance Revolving 7 8 Fund. 9 2. Eight Dollars (\$8.00) of the fee shall be deposited in the

10 Oklahoma Tax Commission Reimbursement Fund to be used for the 11 administration of the Oklahoma Vehicle License and Registration Act; 12 and

Any remaining amounts of the fee shall be apportioned as
 provided in Section 1104 of this title.

E. If F. Except as otherwise provided in subsection D and 15 subparagraph b of paragraph 1 of subsection E of this section, if a 16 17 person applies for a special license plate that provides financial assistance, the application shall designate a state agency to be 18 responsible for expending the funds generated by the special license 19 plate and the application shall designate a specific public purpose 20 for which the funds are to be used. The application shall include 21 an acknowledgment from the designated state agency of their 22 agreement with acceptance of the designated funds. 23

F. G. Special license plates shall not be transferred to any other person but shall be removed from the vehicle upon transfer of ownership and retained. The special license plate may then be used on another vehicle but only after such other vehicle has been registered for the current year.

Special license plates shall be renewed each year by the Tax 6 Commission or a motor license agent, unless authorized by the Tax 7 Commission to be renewed for a period greater than one (1) year. 8 9 The Tax Commission shall notify all persons issued special license plates of the renewal procedures prior to the expiration of the 10 special license plate. The notice shall contain all necessary 11 information and shall contain instructions for the renewal procedure 12 upon presentation to a motor license agent or the Tax Commission. 13 The license plates shall be issued on a staggered system. 14

The Tax Commission is hereby directed to develop and implement a 15 system whereby motor license agents are permitted to accept 16 applications for special license plates authorized under this 17 The motor license agent shall confirm the applicant's 18 section. eligibility, if applicable, collect and deposit any amount 19 specifically authorized by law, accept and process the necessary 20 information directly into such system and generate a receipt 21 accordingly. For performance of these duties, motor license agents 22 shall retain the fee provided in Section 1141.1 of this title for 23 registration of a motor vehicle. The motor license agent fees for 24

G. H. All special plates issued by the Tax Commission prior to
the effective date of this act November 1, 2005, shall not be
subject to the requirements and qualifications outlined in this
section.

H. I. As used in this section, "person" includes an individual,
group, organization or not-for-profit corporation that is recognized
as such by the Internal Revenue Service.

Section 1135.5. A. The Oklahoma Tax Commission is hereby authorized to design and issue appropriate official special license plates to persons wishing to demonstrate support and provide financial assistance as provided by this section.

17 Special license plates shall not be transferred to any other 18 person but shall be removed from the vehicle upon transfer of 19 ownership and retained. The special license plate may then be used 20 on another vehicle but only after such other vehicle has been 21 registered for the current year with a motor license agent.

22 Special license plates shall be renewed each year by the Tax 23 Commission or a motor license agent, unless authorized by the Tax 24 Commission to be renewed for a period greater than one (1) year.

The Tax Commission shall notify by mail all persons issued special license plates. The notice shall contain all necessary information and shall contain instructions for the renewal procedure upon presentation to a motor license agent or the Tax Commission. The license plates shall be issued on a staggered system.

The Tax Commission is hereby directed to develop and implement a 6 system whereby motor license agents are permitted to accept 7 applications for special license plates authorized under this 8 9 section. The motor license agent shall confirm the applicant's eligibility, if applicable, collect and deposit any amount 10 specifically authorized by law, accept and process the necessary 11 information directly into such system and generate a receipt 12 13 accordingly. For performance of these duties, motor license agents shall retain the fee provided in Section 1141.1 of this title for 14 registration of a motor vehicle. The motor license agent fees for 15 acceptance of applications and renewals shall be paid out of the 16 Oklahoma Tax Commission Reimbursement Fund. 17

18 If fewer than one hundred of any type of special license plates 19 authorized prior to January 1, 2004, are issued prior to January 1, 20 2006, the Tax Commission shall discontinue issuance and renewal of 21 that type of special license plate. Any such authorized special 22 license plate registrant shall be allowed to display the license 23 plate upon the designated vehicle until the registration expiration

1 date. After such time the expired special license plate shall be 2 removed from the vehicle.

For special license plates authorized on or after July 1, 2004, 3 no special license plates shall be developed or issued by the Tax 4 5 Commission until the Commission receives one hundred prepaid applications therefor. The prepaid applications must be received by 6 the Tax Commission within one hundred eighty (180) days of the 7 effective date of the authorization or the authority to issue shall 8 9 be null and void. In the event one hundred prepaid applications are not received by the Tax Commission within such prescribed time 10 period any payment so received shall be refunded accordingly. 11

B. The special license plates provided by this section are as follows:

University or College Supporter License Plate - such plates
 shall be designed and issued to any person wishing to demonstrate
 support to any state-supported or private university or college. As
 provided in this section, an amount of the fee collected shall be
 apportioned as provided in Section 1104.1 of this title;

Environmental Awareness License Plate - such plates shall be
 designed, subject to the criteria to be presented to the Tax
 Commission by the Department of Environmental Quality in
 consultation with the Oklahoma Arts Council, and issued to any
 person wishing to demonstrate support to implement the statewide
 general public environmental education program created pursuant to

1 the provisions of the Oklahoma Environmental Quality Code. Such plates shall be designed and issued to any person in any combination 2 of numbers and letters from one to a maximum of seven, as for 3 personalized license plates. A dealer's license plate issued 4 5 pursuant to Section 1116.1 or 1128 of this title may be designated an Environmental Awareness License Plate upon payment of the fee 6 imposed by this section and any other registration fees required by 7 the Oklahoma Vehicle License and Registration Act. As provided in 8 9 this section, an amount of the fee collected shall be apportioned pursuant to Section 1104.2 of this title; 10

3. Firefighter License Plate - such plates shall be designed 11 12 for any career or retired firefighter, volunteer or paid. Firefighters may apply for firefighter plates for up to four 13 vehicles with a rated capacity of one (1) ton or less or for a 14 motorcycle upon proof of a fire department membership by either an 15 identification card or letter from the chief of the fire department. 16 Retirees who are eligible for such plates shall provide proof of 17 eligibility upon initial application, but shall not be required to 18 provide proof of eligibility annually. The surviving spouse of any 19 deceased firefighter, if the spouse has not since remarried, may 20 apply for a firefighter license plate for one vehicle with a rated 21 carrying capacity of one (1) ton or less or for a motorcycle upon 22 proof that the deceased firefighter was a member of a fire 23 department by either an identification card or letter from the chief 24

of the fire department. The license plate shall be designed in
 consultation with the Oklahoma Firefighters Association.

As provided in this section, an amount of the fee collected
shall be deposited to the Oklahoma State Firemen's Museum Building &
Memorial Fund for support of the Oklahoma Firefighters Museum and
the Oklahoma Fallen and Living Firefighters Memorial;

4. Wildlife Conservation License Plate - such plates shall be 7 designed, subject to the criteria to be presented to the Tax 8 9 Commission by the Oklahoma Department of Wildlife Conservation in consultation with the Oklahoma Arts Council, and issued to any 10 person wishing to demonstrate support for wildlife conservation in 11 12 this state through the Wildlife Diversity Fund, provided for in Section 3-310 of Title 29 of the Oklahoma Statutes. Such plates may 13 be designed and issued to any person as for personalized license 14 15 plates.

As provided in this section, an amount of the fee collected shall be apportioned pursuant to subsection D of Section 3-310 of Title 29 of the Oklahoma Statutes;

19 5. Child Abuse Prevention License Plate - such plates shall be 20 designed, subject to the criteria to be presented to the Tax 21 Commission by the Office of Child Abuse Prevention in the State 22 Department of Health and the Oklahoma Committee to Prevent Child 23 Abuse, and issued to any person wishing to demonstrate support for 24 the prevention of child abuse.

As provided in this section, an amount of the fee collected
 shall be deposited in the Child Abuse Prevention Fund;

6. United States Olympic Committee Supporter License Plate -3 such plates shall be designed and issued to any person wishing to 4 5 demonstrate support for the United States Olympic Committee. The plates shall be issued to any person in any combination of numbers 6 and letters from one to a maximum of seven, as for personalized 7 license plates. The plate shall contain the official United States 8 9 Olympic Committee logo. The Tax Commission shall be authorized, if necessary, to enter into a licensing agreement with the United 10 States Olympic Committee for any licensing fees which may be 11 required in order to use the United States Olympic Committee logo or 12 13 design. The licensing agreement shall provide for a payment of not more than Twenty-five Dollars (\$25.00) for each license plate 14 issued; 15

7. Oklahoma History License Plate - such plates shall be
designed and issued to any person wishing to demonstrate interest in
Oklahoma history. As provided in this section, an amount of the fee
collected shall be deposited to the Oklahoma Historical Society
Revolving Fund to be used for educational purposes;

8. Historic Route 66 License Plate - such:
a. vehicle plates shall be designed to honor historic
Route 66, also known as the "Mother Road". As
provided in this section, an amount of the fee

1 collected for each vehicle license plate shall be 2 apportioned to the Oklahoma Historical Society Revolving Fund to be distributed to the Route 66 3 Museum located in Clinton, Oklahoma, and 4 5 b. motorcycle plates shall be designed in consultation with the Oklahoma Route 66 Association, Inc. 6 The Oklahoma Tax Commission shall be authorized to enter 7 into a licensing agreement with the Oklahoma Route 66 8 9 Association, Inc., for any licensing fees which may be required in order to use the Oklahoma Route 66 10 Association, Inc., logo or design. The licensing 11 12 agreement shall provide for a payment to the Oklahoma 13 Route 66 Association, Inc., of not more than Twenty Dollars (\$20.00) for each motorcycle license plate 14 issued; 15

9. Heart of the Heartland License Plate - such plates shall be designed and issued to any person wishing to honor the victims of the terrorist bombing attack on the Alfred P. Murrah Federal Building in downtown Oklahoma City on April 19, 1995. As provided in this section, an amount of the fee collected shall be deposited in the Heart of the Heartland Scholarship Fund, as established in Section 2282 of Title 70 of the Oklahoma Statutes;

23 10. Emergency Medical Technician License Plate - such plates24 shall be designed and issued to any person who is an emergency

1 medical technician. Such persons may apply for an emergency medical technician license plate for each vehicle with a rated carrying 2 capacity of one (1) ton or less upon proof of an emergency medical 3 technician's license. The license plate shall be designed in 4 5 consultation with the state association of emergency medical technicians. As provided in this section, an amount of the fee 6 collected shall be apportioned to the Emergency Medical Personnel 7 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63 8 9 of the Oklahoma Statutes;

10 11. Fight Breast Cancer License Plate - such plates shall be 11 designed to demonstrate support for the prevention and treatment of 12 breast cancer in this state. As provided in this section, an amount 13 of the fee collected shall be apportioned to the Breast Cancer Act 14 Revolving Fund;

12. Crime Victims Awareness License Plate - such plates shall 15 be designed and issued to any person wishing to demonstrate 16 17 awareness of and support for victims of crimes. The license plates shall be designed in consultation with the Oklahoma Crime Victims 18 Centre. As provided in this section, an amount of the fee collected 19 shall be apportioned to the Attorney General's Revolving Fund for 20 the Office of the Attorney General, which is hereby directed to use 21 such funds to contract with a statewide nonprofit organization to 22 provide services to crime victims; 23

1 13. Oklahoma Safe Kids Association License Plate - such plates 2 shall be designed and issued to any person wishing to demonstrate support and awareness of the Oklahoma Safe Kids Association. 3 The license plate shall be designed in consultation with the Oklahoma 4 5 Safe Kids Association. As provided in this section, an amount of the fee collected shall be deposited in the Children's Hospital -6 Oklahoma Safe Kids Association Revolving Fund to be distributed to 7 the Oklahoma Safe Kids Association program; 8

9 14. Four-H Club License Plate - such plates shall be designed, subject to criteria to be presented to the Tax Commission by the 10 Four-H Foundation, and issued to any person wishing to demonstrate 11 12 support of the Four-H Club. Such plates may be designed and issued 13 to any person as for personalized license plates. As provided in this section, an amount of the fee collected shall be apportioned to 14 the OSU Extension Service License Plate Revolving Fund created in 15 Section 1104.4 of this title; 16

17 15. Agricultural Awareness License Plate - such plates shall be designed, subject to criteria to be presented to the Tax Commission, 18 by the Oklahoma Department of Agriculture, Food, and Forestry in 19 consultation with the Oklahoma Arts Council, and issued to any 20 person wishing to demonstrate support of the Department's Ag in the 21 Classroom Education Program. As provided in this section, an amount 22 of the fee collected shall be apportioned as provided in Section 23 1104.3 of this title; 24

1 16. Oklahoma Statehood Centennial License Plate - such plates 2 shall be designed and issued to any person wishing to commemorate the centennial of Oklahoma's admission to statehood in 1907. 3 The license plates shall be designed in consultation with the Oklahoma 4 5 Capitol Complex and Centennial Commemoration Commission. As provided in this section, an amount of the fee collected shall be 6 deposited in the Oklahoma Capitol Complex and Centennial 7 Commemoration Commission Revolving Fund created in Section 98.5 of 8 9 Title 73 of the Oklahoma Statutes;

10 17. Support Education License Plate - such plates shall be designed, subject to criteria to be presented to the Tax Commission 11 12 by the State Department of Education in consultation with the 13 Oklahoma Arts Council, and issued to any person wishing to demonstrate support for education in this state. All motor license 14 agents shall display a sample of the Support Education License plate 15 in the area of the business accessed by the public. Twenty-three 16 Dollars (\$23.00) of the fee collected shall be apportioned as 17 follows: 18

- a. five percent (5%) shall be deposited to the Education
 Reform Revolving Fund,
- b. five percent (5%) shall be deposited to the Higher
 Education Revolving Fund,
- c. five percent (5%) shall be deposited to the State
 Career Technology Fund, and

d. eighty-five percent (85%) of the fee shall be
 deposited to the Teachers' Retirement Benefit Fund as
 set forth in Section 17-108 of Title 70 of the
 Oklahoma Statutes.

However, when the Teachers' Retirement Benefit Fund attains a seventy percent (70%) funded ratio based on an annual actuarial valuation as required by law, the amount of the fee shall be apportioned equally pursuant to subparagraphs a, b and c of this paragraph;

Retired Oklahoma Highway Patrol Officers License Plate -10 18. such plates shall be designed and issued to any retired officer of 11 12 the Oklahoma Highway Patrol. The license plate shall have the legend "Oklahoma" and shall contain, in the center of the plate, the 13 Highway Patrol Officers patch using the same colors and pattern as 14 used in the patch. Centered on the bottom of the license plate 15 shall be the word "Retired". The letters "TRP" shall be used in 16 17 combination with three numbers on either side of the insignia or The color of the letters and numbers shall be brown. 18 emblem. Retirees who are eligible for such plates shall provide proof of 19 eligibility upon initial application, but shall not be required to 20 provide proof of eligibility annually. The surviving spouse of any 21 deceased retired officer of the Oklahoma Highway Patrol, if the 22 spouse has not since remarried, or if remarried, the remarriage is 23 terminated by death, divorce, or annulment, may apply for a Retired 24

Oklahoma Highway Patrol Officers license plate. As provided in this
 section, an amount of the fee collected shall be deposited into the
 Law Enforcement Retirement Fund;

19. Boy Scouts of America Supporter License Plate - such plates 4 5 shall be designed and issued to any person wishing to demonstrate support for the Boy Scouts of America. The plates shall be issued 6 to any person in any combination of numbers and letters from one to 7 a maximum of seven, as for personalized license plates. The plate 8 9 shall contain the official Boy Scouts of America logo. The Tax Commission shall be authorized, if necessary, to enter into a 10 licensing agreement with the Boy Scouts of America for any licensing 11 12 fees which may be required in order to use the Boy Scouts of America logo or design. The licensing agreement shall provide for a payment 13 to the Boy Scouts of America of not more than Twenty Dollars 14 (\$20.00) for each license plate issued; 15

20. Urban Forestry and Beautification License Plate - such 16 plates shall be designed, subject to criteria to be presented to the 17 Tax Commission, by the Oklahoma Department of Agriculture, Food, and 18 Forestry in consultation with nonprofit organizations in this state 19 that develop and operate programs to encourage urban forestry and 20 beautification, and issued to any person wishing to demonstrate 21 support of such programs. As provided in this section, an amount of 22 the fee collected shall be apportioned as provided in Section 1104.5 23 of this title; 24

1 21. Oklahoma State Parks Supporter License Plate - such plates 2 shall be designed, subject to criteria to be presented to the Tax Commission by the Oklahoma Tourism and Recreation Department, and 3 issued to any person wishing to demonstrate support for the Oklahoma 4 5 state parks system. Twenty-three Dollars (\$23.00) of the fee collected shall be deposited in the Oklahoma Tourism and Recreation 6 Department Revolving Fund. Such money shall be designated for and 7 may only be expended for the support of Oklahoma state parks; 8

9 22. Adoption Creates Families License Plate - such plates shall 10 be issued to any person wishing to demonstrate support of pregnant women who are committed to placing their children for adoption and 11 wishing to provide assistance to guardians, adoptive parents and 12 13 other created families to assist in the adoption and placement of children in permanent, safe homes. The license plates shall be 14 designed and final terminology delivered in consultation with the 15 Oklahoma Adoption Coalition and the Department of Human Services. 16 Twenty-five Dollars (\$25.00) of the fee collected shall be deposited 17 in a revolving fund established in the State Treasury for and to be 18 used by the Department of Human Services for the implementation of 19 the Investing in Stronger Oklahoma Families Act specifically for 20 created families; 21

22 23. Choose Life License Plate - such plates shall be designed,
23 subject to criteria presented to the Tax Commission, by Choose Life,
24 Inc., and issued to any person who wishes to demonstrate support of

organizations that encourage adoption as a positive choice for women with unplanned pregnancies. As provided in this section, an amount of the fee collected shall be deposited in the Choose Life Assistance Program Revolving Fund established in Section 1104.6 of this title;

6 24. Future Farmers of America License Plate - such plates shall 7 be designed and issued to persons wishing to demonstrate support for 8 the Oklahoma FFA (formerly known as Future Farmers of America). The 9 license plates shall be designed in consultation with the Oklahoma 10 FFA Foundation Board of Directors. As provided in this section, an 11 amount of the fee collected shall be apportioned as provided in 12 Section 1104.7 of this title;

25. Lions Club License Plate - such plates shall be designed 13 and issued to persons wishing to demonstrate support for the Lions 14 Club of Oklahoma. The plates shall be issued to any person in any 15 combination of numbers and letters from one to a maximum of seven, 16 as for personalized license plates. The license plates shall be 17 designed in consultation with the Oklahoma Lions Service Foundation 18 and shall contain the official logo of the International Association 19 of Lions Clubs. The Tax Commission shall be authorized to enter 20 into a licensing agreement with the Oklahoma Lions Service 21 Foundation. The licensing agreement shall provide for a payment to 22 the Oklahoma Lions Service Foundation of not more than Ten Dollars 23 (\$10.00) for each license plate issued; 24

1 26. Color Oklahoma License Plate - such plates shall be 2 designed, subject to criteria to be presented to the Tax Commission by the Oklahoma Native Plant Society, and issued to any person 3 wishing to demonstrate support for preserving and planting 4 5 wildflowers and native plants in Oklahoma and to promote Oklahoma's wildflower heritage through education. As provided in this section, 6 an amount of the fee collected shall be apportioned as provided in 7 Section 1104.8 of this title; 8

9 27. Girl Scouts of the United States of America Supporter License Plate - such plates shall be designed and issued to any 10 person wishing to demonstrate support for the Girl Scouts of the 11 12 United States of America. The plates shall be issued to any person in any combination of numbers and letters from one to a maximum of 13 seven, as for personalized license plates.
