18	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
19	SECTION 1. AMENDATORY 44 O.S. 2011, Section 235, is
20	amended to read as follows:
21	Section 235. There is hereby created the 45th Infantry Division
22	Oklahoma National Guard Museum, to be under the supervision of the
23	Adjutant General. The Adjutant General may appoint an Executive
24	Director to oversee the daily operations and maintenance of the

museum and perform other duties as requested by the Adjutant 1 General. Appropriate state agencies are directed to make available, 2 for display of items of historical significance and necessary space 3 for administration, the buildings presently occupied by the Oklahoma 4 Military Department, located in the vicinity of 36th Street and 5 North Eastern in Oklahoma City, Oklahoma. The building herein 6 referred to shall be made available by the Adjutant General as soon 7 as same is no longer needed by and is vacated by the Oklahoma 8 Military Department. The Executive Director, subject to the 9 approval of the Adjutant General, may lease to the 45th Infantry 10 Division Association, for periods not exceeding one (1) year and 11 12 with provisions for renewal from year to year, an area to be used as a gift shop, if the lease does not interfere with its use by the 13 45th Infantry Division Oklahoma National Guard Museum. The proceeds 14 of the sales from the gift shop shall remain with the 45th Infantry 15 Division Association for operating purposes. 16

SECTION 2. AMENDATORY 44 O.S. 2011, Section 235.1, as amended by Section 156, Chapter 304, O.S.L. 2012 (44 O.S. Supp. 2020, Section 235.1), is amended to read as follows:

20 Section 235.1. There is hereby created in the State Treasury a 21 special fund to be known as the "45th Infantry Division Oklahoma 22 <u>National Guard Museum Fund"</u>, which fund shall consist of donations 23 received for operation and maintenance of the museum and monies 24 received from the sale of Armed Forces Veterans Motorcycle License

Plates pursuant to Section 1135.5 of Title 47 of the Oklahoma 1 Statutes. Said The fund shall be a continuing fund not subject to 2 fiscal year limitations and shall be under the administrative 3 direction of the Oklahoma Military Department. Expenditures from 4 the fund created by this section shall be used exclusively for 5 expenses of operation and maintenance of the 45th Infantry Division 6 Oklahoma National Guard Museum and shall be made pursuant to the 7 laws of this state and without legislative appropriation. Warrants 8 for expenditures from said the fund shall be drawn by the State 9 Treasurer, based on claims signed by an authorized employee of the 10 department and approved for payment by the Director of the Office of 11 12 Management and Enterprise Services.

SECTION 3. AMENDATORY 44 O.S. 2011, Section 235.2, as amended by Section 157, Chapter 304, O.S.L. 2012 (44 O.S. Supp. 2020, Section 235.2), is amended to read as follows:

Section 235.2. The Adjutant General of Oklahoma is hereby authorized to accept gifts for and on behalf of the state of military artifacts, military books and maps and materials, supplies and equipment which support the construction and operation of the museum which have been or may be specifically donated to the 45th Infantry Division Oklahoma National Guard Museum.

The Executive Director of the 45th Infantry Division Oklahoma National Guard Museum is directed to maintain and preserve appropriate records for all such gifts made to the museum.

Upon declaring that certain military artifacts or military books 1 and maps belonging to the 45th Infantry Division Oklahoma National 2 Guard Museum are surplus to the needs of the museum, the Executive 3 Director of the 45th Infantry Division Oklahoma National Guard 4 Museum is authorized to effect an exchange of the same on an 5 equitable basis for military artifacts or military books and maps 6 needed by the museum with the approval of the Office of Management 7 and Enterprise Services and to sell such military artifacts, books 8 and maps and use the proceeds to fund artifact purchases and museum 9 upgrades. 10

 SECTION 4. AMENDATORY
 47 O.S. 2011, Section 1135.5, as

 last amended by Section 3, Chapter 434, O.S.L. 2019 (47 O.S. Supp.

 13
 2020, Section 1135.5), is amended to read as follows:

Section 1135.5. A. The Oklahoma Tax Commission is hereby authorized to design and issue appropriate official special license plates to persons wishing to demonstrate support and provide financial assistance as provided by this section.

Special license plates shall not be transferred to any other person but shall be removed from the vehicle upon transfer of ownership and retained. The special license plate may then be used on another vehicle but only after such other vehicle has been registered for the current year with a motor license agent.

23 Special license plates shall be renewed each year by the Tax
24 Commission or a motor license agent, unless authorized by the Tax

Commission to be renewed for a period greater than one (1) year. The Tax Commission shall notify by mail all persons issued special license plates. The notice shall contain all necessary information and shall contain instructions for the renewal procedure upon presentation to a motor license agent or the Tax Commission. The license plates shall be issued on a staggered system.

The Tax Commission is hereby directed to develop and implement a 7 system whereby motor license agents are permitted to accept 8 applications for special license plates authorized under this 9 section. The motor license agent shall confirm the applicant's 10 eligibility, if applicable, collect and deposit any amount 11 12 specifically authorized by law, accept and process the necessary information directly into such system and generate a receipt 13 accordingly. For performance of these duties, motor license agents 14 shall retain the fee provided in Section 1141.1 of this title for 15 registration of a motor vehicle. The motor license agent fees for 16 acceptance of applications and renewals shall be paid out of the 17 Oklahoma Tax Commission Reimbursement Fund. 18

19 If fewer than one hundred of any type of special license plates 20 authorized prior to January 1, 2004, are issued prior to January 1, 21 2006, the Tax Commission shall discontinue issuance and renewal of 22 that type of special license plate. Any such authorized special 23 license plate registrant shall be allowed to display the license 24 plate upon the designated vehicle until the registration expiration

1 date. After such time the expired special license plate shall be 2 removed from the vehicle.

For special license plates authorized on or after July 1, 2004, 3 no special license plates shall be developed or issued by the Tax 4 Commission until the Commission receives one hundred prepaid 5 applications therefor. The prepaid applications must be received by 6 the Tax Commission within one hundred eighty (180) days of the 7 effective date of the authorization or the authority to issue shall 8 be null and void. In the event one hundred prepaid applications are 9 not received by the Tax Commission within such prescribed time 10 period any payment so received shall be refunded accordingly. 11

B. The special license plates provided by this section are as follows:

University or College Supporter License Plate - such plates
 shall be designed and issued to any person wishing to demonstrate
 support to any state-supported or private university or college. As
 provided in this section, an amount of the fee collected shall be
 apportioned as provided in Section 1104.1 of this title;

2. Environmental Awareness License Plate - such plates shall be
 designed, subject to the criteria to be presented to the Tax
 Commission by the Department of Environmental Quality in
 consultation with the Oklahoma Arts Council, and issued to any
 person wishing to demonstrate support to implement the statewide
 general public environmental education program created pursuant to

the provisions of the Oklahoma Environmental Quality Code. 1 Such plates shall be designed and issued to any person in any combination 2 of numbers and letters from one to a maximum of seven, as for 3 personalized license plates. A dealer's license plate issued 4 pursuant to Section 1116.1 or 1128 of this title may be designated 5 an Environmental Awareness License Plate upon payment of the fee 6 imposed by this section and any other registration fees required by 7 the Oklahoma Vehicle License and Registration Act. As provided in 8 this section, an amount of the fee collected shall be apportioned 9 pursuant to Section 1104.2 of this title; 10

3. Firefighter License Plate - such plates shall be designed 11 12 for any career or retired firefighter, volunteer or paid. Firefighters may apply for firefighter plates for up to four 13 vehicles with a rated capacity of one (1) ton or less or for a 14 motorcycle upon proof of a fire department membership by either an 15 identification card or letter from the chief of the fire department. 16 Retirees who are eligible for such plates shall provide proof of 17 eligibility upon initial application, but shall not be required to 18 provide proof of eligibility annually. The surviving spouse of any 19 deceased firefighter, if the spouse has not since remarried, may 20 apply for a firefighter license plate for one vehicle with a rated 21 carrying capacity of one (1) ton or less or for a motorcycle upon 22 proof that the deceased firefighter was a member of a fire 23 department by either an identification card or letter from the chief 24

of the fire department. The license plate shall be designed in
 consultation with the Oklahoma Firefighters Association.

As provided in this section, an amount of the fee collected shall be deposited to the Oklahoma State Firemen's Museum Building & Memorial Fund for support of the Oklahoma Firefighters Museum and the Oklahoma Fallen and Living Firefighters Memorial;

4. Wildlife Conservation License Plate - such plates shall be 7 designed, subject to the criteria to be presented to the Tax 8 Commission by the Oklahoma Department of Wildlife Conservation in 9 consultation with the Oklahoma Arts Council, and issued to any 10 person wishing to demonstrate support for wildlife conservation in 11 12 this state through the Wildlife Diversity Fund, provided for in Section 3-310 of Title 29 of the Oklahoma Statutes. Such plates may 13 be designed and issued to any person as for personalized license 14 plates. 1.5

As provided in this section, an amount of the fee collected shall be apportioned pursuant to subsection D of Section 3-310 of Title 29 of the Oklahoma Statutes;

5. Child Abuse Prevention License Plate - such plates shall be
designed, subject to the criteria to be presented to the Tax
Commission by the Office of Child Abuse Prevention in the State
Department of Health and the Oklahoma Committee to Prevent Child
Abuse, and issued to any person wishing to demonstrate support for
the prevention of child abuse.

As provided in this section, an amount of the fee collected
 shall be deposited in the Child Abuse Prevention Fund;

6. United States Olympic Committee Supporter License Plate -3 such plates shall be designed and issued to any person wishing to 4 demonstrate support for the United States Olympic Committee. The 5 plates shall be issued to any person in any combination of numbers 6 and letters from one to a maximum of seven, as for personalized 7 license plates. The plate shall contain the official United States 8 Olympic Committee logo. The Tax Commission shall be authorized, if 9 necessary, to enter into a licensing agreement with the United 10 States Olympic Committee for any licensing fees which may be 11 12 required in order to use the United States Olympic Committee logo or design. The licensing agreement shall provide for a payment of not 13 more than Twenty-five Dollars (\$25.00) for each license plate 14 issued: 1.5

7. Oklahoma History License Plate - such plates shall be
designed and issued to any person wishing to demonstrate interest in
Oklahoma history. As provided in this section, an amount of the fee
collected shall be deposited to the Oklahoma Historical Society
Revolving Fund to be used for educational purposes;

8. Historic Route 66 License Plate - such:
a. vehicle plates shall be designed to honor historic
Route 66, also known as the "Mother Road". As
provided in this section, an amount of the fee

collected for each vehicle license plate shall be 1 apportioned to the Oklahoma Historical Society 2 Revolving Fund to be distributed to the Route 66 3 Museum located in Clinton, Oklahoma, and 4 b. motorcycle plates shall be designed in consultation 5 with the Oklahoma Route 66 Association, Inc. The 6 Oklahoma Tax Commission shall be authorized to enter 7 into a licensing agreement with the Oklahoma Route 66 8 Association, Inc., for any licensing fees which may be 9 required in order to use the Oklahoma Route 66 10 Association, Inc., logo or design. The licensing 11 12 agreement shall provide for a payment to the Oklahoma Route 66 Association, Inc., of not more than Twenty 13 Dollars (\$20.00) for each motorcycle license plate 14 issued: 15

9. Heart of the Heartland License Plate - such plates shall be designed and issued to any person wishing to honor the victims of the terrorist bombing attack on the Alfred P. Murrah Federal Building in downtown Oklahoma City on April 19, 1995. As provided in this section, an amount of the fee collected shall be deposited in the Heart of the Heartland Scholarship Fund, as established in Section 2282 of Title 70 of the Oklahoma Statutes;

23 10. Emergency Medical Technician License Plate - such plates
 24 shall be designed and issued to any person who is an emergency

medical technician. Such persons may apply for an emergency medical 1 technician license plate for each vehicle with a rated carrying 2 capacity of one (1) ton or less upon proof of an emergency medical 3 technician's license. The license plate shall be designed in 4 consultation with the state association of emergency medical 5 technicians. As provided in this section, an amount of the fee 6 collected shall be apportioned to the Emergency Medical Personnel 7 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63 8 of the Oklahoma Statutes; 9

10 11. Fight Breast Cancer License Plate - such plates shall be 11 designed to demonstrate support for the prevention and treatment of 12 breast cancer in this state. As provided in this section, an amount 13 of the fee collected shall be apportioned to the Breast Cancer Act 14 Revolving Fund;

12. Crime Victims Awareness License Plate - such plates shall 15 be designed and issued to any person wishing to demonstrate 16 awareness of and support for victims of crimes. The license plates 17 shall be designed in consultation with the Oklahoma Crime Victims 18 Centre. As provided in this section, an amount of the fee collected 19 shall be apportioned to the Attorney General's Revolving Fund for 20 the Office of the Attorney General, which is hereby directed to use 21 such funds to contract with a statewide nonprofit organization to 22 provide services to crime victims; 23

Oklahoma Safe Kids Association License Plate - such plates 1 13. shall be designed and issued to any person wishing to demonstrate 2 support and awareness of the Oklahoma Safe Kids Association. The 3 license plate shall be designed in consultation with the Oklahoma 4 Safe Kids Association. As provided in this section, an amount of 5 the fee collected shall be deposited in the Children's Hospital -6 Oklahoma Safe Kids Association Revolving Fund to be distributed to 7 the Oklahoma Safe Kids Association program; 8

14. Four-H Club License Plate - such plates shall be designed, 9 subject to criteria to be presented to the Tax Commission by the 10 Four-H Foundation, and issued to any person wishing to demonstrate 11 12 support of the Four-H Club. Such plates may be designed and issued to any person as for personalized license plates. As provided in 13 this section, an amount of the fee collected shall be apportioned to 14 the OSU Extension Service License Plate Revolving Fund created in 15 Section 1104.4 of this title; 16

15. Agricultural Awareness License Plate - such plates shall be 17 designed, subject to criteria to be presented to the Tax Commission, 18 by the Oklahoma Department of Agriculture, Food, and Forestry in 19 consultation with the Oklahoma Arts Council, and issued to any 20 person wishing to demonstrate support of the Department's Ag in the 21 Classroom Education Program. As provided in this section, an amount 22 of the fee collected shall be apportioned as provided in Section 23 1104.3 of this title; 24

16. Oklahoma Statehood Centennial License Plate - such plates 1 shall be designed and issued to any person wishing to commemorate 2 the centennial of Oklahoma's admission to statehood in 1907. The 3 license plates shall be designed in consultation with the Oklahoma 4 Capitol Complex and Centennial Commemoration Commission. As 5 provided in this section, an amount of the fee collected shall be 6 deposited in the Oklahoma Capitol Complex and Centennial 7 Commemoration Commission Revolving Fund created in Section 98.5 of 8 Title 73 of the Oklahoma Statutes; 9

17. Support Education License Plate - such plates shall be 10 designed, subject to criteria to be presented to the Tax Commission 11 12 by the State Department of Education in consultation with the Oklahoma Arts Council, and issued to any person wishing to 13 demonstrate support for education in this state. All motor license 14 agents shall display a sample of the Support Education License plate 15 in the area of the business accessed by the public. Twenty-three 16 Dollars (\$23.00) of the fee collected shall be apportioned as 17 follows: 18

- a. five percent (5%) shall be deposited to the Education
 Reform Revolving Fund,
- b. five percent (5%) shall be deposited to the Higher
 Education Revolving Fund,
- c. five percent (5%) shall be deposited to the State
 Career Technology Fund, and

d. eighty-five percent (85%) of the fee shall be
deposited to the Teachers' Retirement Benefit Fund as
set forth in Section 17-108 of Title 70 of the
Oklahoma Statutes.

However, when the Teachers' Retirement Benefit Fund attains a seventy percent (70%) funded ratio based on an annual actuarial valuation as required by law, the amount of the fee shall be apportioned equally pursuant to subparagraphs a, b and c of this paragraph;

18. Retired Oklahoma Highway Patrol Officers License Plate -10 such plates shall be designed and issued to any retired officer of 11 12 the Oklahoma Highway Patrol. The license plate shall have the legend "Oklahoma" and shall contain, in the center of the plate, the 13 Highway Patrol Officers patch using the same colors and pattern as 14 used in the patch. Centered on the bottom of the license plate 15 shall be the word "Retired". The letters "TRP" shall be used in 16 combination with three numbers on either side of the insignia or 17 The color of the letters and numbers shall be brown. emblem. 18 Retirees who are eligible for such plates shall provide proof of 19 eligibility upon initial application, but shall not be required to 20 provide proof of eligibility annually. The surviving spouse of any 21 deceased retired officer of the Oklahoma Highway Patrol, if the 22 spouse has not since remarried, or if remarried, the remarriage is 23 terminated by death, divorce, or annulment, may apply for a Retired 24

Oklahoma Highway Patrol Officers license plate. As provided in this
 section, an amount of the fee collected shall be deposited into the
 Law Enforcement Retirement Fund;

Boy Scouts of America Supporter License Plate - such plates 19. 4 shall be designed and issued to any person wishing to demonstrate 5 support for the Boy Scouts of America. The plates shall be issued 6 to any person in any combination of numbers and letters from one to 7 a maximum of seven, as for personalized license plates. The plate 8 shall contain the official Boy Scouts of America logo. The Tax 9 Commission shall be authorized, if necessary, to enter into a 10 licensing agreement with the Boy Scouts of America for any licensing 11 12 fees which may be required in order to use the Boy Scouts of America logo or design. The licensing agreement shall provide for a payment 13 to the Boy Scouts of America of not more than Twenty Dollars 14 (\$20.00) for each license plate issued; 15

20. Urban Forestry and Beautification License Plate - such 16 plates shall be designed, subject to criteria to be presented to the 17 Tax Commission, by the Oklahoma Department of Agriculture, Food, and 18 Forestry in consultation with nonprofit organizations in this state 19 that develop and operate programs to encourage urban forestry and 20 beautification, and issued to any person wishing to demonstrate 21 support of such programs. As provided in this section, an amount of 22 the fee collected shall be apportioned as provided in Section 1104.5 23 of this title; 24

Oklahoma State Parks Supporter License Plate - such plates 1 21. shall be designed, subject to criteria to be presented to the Tax 2 Commission by the Oklahoma Tourism and Recreation Department, and 3 issued to any person wishing to demonstrate support for the Oklahoma 4 state parks system. Twenty-three Dollars (\$23.00) of the fee 5 collected shall be deposited in the Oklahoma Tourism and Recreation 6 Department Revolving Fund. Such money shall be designated for and 7 may only be expended for the support of Oklahoma state parks; 8

22. Adoption Creates Families License Plate - such plates shall 9 be issued to any person wishing to demonstrate support of pregnant 10 women who are committed to placing their children for adoption and 11 12 wishing to provide assistance to guardians, adoptive parents and other created families to assist in the adoption and placement of 13 children in permanent, safe homes. The license plates shall be 14 designed and final terminology delivered in consultation with the 15 Oklahoma Adoption Coalition and the Department of Human Services. 16 Twenty-five Dollars (\$25.00) of the fee collected shall be deposited 17 in a revolving fund established in the State Treasury for and to be 18 used by the Department of Human Services for the implementation of 19 the Investing in Stronger Oklahoma Families Act specifically for 20 created families; 21

22 23. Choose Life License Plate - such plates shall be designed,
23 subject to criteria presented to the Tax Commission, by Choose Life,
24 Inc., and issued to any person who wishes to demonstrate support of

organizations that encourage adoption as a positive choice for women with unplanned pregnancies. As provided in this section, an amount of the fee collected shall be deposited in the Choose Life Assistance Program Revolving Fund established in Section 1104.6 of this title;

6 24. Future Farmers of America License Plate - such plates shall 7 be designed and issued to persons wishing to demonstrate support for 8 the Oklahoma FFA (formerly known as Future Farmers of America). The 9 license plates shall be designed in consultation with the Oklahoma 10 FFA Foundation Board of Directors. As provided in this section, an 11 amount of the fee collected shall be apportioned as provided in 12 Section 1104.7 of this title;

25. Lions Club License Plate - such plates shall be designed 13 and issued to persons wishing to demonstrate support for the Lions 14 Club of Oklahoma. The plates shall be issued to any person in any 1.5 combination of numbers and letters from one to a maximum of seven, 16 as for personalized license plates. The license plates shall be 17 designed in consultation with the Oklahoma Lions Service Foundation 18 and shall contain the official logo of the International Association 19 of Lions Clubs. The Tax Commission shall be authorized to enter 20 into a licensing agreement with the Oklahoma Lions Service 21 Foundation. The licensing agreement shall provide for a payment to 22 the Oklahoma Lions Service Foundation of not more than Ten Dollars 23 (\$10.00) for each license plate issued; 24

26. Color Oklahoma License Plate - such plates shall be 1 designed, subject to criteria to be presented to the Tax Commission 2 by the Oklahoma Native Plant Society, and issued to any person 3 wishing to demonstrate support for preserving and planting 4 wildflowers and native plants in Oklahoma and to promote Oklahoma's 5 wildflower heritage through education. As provided in this section, 6 an amount of the fee collected shall be apportioned as provided in 7 Section 1104.8 of this title; 8

27. Girl Scouts of the United States of America Supporter 9 License Plate - such plates shall be designed and issued to any 10 person wishing to demonstrate support for the Girl Scouts of the 11 12 United States of America. The plates shall be issued to any person in any combination of numbers and letters from one to a maximum of 13 seven, as for personalized license plates. The plate shall contain 14 the official Girl Scouts of the United States of America logo. 1.5 The Tax Commission shall be authorized, if necessary, to enter into a 16 licensing agreement with the Girl Scouts of the United States of 17 America for any licensing fees which may be required in order to use 18 the Girl Scouts of the United States of America logo or design. The 19 licensing agreement shall provide for a payment to the Girl Scouts 20 of Magic Empire Council, acting on behalf of all Oklahoma Girl Scout 21 councils, of not more than Twenty Dollars (\$20.00) for each license 22 plate issued; 23

28. Oklahoma City Memorial Marathon License Plate - such plates 1 shall be designed and issued to any person wishing to demonstrate 2 support for the Oklahoma City Memorial Marathon. The plate shall be 3 designed in consultation with the Oklahoma City Memorial Marathon. 4 The Tax Commission shall be authorized to enter into a licensing 5 agreement with the Oklahoma City Memorial Marathon for any licensing 6 fees which may be required in order to use the Oklahoma City 7 Memorial Marathon logo or design. The licensing agreement shall 8 provide for a payment to the Oklahoma City Memorial Marathon of not 9 more than Twenty Dollars (\$20.00) for each license plate issued; 10 29. Oklahoma Scenic Rivers License Plate - such plates shall be 11 12 designed to demonstrate support for the Oklahoma Scenic Rivers. The plates shall be designed in consultation with the Oklahoma Scenic 13
