16       1135.5), which relate to specialty license plates;

requiring monitoring of certain fund; requiring  
transfer of certain funds upon accrual; requiring  
certain fund cease to exist upon certain date;  
repealing Section 4, Chapter 434, O.S.L. 2019 (68  
O.S. Supp. 2020, Section 2368.32), as last amended by  
Section 4 of this act, which relates to the Historic  
Greenwood District/Juneteenth Festival Revolving  
Fund; providing effective dates; and declaring an  
emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1       SECTION 1.       AMENDATORY       47 O.S. 2011, Section 1135.2, as  
2 last amended by Section 1, Chapter 434, O.S.L. 2019 (47 O.S. Supp.  
3 2020, Section 1135.2), is amended to read as follows:

4       Section 1135.2 A. The Oklahoma Tax Commission is hereby  
5 authorized to design and issue appropriate official special license  
6 plates to persons in recognition of their service or awards as  
7 provided by this section.

8       Special license plates shall not be transferred to any other  
9 person but shall be removed from the vehicle upon transfer of  
10 ownership and retained. The special license plate may then be used  
11 on another vehicle but only after such other vehicle has been  
12 registered for the current year.

13       Special license plates shall be renewed each year by the Tax  
14 Commission or a motor license agent. The Tax Commission shall  
15 annually notify by mail all persons issued special license plates.  
16 The notice shall contain all necessary information and shall contain  
17 instructions for the renewal procedure upon presentation to a motor  
18 license agent or the Tax Commission. The license plates shall be  
19 issued on a staggered system except for legislative plates and  
20 amateur radio operator license plates.

21       The Tax Commission is hereby directed to develop and implement a  
22 system whereby motor license agents are permitted to accept  
23 applications for special license plates authorized under this  
24 section. The motor license agent shall confirm the applicant's

1 eligibility, if applicable, collect and deposit any amount  
2 specifically authorized by law, accept and process the necessary  
3 information directly into such system and generate a receipt  
4 accordingly. For performance of these duties, motor license agents  
5 shall retain the fee provided in Section 1141.1 of this title for  
6 registration of a motor vehicle. The motor license agent fees for  
7 acceptance of applications and renewals shall be paid out of the  
8 Oklahoma Tax Commission Reimbursement Fund.

9 B. The special license plates provided by this section are as  
10 follows:

11 1. Prisoner of War License Plates - such plates shall be  
12 designed for honorably discharged or present members of the United  
13 States Armed Forces and civilians who were former prisoners of war  
14 held by a foreign country and who can provide proper certification  
15 of that status. Such persons may apply for a prisoner of war  
16 license plate for no more than two vehicles with each vehicle having  
17 a rated carrying capacity of one (1) ton or less. The surviving  
18 spouse of any deceased former prisoner of war, if the spouse has not  
19 since remarried, or if remarried, the remarriage is terminated by  
20 death, divorce, or annulment, may apply for a prisoner of war  
21 license plate for one vehicle with a rated carrying capacity of one  
22 (1) ton or less. The fee provided by this section for the special  
23 license plate authorized by this paragraph shall be in addition to  
24

1 all other registration fees provided by law, except the registration  
2 fees levied by Section 1132 of this title;

3 2. National Guard License Plates - such plates shall be  
4 designed for active or retired members of the Oklahoma National  
5 Guard. Retirees who are eligible for such plates shall provide  
6 proof of eligibility upon initial application, but shall not be  
7 required to provide proof of eligibility annually;

8 3. Air National Guard License Plates - such plates shall be  
9 designed for active or retired members of the Oklahoma Air National  
10 Guard. Retirees who are eligible for such plates shall provide  
11 proof of eligibility upon initial application, but shall not be  
12 required to provide proof of eligibility annually;

13 4. United States Armed Forces License Plates - such plates  
14 shall be designed for active, retired, former or reserve members of  
15 the United States Armed Forces, and shall identify which branch of  
16 service, and carry the emblem and name of either the Army, Navy, Air  
17 Force, Marines or Coast Guard, according to the branch of service to  
18 which the member belongs or did belong. Former members who have  
19 been dishonorably discharged shall not be eligible for such plates.  
20 Persons applying for such license plate must show proof of present  
21 or past military service by presenting a valid Uniformed Services  
22 Identity Card or the United States Department of Defense Form  
23 (DD)214. Retired or former members who are eligible for such plates  
24

1 shall provide proof of eligibility upon initial application, but  
2 shall not be required to provide proof of eligibility annually;

3 5. Congressional Medal of Honor Recipient License Plates - such  
4 plates shall be designed for any resident of this state who has been  
5 awarded the Congressional Medal of Honor. Such persons may apply  
6 for a Congressional Medal of Honor recipient license plate for each  
7 vehicle with a rated carrying capacity of one (1) ton or less.  
8 There shall be no registration fee for the issuance of this plate;

9 6. Missing In Action License Plates - such plates shall be  
10 designed to honor members of the United States Armed Forces who are  
11 missing in action. The spouse of such missing person, if the spouse  
12 has not since remarried, or if remarried, the remarriage is  
13 terminated by death, divorce, or annulment, and each parent of the  
14 missing person may apply for a missing in action license plate upon  
15 presenting proper certification that the person is missing in action  
16 and that the person making the application is the qualifying spouse  
17 or the parent of the missing person. The qualifying spouse and each  
18 parent of the missing person may each apply for the missing in  
19 action license plate for each vehicle with a rated carrying capacity  
20 of one (1) ton or less;

21 7. Purple Heart Recipient License Plates - such plates shall be  
22 designed for any resident of this state presenting proper  
23 certification from the United States Department of Veterans Affairs  
24 or the Armed Forces of the United States certifying that such

1 resident has been awarded the Purple Heart military decoration.  
2 Such persons may apply for a Purple Heart recipient license plate  
3 for vehicles having a rated carrying capacity of one (1) ton or  
4 less. The surviving spouse of any deceased veteran who has been  
5 awarded the Purple Heart military decoration, if such spouse has not  
6 since remarried, or if remarried, the remarriage has been terminated  
7 by death, divorce or annulment, may apply for such plate for one  
8 vehicle with a rated carrying capacity of one (1) ton or less. The  
9 license plate created by this paragraph shall be exempt from the fee  
10 provided by this section for special license plates;

11 8. Pearl Harbor Survivor License Plates - such plates shall be  
12 designed for any resident of this state who can be verified by the  
13 United States Department of Veterans Affairs or the Armed Forces of  
14 the United States as being:

- 15 a. a member of the United States Armed Forces on December  
16 7, 1941,
- 17 b. stationed on December 7, 1941, during the hours of  
18 7:55 a.m. to 9:45 a.m. Hawaii time at Pearl Harbor,  
19 the island of Oahu, or offshore at a distance not to  
20 exceed three (3) miles, and
- 21 c. a recipient of an honorable discharge from the United  
22 States Armed Forces.

1       Such person may apply for a Pearl Harbor Survivor license plate  
2 for each vehicle with a rated carrying capacity of one (1) ton or  
3 less;

4       9. Iwo Jima License Plates - such plates shall be designed for  
5 any resident of this state who can be verified by the United States  
6 Department of Veterans Affairs or the Armed Forces of the United  
7 States as being:

- 8           a. a member of the United States Armed Forces in February  
9               of 1945,
- 10          b. stationed in February of 1945 on or in the immediate  
11               vicinity of the island of Iwo Jima, and
- 12          c. a recipient of an honorable discharge from the United  
13               States Armed Forces.

14       Such person may apply for an Iwo Jima license plate for each  
15 vehicle with a rated carrying capacity of one (1) ton or less.

16       Such license plate shall have the legend "Oklahoma OK" and shall  
17 contain three letters and three numbers. Between the letters and  
18 numbers shall be a logo of the flag-raising at Iwo Jima. Below the  
19 letters, logo and numbers, the plate shall contain the words "FEB."  
20 at the left, "Iwo Jima" in the center and "1945" at the right. Such  
21 plates shall not be subject to the design requirements of any other  
22 license plates prescribed by law other than the space for the  
23 placement of the yearly decals for each succeeding year of  
24 registration after the initial issue;



1        10. D-Day Survivor License Plates - such plates shall be  
2 designed for any resident of this state who can be verified by the  
3 United States Department of Veterans Affairs or the Armed Forces of  
4 the United States as being:

5            a. a member of the United States Armed Forces on June 6,  
6                1944,

7            b. a participant in the Allied invasion of the coast of  
8                Normandy on June 6, 1944; provided, if such  
9                participation cannot be verified by the United States  
10               Department of Veterans Affairs or the Armed Forces of  
11               the United States, the Tax Commission may, in its  
12               discretion, accept evidence of such participation from  
13               the person applying for the license plate, and

14           c. a recipient of an honorable discharge from the United  
15               States Armed Forces.

16        Such person may apply for a D-Day Survivor license plate for  
17 each vehicle with a rated carrying capacity of one (1) ton or less;

18        11. Killed in Action License Plates - such plates shall be  
19 designed to honor members of the United States Armed Forces who were  
20 killed in action. The spouse of the deceased person, if the spouse  
21 has not remarried, or if remarried, the remarriage is terminated by  
22 death, divorce, or annulment, may apply for a killed in action  
23 license plate upon presenting proper certification that the person  
24 was killed in action and that the person making the application is

1 the qualifying spouse of the deceased person. The qualifying spouse  
2 may apply for a killed in action license plate for no more than two  
3 vehicles with each vehicle with a rated carrying capacity of one (1)  
4 ton or less. The fee provided by this section for the special  
5 license plate authorized by this paragraph shall be in addition to  
6 all other registration fees provided by law, except the registration  
7 fees levied by Section 1132 of this title;

8 12. Gold Star ~~Parents~~ Families License Plates - such plates  
9 shall be designed to honor members of the United States Armed Forces  
10 who were killed ~~during a war~~ while on active duty. The parents,  
11 siblings, half-siblings or grandparents of the deceased person may  
12 apply for a gold star license plate upon presenting proper  
13 certification that the person was killed ~~during a war~~ while on  
14 active duty and that the person making the application is the  
15 parent, sibling, half-sibling or grandparent of the deceased person.  
16 The ~~parent~~ family member may apply for a gold star ~~parent~~ families  
17 license plate for no more than two vehicles with each vehicle having  
18 a rated carrying capacity of one (1) ton or less. The fee provided  
19 by this section for the special license plate authorized by this  
20 paragraph shall be in addition to all other registration fees  
21 provided by law, except the registration fees levied by Section 1132  
22 of this title;

23 13. Military Decoration License Plates - such plates shall be  
24 designed for any resident of this state who has been awarded the

1 Distinguished Service Medal, the Distinguished Service Cross, the  
2 Distinguished Flying Cross, the Bronze Star military decoration or  
3 the Silver Star military decoration. Such persons may apply for a  
4 military decoration license plate for each vehicle with a rated  
5 carrying capacity of one (1) ton or less;

6 14. Vietnam Veteran License Plates - such plates shall be  
7 designed for honorably discharged or present members of the United  
8 States Armed Forces who served in the Vietnam Conflict. Such  
9 persons may apply for a Vietnam veteran license plate for each  
10 vehicle with a rated carrying capacity of one (1) ton or less;

11 15. Police Officer License Plates - such plates shall be  
12 designed for any currently employed, reserve or retired municipal  
13 police officer or full-time, reserve or retired university police  
14 officer certified by the Council on Law Enforcement Education and  
15 Training or common education police officer certified by the Council  
16 on Law Enforcement Education and Training. Police officers may  
17 apply for police officer license plates for vehicles with a rated  
18 capacity of one (1) ton or less or for a motorcycle upon proof of  
19 employment by or retirement from a municipal, university or common  
20 education police department by either an identification card or  
21 letter from the chief of the police department or the Oklahoma  
22 Police Pension and Retirement Board. Retirees who are eligible for  
23 such plates shall provide proof of eligibility upon initial  
24 application, but shall not be required to provide proof of

1 eligibility annually. The license plates shall be designed in  
2 consultation with municipal police departments of this state;  
3 provided, the license plate for motorcycles may be of similar design  
4 to the license plate for motor vehicles or may be a new design in  
5 order to meet space requirements for a motorcycle license plate;

6 16. World War II Veteran License Plates - such plates shall be  
7 designed to honor honorably discharged former members of the United  
8 States Armed Forces who are residents of this state and who can be  
9 verified by the Oklahoma Military Department, the Department of  
10 Veterans Affairs or the Armed Forces of the United States as having  
11 served on federal active duty anytime during the period from  
12 September 16, 1940, to December 7, 1945. The former members may  
13 apply for a World War II Veteran license plate for vehicles with a  
14 rated carrying capacity of one (1) ton or less.

15 The license plate shall have the legend "Oklahoma" and shall  
16 contain, in the center of the plate, either the Thunderbird Insignia  
17 of the 45th Infantry Division in the prescribed red and gold  
18 coloring or the emblem of the Army, Navy, U.S. Army Air Corps,  
19 Marines or Coast Guard according to the branch of service to which  
20 the member belonged. For the purpose of license plate  
21 identification, the plate shall contain four digits, two digits at  
22 the left and two digits at the right of the insignia or emblem.  
23 Centered on the bottom of the license plate shall be the words  
24 "WORLD WAR II";

1        17. Korean War Veteran License Plates - such plates shall be  
2 designed to honor honorably discharged former members of the United  
3 States Armed Forces who are residents of this state and who can be  
4 verified by the Oklahoma Military Department, the Department of  
5 Veterans Affairs or the Armed Forces of the United States as having  
6 served on federal active duty anytime during the period from June  
7 27, 1950, to January 31, 1955, both dates inclusive. The former  
8 members may apply for a Korean War Veteran license plate for  
9 vehicles with a rated carrying capacity of one (1) ton or less.

10        The license plate shall have the legend "OKLAHOMA" and shall  
11 contain, in the center of the plate, either the Thunderbird Insignia  
12 of the 45th Infantry Division in the prescribed red and gold  
13 coloring or the emblem of the Army, Navy, Air Force, Marines or  
14 Coast Guard according to the branch of service to which the member  
15 belonged. For the purpose of license plate identification, the  
16 plate shall contain four digits, two digits at the left and two  
17 digits at the right of the insignia or emblem. Centered on the  
18 bottom of the license plate shall be the word "KOREA";

19        18. Municipal Official License Plates - such plates shall be  
20 designed for persons elected to a municipal office in this state and  
21 shall designate the name of the municipality and the district or  
22 ward in which the municipal official serves. The plates shall only  
23 be produced upon application;

1        19. Red Cross Volunteer License Plates - such plates shall be  
2 designed to honor American Red Cross volunteers and staff who are  
3 residents of this state. Such persons must present an  
4 identification card issued by the American Red Cross and bearing a  
5 photograph of the person. The license plate shall be designed with  
6 the assistance of the American Red Cross and shall have the legend  
7 "Oklahoma OK!" in the color Pantone 186C Red. Below the legend the  
8 symbol of the American Red Cross and no more than three letters and  
9 three numbers shall be in the color Pantone 186C Red. Below the  
10 symbol and letters and numbers shall be the words "American Red  
11 Cross" in black. The plates shall not be subject to the design  
12 requirements of any other license plates prescribed by law other  
13 than the space for the placement of the yearly decals for each  
14 succeeding year of registration after the initial issue;

15        20. Desert Storm License Plates - such plates shall be designed  
16 and issued to any honorably discharged or present member of the  
17 United States Armed Forces who served in the Persian Gulf Crisis and  
18 the Desert Storm operation. Such persons may apply for a Desert  
19 Storm license plate for each vehicle with a rated carrying capacity  
20 of one (1) ton or less;

21        21. Military Reserve Unit License Plates - such plates shall be  
22 designed and issued to any honorably discharged or present member of  
23 a reserve unit of the United States Armed Forces. Such persons may  
24

1 apply for a Military Reserve Unit license plate for each vehicle  
2 with a rated carrying capacity of one (1) ton or less;

3 22. Oklahoma City Bombing Victims and Survivors License Plates  
4 - such plates shall be designed and issued to any victim or survivor  
5 of the bombing attack on the Alfred P. Murrah Federal Building in  
6 downtown Oklahoma City on April 19, 1995;

7 23. Civil Air Patrol License Plates - such plates shall be  
8 designed and issued to any person who is a member of the Civil Air  
9 Patrol. Such persons may apply for a Civil Air Patrol license plate  
10 for each vehicle with a rated carrying capacity of one (1) ton or  
11 less upon proof of membership in the Civil Air Patrol. The license  
12 plate shall be designed in consultation with the Civil Air Patrol;

13 24. Ninety-Nines License Plates - such plates shall be designed  
14 and issued to members of the Ninety-Nines. Persons applying for  
15 such license plate must show proof of membership in the Ninety-  
16 Nines. The license plates shall be designed in consultation with  
17 the Ninety-Nines;

18 25. Combat Infantryman Badge License Plates - such plates shall  
19 be designed to honor recipients of the Combat Infantryman Badge.  
20 The plate shall have the legend "Oklahoma OK". Below the legend  
21 shall be the Combat Infantryman Badge and three numbers. Below the  
22 badge and the numbers shall be the words "Combat Infantryman Badge".  
23 Such persons may apply for a Combat Infantryman Badge license plate  
24

1 for each vehicle with a rated carrying capacity of one (1) ton or  
2 less;

3 26. Somalia Combat Veterans License Plates - such plates shall  
4 be designed and issued to any honorably discharged or present member  
5 of the United States Armed Forces who saw combat in the United  
6 Nations relief effort. Such persons may apply for a Somalia Combat  
7 Veteran license plate for each vehicle with a rated carrying  
8 capacity of one (1) ton or less;

9 27. Police Chaplain License Plates - such plates shall be  
10 designed and issued to members of the International Conference of  
11 Police Chaplains (ICPC) who have completed the ICPC requirements for  
12 basic certification as a police chaplain. The license plates shall  
13 be designed in consultation with the ICPC;

14 28. Joint Service Commendation Medal License Plates - such  
15 plates shall be designed and issued to any resident of this state  
16 who has been awarded the Joint Service Commendation Medal by the  
17 United States Secretary of Defense;

18 29. Merchant Marine License Plates - such plates shall be  
19 designed, subject to criteria to be presented to the Tax Commission  
20 by the Oklahoma Department of Veterans Affairs, and issued to any  
21 person who during combat was a member of the Merchant Marines as  
22 certified by the Oklahoma Department of Veterans Affairs. Such  
23 license plate may be issued for each vehicle with a rated carrying  
24 capacity of one (1) ton or less;



1        30. Legislative License Plates - such plates shall be designed  
2 for persons elected to the Oklahoma Legislature and shall designate  
3 the house of the Legislature in which the legislator serves and the  
4 district number;

5        31. Disabled Veterans License Plates - such plates shall be  
6 designed for persons presenting proper certification from the United  
7 States Department of Veterans Affairs or the Armed Forces of the  
8 United States certifying such veteran has a service-connected  
9 disability rating of fifty percent (50%) or more, regardless which  
10 agency pays the disability benefits, or that such veteran has been  
11 awarded a vehicle by the United States government or receives a  
12 grant from the United States Department of Veterans Affairs for the  
13 purchase of an automobile due to a service-connected disability  
14 rating or due to the loss of use of a limb or an eye. Such persons  
15 may apply to the Tax Commission for a disabled veterans license  
16 plate or to a motor license agent for a regular license plate for no  
17 more than two vehicles with each vehicle having a rated carrying  
18 capacity of one (1) ton or less. The surviving spouse of any  
19 deceased disabled veteran, if the spouse has not since remarried, or  
20 if remarried, the remarriage is terminated by death, divorce, or  
21 annulment, or a surviving spouse in receipt of Dependency and  
22 Indemnity Compensation from the United States Department of Veterans  
23 Affairs, may apply for a disabled veterans license plate for one  
24 vehicle with a rated carrying capacity of one (1) ton or less. The

1 fee provided by this section for the special license plate  
2 authorized by this paragraph shall be in addition to all other  
3 registration fees provided by law, except the registration fees  
4 levied by Section 1132 of this title. The total expense of this  
5 license plate shall not exceed Five Dollars (\$5.00).

6 If the person qualifies for a disabled veterans license plate  
7 and is also eligible for a physically disabled placard under the  
8 provisions of Section 15-112 of this title, the person shall be  
9 eligible to receive a disabled veterans license plate that also  
10 displays the international accessibility symbol, which is a stylized  
11 human figure in a wheelchair. Upon the death of the disabled  
12 veteran with a disabled veterans license plate with the  
13 international accessibility symbol, the plate shall be returned to  
14 the Tax Commission;

15 32. United States Air Force Association License Plates - such  
16 plates shall be designed for members of the United States Air Force  
17 Association. Persons applying for such license plate must show  
18 proof of membership in the Association. The license plates shall be  
19 designed in consultation with the Association;

20 33. Oklahoma Military Academy Alumni License Plates - such  
21 plates shall be designed and issued to any resident of this state  
22 who is an alumnus of the Oklahoma Military Academy. Such persons  
23 may apply for an Oklahoma Military Academy Alumnus license plate for  
24 each vehicle with a rated carrying capacity of one (1) ton or less.

1 The license plates shall be designed in consultation with the  
2 Oklahoma Military Academy and shall contain the shield of the  
3 Academy;

4 34. Amateur Radio Operator License Plates - such plates shall  
5 be designed and issued to any person, holding a valid operator's  
6 license, technician class or better, issued by the Federal  
7 Communications Commission, and who is also the owner of a motor  
8 vehicle currently registered in Oklahoma, in which has been  
9 installed amateur mobile transmitting and receiving equipment.  
10 Eligible persons shall be entitled to two special vehicle  
11 identification plates as herein provided. Application for such  
12 identification plates shall be on a form prescribed by the Tax  
13 Commission and the plates issued to such applicant shall have  
14 stamped thereon the word "Oklahoma" and bear the official call  
15 letters of the radio station assigned by the Federal Communications  
16 Commission to the individual amateur operator thereof. All  
17 applications for such plates must be made to the Tax Commission on  
18 or before the first day of October of any year for such plates for  
19 the following calendar year and must be accompanied by the fee  
20 required in this section together with a certificate, or such other  
21 evidence as the Tax Commission may require, of proof that applicant  
22 has a valid technician class or better amateur operator's license  
23 and proof of applicant's ownership of a vehicle in which radio  
24 receiving and transmitting equipment is installed. Applicants shall

1 only be entitled to one set of special identification plates in any  
2 one (1) year, and such calendar year shall be stamped thereon. The  
3 right to such special identification plates herein provided for  
4 shall continue until the amateur radio operator's license of the  
5 person to whom such plates are issued expires or is revoked;

6 35. American Legion License Plates - such plates shall be  
7 designed for members of the American Legion. Persons applying for  
8 such license plate must show proof of membership. The license  
9 plates shall be designed in consultation with the American Legion of  
10 Oklahoma;

11 36. Deputy Sheriff License Plates - such plates shall be  
12 designed for any currently employed or retired county sheriff or  
13 deputy sheriff. County sheriffs or deputy sheriffs may apply for  
14 such plates for vehicles with a rated capacity of one (1) ton or  
15 less upon proof of employment by or retirement from a county  
16 sheriff's office by either an identification card or letter from the  
17 county sheriff or a government-sponsored retirement board from which  
18 the county sheriff or deputy sheriff may be receiving a pension.  
19 Retirees who are eligible for such plates shall provide proof of  
20 eligibility upon initial application, but shall not be required to  
21 provide proof of eligibility annually. The license plates shall be  
22 designed in consultation with the county sheriff offices of this  
23 state;

1        37. Gold Star Surviving Spouse License Plates - such plates  
2 shall be designed to honor the surviving spouses and children of  
3 qualified veterans. As used in this paragraph, "qualified veteran"  
4 shall mean:

- 5            a. any person honorably discharged from any branch of the  
6                United States Armed Forces or as a member of the  
7                Oklahoma National Guard, who died as a direct result  
8                of the performance of duties for any branch of the  
9                United States Armed Forces or Oklahoma National Guard  
10              while on active military duty, or
- 11           b. any person honorably discharged from any branch of the  
12              United States Armed Forces or as a member of the  
13              Oklahoma National Guard, who died as a result of  
14              injury, illness or disease caused by the performance  
15              of such duties while on active duty, whether the death  
16              occurred while on active duty or after the honorable  
17              discharge of such person.

18        The fee provided by this section for the special license plate  
19 authorized by this paragraph shall be in addition to all other  
20 registration fees provided by law, except the registration fees  
21 levied by Section 1132 of this title;

22        38. Korea Defense Service Medal License Plates - such plates  
23 shall be designed and issued to any resident of this state who has  
24 been awarded the Korea Defense Service Medal by the United States

1 Secretary of Defense. Such persons may apply for a Korea Defense  
2 Service Medal license plate for each vehicle with a rated carrying  
3 capacity of one (1) ton or less;

4 39. 180th Infantry License Plates - such plates shall be  
5 designed for members and prior members of the 180th Infantry.  
6 Persons applying for such license plate must obtain and provide  
7 proof of their membership from the 180th Infantry Association. The  
8 license plates shall be designed in consultation with the 180th  
9 Infantry;

10 40. Operation Iraqi Freedom Veteran License Plates - such  
11 plates shall be designed and issued to any honorably discharged or  
12 present member of the United States Armed Forces who served in  
13 Operation Iraqi Freedom. Such person may apply for an Operation  
14 Iraqi Freedom Veteran license plate for each vehicle with a rated  
15 carrying capacity of one (1) ton or less, or for a motorcycle;  
16 provided, the license plate for motorcycles may be of similar design  
17 to the license plate for motor vehicles or may be a new design in  
18 order to meet space requirements for a motorcycle license plate;

19 41. United States Air Force Academy Alumni License Plates -  
20 such plates shall be designed and issued to any resident of this  
21 state who is an alumnus of the United States Air Force Academy.  
22 Such persons may apply for a United States Air Force Academy Alumnus  
23 license plate for each vehicle with a rated carrying capacity of one  
24 (1) ton or less;

1        42. Operation Enduring Freedom Veteran License Plate - such  
2 plates shall be designed and issued to any honorably discharged or  
3 present member of the United States Armed Forces who served in  
4 Operation Enduring Freedom on or after September 11, 2001. The  
5 license plate shall be designed in consultation with the Military  
6 Department of the State of Oklahoma. Such person may apply for an  
7 Operation Enduring Freedom Veteran license plate for each vehicle  
8 with a rated carrying capacity of one (1) ton or less, or for a  
9 motorcycle; provided, the license plate for motorcycles may be of  
10 similar design to the license plate for motor vehicles or may be a  
11 new design in order to meet space requirements for a motorcycle  
12 license plate;

13        43. Military Multi-Decoration License Plate - such plates shall  
14 be designed and issued to any honorably discharged or present member  
15 of the United States Armed Forces who qualifies for more than one  
16 military decoration license plate pursuant to the provisions of this  
17 section. The Tax Commission shall develop and implement a system  
18 whereby the designs of the eligible license plates can be included  
19 together on a single license plate. Such person may apply for a  
20 Military Multi-Decoration license plate for each vehicle with a  
21 rated carrying capacity of one (1) ton or less;

22        44. Global War on Terror Expeditionary License Plate - such  
23 plates shall be designed and issued to any honorably discharged or  
24 present member of the United States Armed Forces who has earned a

1 Global War on Terror Expeditionary decoration. The license plate  
2 shall be designed in consultation with the United States Institute  
3 of Heraldry and the Military Department of the State of Oklahoma.  
4 Such person may apply for a Global War on Terror Expeditionary  
5 license plate for each vehicle with a rated carrying capacity of one  
6 (1) ton or less;

7 45. Legion of Merit Medal Recipient License Plates - such  
8 plates shall be designed for any resident of this state presenting  
9 proper certification from the United States Department of Veterans  
10 Affairs or the Armed Forces of the United States certifying that  
11 such resident has been awarded the Legion of Merit military  
12 decoration. Such persons may apply for a Legion of Merit recipient  
13 license plate for vehicles having a rated carrying capacity of one  
14 (1) ton or less. The license plate shall be designed in  
15 consultation with the Military Department of the State of Oklahoma;

16 46. 1-179th License Plates - such plates shall be designed for  
17 members, prior members and members of the household of a member or  
18 former member of the 1-179th Infantry. Persons applying for such  
19 license plate must obtain and provide proof of their membership  
20 association with the 1-179th Infantry Association. The license  
21 plate shall be designed in consultation with the 1-179th Infantry;

22 47. 2-179th License Plates - such plates shall be designed for  
23 members, prior members and members of the household of a member or  
24 former member of the 2-179th Infantry. Persons applying for such



1 license plate must obtain and provide proof of their membership  
2 association with the 2-179th Infantry Association. The license  
3 plate shall be designed in consultation with the 2-179th Infantry;

4 48. Combat Action Ribbon Recipient License Plates - such plates  
5 shall be designed to honor recipients of the Combat Action Ribbon  
6 who present proper certification from the United States Department  
7 of the Navy. The license plate shall include the Combat Action  
8 Ribbon earned by the recipient. Such persons may apply for a Combat  
9 Action Ribbon Recipient license plate for vehicles having a rated  
10 carrying capacity of one (1) ton or less;

11 49. Oklahoma Submarine Veterans License Plate - such plates  
12 shall be designed for any resident of this state who is a United  
13 States submarine veteran and presents either a Department of Defense  
14 form 214 or other documentation certifying such service. Such  
15 persons may apply for an Oklahoma Submarine Veterans license plate  
16 for vehicles having a rated capacity of one (1) ton or less. The  
17 license plate design shall include both gold and silver dolphins to  
18 represent both officer and enlisted service members;

19 50. United States Navy Seabees and Civil Engineer Corps License  
20 Plate - such plates shall be designed and issued to any honorably  
21 discharged or present member of the United States Navy Seabees or  
22 Civil Engineer Corps. Such persons may apply for a United States  
23 Navy Seabees and Civil Engineer Corps license plate for vehicles  
24 having a rated carrying capacity of one (1) ton or less. The

1 license plate shall be designed in consultation with the Military  
2 Department of the State of Oklahoma;

3 51. Combat Action Badge Recipient License Plate - such plates  
4 shall be designed to honor recipients of the Combat Action Badge who  
5 present proper certification from the United States Army. The  
6 license plate shall include the Combat Action Badge earned by the  
7 recipient. Such persons may apply for a Combat Action Badge  
8 Recipient license plate for vehicles having a rated carrying  
9 capacity of one (1) ton or less, or for a motorcycle; provided, the  
10 license plate for motorcycles may be of similar design to the  
11 license plate for motor vehicles or may be a new design in order to  
12 meet space requirements for a motorcycle license plate;

13 52. Iraq Combat Veteran License Plate - such plates shall be  
14 designed and issued to any honorably discharged or present member of  
15 the United States Armed Forces who saw combat in Operation Iraqi  
16 Freedom. Such persons may apply for an Iraq Combat Veteran license  
17 plate for each vehicle with a rated carrying capacity of one (1) ton  
18 or less, or for a motorcycle; provided, the license plate for  
19 motorcycles may be of similar design to the license plate for motor  
20 vehicles or may be a new design in order to meet space requirements  
21 for a motorcycle license plate;

22 53. Afghanistan Combat Veteran License Plate - such plates  
23 shall be designed and issued to any honorably discharged or present  
24 member of the United States Armed Forces who saw combat in Operation

1 Enduring Freedom. Such persons may apply for an Afghanistan Combat  
2 Veteran license plate for each vehicle with a rated carrying  
3 capacity of one (1) ton or less, or for a motorcycle; provided, the  
4 license plate for motorcycles may be of similar design to the  
5 license plate for motor vehicles or may be a new design in order to  
6 meet space requirements for a motorcycle license plate; and

7 54. Special Forces Association License Plate - such plates  
8 shall be designed and issued to any honorably discharged or present  
9 member of the Army Special Forces qualified and authorized to wear  
10 upon the person's United States military uniform the Army Special  
11 Forces Tab. Persons applying for the Special Forces Association  
12 license plate must provide a copy of the orders awarding the Special  
13 Forces Tab or authorizing its wear upon a United States military  
14 uniform. The license plate shall be designed in consultation with  
15 the Special Forces Association, Chapter 32-50. The Tax Commission  
16 shall produce up to two distinct designs for the Special Forces  
17 Association license plate. Qualified persons may select one design  
18 at the time of application. The plates shall be issued to any  
19 qualified person in any combination of numbers and letters from one  
20 to a maximum of seven, as for personalized license plates.

21 C. Unless otherwise provided by this section, the fee for such  
22 plates shall be Eight Dollars (\$8.00) and shall be in addition to  
23 all other registration fees provided by the Oklahoma Vehicle License  
24 and Registration Act. Such fees shall be deposited in the Oklahoma

1 Tax Commission Reimbursement Fund to be used for the administration  
2 of the Oklahoma Vehicle License and Registration Act.

3 SECTION 2. AMENDATORY 47 O.S. 2011, Section 1135.3, as  
4 last amended by Section 2, Chapter 434, O.S.L. 2019 (47 O.S. Supp.  
5 2020, Section 1135.3), is amended to read as follows:

6 Section 1135.3 A. The Oklahoma Tax Commission is hereby  
7 authorized to design and issue appropriate official special license  
8 plates to persons wishing to demonstrate support, interest, or  
9 membership to or for an organization, occupation, cause or other  
10 subject as provided by this section.

11 Special license plates shall not be transferred to any other  
12 person but shall be removed from the vehicle upon transfer of  
13 ownership and retained. The special license plate may then be used  
14 on another vehicle but only after such other vehicle has been  
15 registered for the current year.

16 Special license plates shall be renewed each year by the Tax  
17 Commission or a motor license agent, unless authorized by the Tax  
18 Commission to be renewed for a period greater than one (1) year.  
19 The Tax Commission shall notify by mail all persons issued special  
20 license plates. The notice shall contain all necessary information  
21 and shall contain instructions for the renewal procedure upon  
22 presentation to a motor license agent or the Tax Commission. The  
23 license plates shall be issued on a staggered system.

1       The Tax Commission is hereby directed to develop and implement a  
2 system whereby motor license agents are permitted to accept  
3 applications for special license plates authorized under this  
4 section. The motor license agent shall confirm the applicant's  
5 eligibility, if applicable, collect and deposit any amount  
6 specifically authorized by law, accept and process the necessary  
7 information directly into such system and generate a receipt  
8 accordingly. For performance of these duties, motor license agents  
9 shall retain the fee provided in Section 1141.1 of this title for  
10 registration of a motor vehicle. The motor license agent fees for  
11 acceptance of applications and renewals shall be paid out of the  
12 Oklahoma Tax Commission Reimbursement Fund.

13       If fewer than one hundred of any type of special license plates  
14 authorized prior to January 1, 2004, are issued prior to January 1,  
15 2006, the Tax Commission shall discontinue issuance and renewal of  
16 that type of special license plate. Any such authorized special  
17 license plate registrant shall be allowed to display the license  
18 plate upon the designated vehicle until the registration expiration  
19 date. After such time the expired special license plate shall be  
20 removed from the vehicle.

21       Except as otherwise provided in law, for special license plates  
22 authorized on or after July 1, 2004, no special license plates shall  
23 be developed or issued by the Tax Commission until the Commission  
24 receives one hundred (100) prepaid applications therefor. The

1 prepaid applications must be received by the Tax Commission within  
2 one hundred eighty (180) days of the effective date of the  
3 authorization or the authority to issue shall be null and void. In  
4 the event one hundred (100) prepaid applications are not received by  
5 the Tax Commission within such prescribed time period any payment so  
6 received shall be refunded accordingly.

7 B. The special license plates provided by this section are as  
8 follows:

9 1. Round and Square Dance License Plate - such plates shall be  
10 designed and issued to any person wishing to demonstrate support for  
11 round and square dancing;

12 2. National Association for the Advancement of Colored People  
13 License Plate - such plates shall be designed, subject to the  
14 criteria to be presented to the Tax Commission by the NAACP, and  
15 issued to any person wishing to demonstrate support for the NAACP;

16 3. National Rifle Association License Plate - such plates shall  
17 be designed, subject to the criteria to be presented to the Tax  
18 Commission by the National Rifle Association, and issued to any  
19 person wishing to demonstrate support for the National Rifle  
20 Association;

21 4. Masonic Fraternity License Plate - such plates shall be  
22 designed and issued to any resident of this state who is a member of  
23 a Masonic Fraternity of Oklahoma. Such persons may apply for a  
24 Masonic Fraternity license plate for each vehicle with a rated

1 carrying capacity of one (1) ton or less upon proof of a Masonic  
2 Fraternity membership or upon the presentment of an application for  
3 a Masonic Fraternity license plate authorized and approved by the  
4 Grand Lodge of Oklahoma. The license plates shall be designed in  
5 consultation with the Masonic Fraternities of Oklahoma and shall  
6 contain the Masonic emblem;

7 5. Shriner's Hospitals for Burned and Crippled Children License  
8 Plate - such plates shall be designed to demonstrate support for  
9 Shriner's Hospitals for Burned and Crippled Children and shall be  
10 issued to any resident of this state who is a member of a Shriner's  
11 Temple in Oklahoma. The license plate shall be designed in  
12 consultation with the Shriner's Temples in Oklahoma and shall  
13 contain the Shriner's emblem;

14 6. Balloonists License Plate - such plates shall be designed  
15 and issued to any person wishing to demonstrate support for hot air  
16 ballooning in this state;

17 7. Order of the Eastern Star License Plate - such plates shall  
18 be designed and issued to any resident of this state who is a member  
19 of an Order of the Eastern Star. Such persons may apply for an  
20 Order of the Eastern Star license plate for each vehicle with a  
21 rated carrying capacity of one (1) ton or less upon proof of an  
22 Order of the Eastern Star membership or upon the presentment of an  
23 application for an Order of the Eastern Star license plate  
24 authorized and approved by the organization. The license plate

1 shall be designed in consultation with the Order of the Eastern Star  
2 and shall contain the Order of the Eastern Star emblem;

3 8. Knights of Columbus License Plate - such plates shall be  
4 designed and issued to any resident of this state who is a member of  
5 the Knights of Columbus. Such persons may apply for a Knights of  
6 Columbus license plate for each vehicle with a rated carrying  
7 capacity of one (1) ton or less upon proof of a Knights of Columbus  
8 membership or upon the presentment of an application for a Knights  
9 of Columbus license plate authorized and approved by the  
10 organization. The license plate shall be designed in consultation  
11 with the Knights of Columbus and shall contain the Knights of  
12 Columbus emblem;

13 9. Jaycees License Plate - such plates shall be designed and  
14 issued to members of the Jaycees. Persons applying for such license  
15 plate must show proof of membership in the Jaycees. The license  
16 plates shall be designed in consultation with the Jaycees;

17 10. Kiwanis International License Plate - such plates shall be  
18 designed and issued to members of Kiwanis International. Persons  
19 applying for such license plate must show proof of membership in  
20 Kiwanis International. The license plates shall be designed in  
21 consultation with Kiwanis International;

22 11. Certified Public Accountants License Plate - such plates  
23 shall be designed and issued to any resident of this state who is a  
24 Certified Public Accountant. Such persons may apply for a Certified



1 Public Accountant license plate for each vehicle with a rated  
2 carrying capacity of one (1) ton or less upon proof of status as a  
3 Certified Public Accountant. The license plates shall be designed  
4 in consultation with the Oklahoma Society of Certified Public  
5 Accountants;

6 12. Civil Emergency Management License Plate - such plates  
7 shall be designed and issued to persons wishing to demonstrate  
8 support for the state civil emergency management system. Persons  
9 applying for such license plate must show proof of official  
10 affiliation by presenting a nonexpired proof of employment,  
11 affiliation or retirement in the form of an identification card or  
12 letter on official letterhead from a municipal, county or state  
13 emergency management department head;

14 13. Civilian Conservation Corps License Plate - such plates  
15 shall be designed, subject to criteria to be presented to the Tax  
16 Commission, by the Civilian Conservation Corps Association, and  
17 issued to any person wishing to demonstrate support of the Civilian  
18 Conservation Corps;

19 14. Rotarian License Plate - such plates shall be designed and  
20 issued to any resident of this state who is a member of a Rotarian  
21 Club of Oklahoma. Such persons may apply for a Rotarian license  
22 plate for each vehicle with a rated carrying capacity of one (1) ton  
23 or less upon proof of a Rotarian Club membership or upon the  
24 presentment of an application for a Rotarian license plate

1 authorized and approved by a Rotarian Club of Oklahoma. The license  
2 plates shall be designed in consultation with the five Rotarian  
3 District Governors and shall contain the Rotarian emblem;

4 15. Benevolent Protective Order of Elks License Plate - such  
5 plates shall be designed, subject to criteria to be presented to the  
6 Tax Commission, by the Benevolent Protective Order of Elks, and  
7 issued to any resident of this state who is a member of the  
8 Benevolent Protective Order of Elks;

9 16. Humane Society License Plate - such plates shall be  
10 designed and issued to any person wishing to demonstrate support for  
11 the Humane Society of the United States. The plates shall be issued  
12 to any person in any combination of numbers and letters from one to  
13 a maximum of seven, as for personalized license plates. The plate  
14 shall contain the official Humane Society logo;

15 17. Oklahoma Mustang Club License Plate - such plates shall be  
16 designed, subject to criteria to be presented to the Tax Commission,  
17 by the Oklahoma Mustang Club, and issued to any resident of this  
18 state who is a member of the Oklahoma Mustang Club. Such persons  
19 may apply for an Oklahoma Mustang Club license plate upon  
20 presentment of proof of membership in the Oklahoma Mustang Club.  
21 The plates shall be issued to any person in any combination of  
22 numbers and letters from one to a maximum of seven, as for  
23 personalized license plates;

1        18. American Business Clubs (AMBUCS) License Plate - such  
2 plates shall be designed and issued to members of American Business  
3 Clubs. Persons applying for such license plate must show proof of  
4 membership in AMBUCS. The license plates shall be designed in  
5 consultation with American Business Clubs;

6        19. West Point 200th Anniversary License Plate - such plates  
7 shall be designed and issued to any person wishing to commemorate  
8 the Two Hundredth Anniversary of the founding of the United States  
9 Military Academy at West Point, New York. The license plates shall  
10 be designed in consultation with the West Point Society of Central  
11 Oklahoma;

12        20. Oklahoma Aquarium License Plate - such plates shall be  
13 designed and issued to persons wishing to demonstrate support for  
14 the Oklahoma Aquarium. The license plates shall be designed in  
15 consultation with the Oklahoma Aquarium. Subject to the provisions  
16 of subsection A of this section, the Oklahoma Aquarium License Plate  
17 is hereby reauthorized effective November 1, 2021;

18        21. The Pride of Broken Arrow License Plate - such plates shall  
19 be designed and issued to any person wishing to demonstrate support  
20 for The Pride of Broken Arrow marching band. The plates shall be  
21 designed in consultation with the Broken Arrow Public School System;

22        22. Fellowship of Christian Athletes License Plate - such  
23 plates shall be designed in consultation with the Fellowship of  
24

1 Christian Athletes and issued to members and supporters of the  
2 Fellowship of Christian Athletes;

3 23. Parrothead Club License Plate - such plates shall be  
4 designed and issued to members and supporters of the Parrothead  
5 Club. The license plate shall be issued to any person in any  
6 combination of numbers and letters from one to a maximum of seven as  
7 for personalized license plates;

8 24. Oklahoma Bicycling Coalition License Plate - such plates  
9 shall be designed and issued to any person who is a member of the  
10 Oklahoma Bicycling Coalition. The license plates shall be designed  
11 in consultation with the Oklahoma Bicycling Coalition;

12 25. Electric Lineman License Plate - such plates shall be  
13 designed and issued to persons wishing to demonstrate support for  
14 Oklahoma's electric linemen. The license plates shall be designed  
15 in consultation with the Oklahoma Electric Superintendent's  
16 Association;

17 26. Alpha Kappa Alpha License Plate - such plates shall be  
18 designed and issued to any person who is a member of Alpha Kappa  
19 Alpha Sorority. The license plates shall be designed in  
20 consultation with the Oklahoma Chapter of Alpha Kappa Alpha  
21 Sorority;

22 27. The National Pan-Hellenic Council Incorporated License  
23 Plate - such plates shall be designed and issued to any person  
24 wishing to demonstrate support to any of the nine sororities and

1 fraternities recognized by the National Pan-Hellenic Council  
2 Incorporated. The license plates shall be designed in consultation  
3 with the Oklahoma Chapter of the National Pan-Hellenic Council  
4 Incorporated;

5 28. Organ, Eye and Tissue License Plate - such plates shall be  
6 designed and issued to persons wishing to demonstrate support and  
7 increase awareness for organ, eye and tissue donation. The license  
8 plates shall be designed in consultation with the State Department  
9 of Health;

10 29. Central Oklahoma Habitat for Humanity License Plate - such  
11 plates shall be designed and issued to persons wishing to  
12 demonstrate support and increase awareness for Habitat for Humanity.  
13 The license plate shall be designed in consultation with Central  
14 Oklahoma Habitat for Humanity;

15 30. Family Career and Community Leaders of America Incorporated  
16 License Plate - such plates shall be designed and issued to persons  
17 wishing to demonstrate support for Family Career and Community  
18 Leaders of America Incorporated. The license plates shall be  
19 designed in consultation with Family Career and Community Leaders of  
20 America Incorporated;

21 31. Delta Sigma Theta License Plate - such plates shall be  
22 designed and issued to any person who is a member of Delta Sigma  
23 Theta Sorority. The license plates shall be designed in  
24

1 consultation with the Oklahoma Chapter of Delta Sigma Theta Sorority  
2 Incorporated;

3 32. Omega Psi Phi License Plate - such plates shall be designed  
4 and issued to any person who is a member of Omega Psi Phi  
5 Fraternity. The license plates shall be designed in consultation  
6 with the Oklahoma Chapter of Omega Psi Phi Fraternity Incorporated;

7 33. Alpha Phi Alpha License Plate - such plates shall be  
8 designed and issued to any person who is a member of Alpha Phi Alpha  
9 Fraternity. The license plates shall be designed in consultation  
10 with the Oklahoma Chapter of Alpha Phi Alpha Fraternity  
11 Incorporated;

12 34. 50th Anniversary of the Interstate System of Highways  
13 License Plate - such plates shall be designed and issued to persons  
14 wishing to commemorate the 50th Anniversary of the Interstate System

2 designed and issued to any person wishing to honor the victims of  
3 the terrorist bombing attack on the Alfred P. Murrah Federal  
4 Building in downtown Oklahoma City on April 19, 1995. As provided  
5 in this section, an amount of the fee collected shall be deposited  
6 in the Heart of the Heartland Scholarship Fund, as established in  
7 Section 2282 of Title 70 of the Oklahoma Statutes;

8        10. Emergency Medical Technician License Plate - such plates  
9 shall be designed and issued to any person who is an emergency  
10 medical technician. Such persons may apply for an emergency medical  
11 technician license plate for each vehicle with a rated carrying  
12 capacity of one (1) ton or less upon proof of an emergency medical  
13 technician's license. The license plate shall be designed in  
14 consultation with the state association of emergency medical  
15 technicians. As provided in this section, an amount of the fee  
16 collected shall be apportioned to the Emergency Medical Personnel  
17 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63  
18 of the Oklahoma Statutes;

19        11. Fight Breast Cancer License Plate - such plates shall be  
20 designed to demonstrate support for the prevention and treatment of  
21 breast cancer in this state. As provided in this section, an amount  
22 of the fee collected shall be apportioned to the Breast Cancer Act  
23 Revolving Fund;

1        12. Crime Victims Awareness License Plate - such plates shall  
2 be designed and issued to any person wishing to demonstrate  
3 awareness of and support for victims of crimes. The license plates  
4 shall be designed in consultation with the Oklahoma Crime Victims  
5 Centre. As provided in this section, an amount of the fee collected  
6 shall be apportioned to the Attorney General's Revolving Fund for  
7 the Office of the Attorney General, which is hereby directed to use  
8 such funds to contract with a statewide nonprofit organization to  
9 provide services to crime victims;

10       13. Oklahoma Safe Kids Association License Plate - such plates  
11 shall be designed and issued to any person wishing to demonstrate  
12 support and awareness of the Oklahoma Safe Kids Association. The  
13 license plate shall be designed in consultation with the Oklahoma  
14 Safe Kids Association. As provided in this section, an amount of  
15 the fee collected shall be deposited in the Children's Hospital -

22 to any person as for personalized license plates. As provided in  
23 this section, an amount of the fee collected shall be apportioned to

2 Section 1104.4 of this title;

3 15. Agricultural Awareness License Plate - such plates shall be  
4 designed, subject to criteria to be presented to the Tax Commission,  
5 by the Oklahoma Department of Agriculture, Food, and Forestry in  
6 consultation with the Oklahoma Arts Council, and issued to any  
7 person wishing to demonstrate support of the Department's Ag in the  
8 Classroom Education Program. As provided in this section, an amount  
9 of the fee collected shall be apportioned as provided in Section  
10 1104.3 of this title;

11 16. Oklahoma Statehood Centennial License Plate - such plates  
12 shall be designed and issued to any person wishing to commemorate  
13 the centennial of Oklahoma's admission to statehood in 1907. The  
14 license plates shall be designed in consultation with the Oklahoma  
15 Capitol Complex and Centennial Commemoration Commission. As  
16 provided in this section, an amount of the fee collected shall be  
17 deposited in the Oklahoma ~~Capitol Complex and Centennial~~  
18 ~~Commemoration Commission~~ Department of Commerce Revolving Fund  
19 created in Section ~~98.5~~ 5012 of Title ~~73~~ 74 of the Oklahoma  
20 Statutes;

21 17. Support Education License Plate - such plates shall be  
22 designed, subject to criteria to be presented to the Tax Commission  
23 by the State Department of Education in consultation with the  
24 Oklahoma Arts Council, and issued to any person wishing to

1 demonstrate support for education in this state. All motor license  
2 agents shall display a sample of the Support Education License plate  
3 in the area of the business accessed by the public. Twenty-three  
4 Dollars (\$23.00) of the fee collected shall be apportioned as  
5 follows:

- 6 a. five percent (5%) shall be deposited to the Education  
7 Reform Revolving Fund,

20 shall contain the official Boy Scouts of America logo. The Tax  
21 Commission shall be authorized, if necessary, to enter into a  
22 licensing agreement with the Boy Scouts of America for any licensing  
23 fees which may be required in order to use the Boy Scouts of America  
24 logo or design. The licensing agreement shall provide for a payment

1 to the Boy Scouts of America of not more than Twenty Dollars  
2 (\$20.00) for each license plate issued;

3 20. Urban Forestry and Beautification License Plate - such  
4 plates shall be designed, subject to criteria to be presented to the  
5 Tax Commission, by the Oklahoma Department of Agriculture, Food, and  
6 Forestry in consultation with nonprofit organizations in this state  
7 that develop and operate programs to encourage urban forestry and  
8 beautification, and issued to any person wishing to demonstrate  
9 support of such programs. As provided in this section, an amount of  
10 the fee collected shall be apportioned as provided in Section 1104.5  
11 of this title;

12 21. Oklahoma State Parks Supporter License Plate - such plates  
13 shall be designed, subject to criteria to be presented to the Tax  
14 Commission by the Oklahoma Tourism and Recreation Department, and  
15 issued to any person wishing to demonstrate support for the Oklahoma  
16 state parks system. Twenty-three Dollars (\$23.00) of the fee  
17 collected shall be deposited in the Oklahoma Tourism and Recreation  
18 Department Revolving Fund. Such money shall be designated for and  
19 may only be expended for the support of Oklahoma state parks;

20 22. Adoption Creates Families License Plate - such plates shall  
21 be issued to any person wishing to demonstrate support of pregnant  
22 women who are committed to placing their children for adoption and  
23 wishing to provide assistance to guardians, adoptive parents and  
24 other created families to assist in the adoption and placement of

1 children in permanent, safe homes. The license plates shall be  
2 designed and final terminology delivered in consultation with the  
3 Oklahoma Adoption Coalition and the Department of Human Services.  
4 Twenty-five Dollars (\$25.00) of the fee collected shall be deposited  
5 in a revolving fund established in the State Treasury for and to be  
6 used by the Department of Human Services for the implementation of

22 amount of the fee collected shall be apportioned as provided in  
23 Section 1104.7 of this title;

1        25. Lions Club License Plate - such plates shall be designed  
2 and issued to persons wishing to demonstrate support for the Lions  
3 Club of Oklahoma. The plates shall be issued to any person in any  
4 combination of numbers and letters from one to a maximum of seven,  
5 as for personalized license plates. The license plates shall be  
6 designed in consultation with the Oklahoma Lions Service Foundation  
7 and shall contain the official logo of the International Association  
8 of Lions Clubs. The Tax Commission shall be authorized to enter  
9 into a licensing agreement with the Oklahoma Lions Service  
10 Foundation. The licensing agreement shall provide for a payment to  
11 the Oklahoma Lions Service Foundation of not more than Ten Dollars  
12 (\$10.00) for each license plate issued;

13        26. Color Oklahoma License Plate - such plates shall be  
14 designed, subject to criteria to be presented to the Tax Commission  
15 by the Oklahoma Native Plant Society, and issued to any person  
16 wishing to demonstrate support for preserving and planting  
17 wildflowers and native plants in Oklahoma and to promote Oklahoma's  
18 wildflower heritage through education. As provided in this section,  
19 an amount of the fee collected shall be apportioned as provided in  
20 Section 1104.8 of this title;

21        27. Girl Scouts of the United States of America Supporter  
22 License Plate - such plates shall be designed and issued to any  
23 person wishing to demonstrate support for the Girl Scouts of the  
24 United States of America. The plates shall be issued to any person



1 in any combination of numbers and letters from one to a maximum of  
2 seven, as for personalized license plates. The plate shall contain  
3 the official Girl Scouts of the United States of America logo. The  
4 Tax Commission shall be authorized, if necessary, to enter into a  
5 licensing agreement with the Girl Scouts of the United States of  
6 America for any licensing fees which may be required in order to use  
7 the Girl Scouts of the United States of America logo or design. The

16 Dollars (\$20.00) of the fee collected shall be designated by the  
17 purchaser of the plate to be deposited in the Oklahoma Pet  
18 Overpopulation Fund created in Section 2368.13 of Title 68 of the  
19 Oklahoma Statutes or the Animal Friendly Revolving Fund created in  
20 Section 1104.10 of this title;

21 32. Patriot License Plate - such plates shall be designed in

9 As provided in this section, an amount of the fee collected shall be

13 shall be designed and issued to any person wishing to demonstrate

6 to enter into a licensing agreement with the Stillwater School  
7 District for any licensing fees which may be required in order to

9 shall provide for a payment to the Stillwater School District of not  
10 more than Twenty Dollars (\$20.00) for each license plate issued;

11        103. Oklahoma Golf License Plate - such plates shall be issued  
12 to any person wishing to demonstrate support for the sport of golf  
13 in Oklahoma. The plates shall be designed in consultation with the  
14 South Central Section of the Professional Golfers' Association of  
15 America and issued to any person wishing to demonstrate support for  
16 the sport of golf in Oklahoma. The Tax Commission shall be  
17 authorized to enter into a licensing agreement with the South

6 RUF/NEKS. The Tax Commission shall be authorized to enter into a  
7 licensing agreement with the University of Oklahoma RUF/NEKS for any  
8 licensing fees which may be required in order to use the  
9 organization's logo or design. The licensing agreement shall  
10 provide for a payment to the University of Oklahoma RUF/NEKS  
11 Scholarship Fund of not more than Twenty Dollars (\$20.00) for each  
12 license plate issued; and

13        107. Tulsa Community College License Plate - such plates shall  
14 be issued to persons wishing to support Tulsa Community College.  
15 The plates shall be designed in consultation with Tulsa Community  
16 College. The Tax Commission shall be authorized to enter into a  
17 licensing agreement with Tulsa Community College for any licensing  
18 fees which may be required in order to use the organization's logo  
19 or design. The licensing agreement shall provide for a payment to  
20 Tulsa Community College of not more than Twenty Dollars (\$20.00) for  
21 each license plate issued.

22        C. The fee for such plates shall be Thirty-five Dollars  
23 (\$35.00) per year of renewal and shall be in addition to all other

3 1. Twenty Dollars (\$20.00) per year of renewal or any other

11 3. Any remaining amounts of the fee shall be apportioned as  
12 provided in Section 1104 of this title.

13 SECTION 4. AMENDATORY Section 4, Chapter 434, O.S.L.  
14 2019 (68 O.S. Supp. 2020, Section 2368.32), is amended to read as  
15 follows:

16 Section 2368.32 There is hereby created in the State Treasury a  
17 revolving fund to be designated the "Historic Greenwood  
18 District/Juneteenth Festival Revolving Fund" and administered by the  
19 Oklahoma Department of Commerce. The fund shall be a continuing  
20 fund, not subject to fiscal year limitations, and shall consist of  
21 all the monies received by the Oklahoma Department of Commerce  
22 pursuant to the provisions related to the Historic Greenwood  
23 District License Plate in Section 1135.5 of Title 47 of the Oklahoma  
24 Statutes. All monies accruing to the credit of the fund are

1 appropriated and may be budgeted and expended by the Oklahoma  
2 Department of Commerce at the beginning of each fiscal year for the  
3 purpose of providing grants to support and promote the Historic  
4 Greenwood District Juneteenth Festival in the Historic Greenwood  
5 District in Tulsa, Oklahoma. Expenditures from the fund shall be  
6 made upon warrants issued by the State Treasurer against claims  
7 filed as prescribed by law with the Director of the Office of  
8 Management and Enterprise Services for approval and payment and in  
9 consultation with the Black Wall Street Chamber of Commerce. Upon  
10 the effective date of Section 3 of this act, the Oklahoma Department  
11 of Commerce shall transfer all the existing unencumbered monies  
12 contained in the Historic Greenwood District/Juneteenth Festival  
13 Revolving Fund to the Historic Greenwood District Juneteenth  
14 Festival. For ninety (90) days following the effective date of this  
15 act, the fund shall be monitored for the accrual of funds. If any  
16 other monies accrue to the fund in the said ninety (90) days, those  
17 funds shall be transferred to the Historic Greenwood District  
18 Festival as they accrue. At the end of the ninety-day term, the  
19 provisions of this section shall cease to have the force and effect  
20 of law and this fund shall cease to exist.

21 SECTION 5. REPEALER Section 4, Chapter 434, O.S.L. 2019  
22 (68 O.S. Supp. 2020, Section 2368.32), as last amended by Section 5  
23 of this act, is hereby repealed.

1       SECTION 6. Sections 1 and 2 of this act shall become effective  
2 November 1, 2021.

3       SECTION 7. Section 5 of this act shall become effective ninety  
4 (90) days following the date as of which Section 3 of this act  
5 becomes effective as law.

6       SECTION 8. It being immediately necessary for the preservation  
7 of the public peace, health or safety, an emergency is hereby  
8 declared to exist, by reason whereof Sections 3 and 4 of this act  
9 shall take effect and be in full force from and after its passage  
10 and approval.
