11                               COMMITTEE SUBSTITUTE

12           An Act relating to the Oklahoma Conservation  
13           Commission; requiring that portions of certain funds  
14           be used for certain purposes; providing procedures;  
15           providing lapse dates; and requiring and prohibiting  
16           certain budget procedures.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18       SECTION 1. From the funds appropriated to the Oklahoma  
19 Conservation Commission in Enrolled House Bill No. 2900 of the 1st  
20 Session of the 58th Oklahoma Legislature, the sum of Ninety Thousand  
21 Dollars (\$90,000.00) shall, under the direction of the Executive  
22 Director of Conservation, be allocated to the Master Irrigator  
23 Program affiliated with the Oklahoma State University Agricultural

1 Extension Service. Such funds shall be used for training within the  
2 Master Irrigators Program.

3 SECTION 2. From the funds appropriated to the Oklahoma  
4 Conservation Commission in Enrolled House Bill No. 2900 of the 1st  
5 Session of the 58th Oklahoma Legislature, the sum of Fifty Thousand  
6 Dollars (\$50,000.00) shall, under the direction of the Executive  
7 Director of Conservation, be allocated to the Master Irrigator  
8 Program affiliated with the Oklahoma State University Agricultural  
9 Extension Service. Such funds shall be used for studying the  
10 Ogallala Aquifer.

11 SECTION 3. Appropriations made by Enrolled House Bill No. 2900  
12 of the 1st Session of the 58th Oklahoma Legislature, not including  
13 appropriations made for capital outlay purposes, may be budgeted for  
14 the fiscal year ending June 30, 2022 (hereafter FY-22) or may be  
15 budgeted for the fiscal year ending June 30, 2023 (hereafter FY-23).  
16 Funds budgeted for FY-22 may be encumbered only through June 30,  
17 2022, and must be expended by November 15, 2022. Any funds  
18 remaining after November 15, 2022, and not budgeted for FY-23, shall  
19 lapse to the credit of the proper fund for the then current fiscal  
20 year. Funds budgeted for FY-23 may be encumbered only through June  
21 30, 2023. Any funds remaining after November 15, 2023, shall lapse  
22 to the credit of the proper fund for the then current fiscal year.  
23 These appropriations may not be budgeted in both fiscal years  
24 simultaneously. Funds budgeted in FY-22, and not required to pay

obligations for that fiscal year, may be budgeted for FY-23, after the agency to which the funds have been appropriated has prepared and submitted a budget work program revision removing these funds from the FY-22 budget work program and after such revision has been approved by the Office of Management and Enterprise Services.
