10                                   COMMITTEE SUBSTITUTE

11                   An Act relating to waters and water rights; amending  
12                   82 O.S. 2021, Section 105.20, which relates to  
13                   violations; subjecting certain violations to  
14                   administrative penalties; setting maximum penalty;  
15                   requiring certain notice and opportunity for hearing;  
16                   amending 82 O.S. 2021, Section 1020.22, which relates  
17                   to violations; subjecting certain violations to  
18                   administrative penalties; setting maximum penalty;  
19                   requiring certain notice and opportunity for hearing;  
20                   modifying maximum fine; and providing an effective  
21                   date.

22 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

23                   SECTION 1.           AMENDATORY           82 O.S. 2021, Section 105.20, is  
24                   amended to read as follows:

                  Section 105.20   A.   The unauthorized use of water, the  
unauthorized transfer of a water right, the continued use of works  
which are unsafe after receiving notice to repair, the waste of

1 water, the unauthorized severance of a water right from the land to  
2 which it is appurtenant, the refusal to change unsafe works when  
3 directed to do so, ~~or~~ the injury or obstruction of waterworks, or  
4 the violation of a permit condition shall be a misdemeanor and each  
5 day such violation continues shall be a separate violation. In  
6 addition to filing criminal complaints and any other remedies  
7 provided herein, the Oklahoma Water Resources Board shall have the  
8 right to bring an action in the district court of the county wherein  
9 such act or omission occurs to enjoin the same.

10 B. The unauthorized use of water, the unauthorized transfer of  
11 a water right, the continued use of works which are unsafe after  
12 receiving notice to repair, the waste of water, the unauthorized  
13 severance of a water right from the land to which it is appurtenant,  
14 the refusal to change unsafe works when directed to do so, the  
15 injury or obstruction of waterworks, or the violation of a permit  
16 condition are considered violations of Sections 105.1 through 105.32  
17 of this title and shall be subject to administrative penalties  
18 issued by the Board of up to Five Thousand Dollars (\$5,000.00) per  
19 day of violation. Such administrative penalties shall be imposed  
20 only after notice and opportunity for hearing on the proposed  
21 imposition of such penalties.

22 C. The Board and its authorized agents shall have a reasonable  
23 right to go upon private property in the performance of their duties  
24

1 hereunder and shall have the duty to file complaints of violations  
2 of the penal provisions of this section.

3 SECTION 2. AMENDATORY 82 O.S. 2021, Section 1020.22, is  
4 amended to read as follows:

5 Section 1020.22 A. Except as otherwise provided by subsection  
6 C of this section, any person who, after notice from the Water  
7 Resources Board, violates or refuses or neglects to comply with any  
8 provision of Sections 1020.1 through 1020.21 of this title, or any  
9 permit condition, or of any rule or regulation promulgated by the  
10 Board pursuant thereto, or who commits waste as defined in Section  
11 1020.15 of this title shall be subject to administrative penalties  
12 issued by the Board. Said penalties shall not exceed Five Thousand  
13 Dollars (\$5,000.00) per day for each violation and each day such  
14 violation continues shall constitute a separate violation. Such  
15 administrative penalties shall be imposed only after notice and  
16 opportunity for hearing on the proposed imposition of such  
17 penalties.

18 B. In addition to administrative penalties, except as otherwise  
19 provided by subsection ~~B~~ C of this section, any person who, after  
20 notice from the Board, violates or refuses or neglects to comply  
21 with any provision of Sections 1020.1 through 1020.21 of this title,  
22 or of any rule or regulation promulgated by the Board pursuant  
23 thereto, or who commits waste as defined in Section 1020.15 of this  
24 title shall be guilty of a misdemeanor, and upon conviction shall be

1 fined not less than Twenty-five Dollars (\$25.00) nor more than ~~Two~~  
2 ~~Hundred Fifty Dollars (\$250.00)~~ One Thousand Dollars (\$1,000.00) for  
3 each offense. Any person who, after notice that he or she is in  
4 violation thereof continues to violate any provision of Sections  
5 1020.1 through 1020.21 of this title, and fails to comply therewith  
6 within a reasonable length of time, is guilty of a separate offense  
7 for each day the violation continues.

8 ~~B.~~ C. Any person causing pollution of the groundwater or  
9 placing or causing to be placed waste in a location where ~~they are~~  
10 it is likely to cause pollution of the groundwater shall be subject  
11 to the Oklahoma Environmental Quality Code.

12 SECTION 3. This act shall become effective November 1, 2022.
