7 AS INTRODUCED

8 An Act relating to crimes and punishments; amending
9 21 O.S. 2021, Section 1716, which relates to the
10 larceny of livestock or implement of husbandry;
 authorizing the electronic transmission of certain
 information; and providing an effective date.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 21 O.S. 2021, Section 1716, is
15 amended to read as follows:

16 Section 1716. A. Any person in this state who shall steal any
17 horse, jackass, jennet, mule, cow, hog or implement of husbandry as
18 defined in Section 1-125 of Title 47 of the Oklahoma Statutes shall,
19 upon conviction, be guilty of a felony punishable by imprisonment in
20 the custody of the Department of Corrections for a term of not less
21 than three (3) years nor more than ten (10) years, or by a fine in
22 an amount that is equal to three times the value of animals and
23 machinery that were stolen but not more than Five Hundred Thousand
24 Dollars (\$500,000.00), or by both such fine and imprisonment. Each

1 head of cattle stolen may constitute a separate offense and may be
2 punishable as a separate violation.

3 B. Any person in this state who shall steal any dog, sheep or
4 goat shall, upon conviction, be guilty of a felony punishable by
5 imprisonment in the custody of the Department of Corrections for a
6 term of not less than six (6) months nor more than three (3) years,
7 or by a fine in an amount that is equal to three times the value of
8 the animals that were stolen but not more than Five Hundred Thousand
9 Dollars (\$500,000.00), or by both such fine and imprisonment.

10 C. The word "horse" as used in this section includes all
11 animals of the equine species, and the word "cow" includes all
12 animals of the bovine species.

13 D. Persons convicted of violating the provisions of subsection
14 A of this section shall be registered by the Oklahoma Department of
15 Agriculture, Food, and Forestry in the Livestock Offender Registry
16 created in Section ~~4~~ 2-16.1 of ~~this act~~ Title 2 of the Oklahoma
17 Statutes.

18 E. The county in which the offender is convicted shall submit a
19 certified copy of the judgment and sentence confirming the
20 conviction for entry in the Livestock Offender Registry to the
21 Oklahoma Department of Agriculture, Food, and Forestry or, if
22 designated by the Department, to a statewide livestock organization.
23 In lieu of sending a paper copy of the judgment and sentence
24 required by this subsection, the county may transmit the conviction

1 information by using an electronic method authorized by the Oklahoma
2 Department of Agriculture, Food, and Forestry.

3 SECTION 2. This act shall become effective November 1, 2022.
