7 AS INTRODUCED

8 A Resolution relating to the House Rules;
9 establishing a Special Rule for House Bills 1237,
10 1238 and 1239 of the 1st Session of the 58th Oklahoma
11 Legislature; prescribing procedures related to
12 consideration of measures and amendments to measures;
13 providing that the Special Rule shall take precedence
14 when in conflict with the House Rules; providing for
15 strict construction of the Special Rule; and
16 providing for termination of the Special Rule.

17 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE 1ST SESSION OF
18 THE 58TH OKLAHOMA LEGISLATURE:

19 SECTION 1. A Special Rule is created herein pursuant to Section
20 8.5 of House Rules adopted for the 1st Session of the 58th Oklahoma
21 Legislature for purposes of addressing states' rights and
22 constitutional issues.

23 SECTION 2. The following provisions shall apply during
24 consideration of House Bills 1237, 1238 and 1239 of the 1st Session
of the 58th Oklahoma Legislature:

1 Authorship: Rep. Mark McBride shall also be an Author of the
2 measures listed in this Special Rule.

3 Consideration: No more than thirty (30) minutes of total time
4 shall be expended for consideration of each measure listed in this
5 Special Rule.

6 Germaneness: No point of order shall be considered related to
7 the germaneness of any amendment offered to the measures listed in
8 this Special Rule, and the provisions of the House Rules governing
9 germaneness of a floor amendment to a House measure shall not be
10 applicable to the measures listed in this Special Rule.

11 Floor Amendments: Except for floor amendments proposed by the
12 Principal Author of any measure listed in this Special Rule, no
13 floor amendment shall be presented to or considered by the House on
14 the measures listed in this Special Rule, and except as otherwise
15 provided by this Special Rule, the provisions of House Rule No. 8.8
16 shall not be applicable to these measures.

17 Legislative Procedural Schedule: The measures listed in this
18 Special Rule shall not be subject to the provisions of Joint Rule
19 7(a).

20 SECTION 3. The terms of this Special Rule shall take precedence
21 when in conflict with the House Rules; otherwise, the House Rules
22 shall remain applicable. The presiding officer shall strictly
23 construe the provisions of this Special Rule.

1 SECTION 4. The terms of this Special Rule shall become
2 effective upon adoption, and this Special Rule shall terminate upon
3 completion of consideration of the measures named herein.
