17	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:	
18	SECTION 1. AMENDATORY 51 O.S. 2021, Section 24A.3, is	
19	amended to read as follows:	
20	Section 24A.3 As used in the Oklahoma Open Records Act:	
21	1. "Record" means all documents $_{ au}$ including, but not limited to,	
22	any book, paper, photograph, microfilm, data files created by or	
23	used with computer software, computer tape, disk, record, sound	
24	recording, film recording, video record or other material regardless	

of physical form or characteristic, created by, received by, under
the authority of, or coming into the custody, control or possession
of public officials, public bodies, or their representatives in
connection with the transaction of public business, the expenditure
of public funds or the administering of public property. "Record"
does not mean:

a. computer software,

- b. nongovernment personal effects,
- c. unless public disclosure is required by other laws or regulations, vehicle movement records of the Oklahoma

 Transportation Authority obtained in connection with the Authority's electronic toll collection system,
- d. personal financial information, credit reports or other financial data obtained by or submitted to a public body for the purpose of evaluating credit worthiness, obtaining a license, permit, or for the purpose of becoming qualified to contract with a public body,
- e. any digital audio/video recordings of the toll collection and safeguarding activities of the Oklahoma Transportation Authority,
- f. any personal information provided by a guest at any facility owned or operated by the Oklahoma Tourism and Recreation Department or the Board of Trustees of the

information. Provided, however, lists of persons
licensed, the existence of a license of a person, or
an address expressly stated to be a business or

information disclosable under state law submitted with
an application for licensure shall be public records;

- 2. "Public body" shall include, but not be limited to, any office, department, board, bureau, commission, agency, trusteeship, authority, council, committee, trust or any entity created by a trust, county, city, village, town, township, district, school district, fair board, court, executive office, advisory group, task force, study group, or any subdivision thereof, supported in whole or in part by public funds or entrusted with the expenditure of public funds or administering or operating public property, and all committees, or subcommittees thereof. Except for the records required by Section 24A.4 of this title, "public body" does not mean judges, justices, the Council on Judicial Complaints, the Legislature, or legislators;
- 3. "Public office" means the physical location where public bodies conduct business or keep records;
- 4. "Public official" means any official or employee of any public body as defined herein; and

- 5. "Law enforcement agency" means any public body charged with
 enforcing state or local criminal laws and initiating criminal
 prosecutions; including, but not limited to, police departments,

 county sheriffs, the Department of Public Safety, the Oklahoma State
 Bureau of Narcotics and Dangerous Drugs Control, the Alcoholic
 Beverage Laws Enforcement Commission, and the Oklahoma State Bureau
 of Investigation.
- 8 SECTION 2. AMENDATORY 51 O.S. 2021, Section 24A.10, is 9 amended to read as follows:
 - Section 24A.10 A. Any information, records or other material heretofore voluntarily supplied to any state agency, board or commission shall be subject to full disclosure pursuant to Section 24A.1 et seq. of this title.
 - B. If disclosure would give an unfair advantage to competitors or bidders, a public body may keep confidential records relating to:
 - 1. Bid specifications for competitive bidding prior to publication by the public body; $\frac{\partial}{\partial x}$
 - 2. Contents of sealed bids prior to the opening of bids by a public body; or
 - 3. Computer programs or software but not data thereon; or
 - 4. Appraisals relating to the sale or acquisition of real estate by a public body prior to award of a contract; or
- 5. The prospective location of a private business or industry prior to public disclosure of such prospect except for records

- 1 otherwise open to inspection such as applications for permits or 2 licenses.
 - C. Except as set forth hereafter, the Oklahoma Department of Commerce, the Oklahoma Department of Career and Technology

 Education, the technology center school districts, the Oklahoma Film and Music Office, institutions within the Oklahoma State System of Higher Education, and the Department of Corrections may keep confidential:
 - 1. Business plans, feasibility studies, financing proposals, marketing plans, financial statements or trade secrets submitted by a person or entity seeking economic advice, business development or customized training from such Departments or school districts;
 - 2. Proprietary information of the business submitted to the Department or school districts for the purpose of business development or customized training, and related confidentiality agreements detailing the information or records designated as confidential; and
 - 3. Information compiled by such Departments or school districts in response to those submissions.
 - The Oklahoma Department of Commerce, the Oklahoma Department of Career and Technology Education, the technology center school districts, the Oklahoma Film and Music Office, institutions within the Oklahoma State System of Higher Education, and the Department of Corrections may not keep confidential that submitted information

when and to the extent the person or entity submitting the information consents to disclosure.

Although they must provide public access to their records, 3 including records of the address, rate paid for services, charges, 4 5 consumption rates, adjustments to the bill, reasons for adjustment, the name of the person that authorized the adjustment, and payment 6 for each customer, public bodies that provide utility services to 7 the public may shall keep confidential and shall redact from any 8 9 record, personal electronic mail addresses, credit information, credit card numbers, telephone numbers, social security numbers, 10 bank account information for individual customers, and any portion 11 12 of any record that contains the name or any other identifier of the occupants of any residential structure. Public bodies that provide 13 utility services to the public may keep confidential utility supply 14 and utility equipment supply contracts for any industrial customer 15 with a connected electric load in excess of two thousand five 16 hundred (2,500) kilowatts if public access to such contracts would 17 give an unfair advantage to competitors of the customer; provided 18 that, where a public body performs billing or collection services 19 for a utility regulated by the Corporation Commission pursuant to a 20 contractual agreement, any customer or individual payment data 21 obtained or created by the public body in performance of the 22 agreement shall not be a record for purposes of this act the 23 Oklahoma Open Records Act. 24

1	SECTION 3. This act shall become effective November 1, 2022.
