| 13 | SECTION 1. There is hereby appropriated to the Physician                                   |
| 14 | Manpower Training Commission from any monies not otherwise                                 |
| 15 | appropriated from the General Revenue Fund of the State Treasury for                       |
| 16 | the fiscal year ending June 30, 2022, the sum of One Hundred                               |
| 17 | Thousand Dollars (\$100,000.00) or so much thereof as may be                               |

| 20 | SECTION 2. Appropriations made by Section 1 of this act, not                               |
