15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. AMENDATORY 74 O.S. 2011, Section 85.12, as
17	last amended by Section 11, Chapter 98, O.S.L. 2020 (74 O.S. Supp.
18	2020, Section 85.12), is amended to read as follows:
19	Section 85.12. A. The provisions of this section shall not be
20	construed to affect any law relating to fiscal or accounting
21	procedure except as they may be directly in conflict herewith; and
22	all claims, warrants, and bonds shall be examined, inspected, and
23	approved as now provided by law.

B. Except as otherwise provided by this section, the
acquisitions specified in this subsection shall be made in
compliance with Section 85.39 of this title and purchasing card
program requirements but are not subject to other provisions of the
Oklahoma Central Purchasing Act:

6 1. Food and other products produced by state institutions and7 agencies;

The printing or duplication of publications or forms of 8 2. 9 whatsoever kind or character by state agencies if the work is 10 performed upon their own equipment by their own employees. Pursuant 11 to this paragraph, the state agency may only use equipment owned or 12 leased by the agency and may only utilize that equipment for printing services required by the agency in performing duties 13 imposed upon the agency or functions authorized to be performed by 14 15 the agency. Any use of the equipment by the agency pursuant to an agreement or contract with any other entity resulting in delivery of 16 intermediate or finished products to the entity purchasing or using 17 the products shall be subject to the provisions of this act and 18 associated rules; 19

Department of Transportation and Transportation Commission
 contractual services or right-of-way acquisitions, contracts awarded
 pursuant to bids let by the Transportation Commission for the
 maintenance or construction of streets, roads, highways, bridges,
 underpasses, or any other transportation facilities under the

1 control of the Department of Transportation, equipment or material 2 acquisitions accruing to the Department of Transportation required 3 in Federal-Aid contracts, and acquisitions for public-service-type 4 announcements initiated by the Department of Transportation, but not 5 acquisitions for advertising, public relations or employment 6 services;

7 4. Utility services regulated by a state or federal regulatory
8 commission, municipal ordinance or an Indian Tribal Council;

9 5. Acquisitions by the University Hospitals Authority. The 10 Authority shall develop standards for the acquisition of products 11 and services and may elect to utilize the Purchasing Division. The 12 standards shall foster economy and short response time and shall 13 include appropriate safeguards and record-keeping requirements to 14 ensure appropriate competition and economical and efficient 15 purchasing;

16 6. Custom harvesting by the Department of Corrections for the17 Department or its institutions;

18 7. Subject to prior approval of the State Purchasing Director, 19 acquisitions from private prison suppliers which are subject to the 20 contracting procedures of Section 561 of Title 57 of the Oklahoma 21 Statutes;

8. Acquisitions by the Oklahoma Municipal Power Authority;
9. Acquisitions by the Grand River Dam Authority;

10. Acquisitions by rural water, sewer, gas or solid waste
 2 management districts created pursuant to the Rural Water, Sewer, Gas
 3 and Solid Waste Management Districts Act;

Acquisitions by the Oklahoma Ordnance Works Authority, the
Northeast Oklahoma Public Facilities Authority or the Midwestern
Oklahoma Development Authority;

7 12. Expenditure of monies appropriated to the State Board of
8 Education for Local and State Supported Financial Support of Public
9 Schools, except monies allocated therefrom for the Administrative
10 and Support Functions of the State Department of Education;

11 13. Expenditure of monies appropriated to the State Department 12 of Rehabilitation Services for educational programs or educational 13 materials for the Oklahoma School for the Blind and the Oklahoma 14 School for the Deaf;

15 14. Contracts entered into by the Oklahoma Department of Career 16 and Technology Education for the development, revision or updating 17 of vocational curriculum materials, and contracts entered into by 18 the Oklahoma Department of Career and Technology Education for 19 training and supportive services that address the needs of new or 20 expanding industries;

21 15. Contracts entered into by the Oklahoma Center for the
22 Advancement of Science and Technology for professional services;
23 16. Contracts entered into by the Oklahoma Department of
24 Commerce pursuant to the provisions of Section 5066.4 of this title;

1 17. Acquisitions made by the Oklahoma Historical Society from
 2 monies used to administer the White Hair Memorial;

3 18. Purchases of pharmaceuticals available through a multistate or multigovernmental contract if such pharmaceuticals are or have 4 5 been on state contract within the last fiscal year, and the terms of such contract are more favorable to the state or agency than the 6 7 terms of a state contract for the same products, as determined by the State Purchasing Director. The state entity designated by law, 8 9 as specified in Section 1010.3 of Title 56 of the Oklahoma Statutes, 10 shall participate in the purchase of pharmaceuticals available through such contracts; 11

12 19. Contracts for managed health care services entered into by 13 the state entity designated by law or the Department of Human 14 Services, as specified in paragraph 1 of subsection A of Section 15 1010.3 of Title 56 of the Oklahoma Statutes;

16 20. Acquisitions by a state agency through a General Services 17 Administration contract or other federal contract if the 18 acquisitions are not on current statewide contract or the terms of 19 the federal contract are more favorable to the agency than the terms 20 of a statewide contract for the same products;

21 21. Acquisitions of clothing for clients of the Department of
22 Human Services and acquisitions of food for group homes operated by
23 the Department of Human Services;

24 22. Acquisitions by the Oklahoma Energy Resources Board;

Acquisitions of clothing for juveniles in the custody of
 the Office of Juvenile Affairs and acquisitions of food for group
 homes operated by the Office of Juvenile Affairs;

4 24. State contracts for flexible benefits plans pursuant to the
5 Oklahoma State Employees Benefits Act, Section 1361 et seq. of this
6 title;

7 25. Acquisitions by the Department of Securities to
8 investigate, initiate, or pursue administrative, civil, or criminal
9 proceedings involving potential violations of the acts under the
10 Department's jurisdiction and acquisitions by the Department of
11 Securities for its investor education program;

12 26. Acquisitions for resale in and through canteens operated 13 pursuant to Section 537 of Title 57 of the Oklahoma Statutes and 14 canteens established at an institution or facility operated by the 15 Office of Juvenile Affairs;

16 27. Acquisitions by the Oklahoma Boll Weevil Eradication 17 Organization for employment and personnel services, and for 18 acquiring sprayers, blowers, traps, and attractants related to the 19 eradication of boll weevils in this state or as part of a national 20 or regional boll weevil eradication program;

21 28. Contracts entered into by the Oklahoma Indigent Defense
22 System for expert services pursuant to the provisions of subsection
23 D of Section 1355.4 of Title 22 of the Oklahoma Statutes;

29. Acquisitions by the Oklahoma Correctional Industries and
 the Agri-Services programs of the Department of Corrections of raw
 materials, component parts and other products, any equipment
 excluding vehicles, and any services excluding computer consultant
 services used to produce goods or services for resale and for the
 production of agricultural products;

30. Contracts entered into by the Department of Human Services
for provision of supported living services to members of the
plaintiff class in Homeward Bound, Inc., et al. v. The Hissom
Memorial Center, et al., Case Number 85-C-437-E, United States
District Court for the Northern District of Oklahoma;

12 31. Contracts negotiated by the Office of Juvenile Affairs with designated Youth Services Agencies and the Oklahoma Association of 13 Youth Services, or another Oklahoma nonprofit corporation whose 14 15 membership consists solely of Youth Services Agencies and of whom at 16 least a majority of Youth Services Agencies are members, pursuant to the provisions of Section 2-7-306 of Title 10A of the Oklahoma 17 Statutes and contracts entered into by the Department of Human 18 Services pursuant to Section 1-9-110 of Title 10A of the Oklahoma 19 Statutes with designated Youth Services Agencies; 20

32. Contracts for annuities for structured settlements provided
for in Section 158 of Title 51 of the Oklahoma Statutes;
33. Subject to subsection E of this section, purchases made
from funds received by local offices administered by the Department

of Human Services or administered by the Office of Juvenile Affairs for fund-raising activities and donations for the benefit of clients and potential clients at the local offices where such purchases may not otherwise be paid for from appropriated funds; and

5 34. Acquisitions by the Oklahoma Historical Society for 6 restoration of historical sites and museums although the agency may 7 elect to utilize the Purchasing Division for an acquisition with 8 supplier and bid selection being the prerogative of the agency, 9 based on the supplier's documented qualifications and experience; 10 and

11 <u>35. Acquisitions of clothing and food for patients in the care</u> 12 <u>of the J.D. McCarty Center for Children with Developmental</u> 13 Disabilities.

C. Pursuant to the terms of a contract the State Purchasing 14 15 Director enters into or awards, a state agency, common school, 16 municipality, rural fire protection district, county officer or any program contract, purchase, acquisition or expenditure that is not 17 subject to the provisions of the Oklahoma Central Purchasing Act, 18 may, unless acting pursuant to a contract with the state that 19 specifies otherwise, make use of statewide contracts and the 20 services of the Purchasing Division and the State Purchasing 21 Director. Any political subdivision or rural fire protection 22 district may designate the State Purchasing Director as its agent 23

for any acquisition from a statewide contract or otherwise available
 to the state.

3	D. The State Purchasing Director may make periodic audits of
4	the purchasing procedures of acquisitions listed in subsection B of
5	this section to ensure that the procedures are being followed.
6	E. With respect to the Department of Human Services or the
7	Office of Juvenile Affairs, as applicable, monies received by
8	fundraising activities or donations from the local office, vending
9	operations administered by employees of the agency and all other
10	nonrestricted cash and cash-equivalent items received by employees
11	of the agency shall be deposited in the agency special account
12	established for this purpose. The deposits shall be made at local
13	banking institutions approved by the State Treasurer.
14	SECTION 2. This act shall become effective November 1, 2021.
