Supp. 12 2020, Sections 650.4 and 650.5), which relate to assault and battery upon medical care providers and aggravated assault and battery upon medical care 13 providers; modifying definition; and providing an effective date. 14 15 16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: 17 SECTION 1. 21 O.S. 2011, Section 650.4, as 18 AMENDATORY amended by Section 2, Chapter 68, O.S.L. 2020 (21 O.S. Supp. 2020, 19 Section 650.4), is amended to read as follows: 20 Section 650.4. Every person who, without justifiable or 21 Α. excusable cause and with intent to do bodily harm, commits any 22 23 assault, battery or assault and battery upon the person of a medical 24 care provider who is performing medical care duties, upon

conviction, is guilty of a felony punishable by imprisonment in the custody of the Department of Corrections for a term not exceeding two (2) years, or by a fine not exceeding One Thousand Dollars (\$1,000.00), or by both such fine and imprisonment.

- B. As used in this section, "medical care provider" means doctors, residents, interns, nurses, nurses' aides, ambulance attendants and operators, paramedics, emergency medical technicians, laboratory technicians, radiologic technologists, physical therapists, physician assistants, chaplains, volunteers, pharmacists, nursing students, medical students, respiratory therapists and members of a hospital security force.
- 12 SECTION 2. AMENDATORY 21 O.S. 2011, Section 650.5, as
  13 amended by Section 3, Chapter 68, O.S.L. 2020 (21 O.S. Supp. 2020,
  14 Section 650.5), is amended to read as follows:

Section 650.5. A. Every person who, without justifiable or excusable cause and with intent to do bodily harm, commits any aggravated assault and battery or any assault with a firearm or other deadly weapon upon the person of a medical care provider, upon conviction, is guilty of a felony punishable by imprisonment in the custody of the Department of Corrections for a term not less than two (2) years nor more than five (5) years, or by a fine not to exceed One Thousand Dollars (\$1,000.00), or by both such fine and imprisonment.

4	laboratory technicians, radiologic technologists, physical

8	SECTION 3. This act shall become effective November 1, 2021.
